



SRINAGAR, SEP 20: Chief Minister Omar Abdullah today emphasized the need to complement Jammu and Kashmir's tourism success story with an equally robust industrial growth, calling upon industry leaders to view J&K as a viable and promising investment destination.

Addressing the 4th meeting of the Confederation of Indian Industry (CII) Northern Regional Council 2025-26, held in Srinagar, the Chief Minister acknowledged that while the focus in recent months has largely been on tourism,

industrial growth has not received the same attention. He assured stakeholders that the government is determined to correct this imbalance by strengthening the investment ecosystem across Jammu and Kashmir.

"Tourism is one part of our growth story, but the other part that requires equal attention is industrialisation," Omar Abdullah said while interacting with business leaders. ### Soldier dies in Udhampur encounter, hunt on for trapped terrorists

LG Sinha pay solemn tributes to fallen jawan

JAMMU, SEP 20: An Army soldier lost his life in action during an intense gunfight with terrorists in the rugged Seoj Dhar forest area along the Doda-Udhampur border, officials told the news agency-Kashmir News Observer (KNO) on Saturday.

They said the gunfight broke out on late Friday evening prompting a massive joint operation by security forces.

Lance Dafadar Baldev Chand was critically injured when a joint search party from the Army, Special Operations Group (SOG) of Jammu and Kashmir Police came under sudden fire from hiding terrorists during a cordon-and-search mission.

### Over 6,400 Tonnes Apples Transported From Kashmir To Delhi In 2 Weeks

**JAMMU, SEP 20:** Over 6,400 tonnes of apples have been transported from Kashmir to Delhi via parcel trains within two weeks, Jammu Division of

Northern Railways said on Saturday. Kashmir produces around 2-2.6 million metric tonnes of apples annually, accounting for about 70-80 per cent of the country's total apple production.

The Jammu Division of Northern

Railway is operating parcel trains carrying apples from Kashmir to Delhi after starting the service on September 11 with two parcel van coaches — one destined for Jammu and the other for Adarsh Nagar, Delhi.

"Each parcel van coachwas loaded with approximately 23 tons of goods. This was considered a historic achievement, as a parcel van coach first reached Adarsh Nagar, Delhi, from Budgam

SRINAGAR, SEP 20: The Srinagar Baramulla highway stretching from Narbal to Bemina, has increasingly turned into a speedway for vehicles, raising serious concerns over public safety.

Residents and commuters along this stretch report frequent accidents caused by speeding vehicles, with tragic consequences.

The highway, which passes through several

critical junctions, has witnessed multiple accidents in recent years. Just a day ago, a couple lost their lives after being hit by a speeding vehicle near Umarabad. Witnesses say that vehicles often travel at dangerously high speeds, leaving pedestrians with little chance to avoid collisions.

Local residents warn that the problem is exacerbated by several poorly managed junctions along the route.

seen of creating a Nepal style guerrilla movement it has now been confined to a few districts. I firmly believe that in the next three to four months, the nation will be completely free of Naxalism."

"However, terrorism has not disappeared completely. Some activities still remain in parts of Karnataka, Kerala, and a few regions of Jammu and Kashmir. I have always said that where terrorism exists, there is potential for greater danger. Its elimination cannot be the sole responsibility of the police or security forces society as a whole must take part," he said.

"When narratives are created that weaken the nation, they give rise to division and hostility. That is why I particularly urge the industrialists of the Valley to take responsibility. If you choose to remain silent spectators, your businesses and progress will suffer," LG Sinha said.

The Chief Minister presented an overview of ongoing investments and incentives in J&K, noting that industrial hubs such as Kathua, Samba, Bari Brahmana in Jammu, and Lassipora in Kashmir continue to attract the highest inflow of capital.

He underlined recent government efforts to simplify procedures, while candidly admitting gaps in the single-window clearance system:

"We must ensure that our 'single window' is truly a single window, not one that leads to a ventilator, then an exhaust fan, and eventually nowhere. I have directed the Industries Department to engage directly with recent investors and learn from their experiences to fix this system once and for all."

The Chief Minister highlighted J&K's comparative advantages: cheaper land and electricity than neighbouring regions, GST reimbursement benefits, and availability of skilled labour. He encouraged manufacturers to explore J&K for investment in certain investor- friendly sectors which offer competitive advantage and to weigh their options in the wake of new GST rate slabs.

On the perception-versus-reality gap about peace and security in the region, Omar Abdullah said:"[&K today is calm, peaceful, and open for business. Yes, there have been difficult times, but those are behind us. Tragic incidents like the one at Pahalgam are aberrations, not the norm, and every step is being taken to prevent its recurrence."

The Chief Minister urged investors to look beyond subsidy-driven models and invest in sectors where J&K has inherent strengths. He cited examples from agriculture, horticulture, and dairy production, noting that only 4% of milk in Kashmir processed, compared to 80% in Gujarat.

"This is a ready-made opportunity for value addition. We produce the raw material, we have the market, and yet we under-utilise our potential. The same is true for other sectors where J&K can provide both raw materials and skilled man-

Calling unemployment a pressing challenge, he stressed that the state cannot continue to rely only on government jobs. "Industrialisation and tourism together must create new employment avenues for our youth," he asserted.

The Chief Minister encouraged candid feedback from CII members so that the government will work on shortcomings, if any.

"Those of you investing in J&K, tell us what went well and what hasn't. Those of you who are reluctant, tell us why not—and if it is within our power, we will address it. Your feedback is critical to shaping a business-friendly future here.'

Among others who addressed the gathering were CII Northern Region Chairperson Anjali Singh. CII Delhi State Council Chairman Puneet Kaura, Vice Chairman CII J&K Council MA Alim and CII Northern Region Director Rachna Jindal.

The event witnessed wide participation from

industry leaders across the region. The Chief Minister thanked CII for organising the meeting in Srinagar and reaffirmed his government's commitment to facilitate investment, promote value addition and build a sustainable industrial ecosystem in Jammu and Kashmir.

after the April 22 terror attack in Pahalgam that killed many tourists.

Mohammad Yaqoob Dungoo, a renowned houseboat owner, says this is the hardest period he has ever witnessed in his lifetime.

"From April 22 till now, I have had only one booking worth Rs 1,500. After that, nothing. Even in the 1990s, when the situation was worst in Kashmir, we still had some work. But this time, we are finished," Dungoo told the news agency-Kashmir News Observer (KNO), a cold sigh slipping from his lips.

Dungoo said his family is suffering deeply. "I have three children, and my brother has two. We are unable to pay school fees. My children stayed home for over a month because we did not have admission money," he said.

"The school finally agreed because the principal knew me — I too had studied there. But not everyone is that fortunate," he added.

Dungoo said houseboats require expensive annual repairs. "Each houseboat needs at least Rs 1.2 lakh every year just for maintenance and caulking. But right now, we can't even manage basic household expenses, let alone repairs," he said.

The Kashmir Houseboat Owners Association told KNO that the crisis is rippling across the sector. 'Out of over 3,000-plus rooms across 750 houseboats, only 30 to 40 are occupied. The rest are empty," said its chairman, Manzoor Ahmad Pakthoon, adding that staff have been laid off and families have no income.

Dungoo said the situation has pushed many families to the brink. "We are not asking for luxuries. We just want enough to pay fees, buy books for our children and feed our families. Right now, we cannot do even that," he said.

Shikara operators and shopkeepers around Dal Lake said they too are badly affected. "No tourists means no rides, no buyers. Everyone linked to tourism, from vendors to artisans, is suffering, said a local shopkeeper.

It is worth mentioning that the government's decision to close 46 tourist destinations for security reasons has further added to the slump. Chief Minister Omar Abdullah earlier termed the ban "counterproductive," saying it undermines the

Valley's tourism promotion campaigns. Notably, the history of Kashmir's tourism sector has been chilling. In 1995, foreign tourists were kidnapped in Pahalgam, and one of them was killed. In 2000, the Amarnath Yatra massacre claimed multiple lives in Pahalgam. In 2017, eight Amarnath pilgrims were killed in an Anantnag attack, and in 2025, over 25 tourists and a local guide were killed in Pahalgam – the deadliest attack in recent memory–(KNO)

Railway Station (in Kashmir) in less than 21 hours, and another in Jammu in less than six hours," Senior Divisional Commercial Manager, Jammu Division, Uchit Singhal said in a statement here.

On September 15, Lt Governor Manoj Sinha flagged off an eight-parcel van coach train, each with a weight capacity of 23 tonnes, from Srinagar to Adarsh Nagar, Delhi.

affected people, listened to their grievances, and took stock of the ground situation.

Sunil said that the scale of destruction is heartbreaking. He expressed his pain that many families have lost everything

He assured the villagers that he would raise the matter at the highest levels and press the administration for immediate relief and rehabilitation measures. Relief must reach to the people at the earliest, he said and added that temporary shelters, emergency food supplies, medicines, and restoration of road links must be treated as top priority.

Sunil Sharma called upon the Union Territory administration and disaster management authorities to deploy emergency teams, including medical staff and engineers, to the area on an urgent basis. He also appealed to NGOs and civil society to come forward and support the people of Warwan in this critical time. He assured the residents of Margi and adjoining areas that they would not be left alone in this hour of crisis and that he would continue to monitor the relief efforts closely.

Sunil Sharma batted for a long-term plan to strengthen infrastructure in remote regions like

Warwan, which remain especially vulnerable during extreme weather events. Our remote areas need better preparedness, not just sympathy after disaster strikes, he emphasized.

News agency Kashmir Indepth News Service (KINS) reported that areas such as Shalteng Crossing, the Fruit Mandi, and near Ansari Motors are particularly dangerous, with vehicles frequently moving on the wrong side, ignoring traffic rules.

Despite occasional interventions, traffic authorities have largely been unable to maintain control over these high-risk zones. While traffic police occasionally step in to manage flow during peak hours, enforcement remains inconsistent, leaving pedestrians and local commuters vulnerable.

The presence of two major hospitals along this highway adds another layer of concern. While the JVC Hospital has an overhead bridge that allows commuters to cross safely, the Children's Hospital lacks any such facility. Parents and children are often forced to navigate the fast-moving traffic to reach the hospital, exposing them to serious risks. Residents point out that without proper pedestrian crossings or safety measures, crossing this busy highway is a daily gamble.

One of the major challenges, according to locals, is the inadequate monitoring of vehicle speed. Speed limits, though officially in place, are rarely enforced. "Vehicles come at such high speed that it's impossible to cross safely," says a resident near Umarabad. "Even traffic police cannot control all areas at all times, and that leaves pedestrians extremelv vulnerable.'

Adding to the danger is the lack of proper traffic calming measures along this stretch. The combination of wrong-side driving, highspeed vehicles, and frequent junctions creates a hazardous environment for both pedestrians and commuters. Local shopkeepers, daily wage workers, and school children often find themselves at risk as they attempt to navigate the busy road.

Authorities, while occasionally tightening traffic enforcement, have yet to introduce systematic measures such as speed cameras, pedestrian bridges near hospitals, and dedicated crossings at critical junctions. Residents demand immediate action, warning that without effective regulation, the highway will continue to claim lives.

The recent tragedy near Umarabad has once again highlighted the urgent need for comprehensive traffic management on this highway stretch. Experts argue that a combination of stricter enforcement, speed monitoring, public awareness campaigns, and infrastructure improvements is necessary to prevent further loss of life.

In the meantime, local citizens remain apprehensive. "We cannot even step out safely during peak hours," says another resident. "The highway, which is meant to connect communities, has become a zone of fear."(KINS)

at district or sub-district hospitals. Data shows that out of 1,000 patients referred to SKIMS, only about 80 are admitted, while the rest are discharged after preliminary checks.

Experts say that despite the availability of doctors and adequate facilities at government hospitals, people tend to bypass local hospitals even for minor health issues and rush to tertiary centers like SKIMS. This leads to overcrowding and unnecessary strain. They argue that if the referral system is properly followed, doctors at SKIMS would be able to focus more on serious patients.

Meanwhile, Health Minister Sakina Itoo has directed district and sub-district hospitals not to send patients unnecessarily to SKIMS, stressing that adequate facilities are already in place at the district level for the local pop-

Sources told KNO that the Health Minister has sought detailed data from SKIMS about referrals from each district to determine why hospitals, despite having facilities, are still shifting patients for minor treatments.

"We have received reports that patients are being shifted to SKIMS without valid reasons, and this trend cannot be accepted. It needs to be probed. We may have to take action against doctors who, without justification, refer patients and put additional pressure on SKIMS. We are seeking details of each referral and the discharge status of those patients," a senior Health Department official said—(KNO)

telecom connectivity. Moreover the program will focus on creating an enabling environment for expanded livelihood opportunities. This includes promoting tourism, organizing cultural events and awareness campaigns, and providing medical and veterinary camps.

To ensure effective implementation, a comprehensive planning process is in place. This includes a baseline survey to conduct a gap assessment and village profiling, which will be followed by the preparation of detailed Village Action Plans (VAPs).

Committees have been established at both the UT and district levels to oversee the program, ensuring proposals are technically feasible, cost-effective, and aligned with the program's goals.

## JKJA organises one day **Special Training Programme** on 'Code of Civil Procedure (CPC) and Commercial Courts **Act' at Srinagar**

**SRINAGAR, SEP 20:** Under the patronage of Justice Arun Kumar Pali, Chief Justice, High Court of Jammu & Kashmir and Ladakh (Patron-in-Chief, J&K Judicial Academy), and under the guidance of Chairperson and Members of the Governing Committee of the J&K Judicial Academy (JKJA), the Judicial Academy organized a One Day Special Training Programme on "Code of Civil Procedure (CPC) and Commercial Courts Act" at Mominabad here for Judicial Officers of the District Judiciary of Kashmir Province and the Union Territory of Ladakh.

The programme commenced with the introductory remarks by Sonia Gupta, Director, J&K Judicial Academy, who outlined the objectives and scope of the Commercial Courts Act, 2015. She emphasized that the Act has ushered in significant reforms for the speedy and effective adjudication of high-value commercial disputes. She noted that the introduction of pre-institution mediation, case management systems, streamlined pleadings, and provisions for summary judgment have shifted the judicial approach towards efficiency, specialization, and alternate dispute resolution.

Session 1st of programme was conducted by Faisal Qadri, Senior Advocate, High Court of J&K and Ladakh, who elaborated on the background, objectives, and jurisdictional aspects of the Commercial Courts Act. He explained how the Act was conceived to address gaps in the Civil Procedure Code, which was inadequate to meet the needs of complex commercial disputes. He highlighted key features such as the creation of expert courts, streamlined procedures, and the introduction of pre-institution mediation to minimize litigation costs and delays.

While acknowledging the transformative potential of the Act, he also drew attention to practical challenges in implementation, including jurisdictional overlaps, lack of clarity in multi-party disputes, and questions regarding judicial expertise in highly technical commercial matters.

Illustrating with a case study involving a power generation contract dispute, Qadri urged judicial officers to remain vigilant of jurisdictional conflicts and parallel proceedings, while steadily developing their expertise in commercial jurisprudence.

Session 2nd was led by Z.A. Shah, Senior Advocate, High Court of J&K and Ladakh, who reflected on the evolution of commercial courts and the principles of judicial interpretation in commercial law. He emphasized that judges must look beyond the literal text of laws and interpret them in light of their underlying purpose, societal needs, and technological

Highlighting the role of integrity and wisdom in decision-making, he stressed that commercial jurisprudence demands a balance of legal precision with pragmatic understanding.

He further discussed the streamlined procedures under the Act, the growing role of mediation in dispute resolution, and the challenges of inconsistent application across regions. Mr. Shah underlined the need to standardize practices, clarify jurisdictional thresholds, and train judges and lawyers to strengthen the efficacy of the specialized commercial court

The programme concluded with an interactive exchange, where participants shared experiences and raised queries regarding the application of CPC provisions in commercial disputes. The deliberations highlighted the need for continued training and practical guidance to ensure effective implementation of the Commercial Courts Act.

## JMC intensifies thermal fogging, spraying drive to prevent dengue, malaria, other vector-Borne diseases

JAMMU, SEP 20: Commissioner Jammu Municipal Corporation (JMC) Dr. Devansh Yadav today conducted a review of the ongoing citywide thermal fogging and spraying campaign aimed at preventing the spread of vector-borne diseases such as dengue, malaria, and chikungunya. The Commissioner reiterated that safeguarding the health and well-being of citizens is the foremost priority of the Jammu Municipal Corporation and emphasized the need for sustained and coordinated efforts at all

Directing the field teams to intensify operations in sensitive, waterlogged, and densely populated areas, where the risk of mosquito breeding remains high, Dr. Yadav appealed to residents to extend their cooperation by keeping their surroundings clean, avoiding water stagnation in household containers, overhead tanks and open drains and by covering stored water properly. He further advised citizens to adopt preventive practices such as using mosquito nets, repellents, and wearing full-sleeved clothing to reduce exposure to bites.

The special campaign, which is being jointly executed by the JMC, Health Department, and Anti-Malaria Department, marks the third round of fogging this year. The first campaign was launched in July, and in continuation, the present round covers various wards on a daily basis. As part of today's schedule, thermal fogging and spraying were conducted in Ward No. 41 (Bohri area) and Ward No. 61 (Patta Paloura area). The Malaria Control Teams are carrying out door-to-door spraying, while JMC's specialized machinery is engaged in largescale thermal fogging.

To ensure systematic coverage, JMC has prepared a ward-wise roster, under which teams are deployed to different localities every day. The Commissioner informed that the campaign will continue till 18th October, thereby ensuring protection during the post-monsoon period, when the risk of dengue and malaria remains at its



said, "Through thermal fogging and spraying, we are making consistent efforts to protect the people of Jammu from vectorborne diseases. However, the success of this campaign depends not only on government action but also on people's cooperation. Citizens must take responsibility by maintaining cleanliness in their surroundings, not allowing water to stagnate, and adopting basic precautionary measures. Together, we can minimize the risk of diseases like dengue, malaria, and chikungu-

 $The \, Commissioner \, also \, highlighted \, that \,$ while dengue cases reported this year are significantly lower compared to 2024, the JMC is leaving no stone unturned to prevent any sudden rise. Awareness drives are being conducted alongside fogging to educate people about the importance of personal hygiene, safe water storage, and timely medical consultation in case of fever or related symptoms.

Malaria Expert of Jammu Health Department, Dr. Dhruv Raina and Health Officer of JMC, Dr. Vinod Sharma, were also present. They briefed the Commissioner about the technical aspects of the campaign and the precautions being suggested to residents. Both officers stressed that consistent efforts by health authorities, combined with active public participation, are the key to keeping Jammu city free from mosquito-borne ill-

The Jammu Municipal Corporation once again appeals to the citizens to support the campaign by ensuring cleanliness in their neighbourhoods and by promptly reporting any issue of water stagnation or mosquito breeding sites to the concerned authorities.

## **J&K Awaits More** Than Sympathy

The devastation in Jammu and Kashmir has left behind not just broken bridges and ruined roads, but shattered lives and livelihoods. Over 330 bridges and 1,500 kilometers of roads have been washed away, government infrastructure lies in tatters, and the agricultural backbone of the Valley crops and dry fruits has been dealt a crippling blow.

At such a juncture, Chief Minister Omar Abdullah's call for a comprehensive relief package from the Prime Minister during his forthcoming visit is not just an appeal, it is a necessity.

Disasters test the resilience of a people, but they also test the sincerity of governance. The immediate images may fade from the national consciousness, but for the people of J&K the long road to recovery has just begun. Connectivity in the hilly terrain depends on those very bridges that now lie in ruins; mobility, trade, education, and healthcare remain hostage to damaged infrastructure. Announcing a robust relief and rehabilitation package will not only help rebuild bridges of steel and concrete but also strengthen the more important bridges of trust between Delhi and the people of J&K.

This is an opportunity for the Centre to rise above token gestures and show that national solidarity is not seasonal. The broken roads and washed-out bridges are visible scars, but the invisible wounds of displacement, loss of livelihood, and shattered confidence will take longer to heal. Dreams vs. Reality: The Allure of Foreign Lands for Indian Youth

In today's modern era, the aspirations of Indian youth are changing rapidly. One of the most prominent desires is to go abroad to pursue higher education, secure better employment, or settle permanently in a foreign country. This trend is particularly noticeable in rural India, especially in states like Punjab, Haryana, Uttar Pradesh, and Bihar. Many villages are experiencing a sense of emptiness, and agricultural fields are lying fallow, as the younger generation seeks opportunities firstin cities and then abroad. Parents, too, often sell  $ance strall and \, and \, property \, to \, fulfil \, their \, children's$ dreams of going overseas, which has significant social and economic implications for India.

There are several reasons behind this strong desire among Indian youth to go abroad. The primary reason is the belief that a prosperous and  $respectable \ life \ is \ only \ possible \ abroad. \ Manythink$ that incomes are higher and lifestyles more convenient in foreign countries. This perception is often fuelled by media, social media, and stories from relatives living abroad, which tend to present only a glamorous image. However, the reality is very different. Not everyone going abroad secures a high-ranking position or an impressive job. According to a 2023 United Nations report, approximately 18 million Indians live abroad, many of whom, despite their high skills or education, work in lower-level jobs. For instance, they may work as restaurant servers, taxi drivers, delivery agents, or factory labourers. The irony is that the same jobs are often considered "low status" in India, but abroad, the allure of earning in dollars or pounds makes them seem acceptable. This mindset highlights how external glamour can disconnect youth from their roots, as they chase a life of appearances.

Life abroad is not as simple or attractive as portrayed on social media. Living expenses are high. Data from 2022 indicates that in countries like Canada, a student's annual cost averages between roughly ₹16-24 lakh, including tuition fees, accommodation, food, and insurance. In addition, rent, insurance, taxes, and healthcare can be extremely expensive. The mental pressure and challenges are significant. Adapting to a new culture and language, living away from family, and coping with loneliness can be mentally exhausting for young individuals.



In recent years, countries like Canada, Australia, and the United Kingdom have tightened visa regulations for migrant workers. In Canada, 2023 saw an increase in financial requirements for international students. Similarly, the UK has made dependent visa regulations stricter, making permanent residency and family reunification difficult. Surveys indicate that nearly 40% of Indian youth living abroad face mental health issues such as depression and anxiety due to social isolation and financial stress.

Meanwhile, India itself is rapidly developing, and opportunities abound for young people—if they can recognize and utilize them. India boasts the third-largest startup ecosystem in the world. By 2023, India had over 100,000 startups, including more than 100 unicorns. These startups provide youth the opportunity to experiment and launch their own ventures. Government initiatives like 'Startup India' and the 'Mudra Scheme' provide financial support to help turn ideas into reality. Agriculture, too, offers immense potential. Young people can innovate in agriculture-based industries such as organic farming, food processing, and agritech. Government programs like the 'Pradhan Mantri Fasal Bima Yojana' and 'Kisan Credit Card' support farmers and agricultural entrepreneurs. These measures can make villages self-reliant and reduce migration.

India is also the world's largest IT and BPO hub. There are countless opportunities in IT, digital marketing, e-commerce, and technology. Programs such as 'Digital India' and 'Make in India' are promoting technological growth, while the 'Skill India Mission' equips youth with employable skills. When youth migrate abroad, villages face labour short-

ages. Agricultural land remains uncultivated or is leased at low productivity. This affects rural economies negatively. Elderly parents face loneliness and insecurity, sometimes forcing them to live in old-age homes. Family ties weaken as children abroad gradually disconnect from their culture and roots. Prolonged exposure to foreign lifestyles can lead youth to adopt Western customs and practices, weakening the preservation of Indian cultural heritage.

The critical question is: is going abroad the only option? If a young person can do menial jobs abroad, why can't they do the same in their own country? The difference lies only in perspective. With a population exceeding 1.4 billion, India offers a vast market and immense human resources. Real respect and satisfaction come from self-reliance, hard work, and dedication. Youth must understand that the fulfilment of advancing while staying connected to their land cannot be achieved by performing small jobs abroad. Change begins with mindset. Young people should be inspired to use their skills and potential for the progress of their own country. Instead of pursuing dreams alone abroad, they should aim for prosperity while uplifting their villages and society. The government must focus on expanding education, healthcare, and employment opportunities in rural and semi-urban areas. The private sector should be encouraged to invest in these regions as well. Only when India's youth fully utilize their capabilities on their own soil will the country achieve economic strength along with social and cultural richness.

## India's Al Mission and the DPDP Act: A Unifying Strategy or Contradiction?

India's quest for leadership in the world in the field of artificial intelligence, being led by the IndiaAl Mission, is a strategic necessity. Parallelly, the promulgation of the Digital Personal Data Protection (DPDP) Act is an important step in safeguarding the privacy of its people. Although these two programs may seem to be in conflict with each other, they are a moment of reckoning for India to create a world-class AI e cosystem based on trustand ethical data governance. This twopronged strategy, however, has substantial structural and regulatory hurdles to overcome that require to be addressed with immediacy, lest to convert an integrated vision into a disjointed reality.

#### The Symbiotic Imperative of Trust

The success of the IndiaAI Mission is strongly dependent on trust among people. In a country with over a billion citizens, data is a peerless asset, and its judicious use is most important. The DPDP Act's focus on consent, data minimization, and purpose limitation is intended to create this very same trust. By creating a

strong legal framework that endows citizens with the right over their data, the Act builds public confidence necessary for continuous data contribution. For India's AI ecosystem to flourish, its citizens must be confident that their data won't be misused. Against this background, the DPDP Act cannot be considered a regulatory hindrance but a pillar of support for a secure and ethical Aleconomy. It serves as a much-needed check on the unbridled collection and usage of personal data, something that would otherwise create an anarchic and unsafe digital environment. Without such trust, an AI economy driven by data cannot survive.

### The Data Commons and the Talent

The government's suggestion to establishanational data "commons," or AIKosh, is one of the central components of the IndiaAI Mission. The idea is to make highquality, non-personal data accessible to everyone, so that data monopolies are avoided and there is a level playing field for researchers as well as startups. Although the spirit behind it is right, this exercise generates governance issues and the fear of a new kind of centralized power. The line between "personal" and "non-personal" data may be blurred, particularly when bulk, anonymized datasets are aggregated to re-identify individuals. In the absence of strict independent monitoring and open systems of data handling, a central database might ironically result in a concentration of power-and hence the risk of state surveillance—instead of obviating it.

In addition, the DPDP Act's obligation regime poses a paradox for the nation's growing startup scene. While a reputable legal framework is a necessity for a trusted AI hub, the high standards of granular consent and compliance may be a huge ask for smaller companies. Industry associations, like the Internet and Mobile Association of India (IAMAI), have complained that the lack of clarity in the law. especially concerning the utilization of publicly available data, puts an undue burden on them. This regulatory tension may have the effect of disincentivizing the best AI talent and start-ups from opting for India, thus defeating the very human resources the AI Mission wants to develop. The nation must hit a fine balance between trust building and creating a malleable, innovative ecosystem.

#### The Regulatory Mismatch of Deep-

The most important challenge, perhaps, is the regulatory gap around AIgenerated content, in particular, deepfakes. The DPDP Act, as it stands today, is focused most intensely on personal data and doesn't quite cover the unauthorized use of a person's digital likeness. This creates a large gap in liability because the current legal system isn't well-suited to impose responsibility through the involved chain of events of creating and spreading a deepfake. The problem goes far beyond data privacy; it is a categorical attackon a person's "digital persona" and on the integrity of public debate.

This void in the law is starkly contrasted with what is happening on the international stage. The European Union's AI Act, for example, requires a disclosure obligation and transparent marking of AI-generated content, putting a clear onus on creators and platforms. Similarly, a few U.S. states have signed into law legislation focused on deepfakes for fraud or election interference. In India, recent court  $decisions, including those in Anil \, Kapoor$ and Amitabh Bachchan cases, have set some precedent by using existing common law entitlements, but these are no substitute for an overarching legislative framework.

For India to reassert its leadership in AI, it needs to look beyond data privacy to safeguard an individual's digital identity. There should be a distinct legal framework or a significant amendment to the DPDP Act to define clear liability and compelled disclosure for deepfakes so that technological progress is not at the expense of public faith and democratic integrity. This anticipatory measure is necessary to ensure that the digital future of India is one of innovation and integrity.

# Maharaja Agrasen: Architect of Ideal Governance and Socialism

Maharaja Agrasen is remembered among those luminous rulers of Indian culture and history whose glory was not bound by a single era. His people-centric vision became timeless. He enriched not only his subjects but also civilization and culture, making them stronger and more prosperous. His governance was not centered on power, but on humanity and society. He was a karmayogi, a people's leader, a builder of a balanced socialist order, and a guide who gave humanity a new direction. He was not merely a king of the Agrawal community, but a pioneer of ideal social order, founder of republican principles, worshipper of non-violence, and messenger of peace. At a time when our society is struggling with inequality, violence, selfishness, and political disintegration, his thoughts and principles become all the more relevant.

According to tradition, Maharaja Agrasen, regarded as the forefather of the Agrawal community, was born about 5,150 years ago in the Suryavanshi Kshatriya dynasty, the 34th generation of Lord Ram, in the royal family of King Vallabh of Pratapnagar. At his birth, sage Garg had predicted to King Vallabh that this child would be radiant, would establish a new form of governance, and would be remembered for thousands of years. Indeed, his reign resembled a manifestation of Ramrajya, where his life and vision guided humanity towards greatness. A radiant beacon of his times, his birth anniversary—Ashwin Shukla Pratipada, the first day of Navratri—will be



observed this year on 22 September

Agrasen's rule was based on justice, equality, compassion, and coexistence. He was not only a monarch but also a philosopher and visionary. He lived the principle, "The king is the servant of the people." His personality evokes memories of Mahavira, Buddha, and Ashoka—the great messengers of peace. Rejecting violence, he made non-violence, cooperation, and collective responsibility the soul of his society. To establish true socialism, he framed a remarkable rule: every citizen of his city would contribute one rupee and one brick to help any newcomer settle and start a livelihood. This not only provided economic support but also fostered fraternity and shared responsibility. In many ways, this system foreshadowed today's concepts of cooperative societies and corporate social responsibility.

Agrasen's core message was simple yet profound: lasting happiness lies not in violence but in peace and cooperation. He distanced himself from wars, nurturing instead an atmosphere of harmony and integration. In his order, there was no place for discrimination or social hierarchies. Transparency and honesty were paramount in the economy, and women were accorded dignity and rights. At a time when our society is plagued by corruption, violence, and inequality, Agrasen's ideals can guide us toward a new path. His republican outlook in politics can restore sanctity to democ-

Maharaja Agrasen ruled for 108 years. Later, on the advice of his family deity Mahalakshmi, he handed over the reins of the Agreya Republic to his eldest son and withdrew into penance. He believed that progress of individuals, society, and nations rests on four pillars—economic, political, cultural, and social—and his philosophy fortified all four, laying the foundation of a better world. Yet history has largely sidelined his grandeur, reducing him to the patriarch of a single community, though his message was

Born in the Suryavansh, Agrasen was only 15 during the Mahabharata war. When Pandavas invited allies to join their side, King Vallabhsen fought alongside them with his son Agrasen, attaining martyrdom on the 10th day

under Bhishma's arrows. After this, Agrasen took over the kingdom. Skilled in scriptures, politics, economics, and warfare, he later married Princess Madhavi, daughter of King Kumud of the Nagas. He founded the kingdom of Agroha and received blessings from Goddess Lakshmi that his lineage would always remain prosperous as long as they worshipped her. He had 18 sons, giving rise to 18 gotras of the Agrawal community. For Agrasen, society was duty, and religion was integrity. That is why the Agrawal community still practices vegetarianism, non-violence, and faithfulness. He considered dharma the protective armor of politics, believing that without moral strength, weapons and power could not ensure justice. His reign was marked by refinement of the old and creation of the new.

A devastating fire once destroyed much of Agroha, forcing many citizens to disperse across India. Yet they preserved their identity as Agrawals and their 18 gotras, continuing to follow his path of social service. Even today, their contribution to India's economy and philanthropy is remarkable. Surveys suggest that though barely one percent of the population, Agrawals account for more than 24% of the country's income tax, 62% of charitable donations, and nearly 25% of overall development. A true tribute to this great ruler would be to name major welfare schemes after him. His Jayanti reminds us that if we wish to create a happy, prosperous, and peaceful society, we must embrace his ideals: wealth is meaningful only when shared, power is noble only when used for collective welfare, and governance succeeds only when it is rooted in justice and compassion.

## The Generic and Ethical Medicine

(A Scientific and Ethical Perspective)

The Modern healthcare rests upon two key pharmaceutical pathways: generic medicine and ethical (branded) medicine. Although both categories aim to deliver therapeutic benefit to the humanity yet they differ in terms of production cost, market accessibility, research investment and ethical considerations. For policymakers, clinicians and patients, understanding the difference between the two is essential to ensure equitable healthcare.

#### **DEFINING GENERIC AND ETHICAL MEDICINES ETHICAL (Branded) MEDICINES:**

Ethical medicines are those medicines which are marketed under a brand name by the innovator pharmaceutical company. They are typically the outcome of extensive research and development (R&D), including drug discovery, preclinical studies, and multiple phases of clinical trials. Because of the large investment the owner companies hold patent protection which is a legal right allowing them to exclusively market the drug for a certain period.

#### **GENERIC MEDICINES:**

Generic medicines are pharmaceutically equivalent versions of branded drugs, produced once the patent expires. They must demonstrate bioequivalence-meaning they deliver the same active ingredient, dosage, safety profile, strength and therapeutic effect as the branded medicine. Importantly, generics are sold under their chemical name without the marketing costs or brand premiums associated with ethical drugs.

SCIENTIFIC BASIS AND REGULATORY STANDARDS

Regulatory bodies such as the U.S. Food and Drug Administration (FDA), the European Medicines Agency (EMA) and the Central Drugs Standard Control Organization (CDSCO) in India mandate strict equivalence standards. Generics must meet criteria for:

1.Pharmacokinetics (absorption, distribution, metabolism and excretion). 2.Pharmacodynamics (drug action and thera-

peutic effect). 3.Good Manufacturing Practices (GMP) to ensure

safety and quality. Thus from a strictly pharmacological perspective, a generic medicine is not inferior to an ethical

medicine if manufactured under proper compliance.

#### **ETHICAL DIMENSIONS**

 $The \, debate \, between \, ethical \, and \, generic \, medicines$ is not purely scientific but also socio-economic and ethical:

1. Access and Affordability:

Branded medicines are often priced beyond the reach of lower-income populations.

Generics democratize healthcare access by reducing cost.

2. Reward for Innovation:

Ethical medicines incentivize innovation by rewarding pharmaceutical companies for their research and development investment. Without patent protection, fewer companies would invest in developing novel therapies.

3. Equity in Healthcare:

An ethical dilemma arises when life-saving drugs remain inaccessible due to prohibitive pricing, especially in low- and middle-income countries.

#### PROS AND CONS **ETHICAL MEDICINES**

1.They are backed by rigorous, long-term research and development and extensive clinical testing.

2. Generally first to market, offering novel therapeutic solutions.

3. Higher accountability due to brand reputation. CONS:

1.Extremely high cost due to research and devel-

opment recovery and patent monopolies.

2.Limited affordability due to their high costs restrict the access in developing countries.

3. Aggressive marketing practices may influence prescription behavior.

#### **GENERIC MEDICINES**

1. Substantially lower cost with benefits of improving accessibility and affordability.

2.Equivalent in therapeutic effect asxpar with ethical medicine when manufactured properly.

3. Encourages competition, reducing monopolistic pricing. CONS:

1.Quality inconsistencies are possible if manufacturing standards are compromised.

2.Due to lack of research & development contribution the generics medicine rely on prior innovation.

3. The perception bias among patients and physicians that generics are inferior despite equivalence.

#### **GLOBAL AND INDIAN CONTEXT**

Globally over 80% of prescriptions in the United States are filled with generics, a reflection of trust in regulatory oversight. In India, initiatives such as the Jan Aushadhi scheme aim to promote generic drug availability at subsidized prices. However, challenges such as variable quality control and lack of public awareness persist.

The debate between generic and ethical medicines is not a battle of superiority but a call for balance between innovation and accessibility. Ethical medicines fuel progress in pharmaceutical science, while generics ensure the fruits of this progress reach society at large. Policymakers must therefore strengthen regulatory oversight, enforce stringent quality checks and promote patient education. In doing so, healthcare systems can achieve the dual objectives of innovation and equity, ensuring that scientific advancement does not become a privilege of the few but a right of all.

## Should You Get a Flu Shot This Fall? Here's What **Experts Think**

While many forecasts predict a somewhat moderate influenza season this coming winter, health officials continue to recommend that everyone who is eligible get vaccinated against the flu.

They say this applies in particular to people who are more vulnerable to developing more serious illnesses from the flu virus, including older adults, children, and people with compromised immune systems.

Federal agencies' flu vaccine recommendations are consistent with last year's guidelines and differ from the recently changed recommendations concerning COVID-19

Experts note that the flu can cause serious complications, even among healthy people, so the illness should not be taken lightly.

While most cases are mild, some are more severe leading to hospitalizations and tens of thousands of those affected die yearly from the flu," said David Cutler, MD, a family medicine physician at Providence Saint John's Health Center in Santa Monica, CA.

"Influenza can be severe or even deadly, and the vaccine prevents severe disease, albeit not all infections," added Monica Gandhi, MD, a professor of medicine at the University of California San Francisco. "Pediatric hospitalizations for influenza last year were particularly high, so we encourage everyone to get the flu vaccine this year."

Last year, the United States experienced what some experts described as the most severe flu season in more than a decade.

Preliminary dataTrusted Source from the Centers for Disease Control and Prevention (CDC) estimated that between 47 million and 82 million influenza illnesses occurred in the United States during the 2024–2025 flu

There were an estimated 610,000 to 1.3 million hospitalizations and between 27,000 and 130,000 deaths associated with the flu.

In addition, Australia has been recording a strong flu season. In July, Australian officials said this year's flu season was shaping up to be their country's second-worst in a decade.

Flu cases in the Southern Hemisphere, where July and August are considered winter months, often give a glimpse into what the flu season will be like in the Northern Hemisphere during the fall and winter.

In the United States, flu seasonTrusted Source usually begins in October and lasts through March, with the peak period being between December and February.

The CDC releasedTrusted Source a report in August stating that the upcoming fall and winter respiratory virus season will likely have a similar number of hospitalizations as last year.

However, those estimates include projected cases of COVID-19, respiratory syncytial virus (RSV), and influenza.

William Schaffner, MD, an infectious disease specialist and a professor of preventive medicine at Vanderbilt University in Nashville, TN, said this year's flu season might be more moderate compared to last year.

'Last season was quite severe and it is unusual to experience two severe seasons in a row, especially as no new flu strains have appeared on the global scene. Thus, likely we'll have an average, moderately severe season," he told Healthline.

Cutler agreed that flu season severity is difficult to predict.

"It is impossible to predict with certainty the nature of any upcoming flu season. The number of cases, the timing of the peak, and the exact nature of variants are always variable," he told Healthline.



# Studying full implications of proposed restrictions on US H-1B visa program, says India

**NEW DELHI, SEP 20:** As the Trump administration hiked the H-1B visa fees to a massive \$100,000 annually, India said that it is studying the full implications of the measure and added that it would cause disruption for families and expressed hope that this aspect could be addressed by the US authorities.

US President Donald Trump on Friday (September 19) signed a proclamation-- 'Restriction on entry of certain non-immigrant workers', that will raise the fee for H-1B visas to a staggering \$1,00,000 annually, in a move to crack down on immigration. The new rule is effective September 21, 2025.

The fee, which currently

ranges from \$2,000 to \$5,000 per application, may now amount to \$300,000 for the initial three-year H-1B visa period.

In a statement, the Ministry of External Affairs said that industry both in India and the US have a stake in innovation and creativity and can be expected to consult on the best path forward.

The MEA statement reads: "The Government has seen reports related to the proposed restrictions on the US H1B visa program. The full implications of the measure are being studied by all concerned, including by Indian industry, which has already put out an initial analysis clarifying some perceptions related to the H1B program.

"Industry in both India and



the US has a stake in innovation and creativity and can be expected to consult on the best path forward.

"Skilled talent mobility and exchanges have contributed enormously to technology development, innovation, eco-

nomic growth, competitiveness and wealth creation in the United States and India. Policy makers will therefore assess

recent steps taking into account mutual benefits, which include strong people-to-people ties between the two countries.

"This measure is likely to have humanitarian consequences by way of the disruption caused for families. Government hopes that these disruptions can be addressed suitably by the US authorities."

The H-1B visa is a US work visa that allows companies to employ foreign professionals in specialised fields like technology, engineering, and medicine. Indians account for the largest share of H-1B visa holders, making up 71% of all beneficiaries in FY2024. The Trump administration's move has been described by US law makers and community leaders as "reckless" and "unfortunate".

President Trump signed the proclamation saying the abuse of the H-1B visa programme is a "national security threat".

Companies have asked H-1B visa holders or their family members currently outside America for work or vacation to return within the next 24 hours or risk being stranded and denied entry into the US after the proclamation comes into effect from 12:01 am September 21. According to reports, Amazon has 10,044 workers using H-1B visas as of June, 2025, with TCS having 5,505 H-1B visas approved.

Other top companies include Microsoft (5,189), Meta (5,123), Apple (4,202), Google (4,181), Deloitte(2,353), Infosys(2,004), Wipro (1,523) and Tech Mahindra Americas (951). UNI

The accused allegedly laundered the money by withdrawing large cash amounts, transferring funds to relatives, and investing in properties in Alirajpur and Panna. Several assets purchased in the names of family members were later sold to conceal the illicit origin of the funds.

Further investigation is underway.

for Europe, a UNSC resolution on Friday on whether to permanently lift international sanctions on Iran was voted down, giving an edge to the E3 nations' bid to reimpose snapback sanctions on September 28, over Iran's nuclear non-compliance with the IAEA. The resolution, tabled by South Korea

which is currently holding the Security Council presidency, was a procedural part of a process launched last month after the E3 nations – UK, France, and Germany – threatened to trigger the so-called snapback mechanism under the dictates of the 2015 Iran nuclear deal, accusing Iran of "significant non-performance" due to its refusal to allow IAEA inspections, and its vast stores of heavily enriched uranium.

The decision not to lift Iran sanctions means all pre-2015 UN sanctions on Iran will automatically return once the 30-day snapback period ends on Sept 28, unless the Security Council takes further action, reports Iran International.

The move was slammed by Iran, which was supported in its opposition by two of the UNSC's permanent member states Russia and China. Both nations lambasted the vote on Friday as a blow to diplomacy.

Algeria, China, Pakistan, and Russia voted to lift Iran sanctions, while Denmark, France, Greece, Panama, Sierra Leone, Slovenia, Somalia, the UK, and the US voted against the resolution.



Guyana and South Korea abstained on the issue.

US's acting UN representative Dorothy Shea said the European troika was right to pursue sanctions given what she called Iran's clear violations.

"In July, the E3 offered to extend the snapback mechanism if Iran were to take steps to address concerns regarding its highly enriched uranium stockpile, comply with its IAEA obligations, and resume direct diplomacy with the United States,"

"Despite suggestions to the contrary from Iran and others, Tehran has not yet fulfilled those conditions."

The resolution outcome does "not impede the possibility of real diplomacy," Shea added, without elaborating. UNI

Only a handful have held senior cabinet posts, and female candidates have historically faced institutional barriers within the male-dominated LDP, which has governed almost continuously since its founding in 1955.

Notably, former Foreign Minister Yuriko Koike came close to breaking the glass ceiling when she became Tokyo's first female governor in 2016, but she never secured

Her policy positions lean heavily towards national security and conservative social values. Takaichi has been outspoken on countering Beijing's growing military presence in the Asia-Pacific, advocating for a shift from Japan's strictly defensive military posture towards a more active armed force.

She has also supported major government spending and ultra-low interest rates, echoing Abe's economic legacy.

On social and cultural issues, Takaichi has courted controversy through her repeated visits to the Yasukuni Shrine, which honours the soldiers who died in WWII, as many of these soldiers were also convicted war criminals.

The former Imperial Japan is noted to have committed many atrocities and brutalities, and as such visits to the shrine have long provoked strong criticism from neighbouring countries like China and South Korea, which endured the worst brunt of Japanese military occupation.

Takaichi has contested several previous LDP leadership races and has steadily built a stronger base within the party.

In this election, she will face competition from three declared male candidates, including Chief Cabinet Secretary Yoshimasa Hayashi, a political moderate known for his policy expertise, as well as other senior figures within the ruling party. UNI

KOLKATA: Lucknow Super Giants' team mentor Zaheer Khan has parted ways with the franchise after just one season. ESPNcricinfo has learned Zaheer informed LSG of his decision on Thursday. It is understood that the primary reason for Zaheer quitting is that his vision for the franchise did not align with that of head coach Justin Langer and team owner SanjeevGoenka. While Zaheer's relationship with captain Rishabh Pant remained strong, he was affected by the thought process that played a role in LSG sliding down the points table in the second half of IPL 2025.


Zaheer had joined LSG in August 2024, filling the vacancy left by Gautam Gambhir's exit after IPL 2023. Zaheer had been with Mumbai Indians from 2018 to 2022 and agreed to a two-year contract with LSG, taking charge of scouting,  $planning \, and \, strategy. \, After \, making \, the \, playoffs \, in \, their \, first$ two IPL seasons in 2022 and 2023, LSG did not reach the knockouts in the last two seasons. In 2025, they finished seventh with six wins from 14 games. It was a season of contrasting halves: LSG had five wins in their first eight matches but only one in the last six. Of the eight games they played at their home ground, the Ekana Stadium, they won only two. LSG had made headlines at last year's mega auction when they bought Pant for INR 27 crore (USD 3.2 million approx.), making him the most expensive player ever in the IPL. The team was built around him, but Zaheer put in place building blocks he felt were needed to grow stronger every season. Despite there being a lot of chatter about Pant opening the batting, Zaheer spoke to the wicketkeeper-batter early on and told him that the better strategy would be for Mitchell Marsh to open with Aiden Markram. That strategy, Zaheer impressed on both Pant and the leadership group, would reduce the burden on their best batter, Nicholas Pooran,

The role clarity allowed the batters to play with freedom and perform consistently. Markram had never opened in the IPL before, while Marsh, despite having been in the IPL for more than a decade, had never made a major impact. The move worked: Marsh was the fifth highest run-getter in IPL 2025 with 627 runs at a strike rate of 163.70, Pooran made 524 runs at 196.25, and Markram 445 at 148.82.
