Next DGP-IGP Conference To Discuss J&K Situation, Other Issues

PM Modi, HM Shah to attend

NEW DELHI, OCT 01: Prime Minister Narendra Modi and Union Home Minister Amit Shah are set to attend the All India DGP-IGP Conference in Chhattisgarh in November, where top police officials from across the country will deliberate on key issues including internal security, anti-Naxal operations, cyber security, the fight against narcotics, the situation in Jammu and Kashmir, and border management.

According to the details available with the news agency—Kashmir News Observer (KNO) the 60th edition of the three-day conference beginning November 28 will be inaugurated by Union Home Minister Amit Shah, while the valedictory session is likely to be attended by Prime Minister Narendra Modi, said an official.

He said about 250 officers in the rank of DGP and IGP will attend the event physically while more than 200 others would participate virtually, said an official.



He said the special focus at the conference will be on Naxal-affected regions. It is expected to discuss ways to build further on these gains and chalk out new strategies. "Other key issues that will

come up for discussions include internal security, cyber security, the fight against narcotics, the situation in Jammu and Kashmir and border management."

Cabinet okays 3% hike in DA, DR for employees, pensioners

SRINAGAR, OCT 01: In a major relief for government staff and retirees, the Union Cabinet on Wednesday approved a 3 per cent increase in Dearness Allowance (DA) and Dearness Relief (DR). The decision will benefit nearly 49.19 lakh central government employees and 68.72 lakh pensioners across the country.

The hike, effective from July 1, 2025, raises the DA/DR from the existing 55 per cent to 58 per cent of the basic pay or pension. The revision aims to offset the impact of inflation on salaries and pensions.

Briefing the media on the Cabinet decisions, Information and Broadcasting Minister Ashwini Vaishnaw said the move would put an additional burden of Rs 10,083.96 crore per year on the exchequer.

The action was taken under the Unlawful Activities (Prevention) Act (UAPA) in connection with a case registered at Budgam police station. Police said the attachment followed "collected evidence" and due approval from the competent authority.

NEW DELHI. OCT 01: Prime Minister Narendra Modi on Wednesday lauded the RSS on its centenary celebrations, and said the organisation never displayed any bitterness despite several attacks on it as it continued to work on the principle of nation first.

Participating in the centenary celebrations of the Rashtriya Swayamsevak Sangh (RSS) here, Modi highlighted the contribution of the Sangh in nation-building and said it reached every corner of the country with the goal of fostering harmony by removing divisions of caste or creed and spreading the message of an inclusive society.



"The Sangh has fought against the atrocities of the British. Their only interest has always been love towards the nation," Modi said, adding that Sangh volunteers gave shelter to freedom fighters and its leaders were also jailed during the freedom struggle.

The Union Home Minister has already set a deadline of March 31, 2026 to completely wipe out the Naxal menace from the country.

Notably, since 2014, PM Modi has taken a keen interest in the DGP conference. Free flowing thematic discussions over breakfast, lunch and dinner have also been planned in the conference.

The event will provide an opportunity to senior police officials to share their views and recommendations on key policing and internal security issues affecting the country to the Prime Minister.

Till 2013, the annual meet was held in New Delhi. However, after the PM Modi led government came to power, it was decided to hold the event, organised by the Ministry of Home Affairs and the Intelligence Bureau, outside the national capital—(KNO)

will be the grand Ramlila performances and the ceremonial effigy burning at major venues such as the Parade Grounds, Gandhi Nagar Dussehra Ground and grounds near historic sites like Kol Kandoli and Bawe Mata

According to district administration guidelines, events are slated to begin early in the morning with special pujas and aartis at prominent temples, followed by processions that weave through the city's bustling

Devotional programs and Shobha Yatras (grand processions) starting from local temples including floral tributes to Goddess Durga and Lord Rama.

After culminating Ramlila enactments depicting the final battle between Rama and Ravana at designated open grounds.

The much-anticipated burning of massive Ravana effigies would be accompanied by fireworks and cultural shows. Fairs (melas) with traditional games, food stalls and handicraft exhibitions will light up areas around the venues until late night.

Additional attractions include community feasts, bhajans and dance performances showcasing Dogra folk arts.

The Jammu Municipal Corporation (JMC) has organized special sanitation drives along procession routes and congregation sites to maintain hygiene.

Devotees are urged to arrive early to avoid crowds with parking facilities arranged at peripheral lots.

Elaborate security and civic arrangements in light of the large gatherings anticipated, the Jammu and Kashmir Police, in coordination with district authorities, have implemented multi-layered security protocols to ensure public safety.

Additional Deputy Commissioner (ADC) Ansuya Jamwal reviewed these preparations earlier this month, emphasizing coordinated efforts from all departments.

As per officials, over 500 police officers, including specialized anti-goon squads will be stationed across 14 sectors in the city,

with a focus on high-footfall areas. Quick Response Teams (QRTs) and bomb disposal squads will patrol procession routes.

Enhanced CCTV coverage with 100+ cameras at temples, stadiums and key junctions, integrated with real-time monitoring from a central command center.

Drones will provide aerial oversight during evening events. Diversions on major roads like NH-44 and routes to the sports

stadium from 2:00 PM onwards. Commuters are advised to use public transport or alternate paths to minimize disruptions. Fire and Emergency teams will have tenders on standby at all effigy-burning sites, while the Health Department will deploy medical camps with ambulances and paramedics. The Jal Shakti Department guarantees uninterrupted potable water supply via tankers at venues. (KNO)

Observer (KNO) shows that 3,653 cases of violence against women were registered in the Union Territory in 2023 compared to 3,937 in 2021. Kidnapping was the most common crime against women with 895 cases, followed by 524 cases of cruelty by husband and 231 cases of rape. A total of 427 women were abducted for forced marriage, including ten minors. Jammu and Kashmir ranked fourth among Union Territories in domestic violence cases with a rate of 8.1

The NCRB data recorded 84 murders, 1,004 cases of kidnapping overall, and 673 cases of death due to negligence, most of them road accidents. There were nine cases of dowry, 44 cases of abetment to suicide, 438 cases of attempted murder, and 434 cases of attempted suicide.

Cybercrime against women has emerged as a growing concern. Jammu and Kashmir topped all Union Territories with 43 such cases, including 39 related to dissemination of obscene material and four of blackmail or photo morphing.

Cases under Special and Local Laws increased to 4,468 in 2023, with a chargesheet filing rate of 90.7 percent, while cases under the Indian Penal Code fell from 27,447 in 2021 to 25,127 in 2023—(KNO)

'Under present.....

Kashmir will likely be unable to meet and cater the power demands of consumers in the upcoming nine years.

According to the news agency-Kashmir News Observer (KNO), a study by the Government of India (GoI) reads, "The study has analyzed the daily and monthly pattern of unserved energy in the year 2034-35, it can be seen that contracted capacity (present and planned) is unable to meet the demand."

"It can be seen that during the high demand of winter months, the proportion of unserved energy is high," reads the study.

Besides, the report further reveals that the surplus capacity is available with states due to RE availability, demand variation etc.

'The pattern of surplus capacities for J&K and Ladakh has been observed as below. This capacity can be shared with other states which might result in reduced fixed cost burden on the utilities resulting in further reduction in the cost for consumers," it reads.

The report further suggests that J&K and Ladakh have likely surplus capacity available from April to September in the range of 230-740 MW for 2027-28 as shown below which can be shared with other states.

The GoI has further said that a study has been carried out for J&K & Ladakh based on the inputs received from J&K SLDC with a view of fulfilling RPO trajectory.

The study suggests the optimal resource mix till 2034-35 taking into account all technical and financial parameters associated with capacities.

It also optimizes power purchase on a long-term basis while evaluating resource adequacy for meeting the demand on 24 X 7 basis while considering variation in demand, RE generation and forced outages of thermal capacities.

The study has also assessed the requirement of Planning Reserve Margin for catering to above highlighted uncertainties so that demand can be met reliably throughout the year—(KNO)

Schedule of the Constitution.

The officials brief the Lt Governor on the latest security scenario and the measures undertaken to maintain peace and stability in the region.

Addressing the meetings on Wednesday, the Lt Governor lauded the relentless efforts of the security forces and the civil administration in restoring normalcy over the past week under challenging circumstances.

He also expressed appreciation for the patience and cooperation shown by the people of Ladakh.

Reviewing welfare measures, Gupta enquired about the condition of the remaining injured undergoing treatment at the government hospital and directed the administration and hospital authorities to ensure the best possible medical care.

He also directed the Leh deputy commissioner to ensure that the administration provides all possible humanitarian aid and financial support in cases where advanced medical treatment is required outside the UT, so that no individual faces hardship or feels

Appealing to the citizens, the Lt Governor urged people not to pay heed to rumours or misinformation and assured them that peace and harmony will be safeguarded at all costs.

He emphasised that the administration, along with security forces, is fully committed to maintaining peace, law and order across the UT.

The Lt Governor assured that very soon, all restrictions imposed as precautionary measures will be lifted in a phased manner

once the situation fully stabilises. "Peace and development are the top

priorities of the administration. Together, with the cooperation of the people, Ladakh will continue on the path of progress," he

Meanwhile, Urging Leh Apex Body (LAB) and Kargil Democratic Alliance (KDA) to reconsider their decision to stay away from talks with the Centre, Ladakh Lt Governor Kavinder Gupta on Wednesday said any matter can be resolved by sitting across the

He lashed out at Rahul Gandhi for his remarks on the Ladakh situation, alleging that the Congress leader was trying to "vitiate the atmosphere "in the country as he did during the farmers' agitation and other protests.

With the agitating groups demanding a judicial inquiry into the Septmber 24 violence and the release of detainees, including activist Sonam Wangchuk, the LG said a magisterial probe has already been announced "and it will start very soon".

A semblance of normalcy was witnessed in curfew-bound Leh town since Tuesday morning after authorities relaxed week-long curbs for seven hours and also ordered the reopening of shops and business establishments.

The relaxation period was further extended by one more hour from 10 am to 6 pm on Wednesday. However, mobile internet services remain suspended, and stringent prohibitory orders banning the assembly of five or more people are still in effect across much of the Union Territory, including Kargil

The dialogue between the Ministry of Home Affairs and Ladakh representatives, scheduled for October 6, hit a roadblock with both LAB and KDA, which are leading the agitation for statehood and Sixth Schedule safeguards for Ladakh, announcing suspension of the talks until a conducive atmosphere is created.

They demanded a judicial probe into the violence and the release of over 50 detainees, including Wangchuk who was booked under the National Security Act (NSA) for allegedly instigating the violence.

The two outfits have alleged that "highhandedness" by authorities and security forces led to the violence during a shutdown called by a constituent of the LAB.

"The administration has not made the situation worse, nor did we want it to be like this. What led to the violence is a matter of investigation," the Lt Governor told PTI Videos in an interview here.

"The central government had invited them (LAB and KDA) for talks and they should have gone for prior consultations... Any issue can be settled only by sitting across the table. Only through talks, things become possible," he said.

He said he had appealed to the people of Ladakh to come forward for talks.

"The administration wants everyone. including youths and religious bodies, to come forward so that we can sit with them and solve all the issues that are on their mind," he said.

Terming the incidents of violence on September 24 as "tragic and unfortunate", Gupta said they should not have happened in the first place.

"The administration imposed some restrictions under section 163 of BNSS to improve the situation and ordered the closure of schools and colleges as a precautionary measure.

"The restrictions were initially relaxed for four hours on Tuesday and later extended by three more hours. The restrictions were eased from this morning to evening so that the daily routine of the people is not hindered," he said.

He said the situation has improved to a large extent and the administration is working to ensure that people do not face any difficulty.

"Our effort is that life should return to normal as before. I think things will be normal in the next couple of days," he said.

He said the arrests were made in connection with the tragic incident. "Why four people lost their lives is a matter of concern. We have to see that such incidents should not happen again, and, therefore, the culprits have to be investigated for instigating the people." On the criticism over the NSA being slapped on Wangchuk, the LG said, "This is a matter of central government. The charges that the MHA has put forward are contained in the shape of a

"They (MHA) will talk about it, as I am looking at local issues. The NSA is a matter of the central government." On Leader of Opposition in Lok Sabha Rahul Gandhi's criticism of the government on the handling of the Ladakh situation, he said, "The country knows what Rahul Gandhi is saying. He is trying to instigate the people and vitiate the atmosphere in the country.' "His hand is behind farmers' agitation and similar other protests. He should concentrate more on his own rather than making any attempt to disturb the atmosphere in Ladakh," he said.

The Lt Governor said the mobile internet service is down because of the prevailing situation and the facility will be restored once the situation is normal. (AGENCIES

returning to normal as guns have fallen silent and people are rebuilding their lives and damaged settlements.

Residents of border villages earnestly pray for lasting peace so their communities can grow, prosper, and live without fear after years of conflict and hardship.

Villages including Keran, Machil, Bangus, Tangdhar, Gurez, and Uri in north Kashmir are once again witnessing marriage ceremonies being held in local homes rather than being shifted to safer places, as was the case in previous years.

Farming, schooling, marriages, and sports activities are being carried out normally and without fear.

Razia Begum, a resident of Gurez who recently got married, said families are now able to organise weddings in their native villages. "There was a time when we would stay indoors for days due to firing across the border. Now, people attend weddings in large numbers," she said.

Farah Jan from Uri, who also recently got married, said that earlier the frequent ceasefire violations made border life uncertain. "People had stopped organising large gatherings, but over the past two years, things have changed," she said.

In Karnah, Shahbaz Ahmad noted that several weddings have been organised recently with full community participation. "We remember those who lost their lives in the past, but now the atmosphere has changed. People are coming together once again," he said.

Mehreen Akhtar from Machil recalled how some weddings in the past were disrupted or turned into mourning due to shelling. "We are now seeing weddings with proper arrangements in the villages. Guests are attending without hesitation," she

In Gurez, Junaid Lone said that social gatherings such as marriages, engagements, and other community functions have resumed after a long gap. "The normal routine has returned. People are living without the constant fear that used to dominate our lives,"

Sajad Mir, a farmer from Tangdhar, said farming activities are going on without any disruption. "We are working in our fields as usual, and this season has been smooth for cultivation," he said.

In Gurez, 17-year-old Adil Lone, who plays cricket with local youth, said sports activities have become a regular part of their routine. "We're holding local matches and tournaments again. Everyone is taking part actively, and it's good to see the energy back," he said

Recently, the government announced a major relief initiative to provide 1,500 free smart homes to families whose houses were damaged in Pakistan shelling earlier this year.

Locals in Poonch said that this initiative will greatly benefit the families most severely affected by the Pak shelling. "We hope the construction process begins at the earliest so that the affected households can receive timely relief and regain a sense of stability in their lives," Abdul Rashid Khan, a resident said—(KNO)

The aspirants said that as per the provisions of the rule, the number of candidates called for medical examination should have been proportionately fewer than the number of vacancies notified. They alleged that the rule has not been followed and the list declared appears to be final in

"The mechanism of operating a reserve list is very different from a waiting list. Unfortunately, the Commission seems to have overlooked this distinction. The reserve list is a statutory requirement under S.O 61, Section 7, Clause ii, and must be maintained in order of merit below the last recommended candidate in each category," the candidates explained.

The aggrieved aspirants pointed out that under the rule, along with the main list of recommended candidates, the Commission is duty-bound to prepare and maintain a consolidated reserve list. This list, they said, should include both general and reserved category candidates, ranking in order of merit, and is meant to be kept confidential until the process of recommendation is finalized.

They further explained that the

rule also empowers the Government to requisition candidates from the reserve list to fill vacancies that may arise, with the reserve list remaining valid for one year from the date of the recommendation of the first list. "This safeguard is meant to ensure that vacancies caused due to non-joining or other reasons do not remain unfilled. But if the reserve list is not maintained, the purpose of the rule is defeated," they said.

Some candidates also expressed disappointment that despite the Raj Bhawan's intervention six months ago, the Commission has yet to move forward. "If even the Lieutenant Governor's letter is ignored, what hope remains for ordinary aspirants? It is about fairness and transparency in the recruitment process," another candidate remarked.

An official said that there was no question of ignoring the rules and the Commission will act in accordance with the law," he assured. (KNT)

"The RSS has never been bitter, despite attempts to make false cases against them, attempts to ban them, and other challenges, because we are part of society where we accept both the good and the bad," he said, in an apparent reference to the ban on the RSS after the assassination of Mahatma Gandhi.

Modi said even the then RSS chief Madhav Golwalkar was falsely implicated in a case and sent to jail.

'Yet, when he came out, he said with calm wisdom: 'At times, the tongue may get caught under the teeth, but we do not break teeth'," the prime minister said.

He said every 'swayamsevak' has unflinching trust in democracy and constitutional institutions, which gave them strength when faced with challenges.

"When Emergency was imposed, this trust gave strength to every swayamsevak to face it," he said.

The prime minister also released a special postage stamp and a commemorative coin to mark the centenary of the RSS.

"The Rs 100 coin features the national emblem on one side and on the other side it depicts a majestic image of Bharat Mata in Varada Mudra with a lion, while swayamsevaks are shown bowing before her in devotion and dedication," Modi said.

"For the first time in the history of independent India the image of Bharat Mata has been featured on Indian currency which marks a moment of great pride and historical significance," he said.

KU holds two-day master training workshop for mental health

SRINAGAR OCT 01: To strengthen teachers' role in addressing substance abuse, suicide prevention, and overall youth well-being in Kashmir, the Department of Social Work, University of Kashmir (KU), organised a two-day Master Training Workshop for Mental Health (Training the Teachers Programme) at the Main Campus. The workshop included selected faculty members from higher secondary schools and colleges of the Valley to strengthen their capacity as frontline responders for supporting students' mental health.

The workshop was based on an ICMR (Indian Council of Medical Research) research project on primary prevention interventions for youth in Kashmir, carried out by the Department of Social Work, KU, with Dr. Aadil Bashir, faculty member at the department, as the Principal Investigator (Pl). Drawing from extensive research and assessments, the team has developed a practical manual titled "Wal Sukoon Chandaw" (Come let's find peace), designed to provide teachers with structured tools and strategies for guiding young people towards



healthier coping mechanisms and resilience.

Vice-Chancellor KU, Prof. Nilofer Khan, in her message, said, "Equipping teachers with knowledge and skills to address mental health challenges is an important step in ensuring a safer, healthier academic environment. This initiative reflects our varsity's commitment to addressing pressing social concerns through research-based interventions."

Controller of Examinations KU, Dr. Majid Zaman, in his inaugural address, highlighted the urgent need to address the growing mental health challenges among youth. He said, "Teachers, apart from being academic guides, are also key figures in safeguarding the emotional and psychological well-being of students. This workshop equips them with evidence-based tools to detect early signs of distress, intervene effectively, and create safe spaces for dialogue."

Prof. Shazia Manzoor, Head, Department of Social Work KU, emphasized the need to address mental health challenges among children and young adults as Kashmiri society undergoes transitions, highlighting that teachers, parents, and the community must work collectively to ensure early support and wellbeing of youth.

Dr. Aadil Bashir, faculty at the Department of Social Work KU and PI, presented a detailed overview of the Wal Sukoon Chandaw manual, which includes modules on mindfulness, emotional regulation, stress management, and peer support systems. He also unveiled the e-manual, highlighting its accessibility for wider use across schools and colleges.

The workshop featured technical sessions on experiential learning for stress management, role plays focused on classroom-based interventions, group activities to build peer support, and training modules on risk assessment. These sessions aimed to translate the manual into practical classroom strategies for teachers.

fire tender from Khansahib overturned at Kaitch, injuring four firefighters, including the

driver. They were rushed to Sub-District Hospital (SDH) Khansahib, where doctors said their condition was stable despite multiple injuries.

The accident strained firefighting resources at a critical moment. However, other fire service teams, joined by locals and police, battled the blaze for several hours before bringing it under control. By then, the house had been completely destroyed.

Police said a case has been registered, and investigations into the cause of the fire are underway.



Issues strict directives for speedy completion of projects

JAMMU, OCT 01: Secretary, Rural Development department (RDD) & Panchayati Raj, Mohammad Aijaz Asad today chaired a meeting to review the physical and financial progress under UT-CAPEX, Scheme for Special Assistance to States for Capital Investment (SASCI), SNA-Sparsh and Swachh Bharat Mission (Gramin).

The meeting was attended by DG Rural Sanitation, Anu Malhotra; Mission Director NRLM, Shubhra Sharma; Director Panchayati Raj, Sham Lal; Director RDD Kashmir, Shabir Hussain Bhat; Director RDD Jammu, Shahnaz Akhtar; Director Finance, Umar Khan; Joint Director Planning, Kamal Kumar Sharma; Additional Secretary, Waseem Raja, besides all ACDs, ACPs, Executive Engineers, and BDOs of various districts.

While reviewing SASCI, it was revealed that loan assistance of Rs 21.10 crores has been sanctioned

The Secretary highlighted Fi-

nance Department directives mandating utilization of 75% of sanctioned assistance by December and surrender of non-viable projects for reallocation. Departments, he said, must demonstrate capacity to incur at least Rs 2 crore expenditure within the financial year, failing which funds may be withdrawn.

While reviewing UT Capex works, Secretary directed that the pace of execution of works be further accelerated.

Aijaz Asad instructed the concerned Executive Engineers to personally visit construction sites, inspect each building and asset, and ensure their completion strictly within the stipulated time-

The Secretary emphasized that in the Kashmir division, where developmental activities get slowed down during winter, the pace of work must be doubled to meet targets well in time.

With regard to SNA-Sparsh, the Secretary asked the heads of all schemes to complete critical



post-sanction processes, including integration, FTO generation, and DSC enrolment, so that the implementation of schemes does not face any bottlenecks.

Reviewing progress under SBM-Gramin, Secretary laid special emphasis on timely execution of Gobardhan Plants, Faecal Sludge Treatment Plants (FSTPs), and Decentralized Wastewater Treatment Plants (DEWATs). He di-

rected the officers that Detailed Project Reports (DPRs), feasibility studies, and tendering processes for the remaining Gobardhan projects be completed expeditiously so that all such plants are operational within the next two

He added that these projects are a top priority and will be reviewed on a weekly basis.

RTI Act needs a booster shot in J&K

Jammu & Kashmir had the distinction of having a strong Right to Information (RTI) Act of 2009 and the same was being viewed as a revolutionary step in the process where-in an ordinary person can seek information from any government department. Since the central RTI was implemented in 2005 the civil society activists of Jammu & Kashmir along with other important stakeholders including advocates came forward and improved upon the Central RTI Act of 2005.

The loopholes and the shortcomings in the central RTI Act were thoroughly studied by the concerned stakeholders following which the all important RTI Act of Jammu & Kashmir came into existence in 2009. Civil society activists, advocates and other important people across the country acknowledged that the Jammu & Kashmir RTI Act is much more powerful than the central RTI Act. The significant feature of the Jammu & Kashmir RTI Act was that the second appellate authority was directed to dispose of a matter within a period of 120 days once the officer is approached by an RTI applicant.

As there is no such provision in the central RTI Act the success of the RTI Act in Jammu & Kashmir is more visible as compared to the other states and union territories of the country. For the 10 years or so the RTI Act was a success in the state of Jammu & Kashmir but the scenario changed in 2019. The Article 370 was abrogated on August 5, 2019 and the state of Jammu & Kashmir was downgraded into two union territories of Jammu & Kashmir and Ladakh.

Following this Jammu & Kashmir came under the direct control of the Home Ministry and all the central acts were extended to the present union territory. As a result of this the Jammu & Kashmir RTI Act of 2009 got replaced by the Central RTI Act of 2005. Once this became the reality the RTI Act became weak in the union territory and the officers started to dictate the terms to the information seekers. As on date most of the officers give a damn to the RTI applications.

The information seekers are disturbed over the present trend and they want the officers to be made accountable as was being done prior to August 5, 2019. The RTI Act needs to be given a fillip in Jammu & Kashmir so that the RTI applicants are relieved and able to get the information as desired by them through their receptive applications.

It is destructive to mount unnecessary pressure on children to score excessively high or perform consistently beyond their inherent capacity.

I vividly recall a moment last year when a 10th grade student came to me completely overwhelmed and distraught. She was so crippled by exam stress that she had abandoned all hope even appearing for, let alone passing the exam. Through focussed guidance and support she not only appeared for the examination but achieved high scores.

This experience was a powerful realisation that students rarely lack the ability to succeed. What they truly need is to remove fear that paralyzes them. Consistent, compassionate support paired with practical guidance is the key. By simply showing them the way and reminding them of their strength we can immediately dissolve their stress and unlock their path to success. Experiencing some stress and pressure to perform well during exams is completely normal. However the real danger emerges when students fail to manage stress effectively. Unchecked pressure can quickly become detrimental, leading to disturbed sleep patterns, a $dramatic \, loss \, of \, concentration, diminished \, interest$ in studying and ultimately poor academic performance. It is therefore crucial to manage stress before it undermines their health and their results.

First and foremost we must learn to recognise the signs of stress in students. Once the signs are identified, it becomes imperative for parents and teachers to initiate open and honest communication with students to help them emerge stronger.As parents and teachers, our fundamental responsibility is to provide students with the opportunities to set achievable learning goals. It is destructive to mount unnecessary pressure on them to score excessively high or perform consistently beyond their inherent capacity.

Every child possesses a unique ability and pace of learning and they can thrive when allowed to



achieve according to their strengths. When subject to intense external pressure, a student often fails to achieve even their true potential. Therefore the focus must shift from demanding perfection to nurturing potential.

Effective time management is without doubt a crucial tool for stress management. A common pitfall for many students is their failure to manage time efficiently for studies and exam preparation throughout the session. They often start cramming only when the exam looms near leaving insufficient time to cover the entire syllabus. The simple solution is to follow a regular structured study schedule. It will definitely come to students' rescue during

To deliver their best during exams, students must prioritize proper rest and adequate sleep with a minimum 7 to 8 hours each night. Sleep is not luxury, it is essential for memory consolidation and peak cognitive function. Furthermore incorporating a gentle physical activity, such as short walk into their daily routine can do wonders. Educators need to inculcate positive thoughts and encourage $students \, to \, regularly \, look \, and \, reflect \, on \, the \, immense$

journey they have completed and significant achievements they already secured. It is equally important to reinforce that they have prepared well and there is no reason to worry. Besides maintaining a healthy physical body it is equally important to enrich and nourish the mind. Simple yet powerful practices like breathing exercises, meditation and mindfulness are essential tools for mental clarity and stability. Furthermore students can take immense motivation by taking inspiration from successful individuals. Exploring their struggles, resilience and success stories and understanding how they overcome hurdles to achieve milestones can be profoundly encouraging. Ultimately parents and teachers must emphasis the value of sincere efforts over the final results. It is crucial to genuinely appreciate the hard work students put in and reinforce the idea that their efforts are more important than their results.In turn students should focus on giving their sincere best, remain optimistic and actively heed the advice of their parents and teachers.

While there isn't a single widely-documented story of "a weaver's daughter who made it big in Manipur," Bijiyashanti Tongbram from Manipur is a prominent contemporary example of a successful woman from a weaving background who achieved significant recognition. Initially a homemaker and weaver to support her family, she transformed her skills into a successful business, earning her a prestigious Padma Shri award for her contributions to entrepreneurship and women's empowerment. She is an inspiration, embodying the successful journey of a Manipur woman who leveraged traditional crafts into significant economic and social achievement.

The Story of Muktamani: Humble Beginnings: Muktamani began her journey as a weaver from Manipur, driven by the necessity to survive and provide for her children.

Weaving in Manipur is believed to have started with the goddess Panthoibee, who was inspired by observing a spider's intricate cobwebs, or alternatively with the goddess Chitnu Tamitnu who discovered cotton and produced the yarn. The Meitei people's folklore and oral tradition also describes the practice as a cosmic process initiated by Maiba and Maibi, messengers of God, during creation.

Goddess Panthoibee: One legend states that the goddess Panthoibee saw a spider creating fine threads for a cobweb and was inspired to begin weaving.

Goddess Chitnu Tamitnu: Another belief suggests that the goddess Chitnu Tamitnu was the first to discover cotton and to produce yarn, arranging the necessary equipment and constructing a weaving shed (the Sinnaishang) to start the craft.

Cosmic Origin: Another folklore perspective describes weaving as a cosmic creation process, with the sounds of spinning and

weaving stimulated by the god's messengers, Maiba and Maibi.

Historical Context: Weaving is a longestablished tradition in Manipur, with royal patronage seen during the reign of King Meidingu Loiyumba in the 11-12th century, who commissioned the weaving of the Moirang Phee.

Silk weaving also has a deep history in Manipur, with references to its use during the reign of King Kangba and later king Meidingu Senbi Kiyamba.

King Kangba (1405-1359 BC) was a ruler of Ancient Manipur (Kangleipak) traditionally credited with inventing Sagol Kangjei, the earliest form of the modern game of polo. Son of King Tangja Leela Pakhangba, he is a significant figure in Meitei history, with his life and family recorded in the ancient text Ningthou Kangbalon. His memorial is being developed as a tourism site in Kangmong, the village where his last rites are believed to have been performed.

Senbi Kiyamba (Old Manipuri: Senpi Kiyampawas a Meitei monarch and a ruler of Kangleipak kingdom (Manipur kingdom). He was the son of Medingu Ningthou Khomba and his warrior queen Leima Linthoingambi. Born Thangwai Ningthouba, he succeeded his father at the age of 24. He took the name Kiyamba meaning "Conqueror of Kyang", after conquering the Shan kingdom in the Kabaw Valley in alliance with King Choupha Khe Khomba of Pong

The Northeastern region of India is a rich tapestry of tradition, where culture thrives in the intricate patterns of handwoven textiles, the vibrant sparkle of bead jewellery and the earthy wisdom of natural cosmetics. Passed down through generations, these crafts have not only preserved ancestral knowledge but also shaped community identities across states like Manipur and Nagaland.

In Manipur, handloom artistry finds expression in textiles like the Wangkhei Phee and Moirang Phee, woven with fine cotton and ceremonial significance. The iconic phanek, a wraparound skirt, is not just a garment but a symbol of feminine grace and cultural heritage. The tribes of Nagaland - Ao, Angami and Chakhesang are distinguished through their unique shawls which include the Tsungkotepsu that originally served as warrior clothing and now function as identity symbols and status markers. Traditional bead jewelry creation is a vibrant practice which produces spiritual and ancestral heirloom ornaments that the Tangkhul and Konyak tribes specialize in making.

Further details:

In the 18th century, there was a decline in the worship of Panthoibi mirrored a rise of Vaishnavism in Manipur. Hindu King Garib Niwaj Pamheiba (1709-1748) pulled down her temples and broke her statues, and from the 18th century onwards, Panthoibi was treated as a manifestation of the Hindu goddess Durga or as her incarnation or as her manifestation. The identity of Panthoibi was changed to that of Hindu goddess Durga. She was worshipped for five

days in September – October The goddess Panthoibi from Manipur's Meitei mythology is a prominent figure related to handicraft, fertility, and warfare, whose worship has also been extended to the Meitei Tamil community in places like Moreh, where she is known as Konthong Lairembi. Another goddess, Hiyangthang Lairembi (also known as Irai Leima), was associated with the Hindu goddess Kamakhya (a form

In Manipur, Maiba refers to the male religious functionary and a traditional healer in the Meitei culture, while Maibi is the female counterpart, a priestess who serves as a spirit medium and carries the oral traditions of the Sanamahi religion. Both Maiba and Maibi play crucial roles, especially in the Lai Haraoba festival, but the Maibi holds a more prominent spiritual and ritualistic significance, as she is the one who can become possessed by a divine spirit to deliver oracles.

Maiba (Male Religious Practitioner) Role: A male priest, ritual officiant, and often a traditional medical practitioner who

acquires knowledge from mystical texts. Significance: He also plays a vital role in the Lai Haraoba festival, performing rituals

Maibi (Female Priestess):

Role: The female priestess, spirit medium, dancer, and singer who is considered the primary carrier of the oral religious traditions of the Meitei.

Spiritual Significance: A woman becomes a Maibi through direct possession by a divine

Prominence: The Maibi is more significant than the Maiba, playing a leading role in rituals and possessing the ability to

deliver oracles while possessed. Traditional Dress: She wears a distinctive white attire, including a phanek (skirt) and

enaphi (chaddari), often with colorful borders for visual performance. Interrelationship and Cultural Impor-

Lai Haraoba: Both the Maibi and Maibi play essential roles in the Lai Haraoba festival, which honors the Umang Lais and

Spirit Possession: While a Maibi is a woman chosen through divine possession, a traditional Maiba who experiences possession was historically known as a "male Maibi" and was expected to adopt the clothing of a female Maibi, though this practice

is changing. Preservation of Culture: The Maibis are vital in preserving the essence of Meitei culture, religion, and worldview, acting as major carriers of indigenous customs and

King Loiyumba also known as Meidingu Loiyumpa, was a Meitei monarch and a ruler of Kangleipak kingdom. He was the first king to order a written constitution in the 11-12th century CE which is known as the Loiyumpa Silvel (Loiyumba Sinyen).

Roso Phishahanba was appointed the head of weaving loisang (department) during the time of Meidingu Loiyumba. The Puya "Loiyumpa Silyen" or "Loiyumba Shinyen"records the names of royal weavers such as Naotam Phishapa, Ngangti Phishapa, Yangnu Phishapa, Heisu Naha Phishapa and more.

Wangkhei Phee is a delicate, traditional handloom textile from Manipur, India, characterized by its transparency and intricate, fine patterns. Traditionally made with cotton fibers and an airy weave of spaced warp and weft threads, this fabric was historically reserved for the royal family and is now a protected Geographical Indication (GI) product.

Key Characteristics: Fabric: Made from white cotton, often with silk fibers woven

Weave: Features a very open, airy weave with spaced warp and weft threads, making the fabric translucent.

delicate patterns and motifs, showcasing masterful weaving skills. Origin: Originates from Imphal East,

Designs: Handwoven with intricate,

Manipur, and is a protected GI product. Cultural Significance: Embodies tradition and was historically worn by royalty.

The fabric is woven by women. It requires exceptional skill to create the fine patterns and airy texture.

Moirang Phee is a hand-woven textile from Moirang, Manipur, characterized by the MoirangPheejin design—a pattern of triangular motifs on the borders of the cloth. "Phee" means "cloth" in the Meitei language, and while it can be made of cotton or silk, the design itself is significant and historically was reserved for royalty. The fabric is woven on a back-strap loom by skilled artisans, often women, and holds cultural importance, being used in traditional clothing like the Manipuri phanek.

Origin: The Moirang Phee originated in the village of Moirang, Manipur, and is now produced throughout the state.

Moirang Phee: This is the defining design, featuring sharp, consistent triangles on the longitudinal edges of the fabric that point towards the center.

Materials: It can be woven from cotton

Significance: The Moirang Phee is a symbol of Manipuri identity and cultural heri-

Weaving process: Skillful craftsmanship: The intricate MoirangPheejin design requires precision and is a slow, contemplative process, often performed by women in home workshops.

Back-strap loom: The fabric is tradition-

ally woven on a back-strap loom. Cultural significance: Weaving is an art that is taught to girls at a young age in many Meitei clans.

The Tronglaobi Yarn Bank is an Indian Army-backed skill development project in Tronglaobi village, Manipur, that provides raw materials and training to women weavers to revive traditional textile crafts, empower the community, and create a sustainable model for local development and peace-building. The project is a collaboration with the Aseem Foundation, a non-governmental organization, and aims to foster community well-being by creating a platform for women weavers to sell their products and use their profits to sustain the bank.

Key Aspects of the Tronglaobi Yarn Bank: Collaboration: The project is a partnership between the Indian Army and the Aseem Foundation, in collaboration with local villagers, particularly women artisans.

Empowerment: It focuses on empowering local women by providing them with the necessary raw materials, machinery, infrastructure, and guidance to excel in their weaving skills.

Revival of Tradition: The Yarn Bank helps to revive and promote the rich, traditional weaving culture of the region.

Sustainable Development: The initiative creates a self-sustaining model by ensuring that the profits generated by the weavers are reinvested into buying raw materials and supporting the Yarn Bank.

Economic & Social Impact: It serves as a significant step towards community wellbeing, fostering resilience, promoting entrepreneurship, and building a more cohesive and peaceful society.

Peace-Building: The project's emphasis on cultural revival and economic empowerment is seen as a replicable model for peacebuilding in sensitive regions.

What is the Indian Army doing:

Complementing these are the natural cosmetics derived from plants and herbs and flowers like leihao, the turmeric, rice water and sesame oil occurs for both daily care and sacred rituals. The practices demonstrate ecological wisdom before sustainability became the popular buzzword of modern times. Yet, despite their deep roots,

these traditions faced the risk of fading away $until\,a\,heartening\,intervention\,arrived\,from$ the Indian Army.

Reviving Tradition, Empowering Women: Indian Army personnel often received handmade shawls and jewellery from Northeast villagers during their deployment in remote areas where they discovered this valuable yet fading cultural heritage. Recognizing the untapped potential of these heritage crafts and requirement of their exposure to other states, the Indian Army initiated a unique empowerment drive.

Leveraging the local skill set of women in the region, the Army partnered with Aseem Foundation, a Pune based NGO known for its work in entrepreneurship, education and development in remote and conflict-prone areas. This collaboration gave rise to a series of community-driven initiatives under Operation Sadbhavana, result $ingin \, the \, establish ment \, of \, production \, units$ centered on weaving, yarn banking, natural cosmetics and bead jewellery. These projects were crafted with a dual purpose to revive the region's rich cultural heritage and to empower local women through sustainable livelihoods and economic self-reliance.

Loktak Mist: Beauty Rooted in Nature: During community engagements, the local women of Phubala village in Bishnupur district of Manipur showed interest for making natural cosmetics based on traditional Manipuri knowledge. The women from this region used rice water with wild herbs and aromatic oils as part of their beauty practice. The Phubala Cosmetic Centre developed as a new initiative which drew its wisdom from ancestral knowledge. The cosmetic brand, "Loktak Mist", draws its name and inspiration from Loktak Lake, Manipur's iconic freshwater treasure. It beautifully blends age-old beauty recipes with modern cosmetic standards, offering a harmonious fusion of tradition and innovation in every product. The Army provided women with technical skills for skincare formulation and branding with marketing techniques. Loktak Mist products made from rice water, leihao flowers and herbal oils serve as more than natural skincare because they embody cultural pride, entrepreneurial success and resilience.

Zakhama Textile Unit: Threads of Unity in Nagaland: In Nagaland's Kohima district, the Red Shield Division established a textile unit in Zakhama village, tapping into the tribal weaving traditions symbolized by shawls like the Tsungkotepsu. The facility, outfitted with traditional looms and variety of yarns including cotton, polyester, acrylic and silk along with other necessary equipment, became a hub of structured training and income generation.

Local women gained access to structured skill development and sustainable income avenues. The initiative provided livelihood support but also strengthened the emotional relationship between Indian Army and local communities, making Army a true partner of peace and development.

A Skill Development Centre for Bead Jewellery opened its doors at P Moulding Village in Kangpokpi district of Manipur through Operation Sadbhavana. Local women receive hands-on training through this program for traditional beadwork techniques which include wire looping and bead identification and stringing and knotting.

Expert guidance and continuous support from Army enables the center to develop into a sustainable commercial business that turns cultural artistry into financial opportunities for women. This project unites traditional heritage with business practices to create better livelihood options that supports the Army's mission to drive social transformation and self-reliance and inclusive development in the area.

A Tapestry of Change: These initiatives represent economic possibilities beyond their surface value because they revive cultural heritage while providing selfexpression platforms and traditional connections to modern innovation. The women of Northeast now share their narratives through the musical loom rhythms and beadwork elegance and Loktak Mist fra-

The Indian Army's distinctive initiative with Aseem Foundation ensures that traditional crafts which almost disappeared from existence now serve as drivers of social transformation and selfreliance. Through their joint efforts they have established a new perspective that combines empowerment with peace and tradition to show remote areas that a brighter future can be built through vision and compassion.

Clean Air, Healthy People



World Environmental Health Day was initially observed in 2011 following its initiation by the International Federation of Environmental Health (IFEH). Since that time, it has served as an international platform to highlight critical issues such as water quality, food safety, sanitation, and, more recently, the pressing crises of air pollution and climate change. The day serves as a moment to recognise the quiet but critical contributions of environmental health professionals, who work tirelessly to prevent disease and promote healthier living environments. In 2025, the 15th yearly recognition of this day arrives when India's struggle against contaminated air has turned into a crucial public health and development concern.

India today bears the ignominious distinction of hosting the majority of the world's most polluted cities. The World Air Quality Report 2024, released by Swiss company IQAir, ranked India as the 5th most polluted country globally. Delhi frequently dominates the news for its dangerous smog, particularly during the winter season, when a harmful mix of vehicle exhaust, industrial waste, crop burning, and construction dust envelops the city. In November 2023, for example, Delhi's Air Quality Index (AQI) exceeded 450 on multiple days - levels categorised as "severe" and "hazardous" to human health. Cities such as Kanpur, Lucknow, Ghaziabad, and Patna often show air quality levels significantly exceeding safe limits, endangering millions daily. The issue extends beyond large cities; smaller urban areas are similarly facing increasing pollution from unregulated industrial zones and the growth of

The effects on health caused by this toxic air are overwhelming. The Lancet Commission on Pollution and Health stated that air pollution caused almost 1.6 million early deaths in India in 2019, designating it as the primary environmental risk factor for mortality. Children are especially at risk, with increasing instances of asthma, bronchitis, and hindered lung growth noted in city schools. Adults encounter heightened risks of heart disease, stroke, lung cancer, and even cognitive decline associated with prolonged exposure. In addition to human health, air pollution impacts livestock and farming. Animals exposed to elevated levels of particulate matter experience respiratory issues and lower milk production. Ground-level ozone, a result of air pollution, endangers crop yields by disrupting photosynthesis and inhibiting plant growth. Air pollution also carries a heavy economic burden for India. Estimates suggest annual losses between \$95 billion and \$150 billion, equivalent to nearly 3 per cent of the country's GDP. These losses stem from multiple factors — declining labour productivity, higher healthcare costs from pollution-related diseases, and reduced economic output due to premature deaths.

This crisis is rooted in a complicated network of factors. Swift urban growth and industrial development, along with weak enforcement of environmental laws, have transformed Indian cities into pollution hotspots. Vehicle emissions continue to be the primary cause, worsened by the rapid increase in private cars and insufficient public transportation. Coalfired thermal power stations and brick manufacturing facilities discharge significant quantities of pollutants, whereas construction work generates dust that remains airborne. Seasonal stubble burning in regions such as Punjab and Haryana contributes to the winter smog in Delhi. The use of biomass for cooking in rural and peri-urban households remains a quiet yet considerable factor in both indoor and outdoor air pollution. Collectively, these elements form an air pollution emergency that resists immediate solutions.

Public awareness is crucial in tackling this issue. Although government regulations and technological solutions are essential, the behaviour of citizens can determine their effectiveness. Initiatives like the "Odd-Even" vehicle restriction in Delhi or the encouragement of cleaner LPG cooking fuel through the Pradhan Mantri Ujjwala Yojana demonstrate that with active public involvement, significant progress can be achieved. Regrettably, understanding of the health effects of pollution is still limited in numerous communities, resulting in delayed actions. For example, the implementation of masks on high smog days or routine air quality assessments in educational institutions and workplaces remains infrequent. Enhancing environmental health literacy is crucial to fostering demand for cleaner policies and responsible living.

Acknowledging the magnitude of the issue, India has implemented various laws and initiatives to address air pollution. The Air (Prevention and Control of Pollution) Act, enacted in 1981, established the basis for overseeing industrial emissions. The Environmental Protection Act of 1986 granted the government extensive authority to safeguard environmental quality. Recently, the National Clean Air Programme (NCAP), which started in 2019, seeks to lower particulate matter levels by 20-30 per cent across 131 cities by 2024. The Commission for Air Quality Management (CAQM) was also set up in 2021 to oversee pollution control in the National Capital Region and surrounding states. Policies promoting electric vehicles, renewable energy, and stricter emission norms for industries and vehicles reflect India's commitment to tackling the crisis. Still, considerable voids persist. The application of regulations varies, and penalties for offenders are frequently insufficient to discourage repeat violations. Collaboration among state governments — essential during the stubble burning period – is often hindered by political disagreements. Public transport systems are unable to keep pace with urban expansion, leading to reliance on personal cars. Open-air waste burning remains unregulated in numerous cities. The NCAP has faced criticism for insufficient funding and the absence of effective monitoring systems. Lacking strong political will, sufficient funding, and community involvement, these initiatives may fail to meet their ambitious goals. To address these challenges, India requires a thorough and multifaceted action strategy.

Adopting a healthy lifestyle, ensuring timely medical attention key to prevent heart diseases and stroke: Dr Tasaduk on World Heart Day, 2025

SRINAGAR, OCT 01: Prominent Kashmiri doctor, public health expert and columnist, Dr Tasaduk Hussain Itoo on the occasion of World Heart Day, 2025 said that adopting a healthy lifestyle and ensuring timely medical attention is key to prevention of heart diseases and stroke. In a statement issued on World Heart Day 2025, he said that this years theme "Don't miss a beat" encourages individuals and the global community to prioritize heart health by recognizing the importance of every heartbeat and taking action to prevent cardiovascular disease.

He cautioned that adopting unhealthy routines like eating poorly, exercising less, or leaning more heavily on substances such as alcohol, smoking and drug abuse, could increase the potential risks of heart diseases in general and heart attacks and stroke in particular. Dr Itoo said that there are many modifiable risk factors responsible for heart diseases that can be modified well in healthy ways to prevent the latter from occurring.

"Controlling your blood pressure and blood sugar levels, maintaining a healthy weight, eating a healthy diet, exercising regularly, and monitoring your cholesterol and triglyceride levels and keeping them under control are $crucial\,hall marks in\,prevention\,of\,heart$ diseases and stroke", he said



In addition he said that controlling one's lifestyle choices such as avoiding smoking and alcohol consumption are too important to help in prevention of heart diseases and stroke.

He said that cardiac death is largely preventable if patients with a heart attack come to hospital in time to get treatment."If you think you are having any heart issue, it is really important to come to hospital and get evaluated so you can get the problem taken care of early", Dr Itoo said.

He further added that people should also avoid unnecessary stress in their lives by following a good health routine as research has shown that the inflammation caused by depression can increase a person's risk for a heart attack.

TEPA agreement between **India and European Free Trade** Association (EFTA) come into effect

New Delhi, Oct 1 The Trade and Economic Partnership Agreement (TEPA) between India and the European Free Trade Association (EFTA) comprising Switzerland, Norway and Iceland, came into effect today and is expected to reduce tariff barriers and expand India's share in key commodities in EFTA countries.

India's exports to EFTA stood at USD 72.37 million in 2024, contributing 0.41 percent of EFTA's total imports.

The agreement signed on March 10, 2024, offers binding commitment of 100 bn US Dollar investment and one million direct jobs in the next 15 years and will stimulate services exports in sectors like IT, business services, education, audio-visual etc.

It also provides Mutual Recognition Agreements in Professional Services like nursing, chartered accountants, architects etc. and incorporates, for the first time in any Free Trade Agreement (FTA) signed by India, a commitment linked to investment and job creation.

The agreement comprises 14 chapters with main focus on market access related to goods, rules of origin, trade facilitation, trade remedies, sanitary and phytosanitary measures, technical barriers to trade, investment promotion, market access on services, intellectual property rights, trade and sustainable development and other legal and horizontal provisions.

The EFTA's market access offer under TEPA covers 100 percent of non-agri products and tariff concession on Processed Agricultural Products (PAP). Sensitivity



related to PLI in sectors such as pharma, medical devices and processed food etc. have been taken while extending offers.

The agreement goes beyond goods and services and is committed to promoting investments with the aim of increasing the stock of foreign direct investments by USD 100 billion in India in the next 15 years, and to facilitate the generation of one million direct employment in India, through such investments, an official statement said.

EFTA is an important regional group, with several growing opportunities for enhancing international trade in goods and services. EFTA is one important economic block out of the three (other two - EU and UK) in Europe. Among EFTA countries, Switzerland is the largest trading partner of India followed by Norway.

The TEPA will empower India's ex-

porters by providing access to specialized inputs and create conducive trade and investment environment. This would boost exports of Indian made goods as well as provide opportunities for services sector to access more markets.

As per Article 7.1 of TEPA, the EFTA States shall aim to increase foreign direct investment (FDI) in India by USD 50 billion within 10 years and an additional USD 50 billion in the succeeding 5 years, amounting to a total of USD 100 billion over 15 years.

Concurrently, the EFTA States shall aim to facilitate the generation of 1 million direct jobs in India resulting from these investment inflows. This investment commitment explicitly excludes foreign portfolio investment (FPI), focusing on long-term capital for productive capacity building.

HLC approves Rs 4,645 cr for recovery and reconstruction projects across nine states

New Delhi, Oct 1 A High-Level Committee (HLC), under the chairmanship of union Home Minister Amit Shah, today approved a number of mitigation, recovery and reconstruction projects having total outlay of Rs. 4645.60 crore.

Nine states - Assam, Kerala, Madhya Pradesh, Odisha, Rajasthan, Uttar Pradesh, Bihar, Chhattisgarh and Andhra Pradesh -- will benefit, a Home Ministry statement said.

The Committee, comprising of Finance Minister, Agriculture Minister and Vice Chairman NITI Aayog as members considered the proposal for financial assistance to the state from National Disaster Mitigation Fund (NDMF).

The HLC has approved the restoration and rejuvenation of wetlands plan of Rs 692.05 crore to Assam. The implementation of this project will enhance wetland capacity, create flood storage, increase flood resilience, protect the aquatic environment and will help in economic growth through improved fisheries infrastructure

Out of total approved outlay of Rs 692.05 crore for the project, the Central share will be Rs 519.04 crore (75 per cent) and state share will be Rs 173.01 crore (25 per cent). This includes projects for mitigation activities towards restoration and rejuvenation of 24 distinct wetlands of

nine districts of Assam, spread across the Brahmaputra river

Through a number of struc tural and other measures, this project will enhance water re tention capacity of wetlands and Beels and will help mitigate risk of flooding and erosion. This approval is in line with Home Minister's vision for the development of wetlands for conservation and flood mitigation in Assam. The project's long-term coverage is aimed at the entire length of Brahmaputra within Assam and therefore this project would be taken up as a pilot project to establish a floodproof Brahmaputra valley. The HLC has also approved the Urban Flood Risk Management Programme (UFRMP) Phase-2 for eleven cities viz. Bhopal, Bhubhaneshwar, Guwahati, Jaipur, Kanpur, Patna, Raipur, Trivandrum, Vishakhapatnam,

Indore and Lucknow with a total financial outlay of Rs 2444.42 crore to be funded from the National Disaster Mitigation

Fund (NDMF). The selection of these 11 cities is on the basis of their status of being most populous cities, primarily prone to floods, as well as consideration of other physical, environmental, socio-economic and hydro-meteorological factors. The programme will complement the states in mitigating risk of urban flooding in their cities through uniform structural and non-structural intervention measures. The funding pattern will be on cost-sharing between the centre and state as per NDMF guidelines i.e 90 percent from Centre and 10 percent

Additionally, out of afore-stated 11 cities, the HLC has approved the programme designed for flood mitigation projects of cial outlay of Rs 200 crore out of which Rs 180 crore will be the central share from NDMF.

The activities involved for un ban flood risk mitigation project for Guwahati cities ranges from structural measures of interlinking of water bodies to stormwater management, construction of flood protection wall, erosion control and soil stabilisation using Nature-Based Solutions (NBS) etc as well as non-structural measures such as flood early warning system and data acquisition system and capacity building etc. Earlier, Central Government had approved urban flood risk management programmes of total financial outlay of Rs 3075.65 crore for seven metro cities - Chennai, Mumbai, Kolkata, Ahmedabad, Hyderabad, Bengaluru and Pune. Further central government had also approved a number of mitigation projects for mitigating the risks of a number of hazards in the areas of landslides (Rs 1000 crore), GLOF (Rs 150 crore), forest fire (Rs 818.92 crore), lightening (Rs 186.78 crore) and drought (Rs 2022.16 crore). The HLC, also approved financial assistance of an amount of Rs 1270.788 crores to the Assam government and Rs 260.56 crore to Kerala for recovery and reconstruction activities for both the states in the aftermath of flood and landslide incident of 2022 and Wayanad landslide-2024

Delhi records best air quality in first nine months: CAQM

New Delhi, Oct 1 Delhi's air quality showed marked improvement in the first nine months of 2025, aided by favourable meteorological conditions and sustained efforts by all concerned stakeholders, according to a statement here from the union Environment Ministry.

As per data released by the Commission for Air Quality Management (CAQM), the city recorded an average Air Quality Index (AQI) of 164 during the period January to September 2025—the lowest for this period in the past eight years, barring 2020, the year of the COVID-19 lockdown.

It also said that there was not even a single day with average AQI of more than 400, besides witnessing highest number of 'Satisfactory' days, during January – September



period in 2025.

This year's average Air Quality Index (AQI) for the period January to September stood at 164, reflecting a consistent improvement in Delhi's air quality over the past sevveral years. In comparison, the average AQI for the same

The properties, located in Gurugram (Harvana), Greater Noida (UP), and Ludhiana (Punjab), are held by directors of Ansal Properties and Infrastructure Ltd. (APIL)—Sushil Ansal, Pranav Ansal, his Son's HUF, and Kusum Ansal

The action is part of a monev-laundering case stemming from violations of the Water (Prevention and Control of Pollution) Act and the Air (Prevention and Control of Pollution)

space. APIL is engaged in real estate development in the residential, commercial, and retail segments.

The ED initiated its investigation based on prosecution complaints filed by the Haryana State Pollution Control Board (HSPCB).

The complaints involved the commission of scheduled offences specifically, non-compliance with environmental norms by APIL in its two Gurugram-based real estate projects, 'Sushant Lok-I' and 'Esencia'

The ED's investigation revealed that APIL did not install a Sewage Treatment Plant (STP) in its 'Sushant Lok Phase-I' project, instead discharging effluent through a HUDA sewerage line.

The STP installed in its 'Esencia' project was of inadequate capacity.

During inspections, HSPCB officials found the STPs abandoned and non-operational.

The investigation further revealed that by not treating domestic effluent and sewage water as per norms, APIL caused damage to public health and the environment while profiting from its cost-saving actions.

The company's promoters failed to treat the waste or take measures required by HSPCB norms, thereby unduly benefiting to the tune of Rs 10.55 crore.

The ED has identified this amount as the proceeds of crime generated from the criminal activity. Further investigation into the matter is ongoing.

Vance blames Democrats for White House shutdown, accuses them of 'hostage takeover'

Washington, Oct 1: US Vice President JD Vance placed the blame for the government shutdown squarely on the shoulder of Democrats, accusing them of "hostage taking" over health care demands in his first public remarks since the shutdown began at midnight.

In a Fox News interview Tuesday morning. Vance said Democrats had forced the shutdown to extract concessions on health care funding, a move he argued was reckless and unnecessary, reports CNN.

"You don't take the government as a hostage because you want to engage in negotiation about health care costs," Vance said.

"Let's do that negotiation, but let's do it in the context of actually opening the government and ensuring those essential services are actually provided to the American people.

The VP singled out what he called a "far-left faction" of the Democratic Party, accusing it of holding up a short-term funding bill over Obamacare's premium support program.

"What makes it extra preposterous is



until next year," Vance said. "So why are you shutting down the government on October 1?"

Vance insisted the White House remains open to talks on health care costs, but only if Democrats agree to reopen the government first. "We obviously care a lot about lowering health care costs for Americans," he said. "But we're not

going to engage in negotiations with hostage takers, which is exactly what the Democrats have done.

Yunus denies surge in minority persecution in Bangladesh, faces backlash from rights group

Dhaka, Oct 1 Denving a surge in minority violence and persecution, Chief Adviser Md Yunus has dismissed allegations that the Bangladesh's Hindu community was being targeted in Bangladesh, stating that there is "no anti-Hindu violence" in the country, instead attributing the reports to Indian media's peddling of "fake

His denial was strongly condemned by the Bangladesh Hindu Buddhist Christian Unity Council, a human rights organisation against religious discrimination, which expressed both deep sorrow and massive anger over his dismissal, according to Daily Ob-

Speaking to the Global Thinkers Organisation (GTO) on the sidelines of the UN General Assembly in New York, Yunus insisted there was "no anti-Hindu violence" in Bangladesh.

"No, it has not increased. I would say the government is very alert on that one, because this is the one thing India is always pushing," he said.

The remarks stood in stark contrast to Yunus' own comments last year, when he publicly acknowledged the persecution of Hindus and Buddhists as well as the growth of Islamist extremism. At the time, he described minority attacks as a serious challenge for the country, and one his administration was determined to tackle - to no avail yet.

The Bangladesh Hindu Buddhist Christian Unity Council, a prominent rights group, issuing strong condemnation called his dismissal "a denial of the truth."

In a statement, the Council said it had already presented evidence of "ongoing organised violence" against Hindus during an August 2024 meeting with the Chief Advisor.

It also cited a February 2025 UN Fact-Finding Mission report that documented continuing attacks on minorities after the interim government came to power last August.

The Council also weighed in on his comments from last year, noting that he himself had acknowledged the violence in an interview with the US broadcaster NPR last October, remarks later published by Bangladeshi daily Prothom Alo.

"By now dismissing the reality, the Chief Advisor is undermining victims' suffering and the credibility of his own earlier admissions," the Council said.

Despite his dismissal, and claiming that Indian media peddling fake news, separate reports from both its domestic and other independent international media outlets have likewise noted a similar surge in communal violence in recent months, including attacks on Hindu homes, temples and businesses.

The Council's activists stated that many of the assaults have gone unpunished, fostering a climate of impunity and indifference. The country's now banned opposition party, the Awami League also weighed in, accusing Yunus of complicity in the

In a statement, the party said, "Inhuman persecution of Hindus has continued under his interim administration, with looting, arson and indiscriminate killings that amount to

"While these atrocities were previously carried out under the protection of this illegitimate, fascist Yunus regime, it is now the regime itself that is launching attacks," the party stat-

International watchdogs have warned that the treatment of minorities has become a critical test for Yunus' credibility as he seeks to maintain foreign support for his interim govern-

Despite mounting evidence and condemnation, Yunus maintains that allegations of systematic minority persecution are po-

litically motivated and fabricated.

For rights groups and minority leaders, his dismissal of their plight has only deepened anger — and reinforced fears that attacks will continue unchecked.

US govt enters shutdown for first time in nearly 7 years

Washington, Oct 1 The US federal government entered a shutdown at the start of Wednesday as partisan divisions prevented Congress from passing a funding bill, which marks the first government shutdown in nearly seven years.

Hundreds of thousands of federal employees will be forced to take unpaid leave, with some public services potentially suspended or delayed, and the release of economic data possibly impacted as well. The shutdown commenced hours after the US Senate failed to pass a short-term spending bill that would have temporarily kept the government running. The continuing resolution proposed by Senate Republicans was blocked by Democrats, falling short of the 60 votes required for passage. In the latest negotiations,

both the administration's confidence that Democrats will eventually fold and its determination not to give ground on the shutdown itself.

"You're going to see more and more Democrats come to the side of reason and re-Democrats have pushed back, accus-

US govt goes dark as vast swathes of bureaucracy get laid off amid collapse of federal funding

Washington, Oct 1 The US government has for the most part gone dark as much of the bureaucracy was laid off on Wednesday, after Congress failed to reach a deal to approve new funding.

The ruling Republicans had proposed extending government funding at current levels until Nov. 21 to allow for members to continue working on full-year appropriations bills.

Democrats had countered this with a shorter extension until the end of October, but tied their offer to health care provisions and new limits on President Donald Trump's ability to withhold funds conditions Republicans rejected outright.

Talks at the White House on Monday between congressional leaders and Trump failed to produce any compromise, leaving both sides entrenched and the government without money to operate, resulting in the shutdown, reports CNN.

A shutdown occurs when Congress fails to pass funding bills, leaving agencies unable to spend money not explicitly approved by lawmakers. Since 1980, there have been 14 such shutdowns, including the record 34-day standoff in 2018.

A shutdown has drastic effects on all but the most essential of federal services. Essential services like Social Security, Medicare, and Medicaid benefits remain intact, but a wide swathe of federal functions have ground to a



Air traffic controllers and TSA agents continue to work without pay, keeping flights operational. The National Weather Service. Veterans Affairs medical services, and passport and visa processing remain active, though strained.

The disruption comes the backdrop of against Trump's push earlier this year to shrink the federal workforce. In February, he signed an executive order directing agencies to draw up plans for large-scale staff reductions, citing costs to taxpayers and poor performance.

Some agencies cut deeply, others reversed course, and still others quietly asked laidoff workers to return.

Both the political parties took to playing the blame game and accused each other for the blackout.

Republicans accused Democrats of engineering the shutdown for political leverage. "Democrats have officially voted to CLOSE the government." House Speaker Mike Johnson wrote on social media.

"Results: Moms and kids lose WIC nutrition. Veterans lose health care and suicide prevention programs. ... The only question now: How long will Chuck Schumer let this pain go on - for his own self-

ish reasons? Democrats fired back, placing responsibility on Trump and GOP leadership. "After months of making life harder and more expensive. Donald Trump and Republicans have now shut down the federal government because they do not want to protect the healthcare of the American people," House Minority Leader Hakeem Jeffries and Senate Maiority Leader Chuck Schumer said in a joint statement.

With neither party showing signs of compromise, the length of the shutdown is uncertain. Each day it drags on will intensify pressure on lawmakers to resolve their standoff — and add to the economic and political fallout of Washington's latest budget crisis.

Qatar, Turkey, Egypt urge Hamas leaders to accept US peace proposal amid Trump ultimatum

Ankara, Oct 1 Qatar, Egypt and Turkey have reportedly urged Hamas to quickly accept the 20-point proposal presented by US President Don-

ald Trump to end the war in Gaza, as per Axios. The three countries - which have been the longest mediators between Israeli authorities and the terror outfit – have met several of the group's commanders in the past 24 hours.

Trump, on Monday unveiled his plan, and gave Hamas an ultimatum – giving them only "three to four days" to accept - or otherwise be destroyed.

Speaking before a gathering of Pentagon generals and admirals in Quantico, Virginia, he warned 'We have one signature that we need, and that signature will pay in hell if they don't sign. I hope they sign for their own good and create something really great."

Political-military officials in both Washington and Jerusalem have been cautiously optimistic, as they expect the hardline group Hamas to agree, and most likely with reservations.

While Trump was presenting the plan in Washington, Qatari Prime Minister Md bin Abdulrahman al-Thani and Egyptian intelligence chief Hassan Rashad were briefing Hamas leaders in Doha.

According to a source of the media platform, both had pressed Hamas's senior command to accept the proposal, with al-Thani telling the group the proposal was the best deal he could secure and that Trump appeared personally committed to seeing it through.



Hamas leaders had not immediately issued a response post the proposal, and later said that they would study the plan "in good faith."

A day later, al-Thani and Rashad returned for a second meeting in Doha, this time joined by Turkish intelligence director Ibrahim Kalin.

Ahead of that meeting, al-Thani told Qatari media Al Jazeera that he hoped "everyone looks at the plan constructively and seizes the chance to

He stressed that Hamas needed to coordinate with other Palestinian factions in Gaza before issuing a formal response, but stressed that Trump's framework "achieves the main goal of ending the war, though some issues in it need clarification and negotiation.

Trump's 20-point proposal contains several major concessions to Hamas, including the release of 2,000 Palestinian prisoners and a sharp increase in humanitarian aid.

But it also demands the group's full disarma-

ment and outlines a phased Israeli withdrawal from Gaza — points that Hamas has historically

Some of the conditions and timetables for Israel's withdrawal, are said to have sparked the ire of Arab officials, who claimed that these terms made mediation efforts tougher. The new conditions were said to be inserted at the insistence of Israeli Prime Minister Benjamin Netanyahu.

Al-Thani described the plan as "still at an early stage and needing development," saying further negotiations would be required to trans-

late its principles into an actionable framework. Trump has made his stance clear, and said there is next to no room for negotiations, bar-

gaining, or any amendments. "There isn't much room" to negotiate further.

Arab and Israeli officials have thus warned the terror group to accept the proposal quickly, or otherwise embrace its own destruction and cause further deaths in Gaza.

Death toll in strong quake in Philippines rises to 69

Manila, Oct 1 The death toll in the 6.9-magnitude earthquake that struck Cebu province in the central Philippines last night climbed to 69, the Philippines' Office of Civil Defense (OCD) said today.

Assistant Secretary Bernardo Rafaelito Alejandro, deputy administrator for the OCD, told a public briefing that 30 died in

Bogo City, the epicenter of the earthquake, 10 in Medellin town, 22 in San Remigio town, five in Tabogon town, and one each in the municipalities of Sogod and Tabuelan. He said the victims died after they were crushed by the collapsed walls of houses and buildings. The National Disaster Risk Reduction and Management Council (NDRRMC) initially reported that at least 147 people were injured.

Alejandro did not give the latest figures on injuries and the missing people.

The death toll is expected to climb as emergency workers continue search and rescue operations for survivors trapped in the debris and collapsed buildings. "We are waiting for our assessment team to complete their rapid assessment," Alejandro said in an earlier media briefing.

The province of Cebu has declared a state of calamity, enabling the government, particularly local government units, to quickly access emergency funds (calamity funds) to provide relief and rehabilitation, as well as to impose measures such as price freezes on essential goods to protect affected residents. The Philippine Institute of Volcanology and Seismology initially reported that a 6.7-magnitude offshore earthquake struck Cebu province at 9:59 pm local time yesterday.

At least 91 trapped after school building collapse in Indonesia

Jakarta, Oct 1 Indonesia's disaster management agency today said that at least 91 people were trapped after a school building collapsed on September 29 in the Sidoarjo district of East Java province.

Abdul Muhari, spokesperson for the National Disaster Management Agency (BNPB), said that as of last evening, the accident had left three people dead and more than 90 injured, with 26 still hospitalised.

Hundreds of rescuers from

various agencies have been deployed to the site. Due to concerns that the use of heavy machinery could trigger further collapse, rescue workers have focused on manual excavation. They are delivering food and

water to those trapped under the rubble. Rescuers at the scene said signs of life have been detected in parts of the collapsed structure, and efforts are being concentrated there.

Meanwhile, the BNPB is working with construction experts to draw up a safe debris-clearing plan so that heavy equipment can be used in later stages if necessary.

Riyan Parag (67) and Ayush Badoni (50) also hit half-centuries to propel India A to a mammoth total. Iyer's dismissal in the 47th over left India A at 380 for 4, but Badoni and allrounder Nishant Sindhu took them

Australia A used seven bowlers, with only Liam Scott going at less than seven an over.

Chasing 414, Australia A had a good start: they were 116 for 1 in the 13th over, but Cooper Connolly's wicket triggered a slide. They lost their last nine wickets for 126 and left almost 17 overs unused in their

Opener McKenzie Harvey top-scored for the visitors with 68 off 62 balls while captain Sutherland made 50 off 33 balls. Spinners Sindhu, Bishnoi and Badoni shared seven wickets among them.

Gurjapneet Singh, who was making his List Adebut, having been fast-tracked into the India A side, came away with 1 for 40 in five overs.

India A will be bolstered by the arrival of Asia Cup hero Tilak Varma for the remaining two one-dayers.
