

**NEW DELHI, OCT 09:** Reaffirming the PM Modi led government's resolve to achieve a terrorism-free Jammu and Kashmir, Union Home Minister Amit Shah on Thursday asserted that security forces will continue to have full operational freedom to eliminate any threat to peace and stability in the region.

Shah, according to the news agency— Kashmir News Observer, chaired a highlevel meeting in New Delhi to review the security situation in Jammu and Kashmir.

After the meeting ended the Union Home Minister wrote on X: "Reviewed the security of Jammu and Kashmir along with the Lt. Governor and other senior officials. We are committed to cripple the terror ecosystem in J&K."

"Our security forces will continue to have full freedom to crush any attempt to



threaten peace and security in the region. Instructed to further intensify alertness and synergy to accelerate Modi Ji's vision of a terror-free Jammu and Kashmir," he

## J&K, Ladakh likely to see 3470 MWs peak power demand in Oct

**SRINAGAR, OCT 09:** With the onset of cold weather, the Ministry of Power (MoP) has predicted a peak power requirement of 3470 Megawatts (MWs) for Jammu and Kashmir and Ladakh for the ongoing month.

However, contrary to it the ministry has anticipated that there may be a peak power availability of only 2490 MWs for the month of October.

According to the official figures available with the news agency-Kashmir News Observer (KNO), the MoPhas predicted that Jammu and Kashmir and Ladakh may have a shortfall of 980 MWs against the total peak requirement. Stating the anticipated power supply

position in the northern region for October 2025, MoP has said that the representatives of Haryana, SLDC, Punjab SLDC and J&K SLDC informed that the shortfall in I&K would be met through Real time exchang-

# India-UK Partnership a Key Pillar of Global Stability: PM Modi

MUMBAI, OCT 9: The India-UK partnership stands as an important pillar of global stability and economic progress at a time the world is witnessing uncertainties, Prime Minister Narendra Modi said on Thursday after holding wide-ranging talks with his British counterpart Keir Starmer.

The two sides, following the Modi-Starmer talks, announced plans to supply lightweight multirole missile systems to the



Indian military to boost its air defence capabilities besides an in-principle move to finalise an inter-governmental pact to jointly develop maritime electric propulsion systems for India's naval platforms.

In their restricted as well as delegation-level talks, the two leaders held that the sealing of the historic free trade agreement between the two sides in July will inject new energy, boost trade and broaden the overall

Sinha; the Union Home Secretary; the Director, Intelligence Bureau; the Chief of Army Staff; the J&K Chief Secretary and Director General of Police of Jammu and Kashmir; the Directors General of the Central Armed Police Forces (CAPFs); and senior officers from the Government of India, the Army, and the Jammu and Kashmir administration.

The Union Home Minister appreciated the steps taken by the local administration and security agencies following the Pahalgam terror attack. "These initiatives have helped strengthen the overall security landscape of Jammu and Kashmir," he

Shah underlined the critical role of all security agencies in working in close coordination and maintaining utmost vigilance to completely eradicate terrorism from the region.

Pertinently, the Union Home Minister during his visit to Jammu last month chaired a comprehensive security review meeting and had reiterated the Central Government's unwavering zero-tolerance policy against terrorism under the leadership of Prime Minister Narendra Modi.

 $Shah\, had\, arrived\, in\, Kashmir\, soon\, after\, the\, April\,$ 22 Pahalgam terror attack that left 26 civilians, mostly tourists dead, and directed the security agencies to deal with the terrorists and their supporters with a "heavy hand."

### Supreme Court.....

On August 14, during a hearing of the case, the Supreme Court granted eight weeks' time to the Solicitor General of India to seek instructions from the government regarding the pleas for restoration of J&K's statehood.

At that time, the CJI emphasized that the real situation on the ground must be considered and that incidents such as the Pahalgam attack cannot

"You must also take into account the ground realities; you cannot ignore what happened in Pahalgam," said the bench led by CJI.

The petitioners have argued that the continued delay in restoring statehood violates the principle of federalism, which is part of the basic structure

of the Constitution. They have also submitted that no steps have been taken to lay out a clear timeline or implement the Supreme Court's December 2023 directive stating that "restoration of statehood shall take place at the earliest and as soon as possible."—(KNO)

and UK Prime Minister Keir Starmer in Mumbai, both countries, according to the news agency—Kashmir News Observer (KNO), pledged coordinated efforts to counter terrorism and uphold zero tolerance for terrorism and violent extremism.

The two leaders agreed to work together at bilateral and multilateral levels. They outlined plans to counter radicalisation, disrupt terror financing, prevent the cross-border movement of terrorists. and stop the use of new technologies for terrorist purposes. Measures will also target recruitment efforts and include enhanced information sharing, judicial cooperation, and capacity building.

PM Modi and Starmer agreed to deepen defence  $ties, including \, expanding joint \, training \, and \, military$ exercises. The UK's Carrier Strike Group and the Royal Navy's participation in Exercise KONKAN with the Indian Navy were noted as part of ongoing maritime cooperation.

Both sides committed to closer collaboration in the Indo-Pacific region, including the establishment of a Regional Maritime Security Centre of Excellence under the Indo-Pacific Oceans Initiative.

Progress was welcomed on integrating Indian Air Force Qualified Flying Instructors into UK Royal Air Force training programmes. An agreement is also under discussion to support broader defence training and education links between the two countries.

Both governments signalled intent to finalise an Inter-Governmental Agreement on developing maritime electric propulsion systems for Indian naval platforms.

The leaders also agreed to proceed through a government-to-government route for an initial supply of Lightweight Multirole Missile systems to India. This step is aimed at strengthening India's air defence capability and supporting long-term cooperation in complex weapons development between the two countries.

On global issues, the two Prime Ministers affirmed support for peace and a rules-based inter-

national order. The UK reiterated its support for India's bid for permanent membership in a reformed United Nations Security Council. They expressed support for a peaceful resolution to the conflict in Ukraine based on international law and the UN Charter—(KNO)

During the search, forces recovered two AK-series rifles, four rocket launchers, a huge quantity of ammunition, and other war-like stores. Officials said the recovery is a major blow to militant networks operating in the region and underscores the continued vigilance of security agencies.

The Army said the operation reflects the high level of coordination between the Army and Police in maintaining peace and preventing militant regrouping in Kupwara's frontier areas. "The recovery of such a cache indicates the attempts of militants to re-establish their presence, which has been effectively thwarted," an official said.

The seized arms and ammunition have been taken into custody, and further investigations are underway to trace the source and possible links of the hideout to any militant outfit active in the region.

The British prime minister, accompanied by over 100 CEOs, entrepreneurs, university vice-chancellors, landed in India's financial capital on Wednesday to a rousing welcome. It is his first visit to India.

"India and the UK are natural partners. Our relationship is built on the shared values of democracy, freedom, and the rule of law," Modi said in his media statement in presence of

"In today's time of global uncertainty, our growing partnership stands as an important pillar of global stability and economic progress,"

Modi said India's dynamism and the UK's expertise together will create a "unique synergy" to further enhance the bilateral relations

"Our partnership is trustworthy, and driven by talent and technology. And today, as Prime Minister Starmer and I stand together on this stage, it is a clear reaffirmation of our shared commitment to work hand-in-hand towards building a brighter future for the people of both our nations," he said.

In his remarks, Starmer described the signing of the UK-India Comprehensive Economic and Trade Agreement as a "breakthrough moment" as it will slash tariffs, increase access to each other's markets and create jobs.

"It is significant that we're meeting here in Mumbai, India's economic and financial capital, because India's growth story is remarkable. I want to congratulate the prime minister on his leadership, aiming to be the world's third largest economy by 2028," he said.

The two leaders also welcomed the resetting of the Joint Economic and Trade Committee(JETCO) which will support the governance and utilisation of the trade pact and drive forward wider trade and investment partner-

Modi and Starmer also discussed the situ-

ation in West Asia and the war in Ukraine. "The prime minister and I also discussed the need for a just and lasting peace in Ukraine, the need for stability and security in the Indo-Pacific, and the need to co-operate in critical areas like climate and energy, including breaking away from dependence on fossil fuels,"

# CS for giving strategic push to boost Milk and Mutton production in J&K

SRINAGAR, OCT 9: Chief Secretary, Atal Dulloo today chaired a high-level meeting of the Agriculture Production Department (APD) to review the measures being taken to enhance milk and mutton production across the Union Territory. He emphasized that both sectors hold immense potential for growth, value addition, and entrepreneurship if approached with the right policy interventions and sustained departmental support.

The meeting was attended by Additional Chief Secretary (ACS), Agriculture Production Department, Shailendra Kumar; Vice Chancellor, SKUAST-Jammu; Managing Director, HADP; Managing Director, Dairy Development; Directors of Agriculture and Sheep Husbandry from both Jammu and Kashmir divisions; and other senior officers of the department.

During the meeting, the

the need to create replicable success stories in these sectors to inspire public participation and entrepreneurship.

He observed that the region, being primarily a consumer state, offers a significant market for milk, mutton, and their processed products. Even in catering to local demand there exists vast potential in exploring commercial expansion and export of its value-added products.

He maintained that the UT must move beyond basic packaging and branding. The focus should be on scientific processing and value addition that can vield high-demand products and sustainable livelihoods. He urged local entrepreneurs to unlock the potential of the region's dairy and livestock sectors for finding the gainful employment.

While speaking in this meeting the ACS, APD, Shailendra Kumar, gave a comprehensive



overview of the present status and consumption patterns of milk and mutton in J&K. He noted that dairy products form part of the daily diet across the UT, while mutton consumption is among the highest in the country, creating steady market demand.

The department, he said, has

assessed the existing gaps and devised a roadmap to enhance both production and value addition over the next few years.

As per the presentation given by the department, J&K produces 28.75 lakh metric tonnes of milk annually, with a per capita availability of 577 grams per day, which is higher

than the national average of 471 grams. However, only about 4% of milk production is currently organized, accounting for just 4% of the local production. The department aims to bring at least 20% of production under the organized sector within the next5–7 years, the meeting was apprised.

department plans to expand Artificial Insemination (AI) coverage, secure High Genetic Merit (HGM) bulls, establish facilities for sexed semen, and address fodder deficit issues through scientific feeding prac-

Moreover around 1,600 PashuSakhis" (Maitris) have already been engaged to extend Al services at the grassroots level, while two semen stations are being established in the UT. The department is also in the process of procuring 40 HGM bulls from the USA and setting up milk processing and chilling units in every district.

In terms of mutton production, it was informed that J&K currently has 43.68 lakh sheep and 22.5 lakh goats, producing about 370 lakh kilograms of meat and 80 lakh kilograms of wool annually, against a local demand of around 545 lakh kilograms of meat here.

To bridge this gap, the department is pursuing advanced breeding interventions such as Embryo Transfer Technology (ETT) and Multiple Ovulation and Embryo Transfer (MOET) to accelerate genetic improvement.

Plans are also underway to establish Embryo Generation Labs with a target of producing 6,000 embryos annually, develop facilities for cryopreservation, and set up ETT laboratories in every district. Capacitybuilding programmes for veterinarians and para-veterinarians are also being rolled out to ensure effective implementation at the field level.

The Chief Secretary encouraged the Agriculture Production Department for its proactive initiatives and directed it to work in mission mode to transform both dairy and sheep husbandry sectors into engines of rural growth and employment



# New GST rates in the agriculture sector a blessing for farmers

"The revised GST rates will help increase farmers' incomes"

Keeping the interests of farmers and the common people foremost, the government has made sweeping reductions in GST rates - reforms that will energise India's agricultural system and power the progress of farmers. These are not abstract changes in policy; they touch the very soil farmers till every day. Over 10 crore small and marginal farmers will benefit directly. Earlier, agricultural equipment attracted GST rates as high as 18%; now it has been slashed to just 5%, ensuring direct savings of thousands of rupees for every farmer.

Take the case of a farmer buying a 35-horsepower (HP) tractor. What once cost around Rs. 6.5 lakh will now be available for approximately Rs. 6.09 lakh - a saving of Rs. 41,000. For a 45 HP tractor, the saving is Rs. 45,000; for a 50 HP tractor, Rs. 53,000; and for a 75 HP tractor, Rs. 63,000. Even smaller machines are now within easier reach - a power tiller will cost aroundRs. 12,000 less, a paddy transplanter Rs. 15,000 less, and a thresher Rs. 14,000 less. Equipment like power weeders and seed drills are cheaper by Rs. 5,000-Rs. 10,000. Larger machinery for harvesting and sowing - such as a 14-feet cutter bar, a square baler, or a straw reaper will now save farmers Rs. 1.87 lakh, Rs. 94,000, and Rs. 22,000, respectively. Tools like mulchers, super seeders, happy seeders, and sprayers are also more affordable, bringing modernisation to every acre.

Mechanisation is no longer a luxury, it is a necessity for profitable farming. The tax cuts on sprinklers, drip irrigation systems, harvesters, hydraulic pumps, and spare parts will empower even small and marginal farmers to adopt modern tools. Labor costs will fall, time will be saved, and productivity will rise. While prices may vary slightly across states and companies, the overall result remains clear: farmers will spend less and earn more.

Every step we take is guided by the singular aim of farmer prosperity. I have personally met representatives of agricultural machinery manufacturers to ensure that these tax reductions translate into immediate benefits for farmers. But this reform extends beyond agriculture; it is a powerful push for the entire economy. Lower input costs will enable farmers to generate higher returns from their produce, in turn strengthening small and cottage industries. Cheaper raw materials will bring down production costs, boosting MSMEs and creating new employment opportunities.

Agriculture and animal husbandry are twin engines of the rural economy. The GST exemptions granted to

beekeeping, dairy, animal husbandry, and cooperative societies will inject new energy into the countryside. When farmers' expenses go down and their incomes rise, they will naturally invest more in education, healthcare, and better living standards. That is how rural India's holistic development begins - not through handouts, but empowerment.

Prime Minister ShriNarendraModi has always emphasised organic and natural farming as the future of Indian agriculture. At a time when the world is moving toward sustainable cultivation and ecological balance, the government's decision to reduce GST on bio-pesticides and micronutrients from 12% to 5% is both timely and visionary. It will encourage farmers to transition away from chemical fertilisers toward organic inputs. The results will be transformative - richer soil fertility, a healthier planet, and reduced costs of cultivation. Given that most Indian farms are small holdings, the government continues to promote integrated farming and allied activities to ensure sustained income growth.

Value addition is equally crucial. The GST reforms have provided a strong boost to the food processing industry. With more investment in cold storage and processing units, farmers will be able to preserve their produce longer and sell it at better prices. Prime Minister ShriNarendraModi has repeatedly assured that no policy or agreement will ever compromise the interests of farmers, fishermen, or livestock owners. These reforms stand as living proof of that commitment. They will also reduce India's dependence on imports and give momentum to 'Make in India' and 'AtmanirbharBharat'.

At the heart of rural prosperity are the women of self-help groups. GST reforms have reduced their operating costs, helping small-scale rural industries flourish. As new processing units, storage facilities, and transport networks emerge in villages, fresh avenues for entrepreneurship and employment will open up. I am confident these reforms will realise our collective resolve of 'Swadeshi se Samriddhi' (prosperity through self-reliance), turning India's economy into a truly "long-living economy". These changes are not just about lowering tax rates; they represent a moral and economic commitment to reinvigorate the lives of farmers, small traders, animal rearers, fishermen, and women driving the rural enterprise. Guided by the spirit of 'SabkaSaath, SabkaVikas' and 'Antyodaya', our government continues to prove that the prosperity of farms and farmers is the true measure of the nation's progress

This Diwali, India will celebrate the festival with the theme of 'Swadeshi se Samriddhi' - lighting lamps of self-reliance in every home, echoing the chants of 'Jai Swadeshi', and moving confidently towards the vision of a 'ViksitBharat' under the leadership of Prime Minister ShriNarendraModi.

# World Mental Health Day and J&K: A Social and Human Perspective

Every year on October 10, the world observes World Mental Health Day to raise awareness about mental illnesses, their impact, and the urgent need for effective treatment. Mental health is an essential component of an individual's overall well-being, as a person's physical, emotional, and social functioning depend greatly were it.

In a region like Jammu and Kashmir, where decades of instability, tension, uncertainty, and economic pressure have deeply affected everyday life, mental health has emerged not only as a medical issue but also as a social, cultural, and humanitarian crisis.

According to mental health experts, the prevalence of stress, insomnia, depression, anxiety, and post-traumatic stress disorder (PTSD) in Kashmiri society is significantly higher than in many other regions. The prolonged political situation, worrying social transitions, lack of employment opportunities for the youth, educational pressure, and the strain on the traditional family system have further aggravated this crisis.

Reports from the Institute of Mental Health and Neurosciences (IMHANS), Srinagar, indicate that people of all age groups—particularly women and the youth—are the most affected by mental stress. Some studies suggest that at least three out of every ten individuals suffer from some form of mental health issue. However, due to social stigma and lack of awareness, most people do not seek medical help.

In our society, mental illness is often seen as a sign of weakness or shame, which isolates those suffering from it and discourages them from seeking support. This attitude traps them in silent suffering.

It is crucial that mental health be regarded as equally important as physical health, and that widespread awareness campaigns be launched to educate the public. The lack of qualified psychiatrists, counseling centers, and mental health services—especially in rural areas—makes the situation even more alarming in Jammu and Kashmir.

Although the government has initiated programs such as 'Manodarpan' and the National Mental Health Programme, their reach largely remains confined to urban areas. There is an urgent need to establish counseling cells in schools, colleges, and community centers, so that early signs of men-

tal distress in the youth can be identified and addressed.

Religious and community leaders can also play an important role in this effort, as they enjoy deep trust within society. Promoting peace, educational advancement, employment opportunities, and social harmony can naturally

improve the region's mental well-being.

The media must also deal with mental health issues responsibly, avoiding sensationalism and focusing instead on empathy and awareness. Mental health is not an individual matter—it is a measure of a society's overall well-being.



## **MAGNETIC RESONANCE IMAGING (MRI)**

# A Revolution in Modern Medical Diagnostics

Magnetic Resonance Imaging (MRI) is one of the most remarkable achievements of modern medical science. It has combined the principles of nuclear magnetic resonance with cutting-edge computer technology, MRI has enabled the clinicians to visualize the detailed internal structures of the human body without any invasive procedures.

The evolution of diagnostic imaging has transformed the way diseases are being detected and treated. Among the various imaging techniques such as X-rays, CT scans and ultrasound, Magnetic Resonance Imaging (MRI) stands apart due to its exceptional ability to provide detailed soft tissue contrast and multi-planar imaging. Since its introduction in the late 20th century, MRI has become indispensable in neurology, orthopedics,

cardiology, and oncology.
SCIENTIFIC PRINCIPLE BEHIND MRI

MRI works on the principle of Nuclear Magnetic Resonance (NMR). The human body is primarily composed of water molecules and each water molecule contains hydrogen nuclei (protons). When placed in a strong magnetic field these protons align with the field. A radiofrequency (RF) pulse is then applied, which temporarily disturbs this alignment. When the pulse is turned off, the protons return to their original alignment, releasing energy in the process. This released energy is detected by the MRI sensors and converted into detailed images by sophisticated computer algorithms.

The key components of an MRI system include:

It produces a powerful magnetic field (typically 1.5 to 3 Tesla).

**Gradient Coils:** This helps in spatial localization of the

signal.

It transmit and receive radio signals. Computer System:

It processes the data to construct highresolution images. ROLE OF MRI IN MEDICAL SCIENCE

MRI has become an essential diagnostic tool in nearly every medical specialty: Neurology:

It is used in neurology to detect the brain tumors, strokes, multiple sclerosis and spinal cord lesions.

Orthopedics:

The main role of MRI is to visualizes ligament tears, bone marrow disorders and joint abnormalities.

Cardiology:

It is used to evaluates cardiac structure, myocardial infarction and vascular anomalies. Oncology:

MRI helps in tumor detection, staging and treatment monitoring. Abdominal Imaging:

It provides non-invasive assessment of liver, kidneys and pancreas.

Unlike X-rays or CT scans, MRI does not

use ionizing radiation making it safer for aiding in tumor characterization. repeated imaging. WHY MRI IS COSTLY

The high cost of MRI procedures can be attributed to several factors:

1. Expensive Equipment:

MRI machines cost are high and it depends on the strength and technology.

2. Maintenance:

Regular calibration, helium cooling for superconducting magnets and software upgrades are costly.

3. Operational Costs:

Skilled radiologists, technologists and power consumption add to the running

4. Time Consumption:

The agreement marks a significant breakthrough in the two-year-long conflict in Gaza, with Hamas and Israel agreeing to a ceasefire and hostage release. The deal



involves the release of all living Israeli hostages in exchange for nearly 2,000 Palestinian detainees IIS President Donald Trump announced the agreement, saying, "I am very proud to announce that Israel and Hamas have both signed off on the first Phase of our Peace Plan.

This means that all of the Hostages will be released very soon, and Isra-

el will withdraw their Troops to an agreed upon line as the first steps toward a Strong, Durable, and Everlasting Peace." The development has been welcomed globally, with the United Nations Secretary-General Antonio Guterres commending the intense diplomatic efforts and calling on all parties to fully implement the terms of the agreement.

New Delhi, Oct 9 (UNI) Aam Aadmi Party National Convenor Arvind Kejriwal today described the recent attack and subsequent threats against Chief Justice of India B.R. Gavai as a "sinister conspiracy" aimed at intimidating both the Dalit community and the judiciary. In a video message posted on social media, Kejriwal referenced the incident where a shoe was hurled at the Chief Justice and the online threats that followed. He expressed concern over the lack of action against the perpetrators, stating that it suggests a "systematic and wellplanned conspiracy."

Kejriwal connected the attack to the CJI's Dalit background, arguing that the events send a dangerous message. "These people cannot tolerate that someone from a Dalit background, through sheer hard work and dedication, has risen to the top position in the judiciary,"

He questioned how an ordinary Dalit citizen could expect justice when the sitting Chief Justice himself could be targeted.

The AAP leader also

warned of a chilling effect on the judiciary, suggesting that judges may now "hesitate to speak against these forces, fearing similar attacks."

# WHO says closely monitoring toxic syrups

New Delhi Oct 9 (UNI) The World Health Organization (WHO) in a press statement today said that it is closely monitoring the health situation in India following sporadic cases of illness and deaths among children in Madhya Pradesh and Raiasthan.

Yesterday, the agency received confirmation from the Indian Drug Regulatory Authority - Central Drugs Standard Control Organisation of India (CDSCO) that Diethylene Glycol (DEG) had been detected in at least

three oral syrup medicines. These medicines were among those consumed by children in the reported cluster of cases. However, none of the contaminated cough syrups that led to deaths of children were exported from India to other countries. CDSCO informed WHO.

The response came after the WHO sought clarification from India whether the tainted cough syrup linked to over 20 child deaths in the country has been exported to other countries. The Indian Drug Regulatory Authority further noted that contaminated products include Coldrif, Respifresh TR and ReLife adulterated with

# ED raids illegal vehicle import network in Kerala

New Delhi, Oct 9 (UNI) The Enforcement Directorate (ED) Kochi Zonal Office today stated that it recently conducted searches at seventeen locations across Kerala and Tamil Nadu in a case involving the illegal import of high-end foreign-origin vehicles and related unauthorised foreign exchange dealings.

According to the ED, preliminary information identified a Coimbatore-based network led by Sathik Basha and Imran Khan, partners of Shine Motors.

The duo allegedly procured used vehicles from Bhutan using forged No-Objection Certificates and routed payments through unau-

thorised channels. Searches were carried out simultaneously at 17 locations, including residences, workshops, and business establishments in Ernakulam, Thrissur, Kozhikode, Malappuram, Kottayam, Coimbatore, and one address in

Incriminating documents, electronic devices, vehicle papers, and payment records were seized during the operation

During the search, Sathik Basha and Imran Khan gave statements under Section 37 of FEMA. They admitted that be-

tween 2023 and 2024, they procured approximately 16 vehicles from Bhutan through a Bhutanese intermediary,



Sha Kinley, a former Army personnel.

The vehicles were driven to the Indo-Bhutan border at Jaigaon, loaded onto car-carriers, and transported via Kolkata. Bhubaneswar, and Chennai to Coimbatore without customs clearance. No import duty was paid.

The vehicles were subsequently dismantled, and their parts were sold in Kerala, Tamil Nadu, Maharashtra, and other states, often through platforms like OLX.

Payments were received in cash or transferred to personal accounts. Their firms did not possess an Import-Export Code or maintain statutory invoices. Searches at garages and workshops across Kerala confirmed the presence of dismantled vehicle parts and digital evidence of communication with Bhutan-based

suppliers. seized materi-The al includes forged NOCs, WhatsApp chats, bank details, and buyer lists.

The investigation has revealed prima facie violations of Sections 3, 4, and 8 of

FEMA, relating to unauthorised foreign-exchange transactions and the acquisition of foreign assets.

The seized records are being forensically analysed to trace the money trail and confirm the involvement of foreign accounts

The ED is coordinating with Customs, State RTOs, and other agencies for verification and further legal action.

The operation has unearthed a network that exploited porous borders and digital platforms to evade customs duties and move foreign exchange through informal channels.

Admissions obtained during the searches have provided vital leads for tracing the funds and identifying other members of the syndicate.

The ED reiterated its commitment to act firmly against hawala transactions, foreign-exchange violations, and cross-border smuggling networks that undermine India's financial system.

# CJI Gavai "very shocked" at shoe attack, but calls it 'forgotten chapter'

New Delhi, Oct 9 (UNI) Chief Justice of India (CJI) B.R. Gavai to day remarked that he was "very shocked" at the attempted shoe attack on him inside the Supreme Court recently, but said the bench now regarded it as a "forgotten chapter."

Making his first comment on the episode, CJI Gavai said during court proceedings, "My learned brother and I were very shocked with what happened... for us, it is a forgotten chapter."

The incident occurred in court No. 1 on October 6, when Advocate Rakesh Kishore allegedly attempted to hurl a shoe at the C.II. Security personnel swiftly restrained the advocate while the CJI continued with the proceedings, drawing wide admiration for his calm and dignity.

Solicitor General Tushar Mehta termed the act "completely unpardonable," praising the CJI's "majesty and magnanimity" in the face of provocation. He also cautioned against online misinformation that, he said, "breeds hostility and erodes faith in the judiciary."

In immediate disciplinary action, the Supreme Court Bar Association (SCBA) terminated the temporary membership of Advocate Kishore, describing his act as "reprehensible, disorderly, and in-The SCBA's Executive Committee noted that such conduct was

"utterly unbecoming of an officer of the Court" and amounted to a "serious breach of professional ethics and dignity of the Supreme Court of India.' The Bar Council of India (BCI) also suspended Kishore's licence to practice law and issued a show cause notice directing him to explain within 15 days why the suspension should not be made per-

manent. All his court entry passes were deactivated following the Several political and legal bodies, including the CPI(M), All India Lawyers' union (AILU) and All India Bar Association (AIBA). condemned the act, calling it an "attack on the judiciary and the

AIBA Chairman Adish C. Aggarwala urged police to register an FIR against Kishore, terming his conduct "disturbing and unprec-

Following the episode, Delhi Police stated that no FIR could be lodged as the Supreme Court administration had not filed any complaint, though over 700 security personnel continue to be deployed in the court complex daily. Advocate Kishore was released after brief detention. Meanwhile, activist Suraj Kumar Bauddh has sought the Attorney General's consent to initiate criminal contempt proceedings against certain individuals, including YouTu-





# **Williamson Seeks More Resources to Boost Global Test Cricket**

**LONDON:** "There's been a lot of discussion about the Test game and how to keep breathing life into it, especially in countries where it's facing greater challenges," Williamson said on the sidelines of the CEAT Cricket Rating Awards in Mumbai on Tuesday. "The concern with a potential two-tier system is how teams in the second tier can continue to improve and work their way

up to the top division. "There are already many conversations around this, but the reality is that the impact has been felt for some time, so finding a solution sooner would be better. The Test format needs greater importance placed on it by all playing nations, along with additional resources to

support its growth. As a passionate supporter of Test cricket, I would love to see it thrive."

Williamson, who has called for tweaks, like designated windows for Test cricket in the past, supported the argument against twomatchTest series, but also recognised the challenges faced by certain boards to host longer series.

"These circumstances aren't ideal, but the Test game faces more challenges in some countries than others. Organising three- or fourmatch Test series is difficult commercially, making it hard for boards to support," he said. "However, the Test Championship has helped provide context, leading to more results and making the competition meaningful for teams.


"While some adjustments are

needed, the international schedule is very busy with both international and franchise cricket, creating clashes and challenges for players. Managing priorities on the calendar is a big task.

"Two-match Test series aren't ideal - I've played many for New Zealand and we always want more [games in a series] - but often this is the reality. I would love to see the Test game grow with more opportunities for teams and countries to develop, but those are complex discussions."

Williamson is now 35 and has opted out of a central contract with New Zealand Cricket and is on a casual agreement, meaning his international appearances have been and will continue to be sporadic.

## **Doubts over Cummins'** fitness for first Ashes Test grow, return remains unknown

LORD: The chances of Pat Cummins being fit for the first Ashes Test are growing slimmer by the day as he is yet to be cleared to bowl with just over six weeks to go before the first ball of the series in Perth. News Limited and Nine newspapers reported on Wednesday that Cummins' latest scan on the lumbar bone stress issue in his lower back had shown signs of improvement but not enough to be cleared to bowl again.

Cricket Australia have not provided a comment but ESPNcricinfo understands that Cummins' rehabilitation is continuing to progress and no decisions have been made on when the skipper will return to bowl, his participation in the first Test or the Ashes series as a whole.

Cummins has not bowled a ball since Australia's last Test match in Jamaica in July. Shortly after the lumbar issue was revealed in early September Cummins said he was "willing to take a few risks and be a little bit aggressive" to play in the Ashes which included not playing any white or red-ball lead-up games. But the timeline to build his bowling loads adequately to play in Perth, even with some associated risk, have become tighter than would normally be acceptable for CA's medical and high performance staff. Cummins has been doing leg strength work during his time off but has not been able to do any rotational work. Even beyond the back issue itself, the risk of a soft tissue injury becomes greater off a compromised preparation and Cummins has had to manage some soft tissue and ankle issues over the last few years with carefully tailored build-ups into key series.



Last year he was rested from Australia's limitedovers tour of the UK to do a 10-week block of training in the lead-in to the Border-Gavaskar series. Even then he only managed to play one 50-over game for New South Wales and two ODIs for Australia before the first Test against India after initial plans to play a Sheffield Shield game were aborted.
