

# From Art 370 to Op Sindoor, Modi govt broke all walls of terrorism: Amit Shah

SRINAGAR, OCT 14: Union Home Minister Amit Shah on Tuesday said that from the abrogation of Article 370 in Jammu and Kashmir to Operation Sindoor, the Narendra Modi-led Bharatiya Janata Party (BJP) government broke all walls of terrorism. Speaking at the 41st Raising Day of the National Security Guard (NSG) at its headquarters in Manesar, Shah, as per the news agency—Kashmir News Observer (KNO), said the government's approach follows a "zero tolerance" policy toward terrorism.

He mentioned amendments to the Unlawful Activities (Prevention) Act (UAPA), new definitions of terrorism in criminal laws, and bans on organisations such as the Popular Front of India (PFI)

# India's response to Pahalgam massacre was, precise: Lt Gen Rajiv Ghai

NEW DELHI, OCT 14: Director General Military Operations (DGMO) and Army's Deputy Chief Lieutenant General Rajiv Ghai on Tuesday said that India's military response to the April 22 Pahalgam terror attack was measured, meticulously planned and carried out with pre-

Speaking at a function here, Lt Gen Ghai, according to the news agency-Kashmir News Observer (KNO) described the Pahalgam attack — in which 26 tourists were shot dead by terrorists - as a "sponsored" cross-Line of Control (LoC) strike in which terrorists singled out victims on the basis of community. "They asked for the community that they came from and shot them in cold blood in front of their families and loved ones," he said.

"There were immediate claimers; this was 'glory'. However, when the Kashmir Resistance Front initially claimed the attack, they realised that matters had possibly gone beyond their control, and they immediately withdrew," Lt Gen Ghai added, underscoring that while a response was inevitable, the armed forces intentionally took time to plan and prioritise targets.

### J&K Has Always.....

The meeting was attended by FICCI President Harsh Vardhan Agarwal, Senior Vice President Anant Goenka, Director General FICCI Jyoti Vij, Past President Dr. Jyotsna Suri, Chairman FICCI J&K Council Mushtaq A. Burza, and members of the National Executive Council.

Highlighting the immense potential of the agriculture sector, the Chief Minister said that most of the produce from Jammu and Kashmir leaves the region in its raw form, with very little processing or value addition being done

"This opens significant opportunities for industrial growth, both on Jammu side and Kashmir's side," he stated.

Citing the dairy sector as an example, Chief Minister Omar Abdullah said that only about 4–5 percent of the J&K's dairy production is processed within Jammu & Kashmir, while the rest goes unprocessed into the market. He urged industry leaders to explore these areas for investment and growth.

Referring to the broader economic scenario, the Chief Minister said that the J&K has faced challenges due to recent natural calamities and the downturn in tourism following the Pahalgam incident, but the administration remains optimistic about revival across sectors.

"This is not a story of pessimism but of hope and optimism. We are working hard with all stakeholders to put the economy back on track,"

The Chief Minister informed that the government is simultaneously engaging with domestic and international tourism partners to attract visitors and revive the sector. "Jammu and Kashmir has always been the country's premier destination and we are determined to sustain that legacy," he added.

Chief Minister Omar Abdullah also outlined the areas where the government is focusing on sustainable and competitive industrial growth, including agriculture, horticulture, handicrafts. electronics, pharmaceuticals, packaging and cement. He said that new road-connectivity projects such as the Delhi-Amritsar-Katra Expressway and four-laning of the Jammu-Srinagar National Highway will further enhance logistics and investment potential.

Reiterating the government's commitment to improving the ease of doing business, the Chief Minister invited FICCI's inputs on policy reforms to make J&K more investor-friendly.

"We are keen to learn from best practices across the country. Reforms will be guided by feedback from the industry itself," he said.

The Chief Minister also called upon the corporate sector to support Jammu and Kashmir through Corporate Social Responsibility (CSR) in youth-centric areas such as sports infrastructure, libraries and skill upgradation. He urged companies to partner with the government in upgrading Industrial Training Institutes (ITIs) and skill centres to create an employable local

workforce. The Chief Minister reaffirmed the strong partnership between Jammu and Kashmir and FICCI and expressed hope that renewed engagement will yield tangible results for J&K's economic growth.

"This is a long-standing relationship and today's meeting marks another step towards

strengthening cooperation and building new opportunities for the people of Jammu and Kashmir," he added.

The delegations comprising representatives from different areas of Kashmir projected demands relating to infrastructure, civic amenities, power, water supply and road connectivity in their respective areas.

The Chief Minister gave a patient hearing to the visiting delegations and assured that their genuine demands would be examined and addressed in a time-bound manner.

Several legislators also met the Chief Minister and discussed key developmental priorities concerning their constituencies. They briefed him about ongoing works, public grievances, and sector-specific requirements aimed at improving service delivery and accelerating local development.

The Chief Minister assured the visiting delegations that the government will continue to give focused attention to strengthen basic infrastructure and improving delivery of essential services across Jammu and Kashmir.

The Chief Minister was apprised about the progress achieved in respect of utilization of funds under the District capex.

During his visit, the Chief Minister also through virtual mode e-inaugurated several developmental projects completed at a total cost of ₹5.25 crore. Some of the major projects inaugurated were the construction of a 1x6.3 MVA Receiving Station at Kalantra (₹1.84 crore), a 33/11 KV 1x10 MVA Receiving Station at Bharahampora, Rafiabad (₹2.73 crore) and development of footpaths along the National Highway from Post Office to Carriappa Park in Baramulla (₹0.67 crore) executed by the Urban Development Department.

The meeting also held detailed discussions on constituency-wise development priorities. The Chief Minister assured the public representatives that all genuine demands have been noted and will be considered on merit.

Issuing key directions, the Chief Minister instructed the identification of alternate land for the Industrial Estate and to facilitate the expansion of GMC Baramulla. He also directed to initiate the process for handing over TRC Salamabad to the Tourism Department, formulation of DPRs for the Drung Reservoir, multilevel car parking at Tangmarg, and completion

of the Tangmarg Administrative Complex. The Chief Minister further directed that joint exercise be conducted by the Forest and R&B Departments for developing an alternate road to Gulmarg via Baba Reshi. He also emphasized the preparation of a DPR for the Administrative Complex, Baramulla, decongestion and expansion of the Fruit Mandi through coordinated efforts of the Horticulture and Housing Departments, and the creation of a district-level land

bank to support future developmental projects. Emphasizing youth empowerment, Omar Abdullah stressed on making Mission YUVA more vibrant, with J&K Bank playing a proactive

role in promoting youth entrepreneurship. Chief Minister Omar Abdullah reaffirmed the government's commitment to inclusive and sustainable development, underscoring the importance of inter-departmental coordination and time-bound execution of projects to maximize public benefits.

requested for a ceasefire.

In a strongly worded message. Lt Gen Kativar said, "If Pakistan repeats what it did, then what we do next will be more than the last time. Operation Sindoor 2.0 has to be more powerful."

Lt Gen Katiyar said Pakistan follows a policy of causing harm through multiple smaller actions rather than open conflict. "It does not have the capacity to fight a war with us. It does not want to fight a war. Its actions are part of the policy of 'bleed India through a thousand cuts'," he said.

Asked if similar attacks like the one in Pahalgam could happen again, he said, "Until there is a change in Pakistan's thinking, it will continue with these actions."

Earlier during his address at an ex-servicemen rally held to mark 60 years since the 1965 India-Pakistan War ceasefire, Lt Gen Katiyar, said that public support played a key role during Operation Sindoor. "We acted after our people were killed. The response was carried out with the support of the administration, ex-servicemen,

and local people.' He said the army remains prepared to act again if needed. "Pakistan will try again. It has always tried to repeat Pahalgam-type attacks. The army is ready to respond. The action this time will be more than last time."

Referring to the 1965 war, Lt Gen Katiyar said that Pakistan had miscalculated the situ-

ation in Jammu and Kashmir. "They sent around 10,000 Razakars trained by their army. But they failed to understand the people here. The public supported the army. We were able to drive them back."

He said that the same level of support will be required if another response becomes necessary.

Lieutenant General Manoj Katiyar hailed Operation Sindoor, saying the Indian Army gave a befitting reply to Pakistan after the Pahalgam terror attack. "Terrorists killed our innocent people. Our befitting reply to Pakistan taught

corroborated by multiple agencies.

"Alert troops deployed along the LoC in the Machhal sector detected suspicious movement near the forward areas and challenged the infiltrators. The terrorists opened indiscriminate fire, triggering a fierce gunfight. In the exchange of fire, two terrorists were neutralised. A large quantity of weapons and other war-like stores have been recovered from the encounter site," Army said.

The operation was ongoing when the last reports came in, with security forces maintaining a tight cordon in the area to rule out the presence of any additional infiltrators. (KINS)

Dr Jitendra Singh said, PM Narendra Modi's decision to reduce GST tax, has exposed the new generation and the youngsters to the versatile grandeur and beauty of Pashmina and at the same time, encouraged new entrepreneurs to take to this vocation.

Lauding Varuna Anand and her team for this successful venture, Dr Jitendra Singh observed that this was one of the finest examples of women-led entrepreneurship and noted that while on PM Modi's call from the Red Fort, the number of StartUps in the country had gone up from around 350 to over 1.7 lakh, what is significant is that nearly 60,000 of these are women-led and many from Tier 2 and 3 cities.

The exhibition, curated by Varuna Anand, Founder of The Splendor of Kashmir, showcases the rich legacy of handcrafted Pashmina shawls and traditional Kashmiri textiles, representing the centuries-old artistry of the Val-

While interacting with the founder Varuna Anand, Dr. Jitendra Singh appreciated the intricate craftsmanship and the months of dedicated labour that go into the making of a single Pashmina shawl. He was briefed about the entire process, from the delicate hand-spinning of fine Pashmina yarn to the detailed embroidery that reflects the cultural heritage of Kashmir.

Varuna Anand highlighted that the recent reduction in GST on handmade shawls from the earlier 12–22% slab to 5% has given a significant boost to the traditional handicraft sector, enabling artisans to reach wider markets and enhance livelihoods.

Dr. Jitendra Singh commended the initiative for not only preserving India's timeless craft traditions but also providing a platform for women entrepreneurs. This also reflects the growing contribution of women in shaping India's innovation and economic landscape, he

The Minister further said that Prime Minister Shri Narendra Modi's vision of "Vocal for Local" and "Atmanirbhar Bharat" is being effectively realized through such initiatives which combine tradition with entrepreneurship. He also encouraged the artisans and entrepreneurs to leverage digital platforms and e-commerce avenues to take India's heritage products to the global stage. Dr. Jitendra Singh congratulated Ms. Varuna Anand for her efforts in promoting Kashmir's indigenous art forms and supporting local artisans through sustained marketing and capacity-building initiatives. He said such exhibitions not only celebrate India's artistic excellence but also strengthen the spirit of womenled growth and self-reliance.

Shah said that Operation Sindoor successfully destroyed Pakistani terror bases, training camps, and launch sites. He added that in Operation Mahadev, Indian security forces conducted targeted operations to neutralise those responsible for the Pahalgam attack, boosting public confidence in the armed forces.

The Home Minister said that under Prime Minister Narendra Modi, the government maintains a zero-tolerance approach toward terrorism. "The campaign against terror has been broad and coordinated, from the abrogation of Article 370 to surgical strikes, airstrikes, and Operation Sindoor, aiming at dismantling the core of terrorist networks," he said.

"No matter where terrorists try to hide, they cannot find safe havens. Our forces are prepared to take action anywhere to respond to acts of terror," he added.

Shah said that since 2019, the government has taken several steps to enhance national security. These include amendments to the Unlawful Activities (Prevention) Act and the National Investigation Agency Act, along with actions under the Prevention of Money Laundering Act by the Enforcement Directorate to stop funding of terror groups, he said.

"For the first time, terrorism has been clearly defined under criminal law, addressing previous gaps. So far, more than 57 individuals and several organisations have been declared unlawful," Shah said.

The HM said the NSG's new hub is being established in Ayodhya, joining five existing hubs in Mumbai, Chennai, Kolkata, Hyderabad, Ahmedabad, and Jammu to respond to terror threats quickly. The commandos will operate around the clock, with special groups ready to respond to any sudden terror attacks, he added.

These actions, Shah said, have made India's security forces capable of dismantling terror networks inside and outside the country. "We have ensured that terrorists do not find safe havens anywhere, whether inside India or abroad," he said.

On the NSG's role, the Home Minister said the force has been operating for over four decades and remains critical in the fight against terrorism and organised crime.

"The government will continue to strengthen security measures and maintain readiness to respond to any threats, ensuring the safety of the nation's citizens," he said—(KNO)

### India's response.....

He said operations evolved between April 22 and the night of May 6–7, during which precautionary deployments were made along borders and multiple services and government agencies coordinated closely. "The final selection of targets was carried out from a large number of targets that we scrutinised," he said, noting a concurrent "harmonised and proactive information warfare campaign.'

Describing the military escalation in early May, Lt Gen Ghai said drone activity intensified even after two DGMOs had addressed the situation, prompting the Indian Air Force to act. In precision strikes on the nights of May 9 and 10, he said, Indian forces struck 11 Pakistani air bases - damaging eight bases, three hangars and four radars — and destroyed several Pakistani air assets on the ground.

He also claimed the destruction of one C-130 class aircraft, one AEW (airborne early warning) platform, and "four to five fighter jets," with some assets also destroyed

"We now know that the world's longest ever ground-to-air kill was at 300 kilometres plus and five high-tech fighters," Lt Gen Ghai said, adding that the "impunity" with which the attacks were conducted by the perpetrators was a key factor prompting a strong response.

All figures and operational details were attributed by Lt Gen Ghai to India's operational account of the events. The DGMO emphasised that the deliberate timing and multi-service coordination of the response reflected the armed forces' flexibility and intent to deliver a carefully calibrated, effective retaliation.

The Army Deputy Chief while referring to the turmoil that prevailed in J&K for three decades, as per KNO, said, "Over 1,00,000 people, including around 60,000 minority families, had to leave Jammu and Kashmir since 1990 due to threats and violence."

He said, "More than 15,000 civilians and 3,000 security personnel lost their lives in the region over the years."—(KNO)

Additional Chief Secretary, Public Works (R&B); Commissioner Secretary, Forests; Secretary, Information Technology; Divisional Commissioner, Kashmir; Secretary, Rural Development Department; Chief General Manager, BSNL; and other senior officers.

During the review, the Chief Secretary directed both Divisional Commissioners to take weekly appraisals of the progress made on each identified site. He asked them to closely monitor the pace of tower construction, electricity provisioning, and land-related issues, ensuring that every tower is made functional at the earliest.

He also reviewed the status of NoCs from the Forest Department for tower erection and laying of electricity networks and directed for early resolution of such matters through inter-departmental coordination. The Chief Secretary instructed the IT Department to act as the nodal agency for the programme, ensuring effective coordination among all stakeholder departments and timely removal of oper-

ational bottlenecks. Reviewing the extension of 4G network coverage under Bharat Net and Amended Bharat Net Programmes, the Chief Secretary observed that enhanced digital connectivity in these network shadow areas will significantly strengthen grassrootslevel empowerment, governance delivery, and access to public services.

He urged BSNL, the implementing agency, to expedite tower installations and ensure early commissioning. The company was advised to flag any implementation hurdles with the IT Department for prompt redressal.

The Chief Secretary was informed that out of a total 847 identified sites, BSNL has applied for electric connections at 744 sites, of which 505 sites have been energized. Additionally, 466 towers have been put on air, 98 more have been erected, and 95 others are ready for commissioning. Seven sites are off-grid and 19 are currently under execution.

BSNL representatives apprised the Chief Secretary that land issues persist at around 30 locations, for which he directed the concerned Deputy Commissioners to resolve matters at the earliest to avoid project delays.

The Chief Secretary also reviewed the implementation of the 'Call Before U Dig' (CBuD) initiative, highlighting its importance in preventing avoidable damage to road infrastructure. He directed the PWD to enforce mandatory use of the app before any road excavation, maintain strict vigilance, and initiate legal action against

It was informed that the portal currently has 40 registered agencies and 403 asset owners, with 176 unauthorized excavation instances recorded in the past.

The meeting was also apprised that 5G infrastructure mapping is underway, with around 1,58,126 assets including electric poles, traffic lights, bus terminals, and government buildings already mapped by H&UDD so far.

Regarding the Amended Bharat Net project, it was informed that 4,299 Gram Panchayats are targeted for coverage across the UT, providing high-speed internet connectivity to government institutions and the public.

Implemented by the Department of Telecommunications (DoT), the project has a three-year timeline, with 10% Gram Panchayats to be commissioned by December 2025 and 30% by June 2026.

The Chief Secretary reiterated the government's commitment to achieving universal mobile and broadband access, noting that digital inclusion is critical for accelerating socio-economic growth, improving governance efficiency, and bridging the urban-rural divide.

He urged all departments and agencies involved to work in close coordination to ensure that every household in remote and underserved areas gains access to reliable digital connectivity soon.

emphasized the need for comprehensive and coordinated data integration on the portal. He directed all concerned departments to upload data layers pertaining to Mission YUVA and the Holistic Agriculture Development Programme (HADP), besides incorporating the digitized land bank created by the Forest Department, to enable inclusive and informed decision-making.

Underscoring the importance of leveraging the Gati Shakti platform for social sector interventions, Dulloo stressed on the mandatory inclusion of datasets related to education infrastructure, health indicators, employment statistics, drug hotspots, and disaster-prone areas. He said that consolidating such multi-sectoral information on a single digital platform would facilitate focused interventions and better resource planning.

The Chief Secretary also took stock of the Action Taken Report on his previous directions regarding the portal and reviewed progress made in transitioning from point data to polygon data for mapping departmental assets. He called upon departments such as Industries, Tourism, Power Development, Health, and Jal Shakti to expedite the transition and provide clear timelines for completion of the data uploads. Highlighting the value of datadriven governance, Dulloo directed that relevant datasets be shared with research institutions to encourage analytical inputs and innovative solutions for improving

developmental outcomes. During the meeting, Commissioner Secretary, Industries & Commerce, Vikramjit Singh gave a detailed presentation on the current status of the portal. He informed that all 28 mandatory data layers have been successfully uploaded by J&K, in addition to 608 supplementary layers, with the onboarding of 40 departments and conduct of over 100 major and 120 minor training sessions to build departmental capacity.

Providing further insights, Director, Industries & Commerce, Jammu, Arun Manhas, highlighted several new features and initiatives incorporated into the portal to enhance its utility. These include the Unified Geospatial Interface, PMGS offshore integration, Knowledge Management System for sharing best practices, Decentralized Data Sharing Module, formulation of District Master Plans in Aspirational Districts, and the rollout of the LEAPS 2025 framework for effective monitoring and implementation.

The Chief Secretary appreciated the efforts made so far and urged all departments to ensure real-time data updation and cross-sectoral linkages to make the PM Gati Shakti portal a comprehensive planning and monitoring tool for accelerated development across J&K.


# Global antibiotic resistance deepens as WHO warns of mounting health crisis



The worsening situation prompted world leaders to adopt a political declaration on antimicrobial resistance at the United Nations General Assembly in 2024, setting targets to strengthen health systems and coordinate action across human health, animal health, and environmental **sectors.** The WHO report reinforces the importance of this "One Health" approach, which recognizes that antibiotic resistance arises not only from human medicine but also from agriculture and the environment. The use of antibiotics to promote animal growth or prevent disease in livestock remains widespread in many parts of the world, contributing significantly to the development of resistant bacteria that can spread through food chains, water sources, and direct human contact. Controlling resistance therefore requires policies that address antibiotic use across all sectors and ensure responsible practices in

both healthcare and

The world is confronting a mounting health emergency as bacteria increasingly develop resistance to the antibiotics once relied upon to cure common infections. The World Health Organization (WHO) has sounded a grave warning in its latest Global Antibiotic Resistance Surveillance Report 2025, which reveals that one in six laboratoryconfirmed bacterial infections  $worldwide \, in \, 2023 \, did \, not \, respond$ to standard antibiotic treatments. The findings underscore how antimicrobial resistance is spreading at a pace that threatens to outstrip medical innovation and undermine

global health security. The WHO report shows that between 2018 and 2023, antibiotic resistance rose in more than forty percent of the pathogen-antibiotic combinations it monitored, with average annual increases ranging from five to fifteen percent. The data, gathered from over one hundred countries through the Global Antimicrobial Resistance and Use Surveillance System (GLASS), highlights an accelerating crisis in which life-saving drugs are losing their power against some of the world's most widespread infectious diseases. The report compiles resistance prevalence estimates for  $twenty-two\,antibiotics\,used\,to\,treat$ infections of the urinary and digestive tracts, the bloodstream, and certain sexually transmitted infections, revealing disturbing patterns of resistance across eight major bacterial pathogens that cause mil-

lions of infections each year. Antimicrobial resistance is not evenly distributed around the world. The WHO notes that the problem is most acute in the South-East Asian and Eastern Mediterranean regions, where one in three infections are resistant to antibiotics, while in the African region one in five show resistance. Countries where health systems are fragile, diagnostic capacity is weak, and regulation of antibiotic use is poor are the most severely affected. In many such places, antibiotics can be purchased without prescription, leading to widespread misuse and overuse. The absence of strong surveillance networks and laboratory infrastructure has made it difficult to detect resistance early or track its spread, allowing resistant strains to circulate unchecked in communities and

hospitals. The rise of antimicrobial resistance is eroding one of the fundamental pillars of modern medicine. Medical procedures such as organ transplants, cancer chemotherapy, and caesarean deliveries depend on effective antibiotics to prevent and treat infections. As these drugs lose their efficacy, routine surgeries and common illnesses risk becoming fatal. The WHO warns that the progress achieved over decades of medical advancement could be reversed, pushing the world toward a postantibiotic era in which once-curable diseases again become deadly.

The report draws attention to the growing threat posed by Gramnegative bacteria, which are developing resistance faster than most

other pathogens and are particularly difficult to treat. Among them, Escherichia coli and Klebsiella pneumoniae have emerged as leading causes of bloodstream infections that often lead to sepsis and organ failure. Globally, more than forty percent of E. coli and over fifty-five percent of Klebsiella pneumoniae are now resistant to third-generation cephalosporins, which have long been considered first-line treatments for such infections. In Africa, the situation is even more dire, with resistance exceeding seventy percent in some areas. Resistance is also increasing against carbapenems and fluoroquinolones, antibiotics that were once reserved as lastresort options. The growing inefficacy of these drugs has drastically narrowed treatment options and pushed healthcare providers to depend on older, less effective, or more toxic alternatives. In many developing countries, newer antibiotics remain prohibitively expensive and are often unavailable, leaving large sections of the population without access to adequate care.

While the spread of resistance continues, there has been some progress in global monitoring. Participation in WHO's GLASS network has expanded from twenty-five countries in 2016 to more than one hundred in 2023, representing a significant step toward understanding resistance trends worldwide. However, gaps remain considerable. Nearly half of WHO member states failed to report any data to the system in 2023, and among those that did, many lacked the infrastructure to ensure the accuracy and consistency of the information collected. Countries with the greatest burden of resistance are often the least equipped to monitor it effectively, leaving the global community without a complete picture of the crisis. The WHO emphasizes that reliable surveillance data are essential for guiding treatment protocols and designing effective national strategies, and calls for investments in laboratory capacity, training, and data systems.

Innovation remains central to addressing the crisis, yet the development of new antibiotics has slowed to a near standstill. Pharmaceutical companies have scaled back research due to high costs, regulatory hurdles, and limited financial returns, leaving few new drugs in the pipeline. The WHO stresses the need for global incentives to reinvigorate antibiotic research while guaranteeing equitable access to new medicines, especially in lowand middle-income countries. Alongside innovation, preventive measures are vital. Improved vaccination coverage, better sanitation, clean water, and hygiene can reduce infection rates and limit the need for antibiotics in the first place. Equally important is the promotion of public awareness about responsible antibiotic use. The misuse of antibiotics — taking them without medical advice, stopping treatment too early, or using them for viral illnesses - remains a widespread problem that accelerates resistance. Combating these behaviors requires  $sustained\,education\,and\,awareness$ efforts targeting both the public and healthcare professionals.

To support countries in tracking and managing resistance, WHO has expanded its digital GLASS dashboard, which provides detailed data visualizations of global and regional trends in resistance and antimicrobial use. The platform allows policymakers and researchers to access country profiles, analyze progress, and identify priority areas for intervention. This move toward greater transparency and accessibility aims to strengthen international collaboration and promote accountability in the fight against antimicrobial resistance.

The WHO's 2025 report portrays both progress and peril. On one hand, growing international participation in surveillance efforts marks an important achievement in collective response. On the other, the continuing rise in resistance, the uneven capacity among countries to respond, and the lack of new treatment options point to a global health threat that remains largely unchecked. Without decisive and coordinated action, the world risks entering a future where minor injuries or routine infections once again carry deadly consequences.

Antimicrobial resistance now stands as one of the most urgent health challenges of the century. It demands not only stronger policies and systems but also a fundamental shift in how societies value and use antibiotics. The preservation of these vital medicines depends on global solidarity, scientific innovation, and responsible stewardship at every level. The coming decade will determine whether humanity can stay ahead of the evolving resistance or succumb to an era where the simplest infections become untreatable

**SRINAGAR, OCTOBER 14:** The Food Supplies & Consumer Affairs Department (FCS&CA) Kashmir conducted extensive inspections across multiple restaurants and food establishments in Srinagar district today.

The inspection drive was led by Assistant Director Enforcement (First Class Magistrate), Shohab Latief, along with officials from the Food & Safety Department and Legal Metrology Department. The inspection team visited several prominent establishments and other high-footfall restaurants and sweet

The focus was on ensuring compliance with food safety standards, proper hygiene practices, and consumer protection regulations.

The inspection covered multiple critical aspect including quality verification, quantity verification, cleanliness and hygiene standards, proper product dating and labeling, and overall food safety compli-

Officials from the Legal Metrology Department conducted thorough checks on measurement accuracy and quantity standards. The inspection results were largely satisfactory with no major violations

Minor issues were identified at some establishments, for which warning were issued. The Food & Safety Department imposed compound fines for minor violations to ensures strict compliance.

Speaking on the occasion, Assistant Director Enforcement reaffirmed the department's unwavering commitment to consumer rights and safety, emphasizing that regular inspection drives are being conducted to maintain transparency and accountability. The PCCF appreciated the proactive role of local communities and BMC members in protecting their natural heritage. He emphasized the need to blend traditional ecological knowledge with scientific forest management for sustainable conservation outcomes.

Later, the PCCF along with senior officers visited the under-construction Habba Khatoon Park in Gurez, where he reviewed ongoing eco-tourism development works being executed by the Forest Department. The team inspected landscaping, fencing, and pathway construction works being carried out under the eco-tourism promotion initiative aimed at showcasing the natural beauty of Gurez Valley.

Gupta underlined the importance of developing eco-friendly tourism infrastructure that attracts visitors while ensuring livelihood generation for local communities through homestays, eco-guiding, and handicrafts, maintaining ecological balance at the same time.

Speaking on the occasion, Conservator of Forests, appreciated the efforts of Bandipora Forest Division in integrating biodiversity conservation, habitat restoration, and eco-development works, particularly in remote areas like Gurez. He also emphasized convergence with other departments to promote nature-based tourism and improve community welfare.

At Zila Sainik Bhawan, an awareness programme was held in collaboration with the District Social Welfare Department and the Human Rights and Anti-Corruption Forum, bringing together government officials, legal professionals, and social workers on a common platform to deliberate on the challenges faced by widows and measures to address them effectively. Panel Lawyer, Advocate Laila

They emphasized that awareness is the firststeptowardsempowermentand encouraged participants to act as community advocates by spreading the message further.

The speakers also highlighted the role of DLSA Srinagar in ensuring access to justice for all, especially for the marginalized and vulnerable groups, through its legal aid clinics, counseling sessions, and regular outreach programmes. Participants expressed grati-

# NATIONAL SEMINAR ON DISASTER RISK REDUCTION HELD AT GDC SURANKOTE

The event, held in hybrid mode with online and offline participation marked the observance of the International Day for Disaster Risk Reduction (IDDRR). The seminar aimed to raise awareness among youth about disaster resilience, preparedness  $and\,environ mental\,sustainabil-$ 

The seminar, themed "Youth for Resilient Pir Panjal: Reducing Disaster Risks through Awareness, Action and Preparedness," focused on engaging students and academic professionals in proactive measures for reducing disaster risks in the Pir Panjal region. The event encouraged youth to act as advocates of climate action and sustainable living, aligning with the national vision of Mission LiFE (Lifestyle for Environ-

Member Legislative Assembly Er Chowdhary Mohammad Akram was the Chief Guest. The programme featured lectures by distinguished speakers including Dr. Arif Wali (Associate Director, Land Resources Division, TERI), Prof. Shabir Hussain Shah (retired college Principal) and Jhanghir Hussain Mir (Environmental Thinker and Activist).

community and social organisations were also present, with students actively engaged in discussions, made the sessions interactive and impactful.

The seminar started with the recitation of the National Anthem, followed by a welcome address by Prof. Fateh Mohammad Abasi, Head of the Department of Zoology. He welcomed guests and participants, while lauding the joint efforts of GDC Surankote and TERI for promoting academic exchange and community awareness on disaster management and environmental

In his address, the Chief Guest Chowdhary Mohammad Akram, an engineer by profession, analysed the root causes of frequent landslides and erosion hazards in the Pir Panjal region. He highlighted the impact of deforestation, poor drainage and unscientific urban planning on terrain instability. He advocated for slope strengthening, eco-friendly infrastructure and resilient landuse strategies. The Chief Guest appreciated Prof. (Dr.) Rani Mughal, Principal GDC Surankote for hosting such a significant seminar on disaster risk reduction and ensuring that the college continues to engage in meaningful environmental discourses. He assured full governmental support in strengthening community-based disaster preparedness and integrating scientific inputs into local development planning.

In his virtual address, Dr. Arif Wali offered an in-depth overview



of the Intergovernmental Panel on Climate Change (IPCC) and discussed the growing impact of greenhouse gases on global ecosystem. He highlighted the concept of carbon trading and shared successful communityled resilience stories from the

Sundarbans Tiger Reserve. Dr. Wali emphasised that investing in prevention and preparedness is far more beneficial than post-disaster recovery, urging young people to adopt science-based climate solutions and become leaders of local adaptation initiatives.

Prof. Shabir Hussain Shah discussed the growing environmental challenges in the Rajouri-

Poonch region, particularly illegal mining, poor land management and unplanned urbanization. He drew special attention towards the Surankote river belt, where increasing soil erosion has turned river water red, posing a grave threat to future agricultural productivity. He stressed that soil conservation

must be prioritized to prevent long-term ecological decline. Prof Shah urged the policymakers and intellectuals to collaborate for sustainable development and environmental protection across the Pir Panjal range.

Er. Zia Ur Rehman, an expert in Soil Mechanics and Foundations, elaborated on soil stability and consolidation, citing case studies from Kalaban and Mendhar. He explained that unchecked deforestation and unregulated construction weaken soil cohesion, increasing the risk of landslides. He asserted that scientific land-use planning, environmental impact assessments and soil testing must become mandatory before any developmental project in mountainous

Nazir Hussain Qureshi emphasized the need for conserving natural resources-especially water-and promoting sustainable housing designs suited to local topography. He called for responsible use of resources, proper watershed management and environmentally conscious construction practices to ensure harmony between human development and nature.

Students presented their papers on the theme "Youth for Resilient Pir Panjal: Reducing Disaster Risks through Awareness, Action and Preparedness", addressing environmental conservation, climate change adaptation and community-based disaster management.

The panel of judges included HOD Geography Dr. Ashfaq Mughal; HOD Physics Prof. Rizwan partment of Zoology Dr Prince

First Position was bagged by Syed Tahir Sajad from semester first while second and third positions were secured by Adrees Ahmed Rather and Asma Badar respectively. Moreover, Kalam of Alama Iqbal also added a cultural and thoughtful dimension to the day's proceedings.

Jhanghir Hussain Mir in his talk linked environmental consciousness with moral and spiritual responsibility, drawing inspiration from the story of Hazrat Nuh (A.S.). He urged the audience to adopt sustainable lifestyles and pressed for investing in renewable energy-particularly solar and wind power projects at Pir Ki Gali. He also paid tribute to late M.B Mughal, describing him as "a great environmentalist" and a lifelong inspiration for community service and environmental preser-

Delivering the closing address, Prof. (Dr.) Rani Mughal, Principal of GDC Surankote, expressed her delight over the active collaboration with TERI and the enthusiastic participation of the participants. She remarked that disaster management should move "from a reactive response system to a proactive culture of learning, awareness and preparedness."

Prof. Abdul Karim delivered the Vote of Thanks, extending gratitude to all dignitaries, guests and participants for their valuable contributions.

The Mega Health Camps aim to extend free medical services, diagnostic care, and surgical interventions to the needy and marginalized sections of society, particularly those residing in far-flung and difficult terrains of the district.

The Deputy Commissioner directed the Health Department to give wide publicity to the initiative and prepare a comprehensive database of potential beneficiaries. He also instructed the CMO and BMOs to identify



patients requiring surgical or specialized medical attention and ensure their inclusion in the programme.

It was informed that Rotary Club International has previously organized similar health outreach programmes across several districts, benefiting thousands through quality medical treatment, free surgeries, and post-operative care.

During the forthcoming camps, teams of renowned doctors, surgeons, and medical specialists from across the country will participate, offering free consultations, diagnostics, and surgeries in fields such as ophthalmology, orthopaedics, general surgery, ENT, and gynecology.

The District Administration, in collaboration with Rotary Club International and the Health Department, will provide full logistical support including transportation, accommodation, and medical infrastructure to ensure




