



According to officials, the coordinated searches targeted the residences of individuals allegedly linked with proscribed groups or suspected of facilitating militant activities.

terrorists is his top priority. He said criminal justice system will ensure perpetrators and elements of terror ecosystem are punished, providing a sense of justice and closure for victim's family and the society.

"I have assured the family members that their decades-long trauma, torment and suffering is over. We will ensure all the support so that they can reclaim their lives," the Lieutenant Governor said.

He also observed that families of civilian martyrs have gone through deep trauma, suffered various challenges including unemployment and education and felt loss of hope in the past three decades.

"Families of civilians who were killed by Pakistan-backed terrorists also suffered systemic barriers which stifled their progress. They were denied their rights and access to resources. All obstacles are now removed and we are ensuring justice and dignity for terror victim families," the Lieutenant Governor said.

The Lieutenant Governor paid homage to the civilians who were mercilessly killed by Pakistan sponsored terrorists in Jammu Kashmir. The families of terror victims also narrated their ordeal.

"It is difficult to articulate the pain and suffering of terror victim families due to their profound emotional and psychological trauma and the administration will handle each case with full sensitivity and responsi-

So far around 250 terror victim families provided with government jobs. This mission will continue till justice is done to every affected family. This is the beginning of a new era of justice in Jammu Kashmir," the Lieutenant Governor said.

The Lieutenant Governor also spoke on the Memorandum of Understanding signed between the High-range Rural Development Society (HRDS India) and Divisional Commissioner Jammu and Divisional Commissioner Kashmir, under which the houses of terror victims having their own land will be constructed. Under the initiative, the HRDS India and Divisional Commissioners of both the divisions will identify terror victim families whose houses were destroyed by the terrorists.

The Lieutenant Governor said the culprit Pakistani terrorists and their support system in the valley ran a false narrative for three decades to absolve terror country Pakistan

"Pakistan, breeding ground of terrorism, is exposed now and those involved in peddling a fake narrative on behalf of terrorists will be brought to justice," the Lieutenant Governor said.

While inspecting the Community Centre Hyderpora, the Deputy Chief Minister directed the officers to submit a detailed report for early resumption of works so that the facility can be dedicated to the public at the earliest.

He also issued instructions for utility shifting and removal of bottlenecks along the Rawalpora-Mocho Road to expedite work and ensure smooth and enhanced road facility to the general public.

To enhance connectivity and mobility for residents of the Chanpora area, the Deputy Chief Minister directed the concerned departments to initiate work on the construction of the Bailey Bridge at the earliest.

He further instructed officers to ensure that all ongoing works, including the Bund Road, Chanpora-Natipora Junction and other road projects, are completed within the stipulated timeframe.

During his visit to Bagh-e-Mehtab, the Deputy Chief Minister inspected ongoing macadamization works in Baghe Mehtab area and assured strict action against use of sub-standard material or any other negligence are reported.

During tour, various delegations called on the Deputy Chief Minister and appreciated the Deputy CM for taking spot inspections of the ongoing works.

Among others, Chief Engineer R&B Sushil Kumar; SEs from R&B, SMC, Housing, and other senior officers from concerned departments accompanied the Deputy Chief Minister during the tour.

outcomes achieved in recent years. A major highlight of the review was a presentation and live demonstration of the **Integrated Mining Surveillance System** (IMSS) — a digital initiative developed in collaboration with BISAG (Bhaskaracharya Institute for Space Applications and Geoinformatics). The IMSS portal and mobile application provide real-time monitoring of mining activities through dashboards integrated with e-Challan and e-Market systems. This innovation aims to enhance transparency, accountability, and regulatory compliance in mineral operations across Jammu and Kashmir.

He informed the meeting that over 243 triggers have already been generated for field verification through features such as vehicle tracking, GPS-enabled monitoring, PoSlinked e-challaning (integrated with J&K Bank), and on-the-spot enforcement to curb illegal mining.

While appreciating the initiative, the Chief Minister directed the developers to explore delineating and delegating PoS functions to expand the use of digital monitoring systems. He also called for integration of the department's existing portal with the IMSS platform to ensure seamless implementation and improved

Omar Abdullah further suggested that the application should allow citizens to register complaints through mobile gadgets to be integrated in the system with satellite imagery or other evidence, strengthening public participation and grievance redressal.

The Chief Minister instructed the department to categorize active and non-active mineral vendors or suppliers and establish a dedicated monitoring cell at the Directorate level for continuous data tracking and real-time oversight.

Reviewing ongoing reforms under the Special Assistance to States for Capital Investment (SASCI) 2025-26, the Chief Minister was informed that the department has initiated a series of key measures aimed at strengthening institutional capacity and ensuring greater transparency in the mining sector. These include a shift towards an auctionbased system for allocation of mineral blocks, introduction of mine closure and rehabilitation provisions, and the implementation of advanced survey and mapping mechanisms. The department has also operationalized the District Mineral Foundation Trust (DMFT) framework to ensure that mining revenues directly contribute to local area development and welfare initiatives.

Further, the meeting was informed, efforts are underway to revise royalty fee structure and penal provisions to align with current market realities while improving compliance.

The Mining Department has made the use of GPS-enabled transport and PoS-based transactions mandatory to track mineral movement and prevent leakages. Legal enforcement mechanisms have been reinforced through the requirement of royalty clearance certificates, in line with recent directions from the Hon'ble High Court, thereby tightening regulatory oversight and ensuring responsible mineral extraction practices.

The department also presented the status of major and minor mineral blocks, highlighting progress in auctioning and granting of mining leases across districts. The Chief Minister emphasized that all clearances and NoCs must be obtained in advance before blocks are allocated through auction to avoid procedural and operational delays faced by successful allotees & bidders who have to run from pillar to post in obtaining environmental and other clearances.

Speaking on the issue of illegal mining, Omar Abdullah underscored the need to eliminate collusion at lower levels of administration, asserting that illegal operations cannot persist without internal complicity.

"In my previous tenure, illegal mining was never a concern. With the technological tools now available, any such activity is only possible if there's collusion at the lower level. The department must use these systems effectively to eliminate that possibility. The more we reduce such collusion, the lesser the chances of illegal mining," the Chief Minister said.

The Chief Minister also reviewed exploration projects currently being carried out by MECL and GSI, covering sapphire, lithium, lignite, and shallow biogenic gas reserves in various districts. He was informed about ongoing exploration of granite, graphite, gypsum, copper, and base metals, supported by detailed geological mapping, drilling, and feasibility assessments.

He stressed on ensuring strict compliance

with environmental regulations, particularly in eco-sensitive zones, while expanding mineral development activities in a sustainable manner.

The Chief Minister commended the Mining Department for adopting digital innovation and institutional reforms and urged continued focus on transparency, efficiency, and environmental responsibility in the sector.

across several states, including Jammu and Kashmir, Jharkhand, Odisha, and Telangana.

The party has stated that the selected candidates represent "strong grassroots connections and leadership potential" in their respective constituencies.

"It is our collective responsibility to ensure the smooth functioning of the assembly and all departments have to be prepared in advance in this regard," he said.

He asked the General Administration Department to ensure that the reply to the Assembly Questions shall reach to the Assembly Secretariat as early as possible and necessary instructions need to be issued to all the departments in this regard.

He also called upon the Department of Law, Justice and Parliamentary Affairs that Government Bills be forwarded to the Assembly Secretariat well on time and necessary instructions be issued to all the concerned departments.

Speaker called upon the Information Department to ensure proper coverage of the proceedings of the House. He also asked the Information Department to provide logistical support by making available technical equipment like public address systems, mikes and other related items for the media.

Information Technology Department was asked to ensure Wifi and Internet Services with High Speed and installation of Routers wherever required before the ensuing Assembly Session.

He also called upon the security agencies for deployment of adequate staff well versed with Parliamentary traditions within the premises of J&K Legislative Assembly at Srinagar and make adequate arrangements for safety and security of Legislators.

Speaker further called upon the Estates department to expedite execution/completion of repair/renovation works within the Jammu and Kashmir Legislative Assembly, Srinagar particularly in the Assembly Hall and VIP Chambers.

They have been also asked to install intercom telephone facilities within the Jammu and Kashmir Legislative Assembly at Srinagar, besides checking of telephones already installed within the VIP Chambers.

To ensure proper regulation of traffic on roads leading to J&K Legislative Assembly Complex/Civil Secretariat Srinagar and MLA's Hostel Srinagar, Speaker called upon the concerned to put in place necessary measures for avoiding inconvenience to general public on this account.

Regarding water supply, Speaker called upon the Jal Shakti Department to keep necessary measures for providing sufficient and regular water supply to the Legislature Complex and Legislator's Hostel, Srinagar.

He also called upon the Power Development Department to check loopholes in transmission lines, if any, in order to ensure uninterrupted power supply during the course of session, besides ensuring uninterrupted power supply in the MLA' hostel.

Srinagar Municipal Corporation was asked to keep the entire premises and lawns of the Assembly and MLA's Hostel neat and clean, before the commencement of the

Speaker also issued necessary directions to the concerned departments to make advance preparations and put in place foolproof arrangements to provide timely medical support, installation/restoration of telephones in VIP chambers, emergency assistance, fire safety, cafeteria, proper hospitality for members, staff, and visitors throughout the session.

The Speaker emphasised that all protocol measures should be meticulously followed to ensure smooth functioning and the safety of all stakeholders during the proceedings.

The meeting was attended by Principal Secretary, Culture; Commissioner Secretaries of GAD, Youth Services & Sports, and Floriculture; Secretaries of School Education, Health & Medical Education, and Skill Development Departments; besides several other Heads of Departments and senior officers.

At the outset, the Chief Secretary termed the youth engagement programme a significant step towards nurturing creativity, innovation, and leadership among young people across the Union Territory. He emphasized the need to make the initiative multidisciplinary so that every young person is engaged meaningfully in line with their individual talents and aspirations.

The Chief Secretary impressed upon departments including Youth Services & Sports, Culture, School Education, Higher Education, Health, Rural Development, and others to devise strategic departmental plans for engaging maximum youth across their respective sectors. He also directed the Deputy Commissioners to prepare district-specific action plans for effective on-ground implementation.

Highlighting the centrality of coordinated efforts, the Chief Secretary designated the Planning Department as the nodal agency for overall implementation and monitoring of the initiative. He instructed it to develop a unified online platform for uploading and tracking all youth engagement activities across departments. The General Administration Department (GAD) was tasked with framing a Steering Committee to ensure smooth inter-departmental coordination and effective execution of the programme.

Underscoring the need to leverage existing national-level initiatives, he called for tapping into schemes and platforms of the Ministry of Youth Affairs such as My Bharat, NSS, Youth Exchange Activities, and Viksit Bharat Young Leaders Dialogue, which provide valuable exposure and skill-building opportunities for youth.

During the meeting, the Chief Secretary took feedback from Administrative Secretaries and Deputy Commissioners regarding their proposed strategies for maximizing outreach and participation under the programme. He urged all departments and district administrations to adopt a collaborative and convergent approach, pooling resources and expertise for impactful implementation at the grassroots level. He further enjoined upon the Information Department to create necessary awareness among the public about the youth welfare schemes and other orientation programmes for furthering their career pursuits.

Presenting the framework, Director General, Planning, Satvir Kour, highlighted that the initiative seeks to harness the creativity and dynamism of youth recognizing them as key drivers of social transformation and economic progress. She said the programme would equip young people with life skills, values, and self-confidence. steering them away from vulnerabilities such as substance abuse, unemployment, and social evils.

The Strategic Action Plan presented covers multiple dimensions of engagement, including Sports and Cultural Development. Revival of traditional arts, crafts, and cultural festivals such as Sufi festivals, classical arts performances, literary gatherings, and visual arts exhibitions promoting J&K's rich heritage while creating livelihood

opportunities is going to be the innate part of this programme.

With respect to furthering the Education and Skill Development the action plan focuses on making education and vocational training more accessible, market-relevant, and skill-oriented to enhance employability and promote sustainable livelihoods.

Another key pillar of the strategy includes entrepreneurship and business development which envisages expanding access to startup ecosystems, incubation centres, and financial assistance through schemes like PMEGP, REGP, NRLM (Lakhpati Didis), and Startup J&K, to nurture a new generation of self-reliant entrepreneurs across agriculture, technology, tourism, and handicrafts.

Encouraging productive digital engagement through webinars, innovation contests, and online learning platforms to connect rural youth with experts and mentors, is another strategic feature of this youth engagement programme.

Further, the District Development Commissioners (DDCs) are going to identify two socio-economically backward blocks in each district and prepare targeted plans for youth engagement across education, skilling, cultural activities, sports, and livelihoods. The DDCs were also instructed to ensure extensive awareness among young citizens regarding various government welfare and empowerment schemes to encourage their proactive participation.

The meeting concluded with a resolve to make youth empowerment a collective mission, integrating efforts of all departments to channelize the energy and potential of the young population towards a vibrant, inclusive, and progressive Jammu and Kashmir.

with legal procedure and in the presence of Executive Magistrates and independent witnesses, under the supervision of senior officers of Jammu and Kashmir Police.

The raids were carried out at the residences of several individuals, including Asrar Ahmad Bala of Omer Colony Lal Bazar, Shahbaz Ahmad Bhat of Palpora Noorbagh, Fayaz Ahmad Ganie of Suthsu Kalan, Burhan Nazir of Beeroni Kathidarwaza, and Sajid Majeed Shah of Nowpora Sekidafar. Other locations included Soiteng, New Theed, and Mughal Mohalla Raniwari, where multiple suspects such as Ashiq Bashir Najar, Umer Adil Dar, Shabir Ahmad Ganie, Ajaz Ahmad Bhat, and Ahsan Ahmad Bhat alias Munna were searched.

Police sources said the objective of these operations was to seize incriminating materials including digital devices, documents, and other evidence connected to ongoing investigations. The raids also form part of a larger intelligence-gathering exercise aimed at pre-empting potential militant conspiracies and safeguarding public security.

Authorities reaffirmed that such actions are part of a sustained effort to dismantle the support network of banned organisations and to curb any attempts to revive militant infrastructure in Srinagar.

Meanwhile, Srinagar Police has reiterated its firm stance against individuals involved in aiding, abetting, or harbouring elements linked with militancy and assured that strict legal action will be taken against all violators.

Kulgam Police Attaches Property Worth ₹61 Lakh of Detained Drug Peddler under NDPS Act

KULGAM, OCT 15: In a major crackdown on drug trafficking, Kulgam Police on Tuesday attached property belonging to a detained drug peddler, Ghulam Rasool Dar, son of Late Abdul Rehman Dar, resident of Vidoe Mishipora, Police Station Qaimoh, under the provisions of Section 68-F of the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985.

The said accused is involved in FIR No. 62/2021 U/S 8/15-29 NDPS Act of Police Station Qaimoh, in which 520 kilograms of poppy straw were recovered. He is already detained under the Prevention of Illicit Trafficking in NDPS Act (PIT-NDPS) and is presently lodged



at Central Jail Kot Bhalwal, Jammu.

The attached property, valued at approximately ₹61 lakh, was identified as being illegally acquired through the proceeds of narcotics trafficking. The attachment order was executed by a police team in the presence of local residents and an Executive Magistrate, following a detailed investigation conducted by Police Station Qaimoh. This decisive action is part of the ongoing anti-drug drive by Kulgam Police, aimed at dismantling narcotics networks and eliminating their sources of funding in the district.

Speaking on the occasion, SSP Kulgam, Shri Anayat Ali Choudhary (IPS), reaffirmed the police's commitment to eradicating the menace of drugs from society. He said that strict action will continue against all individuals involved in drug trafficking, including the attachment of properties acquired through illegal narcotics trade, to break the drug supply chain and safeguard youth from addiction.

Local residents appreciated the strong action taken by Kulgam Police, lauding their continuous efforts to protect the community from the threat of drugs.

Kulgam Police has urged the general public to extend cooperation and share any information related to drug peddling or trafficking activities, assuring that the identity of informants will be kept strictly confidential.

Shopian Police, Drug Control Department Conduct Joint Inspection to Enforce Ban on Unsafe Cough Syrups

SHOPIAN, OCT 15: Acting upon the recent advisory issued by the Jammu and Kashmir Drug and Food Control Organisation (DFCO) regarding the ban on several pediatric cough syrups declared "Not of Standard Quality," the Shopian Police in coordination with the Drug Control Department carried out extensive inspections of medical shops and pharmacies across the district.

The enforcement drive was aimed at ensuring full compliance with the DFCO directive, which banned the sale and distribution



of ColdRif Syrup, RespiFresh-TR Syrup, and Relif Syrup after these medicines were found to contain Diethylene Glycol (DEG) impurities beyond permissible safety

During the inspection, officials confirmed that no banned syrups were found in any of the medical shops checked. Pharmacists were sensitized about the DFCO's directions and were advised to strictly adhere to all health and safety regulations while maintaining transparency in their supply chains.

Authorities also urged chemists to remain vigilant and report any suspicious consignments or

unverified pharmaceutical products being circulated in the mar-

A police spokesperson said that Shopian Police remains committed to safeguarding public health and will continue to conduct such joint drives with civil and enforcement agencies to ensure that unsafe or substandard drugs do not reach consumers.

The inspection teams reiterated that violators found stocking or selling banned medicines will face strict legal action under the relevant provisions of the Drugs and Cosmetics Act. [KNT]

SRINAGAR, OCTOBER 15: The Department of Science and Technology, Government of Jammu and Kashmir, organized a two-day meeting of the Technical Advisory Committee (TAC) of the J&K Science, Technology & Innovation Council (JKST&IC) on 14th and 15th October 2025 at the SKICC, Srinagar. The meeting was chaired by Dr. Shahid Iqbal Choudhary, Secretary, Science & Technology, as the Chairperson of the Com-

The TAC convened to evaluate and finalise research proposals under the Sponsored Research and Extension Programme (SREP)—a flagship initiative of the Science & Technology Department aimed at promoting indigenous research and supporting scientists in developing solutions to region-specific socio-economic and environmental challenges.

This year, the Department received 525 project proposals, including 306 from the Kashmir region and 219 from the Jammu

region, from a wide range of universities, medical and technical institutions, and research laboratories across the Union Territory. The proposals were reviewed across 20 thematic areas, focusing on climate change, glacier studies, water and energy security, food sufficiency, environmental protection, public health, and natural disasters, among others.

The Committee comprised eminent scientists and academicians, including Dr. Anish Yadav (SKUAST-Jammu), Dr. Parvinder

Pal Singh (CSIR-IIIM Jammu), Dr. Mudasir Andrabi (SKUAST-Kashmir), Dr. Aabid Hussain Shalla (IUST-Kashmir), Dr. Meena Sharma (University of Jammu), Dr. Kumud Ranjan Jha (SMVDU), Dr. Ambika Prasad (IIT Jammu), and Dr. Anil Bhat (SKUAST-Jammu). Dr. Mushtaq Ahmad Bhat, Additional Director, JKST&IC, served as Member Secretary of the Com-

In his remarks, Dr. Shahid Choudhary emphasized that novelty, methodology, and societal

impact should be central to the evaluation process. The selected projects are expected to contribute significantly to scientific advancement, policy innovation, and sustainable development in Jammu & Kashmir.

SRINAGAR, OCTOBER 15: Secretary, Rural Development Department (RDD) and Panchayati Raj, Mohammad Aijaz Asad, today finalized an action plan under which the Jammu & Kashmir Rural Livelihoods Mission (JKRLM), in collaboration with Kerala's acclaimed Kudumbashree Mission, will establish 20 standardized food service enterprises across the Union Territory.

Chairing a review meeting of JKRLM, Secretary said that the partnership with Kudumbashree aims to replicate a proven, holistic ecosystem for enterprise development. "The focus goes beyond creating food stalls—it is about building a structured, sustainable, and quality-driven framework for women entrepreneurs," he emphasized.

As part of the plan, a baseline study will identify potential locations, while standardized training modules and continuous mentorship will ensure long-term viability of the enterprises. A unified brand and operational guideline will be developed to maintain consistency in quality and service across all units.

A dedicated Kudumbashree National Resource Organization (NRO) team has already been positioned to oversee the rollout, which includes 'Café Mentor' train-

ing and the creation of a cadre of Master Community Resource Persons (MCRPs) to provide onground support. "An enterprise monitoring system will also be put in place to track progress and provide sustained handholding to women entrepreneurs," the Secretary added.

Aijaz Asad highlighted that JKRLM is intensifying efforts under the "Lakhpati Didi" initiative, with a strategic shift towards nurturing "Millionaire Didis." The goal is to help women from Self-Help Groups (SHGs) move from earning 1 lakh annually to 10 lakh and beyond. "So far, 50 women in Jammu and Kashmir have already achieved this milestone, proudly earning the title of 'Milonaire Didi'," he informed.

This remarkable success was nationally recognized during the launch of the compendium "Har Didi Ek Kahani" in Jammu & Kashmir on July 3, 2025, unveiled by Union Minister for Rural Development Shri Shivraj Singh Chouhan during his visit to Jammu and

Presenting a comprehensive overview, Managing Director, IKRLM, Subhra Sharma, highlighted that under the UMEED Programme, 7.66 lakh rural households have been mobilized into 94,962 SHGs across 20 districts and 265 blocks. These groups have received 528.86 crore in capitalization support

and have collectively accessed 2,806.06 crore in bank credit since 2013-14, reflecting a strong credit culture and repayment discipline.

Under the Start-up Village Entrepreneurship Programme (SVEP), 7,280 rural enterprises have been established across 14 blocks, with 16.53 crore disbursed through the Community Enterprise Fund.

The dignitaries lauded Rajinder Singh's remarkable dedi-








Address human resource gap in health sector

There has been an exponential growth of the MBBS seats across the union territory of Jammu & Kashmir over the past few years. However, the same does not correspond to the employment opportunities for the medicos and it is due to this reason that there is large scale unemployment of doctors in the government sector. At the end of the day the common masses suffer and they are at the receiving end.

It is an established fact that hundreds of posts of medicos are vacant in the health institutions at the government level but still then the medicos are not appointed in the number as they should be. Over the years multiple Right to Information (RTI) applications have been moved with regards to staff availability and the vacancies in the government hospitals in Jammu & Kashmir. Almost all the districts have given out the information that hundreds of vacancies of doctors and para-medical staff are there.

At a time when the Omar Abdullah led government has been claiming to improve the health scenario in the union territory the situation on the ground suggests that the people at helm are not serious in this regard. Last year the health and medical education department advertised 575 posts of doctors in Jammu & Kashmir but as on date nobody knows the progress of such a development. The posts have been referred to the Public Service Commission but no written examination or interview has been carried out so far.

It is imperative that the health and medical education department takes drastic steps in addressing the human resource gap in the health sector. Immediate steps should be taken to fill the vacancies of not only the doctors but also the para-medics. Once the requisite staff is in place in the health institutions the people would feel relieved and there would be fewer complaints. The sooner it is done the tor of Jammu & Kashmir.

Once the health institutions in the villages and far-flung areas are adequately staffed then there would be less pressure on the hospitals in cities, towns and district headquarters. This would result in a situation where the patients would have to visit the hospitals and health institutions in their vicinity. This is more important for the patients who are critically ill and need immediate treatment so that their lives are saved.

Sir Syed and the Rebirth of the Modern Muslim Mind



The founding of the Scientific Society in 1864 was an early attempt to bridge the gulf between traditional scholarship and modern sciences.

The Society translated Western works on science and literature into Urdu, making knowledge accessible to a wider audience. This was not imitation but adaptation: Sir Syed wanted his people to engage with the intellectual currents of the modern world without losing their cultural moorings

Sir Syed Ahmad Khan (1817–1898) was one of the greatest reformers and thinkers in modern Indian history. A scholar, jurist, and visionary, he devoted his life to the intellectual and moral upliftment of Indian Muslims under British rule. As the founder of the Muhammadan Anglo-Oriental College, which later evolved into the Aligarh Muslim University (AMU), Sir Syed laid the foundations of modern education among Muslims, inspiring generations to harmonize faith with reason and tradition with progress.

There are moments in history when nations lose their compass, when despair and inertia weigh down collective will. For Indian Muslims, the 19th century was such a time. The trauma of 1857 had left them politically powerless, socially vulnerable, and intellectually paralyzed. Their once-proud heritage of scholarship, art, and governance appeared to have collapsed under the heavy boots of colonial dominance. It was in this bleak and uncertain landscape that Sir Syed Ahmad Khan appeared—not simply as an educationist, but as a visionary who believed that the journey from darkness to dignity could only be under-

taken with the lamp of knowledge. For Sir Syed, education was never a matter of degrees or employment alone; it was the rebirth of a community's spirit. He saw ignorance as the greatest enemy-more destructive than poverty, more crippling than political defeat. His idea of modern education was bold, yet balanced: it sought to harmonize faith with reason, tradition with modernity, and identity with progress. He understood with rare clarity that religion and science were not adversaries, that the heart and the mind could enrich rather than oppose each other, and that true learning must elevate both intellect

and character. His reformist journey began with courage at a time when few dared to speak truth. In his famous treatise Asbab-e-Baghawat-e-Hind (The Causes of the Indian Revolt), Sir Syed critically analyzed the 1857 uprising. He showed remarkable honesty in blaming both colonial misgovernance and the internal weaknesses of Indian society. Such condor was unusual for his time, when most were either silent out of fear or consumed by bitterness. This spirit of intellectual honesty defined his life: he believed that no nation could progress without self-criticism and

To awaken his people from centuries of slumber, Sir Syed launched journals such as Tahzib-ul-Akhlaq

(The Mohammedan Social Reformer). In its pages, he pleaded with Muslims to abandon superstitions, sectarian quarrels, and rigid dogmas that shackled progress. His words were sharp, but they carried the warmth of care, like a father scolding his children out of love. For him, education meant more than literacy-it meant cultivating rational thought, moral responsibility, and social harmony.

The founding of the Scientific Society in 1864 was an early attempt to bridge the gulf between traditional scholarship and modern sciences. The Society translated Western works on science and literature into Urdu, making knowledge accessible to a wider audience. This was not imitation but adaptation: Sir Syed wanted his people to engage with the intellectual currents of the modern world without losing their cultural moorings.

Yet the true flowering of his vision came with the establishment of the Muhammadan Anglo-Oriental College at Aligarh in 1875. To Sir Syed, Aligarh was not simply a college-it was a movement, a living experiment in synthesizing tradition with modernity. He envisioned classrooms where Newton and the Quran could be studied side by side, where science sharpened the intellect, literature refined sensibility, and history deepened perspective. This institution nurtured a generation of leaders who were rooted in their culture yet ready for the challenges of a rapidly changing world.

His efforts, however, were not free from resistance. Orthodox clergy accused him of diluting Islam by promoting Western sciences and modern education. Some even issued fatwas against him, branding his ideas heretical. On the other side, colonial authorities viewed him with suspicion, fearing that an educated Muslim class might turn politically assertive. But Sir Syed endured this opposition with remarkable patience. His response was not defensive rhetoric but quiet conviction. He once said: "Do not show the face of Islam to others; instead, show your face as a true follower of Islam." By this, he meant that the most powerful defence of faith lay not in polemics but in embodying its values through moral conduct, rational thought, and human dignity.

What makes Sir Syed's legacy timeless is its humanism. He did not dream of education only for Muslims but for all Indians. He believed deeply in Hindu-Muslim unity, in the possibility of a shared destiny shaped

by mutual respect and learning. For him, education was the bridge that could connect divided communities, replacing fear with understanding. His idea was never to produce clerks for colonial offices alone, but to nurture citizens who could think, question, and lead.

Today, more than a century later, Sir Syed's message still resonates with urgency. In Kashmir, as in many parts of the subcontinent, education is seen as the ladder of hope—lifting young men and women out of adversity toward dignity and opportunity. Yet his vision reminds us that education must not stop at employability. It must prepare us to coexist in diversity, to lead with compassion, and to resist the temptations of division. His dream of Aligarh was not tied to a physical place alone—it was an idea. That idea can take root wherever knowledge is pursued with courage and humility, even in the valleys of Kashmir.

The challenges of our age may be different from Sir Syed's-today we face the perils of polarization, misinformation, and shallow thinking. Yet the solution he proposed remains strikingly relevant: education that enlightens the mind, reforms society, and unites humanity. His insistence on harmonizing faith with reason is perhaps more urgent now, when the world is often torn between blind traditionalism and soulless moder-

As we mark Sir Syed Day on 17th October, the greatest tribute we can pay him is not in ceremonial speeches or floral wreaths, but in carrying forward his unfinished mission. We must ask ourselves: are our institutions nurturing critical thought, tolerance, and moral courage—or are they producing degrees without depth, professions without purpose? Sir Syed's life warns us that communities that stop questioning, stop progressing.

Sir Syed Ahmad Khan lit a lamp in an age of darkness, a lamp that continues to glow. To honor him is to keep that flame alive—to ensure that the next generation does not stumble in ignorance but walks with the dignity of knowledge, the balance of faith and reason, and the courage to serve humanity. His dream was not of a yesterday but of a tomorrow, and that tomorrow still awaits our commitment.



The Marriage And Divorce In The Life Of Women

Sometimes, when a bond breaks, it saves the very soul it once confined. Yet in our Kashmir Valley, where the scent of chinar leaves mingles with the weight of unsaid words, divorce still echoes like a sin. It is uttered softly, as if naming it might bring shame to the walls that hear it. We, who have witnessed wars and winters, still tremble at the idea of a $marriage\,ending, as\,if it\,were\,a\,crime,$ not a choice born of pain, reflection, and the simple human will to breathe freely again.

In Jammu and Kashmir, when a marriage breaks, it is not just two people parting ways, it feels as if an entire community gathers to pass its silent judgment. The woman becomes an object of pity or suspicion; the man, a symbol of failure or arrogance. And in this cruel theatre of perceptions, no one stops to ask, what must they have endured to take such a step?

Courage in Silence

Komal, a young woman from Doda, had dreamt of a gentle love. Her marriage began with promises and photographs, smiles and expectations, but soon turned into a battlefield of words that wounded deeper than any weapon. She endured humiliation, manipulation, and isolation, until her laughter, once loud and infectious, began to fade into quiet obedience.

When she finally gathered the courage to seek divorce, she did not expect applause, but she hoped for understanding. Instead, she was met with silence, the kind that cuts deeper than cruelty. Relatives whis-

pered her story as though it were imate resort, a means to preserve gossip, not grief. Even her parents, though supportive, lowered their voices when her name came up in

gatherings. Now, she teaches at a small private school, raising her head a little higher each morning. Her life is no longer bound by someone else's approval, but society still refuses to unlearn its habit of labeling her as "the divorced one."

When Men Too Are Judged

We often forget that the stigma of separation spares no one. Raju, a young entrepreneur from Doda, decided to part ways after realizing that his marriage was more a cage than companionship. But society was not kind to him either.

"He must have been harsh," people assumed. "He must have failed to keep his wife happy." Proposals for remarriage faded the moment someone whispered, "He's

He once told me, his eyes distant yet steady, "Divorce didn't break me, sir. People's judgment did. It's strange, we are allowed to mourn deaths with compassion, but not broken marriages with empathy."

In these stories, of Komal, of Raju, of countless others whose names remain unspoken – lies a collective truth about our society's discomfort with choice, especially when that choice is made in defiance of endurance.

The Paradox of Faith and Culture What makes this stigma more tragic is the contradiction we live with. The faith we profess, Islam, neither glorifies nor prohibits divorce. It treats it as a last but legitpeace when love and respect have perished. Yet, in practice, our cultural pride often overrides our spiritual wisdom.

We would rather see two people live in quiet misery than part with dignity. We glorify the endurance of suffering but ridicule the courage of release. Our social gatherings overflow with discussions about others' "failures," while we ignore our own lack of compassion.

Divorce, in its essence, is not rebellion; it is the final act of honesty – the moment when two people admit that their hearts no longer share the same rhythm.

The Fear of Beginning Again

Even more heartbreaking is how divorce, or even a broken engagement, becomes a lifelong label that shadows people in their pursuit of new beginnings. The moment a woman or man is described as "divorced," potential alliances vanish. Families hesitate, whispers begin, and the same society that once pushed them into marriage now denies them another chance at happiness.

A young woman from Marmat Goa once told me, "It's not divorce that frightens me. it's how the world will look at me after it." Her fear is not misplaced. Our community's gaze is harsh and unrelenting. We speak of forgiveness, of second chances, of destiny, yet we deny those very things to the living, breathing people before us.

Health Department Seals Six Unregistered Diagnostic Labs in Khag and Beerwah

BUDGAM, OCT 15: In a continued drive to curb unauthorized medical practices, the Health Department Budgam on Wednesday sealed six unregistered diagnostic laboratories operating illegally in Khag and Beerwah towns of the district Budgam.

The operation was carried out under $the \, supervision \, of \, District \, Health \, Of ficer$ (DHO) Budgam, Dr. Lahoot Hassan, in coordination with the Block Medical Officers (BMOs) of Khag and Beerwah, and a special enforcement team from the district health office.

Officials said the action followed a series of complaints from locals alleging that several diagnostic labs were functioning without registration, valid licenses, or qualified technical staff. During the inspection, the team found these establishments operating in viola-



tion of health and safety regulations, prompting immediate sealing.

Dr. Lahoot Hassan said the Health Department is determined to enforce the Clinical Establishments Act and ensure that all diagnostic and medical centers operate within legal boundaries.

No one will be allowed to compromise public health. We will continue to inspect, identify, and take strict action against unregistered and unqualified facilities across the district," said Dr. Lahoot Hassan.

He added that similar inspection drives will be intensified in other medical blocks to ensure compliance with the Biomedical Waste Management Rules and other statutory requirements.

The Health Department has also warned that strict legal proceedings will be initiated against violators found running diagnostic centers without valid

Beauty Tips For The Perfect Diwali Look

Diwali is just around the corner! What better time than now to make sure you shine your brightest.

The days running up to Diwali are more hectic than wedding season in terms of cleaning, shopping, house decoration etc which generally dampens your mood leaving you looking exhausted, tired and dull at the end of the day. Diwali involves joy, celebrations, family dinner and a whole lot of great excitement. As we immerse ourselves in the festivities, women and men set to Sparkle brighter than the fireworks and shine more than the diyas to look perfect this Diwali..

Most of us seek quick solutions to fix our beauty woes and tend to laden up the skin with numerous varieties of chemical laden costly cosmetics to look natural, youthful and evergreen As you indulge in family gatherings and step out to celebrate, It's time to get a radiant glow with organic homemade ingredients for Diwali which is an absolute favourite with most Indians.

Here are simple things to shine brighter than the festive lights from the comforts of your home.

 $Night time \, clean sing \, is \, an \, absolute \, must, especially \, for \,$ citydwellers. Chemical air pollutants, dirt and grime hang in the air. They are potent skin irritants. Make up should also be removed at night. All these can cause dryness of the skin, or disrupt the normal acid-alkaline balance of the skin, leading to rashes and other eruptive conditions, like pimples and acne.

As Diwali approaches, the weather also changes. Seasonal changes also influence the skin. The humidity becomes less and the skin loses moisture to the atmosphere. So, one needs to keep the skin moisturised and also protect it from sun exposure. For normal to dry skin, cleanse twice aday, with a cleansing gel, containing ingredients like aloe

vera. Massage the cleanser lightly into the skin and remove it with moist cotton wool. Then apply rose water or skin tonic, using cotton wool. During the day, use a sunscreen, before going out in the sun. Or, use moisturizer, if you are indoors. Moisturisers are available in cream and liquid form. For dry skin, at night, after cleansing, apply a nourishing cream and massage it on the face. Wipe off with moist cotton wool. You can apply a serum afterwards.

Oily skins also need moisture. But, if they apply creams, they can get pimples. To moisturise oily skin, mix one teaspoon pure glycerin with 100 ml rose water. Keep it in an airtight jar in the fridge. Use a little of this lotion after cleansing. This moisturizes the skin, without making it oily. Use cleansing milk or face wash to cleanse the skin.

The use of facial scrubs helps to brighten the skin and add a glow. Use a facial scrub twice a week. Mix ground almonds (badaam) or rice powder with curd and a pinch of Haldi. You can also add dried and powdered orange and lemon peels. Apply on the face and rub gently on the skin with small circular movements. Then wash off with water.

Apply a sunscreen before going out in the sun. So, you can look for a sunscreen lotion or cream, depending on your skin type. You should also look for day creams, nourishing or night creams and serums.

As Diwali and winter approach, try some home remedies to relieve dryness. Apply honey on the face daily for 10 minutes and wash off with water. If you have an aloe vera plant at home, the gel, found in the inner portion of the leaves, can be applied on the face to moisturize it.

Grate carrots and apply on the face for 15 to 20 minutes. Carrot is rich in Vitamin A and good for nourishing the skin in winter. It suits all skin types.

Mix half a teaspoon honey, one teaspoon rose water and one teaspoon dried milk powder. Mix into a paste and apply on the face. Remove after 20 minutes with water. Suits normal to dry skin. Applying mayonnaise or eggyolk on the skin also helps to relieve dryness. Suits dry skin.

 $Nour is hthe \ hair with oil treatments. He at olive oil \ and$ apply on the scalp and hair. Then dip a towel in hot water, squeeze out the water and wrap the hot towel around the head, like a turban. Keep it on for 5 minutes. Repeat the hot towel wrap 3 or 4 times. This helps the hair and scalp absorb the oil better.

Egg white is a wonderful natural cleanser for oily hair

and its protein content helps to add body. Apply egg white on the hair about half-an-hour before your shampoo. To nourish dry hair, massage egg yolk or mayonnaise into the scalp. Leave it on for half an hour and then wash the hair. It helps to soften the hair and is very useful for hair that has suffered damage through colouring, straightening or perming.

If you have been working hard just before Diwali, a few "pick me up" tips will help. Give yourself a manicure and pedicure the day before. In fact, after soaking the hands and feet in warm water, massage with a rich cream, so that the skin is smooth and soft. A good pick-me-up treatment for the hands is to rub them with sugar and lemon iuice. Pay attention to details like waxing and threading too, at least a day in advance.

A "pick-me-up" face mask can leave your skin clean and glowing. Cleanse the skin. Mix honey with egg white and apply it on the face. Wash off with water after 20 minutes. For those with very dry skin, mix half a teaspoon honey, eggyolk or pure almond oil and one teaspoon dried milk powder. Mix into a paste and apply on the face. Leave it on for half an hour and rinse off with water. After washing off the pack, give the skin a compress with cotton wool pads soaked in rose water.

For hands and nails, mix almond oil and honey in equal parts and massage into the nails and cuticles. Leave on for 15 minutes and wipe off with a moist towel. Mix together 3 tablespoons of rose water with one tablespoon each glycerin and lemon juice. Apply on hands and feet and leave for half an hour. Wash off with plain water.

If your hair is looking dull give it a quick conditioning treatment before your shampoo. Mix one teaspoon each of vinegar and honey with one egg. Beat them together well. Massage the mixture into the scalp. Then wrap the hair in a hot towel for twenty minutes, before washing the hair. Your hair will have more body and look shiny and manageable. Give your hair a tea-water and lemon rinse after shampoo, to add shine. Boil used tea leaves again in enough water. After boiling, you should have about 4 cups of tea-water. Cool and strain it. Then add the juice of a lemon and use it as a last rinse after shampoo.

Illegal Constructions Along Sindh: Flood **Control Department Acts Against Violators**

KANGAN, OCT 15: An inspection team comprising officers from the Flood Control Department, Revenue Department, and Block Development Office on Wednesday carried out a joint operation across various areas of Kangan in central Kashmir's Ganderbal district, halting illegal construction activities along the banks of the Sindh Nallah in compliance with court orders.

Officials said the action followed strict directions from the District Development Commissioner (DDC) Ganderbal, who had instructed authorities to ensure implementation of the Jammu and Kashmir and Ladakh High Court's 2013 order that prohibits all types of construction within 100 meters on either side of the Sindh Nallah.

Assistant Executive Engineer, Flood Control Ganderbal, Saeed Asif Qadri, told the news agency Kashmir News Trust that the inspection covered multiple locations, including Dr's Colony,



Kangan, where several illegal structures were found being raised in violation of the court directive. "We have stopped all such works immediately and prepared a detailed report that will be submitted to the District Development Commissioner," Qadri said.

He added that two individuals in Dr's Colony, Prang, who had earlier obtained No Objection Certificates (NOCs), saw their approvals revoked after officials confirmed that their construction activities fell within the restricted zone. "The sites where construction was underway clearly violated the High Court's standing

Meanwhile, locals said that despite the decade-old ban, certain individuals had continued to undertake construction projects along the riverbanks, allegedly hiring labourers from outside districts. They said these unchecked activities were not only degrading the natural beauty of the Sindh Nallah but also amounted to open contempt of the High Court's ruling.

Sources within the administration said enforcement agencies had been directed to maintain regular inspections and ensure no fresh violations occur along the Sindh Nallah in future.

SC pulls up states for ignoring ICU safety directions; issues show-cause notices to 28 states, UTs

NEW DELHI, OCT 15: The Supreme Court today issued show-cause notices to 28 States and union Territories for failing to comply with its directions to frame uniform standards for patient safety in Intensive Care Units (ICUs) and Critical Care Units (CCUs) across the country.

A Bench, comprising Justices Ahsanuddin Amanullah and N.K. Singh, directed the Additional Chief Secretaries or $senior-most\,Health\,Department$ officials of the defaulting States and UTs to personally appear before the Court on November 20, 2025, along with personally affirmed affidavits explaining their inaction.

"Notice is issued to the concerned Additional Chief Secre-

tary/Senior-most Official of the Department of Health of all the concerned States/Union Territories, as to why action is not taken against them for such a casual approach shown towards the Court," the Bench observed, expressing strong displeasure over the continued non-compliance.

The Court made it clear that no excuses for absence would be entertained, stating, "It is made clear that the officers who have been directed to appear shall not cite any excuse, including any prior engagements or other programmes, which shall be rescheduled to give priority to the order passed today."

The defaulting States and UTs include Arunachal Pradesh. Assam, Chhattisgarh, Goa, Gujarat, Himachal Pradesh, Jharkhand, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Manipur, Mizoram, Odisha, Punjab, Rajasthan, Sikkim, Telangana, Tripura, West Bengal, Chandigarh, Delhi, Jammu & Kashmir, Puducherry, Lakshadweep, Ladakh, Andaman & Nicobar Islands, and Dadra & Nagar Haveli and Daman & Diu.

To facilitate the process, the Court had earlier appointed a three-member expert committee comprising Additional Solicitor General Aishwarya Bhati, Amicus Curiae Karan Bharihoke, and Dr Nitish Naik (Professor of Cardiology, AIIMS, New Delhi).

The States were instructed to submit draft frameworks by September 30 and forward them to the committee by Octo-

Issuing the latest round of show-cause notices, the Bench warned that further non-compliance or perfunctory responses would invite strict action against both the officers and their respective States.

Meanwhile, the Court directed the committee to proceed with deliberations based on the material already received and prepare a draft national framework for ICU safety standards.

The matter will be taken up next on November 20, 2025, when top health officials from across the country are expected to personally appear before the Supreme Court. UNI

The States were instructed to submit draft frameworks by September 30 and forward them to the committee by October 5.

Issuing the latest round of show-cause notices, the Bench warned that further non-compliance or perfunctory responses would invite strict action against both the officers and their respec-

Meanwhile, the Court directed the committee to proceed with deliberations based on the material already received and prepare a draft national framework for ICU safety standards.

The matter will be taken up next on November 20, 2025, when top health officials from across the country are expected to personally appear before the Supreme Court. UNI

Amit Shah will today inaugurate Conference on tracking and bringing back fugitives

NEW DELHI, OCT 15: Home Minister Amit Shah will inaugurate a two-day conference here tomorrow on issues of international police cooperation to track fugitives and coordinate efforts to bring them back to face criminal justice in India.

The Conference 'Extradition of Fugitives-Challenges and Strategies' will deliberate on issues including effective use of formal and Informal channels, use of technology in locating fugitive criminals, strategic approach for extradition of fugitives and analysis of financial footprint of wanted fugitives.

Law enforcement agencies and experts will deliberate on various challenges to find a roadmap for expeditious extradition of these fugitive

The Conference being organized by the Central Bureau of Investigation (CBI), will focus on Narco, Terror, Cybercrime, Organized crime and Economic offenders.

During the conference, senior police officers from various Central and State Police agencies will participate. Officials from the Ministry of External Affairs (MEA) and Ministry of Home Affairs (MHA) will also participate.

Gambhir On Rohit, Kohli: 'Focus On Present'

BIRMINGHAM: Are Rohit Sharma and Virat Kohli still part of India's plans for the 2027 World Cup? The ODI captaincy has passed from Rohit to Shubman Gill, and both Rohit and Kohli are now in their mid-30s and retired from Tests and T20Is. What does their selection for the ODI series in Australia later this month say about their future?

India head coach Gautam Gambhir isn't looking that far ahead.

"Look, 50-over World Cup is still two-anda-half years away, and I think it is very important to stay in the present," he said in a press conference after India beat West Indies 2-0 in their Test series. "That is very important. Obviously, they are quality players, they are coming back, their experience is going to be a handful in Australia as well. Hopefully, those two guys will have a successful tour, and more importantly, as a team, we will have a successful series." As Test and ODI captain and T201 vice-captain, Gill can expect a packed schedule with little scope

for taking breaks between series. Gambhir felt he was in a good space to do this.

"First and foremost, I need one," Gambhir joked when asked if Gill could benefit from having a mental-conditioning coach. "I think he is scoring runs, so he does not need any bit of it. So probably I think he is in a good space. I think all of us are in a good space.


"I think when you get the results, you are always in a good space. But if you don't get the results, I think it is my responsibility to keep him and the entire group in a good space. That is my job. Sometimes it is not only about skills, but it is also about the mental aspect of the game as well. Especially guys who are playing all the three formats. It is not only about Shubman, it is about everyone in that dressing room. I have equal responsibility towards every-

One of the selections for the Australia tour that has attracted comment from explayers in the media is that of Harshit Rana. with the fast bowler part of both the ODI and

T20I squads. Among those who have commented on the selection is former India captain and chairman of selectors Kris Srikkanth, who alleged in his YouTube channel that Rana was only part of the squad because he was Gambhir's yes-man.

"Look, it's a bit shameful. And I will be very honest with you. If you do not spare even a 23-year-old boy to run your YouTube channel, it's unfair," Gambhir said. "Because ultimately (Rana's) father is not an exchairman (of selectors) or an ex-cricketer or an NRI. He plays cricket on his own merit. And he will continue to play on his

"Targeting someone individually is not fair. You can target people's performance. And there are coaches and selectors who target people's performance. But if you say such things to a 23-year-old kid, then social media amplifies it more, and in social media, you are told things in such a way, imagine (what it does to) the mindset (of the player). In the future, your child can also play cricket, anyone's child can play cricket.



Tireless Bawne will 'put the body on the line' again to try and win the Ranji Trophy

NEW DELHI: Maharashtra's marathon man Ankit Bawne is entering his 13th Ranji Trophy season after having made his debut as a 15-year-old against Karnataka in Ratnagiri back in December 2007. Eighteen years on, he still relishes the domestic grind and is motivated to perform.

Being the second-highest rungetter among active Ranji players, behind Jammu & Kashmir professional Paras Dogra (9505), with 7244 runs, and the highest run $getter\, over all\, in\, the\, 50- over\, Vijay$ Hazare Trophy with 4010 runs is a testament to the 32-year-old's

durability and consistency. "I'm the only child for my parents and I've been staying away from home since I was 14," Bawne told ESPNcricinfo in the lead-up to the new domestic season. "It has been a great journey, but still a long way to go and I believe there's

still a lot of runs left in me. "I feel the grind is important no matter what level of cricket you play. Some play for India, some play for the state and maybe some players will stay at the league level and



they won't get higher honours. But to pass. It has been more than five I feel that attitude and discipline should always be there. I want people to remember me as a hardworking person and not somebody all-time top-scorer in Vijay Hazare and all. It's okay if they [selectors] drop me because I'm not scoring enough runs, but nobody should drop me because I'm not fit and just pushing my career."

Bawne was able to translate his domestic success to the India A level in red-ball cricket - he scored 663 runs in 19 innings at an average of just over 55 - but an opportunity at the next level didn't come

years since he last represented India A - the team management has moved on to a new pool of emerging players post Covid-19 - but that who has scored 10,000 runs or the hasn't deterred him from toiling away in domestic cricket.

"I just want to control the controllables. Selection is not in my hands," Bawne said. "I have got some centuries against good sides and captained India A. Suddenly, I was not part of India A, but I'm a player who doesn't question the selection committee and whatever is written for me, I'll do that. See, some umpiring decisions are not in your hands. Like that, the


Aftermanagingonlytwooutright wins in seven matches in the previous Ranji season, Maharashtra have revamped their team, hiring two new professionals in Prithvi Shaw and Jalaj Saxena. 

While Saxena was a late signing, Shaw has already eased his way into the Maharashtra set-up with a century on debut in the pre-season Buchi Babu tournament in Chennai. Shaw even got a taste of Maharashtra captaincy in the KSCA's K Thimmappiah Memorial Trophy. Bawne, who will captain Maharashtra in the upcoming Ranji Trophy, believes that the change in personnel will bring about a change in fortunes.
