

Congress Supports NC For J&K Rajya Sabha Polls: Farooq Abdullah

SRINAGAR, OCT 23: National Conference president Farooq Abdullah on Thursday claimed the Congress supports the ruling party in Jammu and Kashmir for the Rajya Sabha elections scheduled to take place a day later.

Differences erupted between the alliance partners after the Congress had accused the National Conference (NC) of backtracking on its

promise of giving the party a safe seat in the Rajya Sabha polls. The Congress on Wednesday did not attend a meeting of the MLAs of the coalition that was called by the NC.

"The Congress is with us, and supports us," Abdullah told reporters here when he was asked about the Congress not yet announcing its support to the NC – its alliance partner in J-K – for the Rajya Sabha polls.

Legislators across party lines lauded the contributions of their former colleagues, recalling their dedication to public service and commitment to the welfare of the people.

The Speaker and members of the house also held two minute silence in their remembrance.

Regarding the proposed suggestion by Chief Minister Omar Abdullah to follow parliamentary convention of House observing two minute silence in honour of departed souls during obituary references instead of long speeches, the Speaker said that the suggestion will be thought and looked into as the argument carries significant weight.

in their own ways toward the welfare of the people. "None of us is perfect; mistakes are inevitable, whether made knowingly or unknowingly," he observed.

The Chief Minister also suggested that the Assembly adopt a concise format for obituary references, similar to that of the Parliament. "We are politicians, and politics often finds its way into our speeches. It would be more appropriate to pay respects briefly without lengthy addresses," he said.

Welcoming the suggestion, Speaker Abdul Raheem Rather said it would be duly considered. "As we remember them today, one day we too will be remembered. Let us learn from their lives and service," the CM

Chief Minister Omar Abdullah noted that all the leaders being remembered had dedicated themselves to public service, whether through elected office or party association. Referring to former J&K Governor Satya Pal Malik, he said Malik had a long public career, serving as an MLA, minister and Governor in various

Paying tribute to G. M. Shaheen, the Chief Minister described him as a courageous leader who continued to serve the people with determination even after surviving a major landmine blast.

The Chief Minister also expressed concern over the negligence of the concerned district administration for failing to inform the Assembly Secretariat about the demise of former Legislator Mohammad Sultan

Ocean Region (IOR) as a matter of "comfort for the friendly nations" and "discomfort for those who seek to destabilise the region".

"IOR has become the centre of contemporary geopolitics. It is no longer passive; it has become an area of competition and cooperation. The Indian Navy, through its multi-dimensional capabilities, has played a leadership role in the region. In the last six months, our ships, submarines and Naval aircraft have been deployed at an unprecedented scale. In addition, our Navy has provided safe passage to approximately 335 merchant vessels, carrying around 1.2 million metric tons of cargo and a trade value of USD 5.6 billion. This is proof that India has now become a trusted and capable partner in the global maritime economy,"

Terming a self-reliant Navy as the foundation of a confident and powerful nation, the Defence Minister acknowledged the Indian Navy for enhancing its capabilities through in digenous equipment and emerging as the flag bearer of Aatmanirbhar Bharat.

"In the last 10 years, nearly 67 percent of the Navy's capital acquisition contracts have been with Indian industries. This proves that we are no longer dependent solely on imports. We rely on our own talent and the capabilities of MSMEs and start-ups. Currently, the Indian Navy is working on 194 innovation and indigenisation projects under iDEX, TDF, SPRINT, and Make-in-India. These initiatives have not only made the Navy technologically self-reliant, but have also made private industries and young innovators a part of this mission," he said.

Dubbing the present-day warfare as technology and intelligence-based, Rajnath highlighted that the government, is paying greater attention to A atman ir bharta in defence, indigenous innovation and state-ofthe-art technologies.

"Maritime preparedness is no longer only about ships or submarines, it is based on technology-driven, network-centric, and autonomous systems. We need to protect ourselves from our adversaries' modern technologies, while enhancing our capabilities in these areas. We have the potential and the capabilities. We're manufacturing our equipment on our own soil." he

He appreciated the fact that, under Aatmanirbhar Bharat, Indian Navy is not only engaged in defence production, but also contributing significantly to nation-building. "Today, our Navy has become a pioneer in the country's self-reliance, innovation, and industrial development. With every ship and submarine built, a new job is created; with every engine, a new skill is created, and with every indigenous system, India's dependency is decreasing. Project 17A ships, which have more than 75 percent indigenous content, have created approximately 1.27 lakh jobs in shipyards

like MDL and GRSE. It is proof that every Navy project is linked to security as well as the economy and youth employment," he stated.

Noting the significant increase in Indian Navy's collaboration with MSMEs and small shipyards, he noted that, recently, contracts worth around Rs 315 crore have been awarded for the construction of vard crafts, a major step towards the Vocal for Local vision.

"The Navy has made several innovations towards self-reliance in its aviation sector. Projects such as the Multi-role Maritime Reconnaissance Aircraft, Utility Helicopters, Twin-engine Deck Fighters, and Naval Shipborne Unmanned Aerial Systems are giving a new direction to our domestic aviation industry. This is not $only filling \, critical \, capability \, gaps \, but \, also \, strengthen$ ing self-reliance." he added.

Rajnath underlined the importance of laying equal emphasis on formulating strategy and acquiring stateof-the-art equipment to fight present-day wars. "No nation can win a war solely with equipment and warships. Technology gives us an edge, but geography, deception, timing, and human judgment must always be factored into the tactical framework. Fleet-size and modernisation is important, but tactically utilising platforms is equally crucial. Agility and adaptability are essential in planning," he said.

He also underlined the need to advance the Naval strategy and thinking in sync with the rapidly-evolving world. "We must work together in three areas: capability, people, and partnerships. Capability means technology & strength; people means sailors & their families; and partnerships mean industries, academia & international cooperation. When these three come together, our Navy will emerge as an even more reliable and powerful force," he said.

The BJP leader added that unemployment, problems faced by temporary employees, and issues concerning water, electricity, roads, and corruption will be among the key matters his party plans to highlight during the session. Reacting to a recent comment made by the Chief Minister about him, the Opposition leader remarked that the Chief Minister should focus on his own responsibilities instead of advising the Opposition. "Now the Chief Minister wants to decide what the Opposition should do. Someone should ask him how much of his own work he gets done," Sharma said. (KNT)

direct contest with Ali Mohammed Mir of the BJP in one of the seats.

For the second seat, NC's Sajjad Kitchloo will fight against Rakesh Mahajan of the BJP. The third notification will see a contest for two seats in which the NC has fielded party treasurer G S Oberoi, also known as Shammi Oberoi, and Imran Nabi Dar against BJP's Sat

The NC on Thursday issued a whip to all its MLAs to ensure their presence for casting votes in favour of the party candidates.

Going by numbers, the 41-member strong NC, which has the backing of the six Congress and one CPM MLAs, and six Independents, is likely to sail through in three seats.

The contest for the final seat is razor-thin. The Assembly has a strength of 88 MLAs out of

which the NC-led ruling coalition has 54. The BJP, with 28 Assembly members, strategically named its Jammu and Kashmir unit chief Sat Sharma

in the third notification. Sharma has already got a crucial edge after the Jammu and Kashmir People's Conference (JKPC) led by Sajad Gani Lone, an erstwhile ally of the BJP-PDP

government, last week announced that his party will abstain from the Rajya Sabha elections. Chief Minister Omar Abdullah on Thursday expressed confidence that his party will win all four seats but deep down, he would also know that it would require every non-BJP vote to be cast in favour of NC

candidates. Congress legislators did not attend a key meeting of allies convened by the NC on Wednesday, two days ahead of the Rajya Sabha polls.

Abdullah also sought to play down the absence of

Congress, saying every party follows its own procedure. "They (Congress) have their own process. There is a difference between their party and ours. Their leadership has to wait for the signal of their high command, while we take our decisions here. This is not something new, and no one should have any problems with it," Abdullah told reporters.

Asked if Congress' abstention will hurt the chances of NC candidates in the Rajya Sabha polls, Abdullah said as far as the elections are concerned, the national party has regularly maintained that it will not support the BJP, nor will it allow the saffron party to win.

"So, let them have their meetings, no one should have any objection to that. The signal from the (Congress) high command will not be such that will help the BJP," he added. Abdullah also said he is thankful to CPM leader M

Tarigami and Independents for attending the meet-"The enthusiasm I see in my members and those

with us, I am hopeful that the NC candidates will emerge winners on all four seats," he said.

Asked if the opposition PDP was ready to support

the NC candidates, Abdullah said while PDP president Mehbooba Mufti has not made any announcement, she has assured that a right decision will be taken after consulting her party colleagues.

"One of our candidates, Shammi Oberoi, met Mehbooba Mufti and requested her on behalf of the party to vote in favour of the NC to make our candidates successful. First, our president (Faroog Abdullah) had dialled Mehbooba.

"While the PDP has not announced anything, she (Mehbooba Mufti) has told Farooq Abdullah as well as Oberoi that she will discuss the matter with her party colleagues and take a right decision," he said.

The Union territory, with four Rajya Sabha seats, had remained unrepresented in the Upper House since February 15, 2021, the day when Ghulam Nabi Azad and Nazir Ahmed Laway completed their terms.

Two other members — Fayaz Ahmed Mir and Shamsheer Singh Manhas – completed their terms on February 10 the same year. (Agencies)

Congress, PDP.....

Congress and the opposition Peoples Democratic Party (PDP) have decided to extend their support to NC candidates in the Rajya Sabha elections, slated to be held on Friday.

After threadbare discussion, the Jammu and Kashmir Pradesh Congress Committee, headed by its Chief Tariq Hameed Karra announced its support to the National Conference (NC) candidates in Rajya Sabha elections.

In a statement, the party said that after two rounds of deliberations since yesterday and following detailed consultations with the central leadership, who had sought certain clarifications and inputs from them, the party has collectively arrived at a decision.

"Taking into account our sensitivities as a suffering state and our identity as a tested voice for a diverse and secular India, the Congress Party has decided to keep all differences with the National Conference on the back burner—solely to reaffirm our commitment to our own ethos and principles," the statement added.

"During the 2024 elections, we chose unity over division, ignoring all dissenting voices, to defeat the BJP and free the people of Jammu and Kashmir from a climate of fear and suppression. In keeping with our political culture and moral uprightness, we refuse to act out of expediency," it reads.

"The upcoming Rajya Sabha elections have posed a new challenge. We sincerely hope that the National Conference keeps its flock together against all temptations and manipulations—and in that endeavor, we extend our full support. All our 6 congress MLAs will support NC," it added.

Meanwhile, PDP Chief, Mehbooba Mufti while addressing a news conference here has announced party's support for the ruling NC in the Rajya Sabha

"We have decided to give support to the NC and vote for their candidates," Mehbooba said, adding that the decision has been taken to keep the BJP away.

"This party (NC) doesn't deserve it, but we have to give our support for the larger cause of keeping the fascist forces away," Mehbooba said, adding that the decision was made after a discussion with the party's leadership and its MLAs on the NC's request for support in the Rajya Sabha election.

She said NC president Farooq Abdullah had spoken to her over the phone, requesting her party's support.

Addressing the "Mera Booth Sabse Mazboot: Yuva Samvaad"eventthrough audio-conferencing, the Prime Minister said people will not forget the "jungle raj" in Bihar for another 100 years and no matter how hard the opposition tries to hide its misdeeds, people will not forgive it.

Vigilance Organization Kashmir revealed that the accused had forged his Matriculation certificate and service Book, fraudulently altering his date of birth from 08.06.1940 to 08.06.1945, thereby overstaying in Government service for 21 months and drawing undue salary amounting to ₹2,62,760, causing equivalent loss to the State exchequer.

Expert examination by the Forensic Science Laboratory, Srinagar confirmed forgery of signatures and seals, while verification from the J&K Board of School Education established his actual date of birth. After a full trial, the Hon'ble Court held that the ACB had proved the case beyond reasonable doubt through convincing documentary, expert and oral evidence and consequently sentenced the accused to undergo seven years simple imprisonment and imposed fine of ₹352,760/and ordered his lodgement at Central Jail Srinagar.

This conviction stands as a testament to the Anti-Corruption Bureau's unwavering commitment to

fighting corruption and promoting integrity in public administration.

system and then, of course, human-centric products," Narayanan said while responding to a question about the progress of the mission.

He was speaking to reporters on the sidelines of the promotional activities for the upcoming Emerging Science, Technology, and Innovation Conclave (ESTIC-2025), scheduled to be held from November 3 to 5 in New Delhi.

He said that approximately 90 per cent of the development work has been completed.

"Now three uncrewed missions have to be accomplished before going for the crewed mission and we are working towards it. In the first uncrewed mission, Vyommitra is going to fly and we are working towards that to accomplish the crewed mission by the beginning of 2027," he

On August 24, 2025, ISRO accomplished the first integrated air drop test for the Gaganyaan programme at the Satish Dhawan Space Centre

According to ISRO, this test successfully demonstrated the objective of end-to-end performance validation of the critical parachute-based deceleration system of the crew module for the Gaganyaan mission in one of the typical mission

"For the Gaganyaan programme, the integrated air drop test — because when the entire module returns in the final phase almost nine parachutes have to work in a synchronised way for the proper splashdown — so we lifted off a simulated module using a helicopter to a height of around three kilometres above the Earth. Using nine parachutes, it was successfully splashed down," the ISRO Chairman said. (Agencies)

"I have done a lot of Parliament. Now. I have to take care of my home. When the house is prosperous, the nation will also be prosperous. We have to strengthen our home, remove its difficulties, and give respite to the people here. That is our aim," he said.

The NC chief said there is no need for him to go to Parliament as it is the turn of the younger generation to go to Parliament now.

"The young will go there now, who will speak about our difficulties there. Our Parliament members are not for us only, they will have to see about the nation as well. They have to address the problems of the nation," he added.

Responding to a question on Uttar Pradesh Chief Minister Yogi Adityanath urging people to checkfor "halal certification" on products before purchasing them, Abdullah said the people of the state have to decide on that.

"You should ask that question to the people of UP. It is not related to us. The people of UP should decide on that," he said.

However, the former chief minister of J-K said India is a country with unity in diversity.

 $\hbox{``As long as we strengthen diversity,} India will$ be strong. It is a question of time, change takes place, no government remains forever. Their time to leave will also come. We should not lose hope, we should have patience and tolerance. Everything will be alright till we remain patient. God is for everyone, whichever religion a person belongs to. This is God's biggest blessing on India," he said.

Talking about the US tariffs, Abdullah said that should be rolled back.

"See the amount of tax America has imposed on us. What is that? Are we trying to destroy the world? I want to tell Trump to roll it back and move forward, thinking that while God has bestowed powers on him, the same God can take those powers away.

"Where did the British Empire or the Persian Empire go? Where is the Roman Empire or the Russian Empire? They were destroyed. All the empires get destroyed when their arrogance reaches their peak," Abdullah added.

Responding to a question about the people of Kashmir being angry with the installation of smart electricity metres, the NC president said the people need to understand that the government has to buy power worth crores of rupees. He also called upon the people to use electricity judiciously. (Agencies)


Joint drive conducted in Ukhral to enforce drug control regulation

All medical shop owners were asked to adhere to the prescribed norms and avoid selling psychotropic drugs without valid prescriptions. The shopkeepers were also directed to maintain an adequate stock of essential medicines to ensure genuine patients are not inconvenienced.

Div Com Kashmir Inspects Operational Readiness of 60 MLD STP Noorbagh

Project covering 15000 Households in Srinagar, to be commissioned on October 31: Anshul Garg

SRINAGAR, OCTOBER 23: Divisional Commissioner (Div Com) Kashmir, Anshul Garg, today conducted an on-site inspection of the 60 Million Litres Daily (MLD) Sewerage Treatment Plant (STP) at Noorbagh, Srinagar, to assess its operational readiness ahead of its commissioning scheduled for October 31.

 $The inspection \, was \, carried \, out \,$ after completion of a project of the Comprehensive Sewerage Scheme for Greater Srinagar, initiated under the Jawaharlal Nehru National Urban Renewal Mission (JnNURM) at a cost of Rs 143 Cr which was later revised to Rs 157 Cr.

During the visit, Div Com highlighted the critical importance of the project in strengthening urban sanitation infrastructure and improving environmental and health standards in the city.

Speaking on the occasion, Garg



informed that the project was executed by the Urban Environmental Engineering Department (UEED) under the supervision of the Housing and Urban Develop-

ment Department.

"We have commenced the trial run of the 60 MLD STP after NBCC and UEED geared up their resources to complete this longpending project", Div Com said and added that once commissioned it will immediately benefit around 15,000 households in Srinagar city.

Acknowledging the city's expanding population since the project's inception, Garg announced that the administration is already planning the second phase of the project of 70 MLD capacity to cater increasing requirements in proportion to growth of the city.

He also directed the Superintending Engineer, UEED, to initiate the process for acquiring a dedicated power supply line to ensure uninterrupted functioning of the plant and also get the DPR finalised for the utility shifting, tertiary treatment, automated quality monitoring and other infrastructural requirements within 1 week for consideration of the Administrative Department.

During his interaction with local residents, the Div Com listened to their grievances regarding sewerage and stormwater issues and assured them that their concerns would be resolved at the earliest.

Addressing media queries about the power scenario in the valley, Garg said that power supply remains a top priority for the administration. "Regular reviews are being conducted at both the UT and Divisional levels to ensure regular power supply", he said.

"Currently the concerned department is conducting pruning of trees, maintenance works, and augmentation of buffer stock of transformers to ensure overall preparation for winter", he said. The power scenario this winter is expected to be better than in previous years," he added.



Vedic Code, Modern Cure:

The Neurophysiological Wisdom of Kartik and Magh Snan

Dharma, often called the eternal way, has for millennia anchored itself in practices that harmoniously integrate the physical, mental, and spiritual aspects of human existence. Among the most rigorous and revealing of these are the ritual baths, or Snans, performed during the cold winter months of Kartik and Magh. These centuries-old observances are far from mere hygienic acts; they are meticulously timed acts of spiritual discipline that intuitively harness the very physiological benefits modern science is now validating through cold hydrotherapy. The ancient Indian knowledge system, as encoded in these rituals, demonstrates a sophisticated and prescient understanding of hormesis—the principle that controlled, mild stress can trigger a beneficial biological response, leading to greater resilience and well-being.

The sacred mandates for these baths are deeply rooted in the foundational texts of the Indian tradition, revealing their cosmic and spiritual importance. The Padma Purana, particularly its Uttara-Khanda, extensively details the spiritual efficacy of Kartik Snan (October-November). This month is deemed exceptionally sacred, marking the time of Lord Vishnu's awakening from cosmic sleep (Yoganidra). Consequently, bathing in early hours during this period is believed to purify the body, mind, and soul, acting as a potent mechanism for the cleansing of accumulated karma and the removal of ultimately leading toward salvation (moksha). This act of confronting and overcoming physical inertia at the coldest time of the day is itself the spiritual mechanism for generating accelerated Punya.

Following Kartik, the observance of Magh Snan (January-February) intensifies the discipline. Lauded in texts like the Skanda Purana and Matsya Purana, Magh is considered a month when celestial beings and ancestors descend to Earth to participate invisibly in the ritual. These ancient mandates confirm that the

The profound tradition of Sanatan bath is not just a ritual but an anchor for profound self-mastery, often integrated into intensive ascetic regimens.

This insistence on cold immersion, particularly at the Brahma Muhurta, reveals the practical genius of the ancient sages. Modern scientific research into Cold Water Immersion (CWI) provides compelling, concrete validation for the physical and mental benefits traditionally associated with these snans. The traditional claim of enhanced freshness, energy, and focus directly corresponds to CWI's effect on the neurochemical cascade. Studies have shown that cold exposure triggers a massive release of catecholamines, including a staggering 530% increase in Noradrenaline and a 250% increase in Dopamine. Noradrenaline is vital for vigilance, and cognitive function, while Dopamine regulates motivation. This acute release of powerful neurotransmitters provides a clear biochemical basis for the hyper-alertness required for pre-dawn rituals and the traditional claim of improved mental clarity.

Furthermore, the spiritual goal of cultivating discipline finds a powerful correlative in modern neurophysiological adaptation. Stepping into cold water requires the conscious decision to override the primal, survival-driven instinct to retreat. This intentional embrace of discomfort strengthens the Prefrontal Cortex (PFC), the brain region responsible for impulse control, decisionmaking, and self-discipline. The consistent, month-long practice ensures that this acute physiological stressor is transformed into a repeated training tool, reinforcing the self-mastery pathways essential for spiritual and mental

The concept of the theological purification of the spiritual essence, also finds a parallel in the body's physiological cleansing. The cold shock induces intense vasoconstriction followed by a strong, compensatory vasodilation. This action stimulates circulation and lymphatic drainage, effectively acting as a biological pump to remove cellular waste and inflammatory markers—a process akin to a measurable physiological detoxification. Moreover, longterm CWI has been associated with cardiovascular resilience and, immunologically, studies have demonstrated a significant reduction in self-reported sickness absence among regular cold shower participants, confirming the traditional view that snans enhance immunity and prevent disease through purification.

A key element in the survival of this tradition is the nuanced understanding provided by Ayurveda. While the ritual mandates cold baths, the traditional system of medicine also recognizes that cold water during winter can aggravate the Vata and Kapha Doshas. To mitigate this potential systemic imbalance and avoid pathology, the tradition integrated sophisticated countermeasures. The rigorous discipline of Kartik Snan often extends beyond the daily bath for many devotees who undertake Ganga Sevan (residence by the Ganga). These individuals observe Kalpvas, residing on the banks of the holy river, particularly the Ganga, for the entire month of Kartik. This profound dedication is exemplified in sacred cities like Varanasi (Kashi), where the tradition of residing near the ghats for the full month is a time-honoured spiritual aspiration.

The rituals of Kartik Snan and Magh Snan stand as profound proof of the foresight embedded within the ancient Indian knowledge system. By aligning human practices with cosmic rhythms and environmental stressors, the sages codified hydrotherapy's benefits centuries before Western science, offering a holistic model that addresses physical vitality, mental clarity, and spiritual connection. The enduring value of this wisdom lies in its accessibility and its comprehensive, integrated approach to wellbeing, providing a powerful and lowcost solution for enhancing resilience in the modern world.

Darbar Move: A Cultural Bridge Between J&K

The revival of the historic Darbar Move by the Jammu and Kashmir government marks a momentous development in the region's administrative and cultural landscape. Chief Minister Omar Abdullah's decision to restore this age-old practice has reignited a long-standing debate over tradition, governance, and economic practicality. The move, which involves the biannual shifting of the civil secretariat and other government offices between the twin capitals of Srinagar and Jammu, was a defining feature of Jammu and Kashmir's administrative heritage for nearly a century and a half. It symbolized not only a functional necessity in the bygone era but also a cultural bridge uniting two diverse regions-each distinct in geography, climate, and sentiment. The Darbar Move, first introduced by Maharaja Gulab Singh in 1872, was conceived to ensure equitable administrative access to both the Kashmir Valley and the Jammu plains. In those days, the road connectivity between the two regions was poor, and communication was often hindered by harsh weather conditions. To overcome these limitations, the Maharaja decided that the civil secretariat and key government departments would shift to Jammu during the winter months and return to Srinagar in the summer. Over time, this semiannual migration evolved into a deep-rooted tradition, representing a symbol of unity, administrative inclusiveness, and cultural integration. Even after 1952, when Jammu and Kashmir was accorded special status, the practice continued as a vital link between the regions-ensuring that governance was not confined to one part of the state but accessible to all.

However, the Darbar Move was abolished in June 2021 by the then Lieutenant Governor, Manoj Sinha, citing the advent of modern technology, improved

road networks, and the establishment of a robust e-office system. The decision was justified on the grounds of efficiency and economy, as the annual shifting of thousands of employees, records, and logistics incurred huge expenses running into crores of rupees. Despite these arguments, the abolition was met with disappointment and resentment in several quarters, particularly among Jammu's business community, for whom the Darbar Move had long been a source of livelihood. Hotels, restaurants, transporters, taxi operators, and traders in Jammu relied heavily on the influx of government employees and officials during the winter months, which provided a muchneeded economic boost to the region. Now, after a hiatus of more than four years, the Omar Abdullah-led National Conference government has decided to reinstate this traditional practice. The decision, according to the Chief Minister, aims to restore the historical and socio-cultural legacy of Jammu and Kashmir while simultaneously taking the administration closer to the people. The move has been described by the government as a step toward reviving an old bond of interregional interaction and ensuring that governance remains people-centric rather than confined to the digital domain. The file proposing the restoration of the Darbar Move was recently approved by the Lieutenant Governor, signaling the formal commencement of the process. The General Administration Department (GAD) has since issued Order No. 1357-JK(GAD) of 2025, outlining the schedule for the closure of government offices in the summer capital Srinagar and their reopening in the winter capital Jammu.

As per the order, thirty-nine departments, including the Chief Minister's Secretariat, will move to Jammu in full strength, while forty other departments will move partially, with a limited staff contingent of ten officials or thirty-three percent of their total workforce, whichever is less. This hybrid arrangement seeks to balance tradition with administrative efficiency, reducing the logistical burden while retaining the spirit of the Darbar Move. The decision has been received with enthusiasm in Jammu, especially among the business community, who see it as a revival of the city's economic lifeline. The Jammu Chamber of Commerce and Industry, led by its president Arun Gupta, has hailed the government's decision, expressing optimism that

a complete restoration of the Darbar Move in its original form will rejuvenate trade, tourism, and local enterprise. Yet, the revival of this practice has also reignited debates over its contemporary relevance. Critics argue that the socio-economic and technological realities of the 21st century have rendered the Darbar Move obsolete. With advanced e-governance platforms, seamless communication networks, and all-weather road connectivity between the two capitals, there seems to be little administrative justification for physically relocating entire departments twice a year. Opponents view the move as an unnecessary expenditure that drains the exchequer and disrupts the continuity of governance. They contend that the funds spent on logistics, transport, and temporary accommodation could instead be redirected toward public welfare projects, infrastructure, and digital transformation initiatives that would benefit citizens year-round.

Nevertheless, supporters of the Darbar Move counter that the decision transcends mere economics. They emphasize its symbolic and integrative value, asserting that it fosters a sense of unity and shared governance between the regions. The move, they argue, is not simply about shifting offices-it is about bridging historical divides, nurturing inter-regional understanding, and preserving a legacy that has defined Jammu and Kashmir's unique administrative identity for generations. For many, its restoration represents not just a political or administrative act but an emotional reaffirmation of the region's composite culture. Chief Minister Omar Abdullah, in defending his decision, has stated that governance is not only about files and computers but about human connection and accessibility. By reinstating the Darbar Move, he aims to revive a tradition that once ensured thegovernment's presence in every corner of the region. The administration, he says, must not operate from the confines of a single capital but should remain visible, mobile, and responsive to people's needs across geographical and cultural boundaries. This vision, though rooted in history, is projected as a bridge to the futureone that combines traditional inclusivity with modern adaptability.

Battle of Op Hill! One of the finest battles fought by the Indian Army

Battle of Op Hill! Everyone was a stranger that night and so was the strange fight to the finish! 1965 had some bullet and bomb scorchers and this was one of the biggest explosions that shook the nuts and bolts of Pakistan grand slam plans!

'OP Hill is located on the Mendhar Ridge which dominates the Line of Control, occupation of OP Hill denies access to our own (Indian) rear areas and provides protection to our lines of communications. Pakistan occupied it and we had to free it'! Needless to mention it was!

The inter-battalion boundary passes through OP Hill. The Pakistan Generals referred to this complex as 'Chu-e-Nar' and attached great importance to it. Consequently they occupied it at the first opportunity, finding it vacant. A captured diary of a Pak officer revealed that 'Chu-e-Nar' was awarded the Banner of GOC 12 Inf Div of Pakistan, the Pak formation respectively for the sector at that time.' It still is!'

Before I proceed, let me talk you through 12th Infantry Division of Pakistan. The 12th Infantry Division is the largest Pakistani Army infantry division and is currently based in Murree, Punjab close to Pakistan Occupied Kashmir. The Chinar Division's headquarters are located in the Murree Hills Cantonment. The brigades of 12th Division are deployed all across Pakistan Occupied Jammu Kashmir and the Line of Control. With 6 Infantry Brigades, First Divisional Artillery brigade and a number of supporting units of Air Defence, Supply, Engineering, Signals and Remount and Veterinary Corps under its command, 12th Infantry division is the largest division of Pakistan Army. The division was formed in 1948, from troops allocated to Pakistan from the $old\,British\,Indian\,Army.\,It\,was\,the\,first\,division\,sized$ formation to be created by the Pakistan Army (the three prior ones, 7th (Golden Arrow), 8th and 10th infantry divisions predated Pakistan). The division went into combat against the Indian army in Kashmir. A notable action was the recapturing of Skardu from the Indian forces, accomplished with help from

tribesmen from the tribal areas. In between the wars the division was active on the ceasefire line, where fighting broke out on several occasions. In 1965 the division undertook Operation Grand Slam, where under the command of 7th Infantry Division, it attacked Chamb. Although its performance was greatly lauded at the time, its commander Maj-Gen Akhtar Hussain Malik was privately criticized by General Ayub Khan, for abandoning several posts in Poonch which were then taken by the Indian army, and for losing the strategically vital Hajir Pir Pass (this would not be retaken until after the ceasefire). Six years later, the division went into action again, this time in the Poonch-Rajouri sector. During the war, it was commanded by Maj-Gen Mohammad Akbar Khan!'

'Down the long corridors of documented history there are many sagas of bravery, raw courage and fighting in the face of insurmountable odds which adorn the great history of our army. The Battle of OP Hill is one such operation which was demonstrative of the valor and steadfast resoluteness of the brave Indian soldiers who passed away into oblivion with the words 'For your tomorrow we gave our today'!

'Those who fought it very distinctly remember, OP Hill was an Indian post prior to the 1965 Operations. Vacated by the Indians due to operational commitments, it was occupied by the Pak soldiers. The Pak commanders, realizing its tactical significance, due to its vantage significance overseeing the Mendhar Valley held the post even after the termination of the 1965 war and the consequent Cease Fire Agreement on 23 Sep 1965. A Pakistan OP (observation post) was deployed on the post who directed lethal and effective matchlock shelling on the road axis Mendhar - Balnoi and the Balnoi Base. India reported the violation to the UN. After parleys and discussions with the UN Observers failed, 25 Inf Div decided to evict the enemy from this position. Commander 120 Infantry Brigade was assigned the task to do that. Subsequent to the receipt of orders and quick formulation of plans, a battalion attack was launched on the night of 6/7th Oct 1965, this attack failed. The lessons learnt were applied for the second battle fought on the night of 02/03 Nov 1965 in which OP Hill was captured, though at a very high cost!'! But the battle was legendary for more than one reason!'

'OP Hill was the scene of a bloody and historic battle fought 56 years ago. Bloody it was, because of its intensity and violence which left heavy casualties. This battle is a classic example of an Infantry Brigade capturing a Battalion defended area in one night in mountainous terrain. The battle itself is a tribute to

the valor and determination of the attacking infantry and Support Artillery!'

'I'm not Tennyson who created words with his magical poetry when he wrote the 'Charge of the Light Brigade', just I will recite those words, 'cannon to right of them, cannon to left of them, cannon in front of them, volleyed and thundered; Stormed at with shot and shell, yet they rode on'! But if I have to recreate that magic of that night, 'everything that the enemy had in form of the machine gun barrels sending spit fire and the guns landing left right and center, these men climb full well knowing as to what would happen at the target end! Had to be a hand to hand, fist and dagger fight (call it bayonet fighting). It was!'

Perhaps at that time in the night the gossip would have been like this on the forming up place (FUP if I'm not wrong), 'wound or Injury or maybe we never meet after the assault? Whatever happens I am your cowarrior; I was born to fight this battle with you.' That night many friends said ad they assaulted the OP Hill, with one aim, 'Aaj to marenga, yah mit Jayenge, OP Hill par Kal hamara hi OP hoga, Chalo Chalen, dekhte hain kitne pahunchenge aur kitnon ko yaad Rakhegi Duniya'! Everyone of us remembers them in Mendhar and

In 1965 General Ayub Khan forgot one thing, though he was a good friend of our former Field Marshal KM. Cariappa and the latter told him something on the last day of the 1965 Indo-Pak war. The 36-year-old Squadron Leader KC Cariappa was flying near the border and was shot down. A few moments later, he emerged from the wreckage of the war plane and was taken prisoner by the Pakistan army. Like all the officers, he gave his name, rank and unit number and nothing more. The information was relayed to Pakistan Army headquarters at Rawalpindi. An hour later, his captors came rushing to a small cell where he was kept prisoner to know if he was the son of Field Marshal KM Cariappa, the first Indian chief of armed forces after Independence. KM Cariappa was first appointed as the chief of all three services and later made Army chief. He told them that he was indeed the son of the military legend and they returned. KC Cariappa was never sure of what happened after that but he was worried that his family would not know about his arrest in Pakistan.' These are old stories but still matter because they will eventually do so in future!

'A battle starts with the self, and if we lose that there can be a battle with another, Imran Khan should be knowing this because in every battle a human being is a loser just for a bullet head it matters less since the shell drops off. What does it cost in defense industries in the world, perhaps peanuts but human blood costs more! Lead does not!'

169 Field Regiment Gunners always strike me and in this battle they did an exceptional job! The regiment was raised as 169 Field Regiment in Naushera on 1 November 1963 under the command of Lieutenant Colonel HS Dhaliwal. The class composition of this unit is 'Maratha' with the war cry 'Chhatrapati Shivaji Maharaj Ki Jai'. The regiment is presently a medium regiment. The Battle of OP Hill took place after the ceasefire came into effect on 23 September 1965. OP Hill was a Border Observation Post in the Bhimber-Gali-Mendhar Sector, 20 km south west of Poonch. This Observation Post (OP) was being used by the Pakistanis to direct accurate artillery fire. To avoid isolation of Balnoi from Mendhar and Krishna Ghati, capture of OP Hill was imperative. 120 Infantry Brigade was tasked to evict the enemy from this strategic location. Following a failed battalion level offensive by 2 Garhwal on 6 and 7 October 1965, a full-fledged brigade attack was mounted on 2 November 1965. After a grim battle lasting 2 days, the enemy was dislodged. For its actions, the 169 Mountain Regiment along with 5 Sikh Light Infantry, 2 Dogra, 7 Sikh and 2r Mountain Composite Regiment (Artillery) were awarded the battle honor 'OP Hill'.

If you want to see what happened 56 years ago then go and see the names of the fighters who charged up the OP Hill on the magnificently made war memorial! A few against many is always at times as to get into dreams of valor and determination. Here the fight was live and not a cinematic interpretation!

But I will still make an attempt to describe the battle, 'the starless sky was casket-black and brooding. Even the clouds seemed morose. Gelid (frozen) hands clasped algid (cold) steel as we gazed upon our foe who was relentless with cannons and the machine guns. Everyone was moving up but some were falling by the bites of the invisible vipers hissing in air! Suddenly the clouds cleared. Their bayonets glimmered cruelly under the eerie moon. The monsters swarmed and swayed below us like corn in a field, yet it seemed there were more of them than a thousand bushels could hold. Our commander raised our proud pennant aloft in defiance. It represented our dreams, our lives and our salvation. If it was taken, OP Hill was ours, the enemy was wrong! We were right up there on OP Hill with tricolor fluttering! But the worst possible thing was that some of them gossiping at FUP (forming up place were not amongst the victorious! The memorial at Balnoi signifies a lot! 'For our tomorrow they gave their today' Remember that!

A Truth Hidden in the Shadows of History

Ambedkar or B.N. Rao? The True Story of the Constitution

suggestions for the Constitution in his office. Consequently, he prepared the "First Draft" of the Constitution and submitted it to the Constituent Assembly on October 30, 1947. This draft later became the basis of the Indian Constitution.

The Constitution of India is the world's largest and most comprehensive democratic document. It would be an injustice to history to attribute it to a single individual. The journey of Constitution-making, which began in 1919 and stretched until 1949, involved numerous minds, perspectives, and ideological differences. The roles of B.N. Rao, who drafted the Constitution as Constitutional Advisor, and Dr. Bhimrao Ambedkar, who presented it to the Constituent Assembly as Chairman of the Drafting Committee, are two pillars of Indian democracy. This article presents an objective assessment of their contributions.

One of the most significant events in India's history was November 26, 1949, when the Constituent Assembly adopted the Constitution of India. This document is not merely a legal framework, but a living philosophy—a symbol of liberty, equality, and justice. But over time, questions have arisen as to who was the true architect of this Constitution? Was it solely the work of Dr. Bhimrao Ambedkar, or did a silent but decisive figure like B.N. Rao play a greater role in

The story of Constitution-making doesn't begin with 1947. Its roots go much deeper-from the Montagu-Chelmsford Reforms of 1919 to the Government of India Act of 1935. These reforms first gave birth to the concept of federal government in India. It was during this period that a name emerges-Sir Binod Behari Narayan Rao, later known as B.N. Rao. Serving in high judicial and constitutional positions in the British administration, he developed a profound understanding of the Indian administrative structure.

By the time the Second Round Table Conference was held in the 1930s, the direction of self-government in India had become clear. After 1932, B.N. Rau was formally involved in the preliminary

preparations for the Constitution. The Constitution Drafting Office was established under his leadership in Delhi, In 1944, he was appointed "Constitutional Adviser" and in 1946, "Principal Constitutional Adviser." His task was to compile all the constitutional drafts, British laws, reports of provincial legislatures, and suggestions from Indian leaders and prepare a basic draft.

By the time the Constituent Assembly was formally announced on July 14, 1946, Rao had already collected numerous drafts and legal suggestions for the Constitution in his office. Consequently, he prepared the "First Draft" of the Constitution and submitted it to the Constituent Assembly on October 30, 1947. This draft later became the basis of the Indian Constitution.

Meanwhile, political events were rapidly changing. In 1946, elections were held for the Constituent Assembly. Dr. Bhimrao Ambedkar, by then known as a renowned jurist and champion of Dalit rights, lost the election from Maharashtra. However, at the urging of Lord Wavell and later Mountbatten, Nehru and the Congress leadership recognized the need for a scholar like Ambedkar to be in the Constituent Assembly. Consequently, the Muslim League of Bengal allocated him a seat from its quota, enabling him to enter the Constituent Assembly in July 1947.

On August 29, 1947, the Constituent Assembly formed a "Drafting Committee," with Ambedkar as its chairman. This committee's task was to review and finalize the draft prepared by B.N. Rao. Rao remained associated with the committee as an official advisor. This is where Ambedkar's role becomes

 $Dr. Ambedkar's \, greatest \, contribution \,$ was that he did not allow Rao's draft to remain a mere legal document-he imbued it with the spirit of social justice and human rights. The fundamental

rights of the Constitution, from Articles 12 to 35, are a result of that vision. Provisions such as equality, liberty, the right against exploitation, religious freedom, and constitutional remedies are rooted in Ambedkar's social vision.

Although many fundamental ideas and institutional structures, such as the Supreme Court, High Courts, the federal structure, and the Directive Principles of State Policy, had already been discussed in the Constituent Assembly, Ambedkar adapted them to the practical and Indian social structure. This is why the Constitution is called a "living docu-

The roles of B.N. Rao and Ambedkar were complementary. Rao's approach was legal and structural, while Ambedkar's was social and reformist. Rao laid the foundation for the Constitution, while Ambedkar gave it its soul. This balance is what makes the Indian Constitution unique.

It is also true that the Objectives Resolution of the Constitution (later known as the Preamble) had already been passed by the Constituent Assembly in January 1947. It already contained the spirit of declaring India a "sovereign, democratic republic." Similarly, discussions on fundamental rights had begun in June 1947. But the credit for giving practical shape to these principles goes to the Drafting Committee, headed by Ambedkar.

When the Constitution came into effect after independence, the world saw how a diverse, multilingual, and multi-religious nation could remain united within a constitutional framework. This achievement wasn't the work of a single individual—it was the work of all 299 members who deliberated in the Constituent Assembly for 2 years, 11 months, and 18 days. But it's also true that without B.N. Rao, that basic structure would not have existed,

and without Ambedkar, that structure would have been soulless.

It often happens in history that political symbols overshadow intellectual contributions. Ambedkar was a people's leader, so naturally his name became more famous. Rao's contribution was silent, but deeply decisive. It's like an architect planning a building and someone else bringing it to life and decorating it. If either one is removed, the work remains incomplete.

The time has come for Indian society to view the story of the creation of its Constitution not merely through the lens of personality cult, but as an institutional and intellectual process. The Constitution is not the product of any one individual, but of India's collective con $sciousness-the\,consciousness\,that, after$ slavery, dreamed of democracy and transformed it into reality.

If we are citizens of independent India today, enjoying the rights of equality and freedom, we must pay tribute to all those who made this journey possible. B.N. Rao's profound legal knowledge, Dr. Ambedkar's social vision, Jawaharlal Nehru's political foresight, Sardar Patel's organizational ability—these are the roots of the mighty tree we call the Indian Constitution.

Therefore, the debate about "who is the real architect" is a narrow perspective. The correct question should be, "Who contributed what to our constitutional process?" History does justice when it looks at the whole truth, not just famous figures. Both B.N. Rao and Dr. Ambedkar are indispensable chapters in that history—one drafted the Constitution, the other gave it soul.

The Food Addiction

The Food addiction has emerged as one of the most common yet underrecognized public health challenges of the 21st century. It is scientifically defined as a compulsive and uncontrollable urge to consume the food despite negative physical and psychological consequences. The food addiction mimics the neurobiological pathways of substance dependence.

In an age of abundance and convenience, the food has transcended its biological purpose of nourishment to become a source of comfort, reward, enjoyment and even escape. While occasional indulgence is normal, the chronic compulsion to eat-especially high-calorie, high-fat and sugary foods can evolve into food addiction, a behavioral disorder with complex physiological and psychological underpinnings. The phenomenon is now being recognized by nutritionists, psychiatrists and neuroscientists as a genuine addiction parallel to drug or alco-

SCIENTIFIC BASIS OF FOOD ADDICTION

The Food addiction primarily involves the brain's reward circuitry, particularly the mesolimbic dopamine pathway, which also plays a central role in substance addiction. When palatable foods are consumed, they stimulate the release of dopamine, the pleasure chemical. Repeated exposure to these foods conditions the brain to crave them more intensely. Over time, the brain's reward threshold increases, requiring larger quantities or more frequent intake to achieve the same pleasure—a phenomenon identical to drug tolerance.

Additionally, opioid receptors in the brain are activated by fats and sugars further reinforcing compulsive eating behavior. This neurochemical interplay explains why individuals with food addiction often experience withdrawal-like symptoms such as irritability, anxiety and fatigue when attempting to reduce intake.

POSSIBLE REASONS FOR FOOD ADDICTION 1. Neurochemical Imbalance:

Dysregulation of dopamine and serotonin levels can increase vulnerability to addictive eating behaviors.

2. Emotional and Psychological Triggers: Emotional distress, anxiety, loneliness and depression often push individuals toward comfort eating as a coping mechanism.

3. Genetic Predisposition:

Genetic studies indicate that certain individuals may have inherited traits that make their reward system more sensitive to food stimuli.

4. Environmental and Social Factors: The omnipresence of fast food outlets, per-

suasive marketing and social normalization of overeating accelerate the development of food addiction.

5. Childhood Conditioning:

Early exposure to sugary or processed foods and using food as a reward during childhood can program lifelong patterns of food depen-

FACTORS THAT ACCELERATE FOOD ADDIC-TION

Ultra-Processed Foods:

These contain combinations of sugar, salt and fat scientifically engineered to trigger addictive pleasure responses.

Stress and Sleep Deprivation:

The chronic stress elevates cortisol levels leading to cravings for high-calorie comfort

Digital Influence:

Constant exposure to food imagery through advertisements and social media increases subconscious cravings.

Sedentary Lifestyle:

Lack of physical activity reduces natural dopamine release making the brain seek stimulation through eating.

RISK FACTORS AND HEALTH IMPLICATIONS

Food addiction is associated with numerous medical and psychological risks, including:

Obesity and Metabolic Syndrome is caused due to consistent overconsumption of calorie-

Type 2 Diabetes and Cardiovascular Diseases are caused from insulin resistance and dyslipidemia.

Gastrointestinal Disorders including acid reflux, fatty liver and gut microbiome imbalance. Cases of mental Mental Health Decline are rising with higher rates of anxiety, depression, guilt and low self-esteem are observed in foodaddicted individuals.

Reduced Quality of Life – as the addiction interferes with productivity, relationships, and overall well-being.

In severe cases, anti-craving medications or antidepressants may be prescribed under clinical supervision.

5. Physical Activity:

Regular exercise enhances dopamine sensitivity naturally, providing a healthy alternative to food-induced pleasure.

6. Social and Family Support:

Peer groups, counseling and family involvement play a crucial role in long-term recovery and relapse prevention.

Food addiction stands at the crossroads of neuroscience, psychology and public health, reflecting both the vulnerabilities of the human brain and the excesses of modern society. Recognizing it as a legitimate disorder is the first step toward effective intervention. Addressing food addiction requires a multi-dimensional strategy encompassing medical treatment, psychological support, policy reform and societal awareness.

In a world where food is omnipresent yet self-control is fleeting, understanding and combating food addiction may be one of humanity's most significant health challenges-and triumphs-of the modern era.



Office of the Assistant Director, Fire & **Emergency Services, Command Ganderbal**

Fire Advisory for winter Season for district Ganderbal.

With the onset of winter and plummeting temperatures across District Ganderbal, the risk of fire incidents increases significantly due to extensive use of heating appliances, electric gadgets and traditional fire/ heating sources. Given the district's unique topography, the residents of District Ganderbal are advised to follow the following Fire Safety precautions to prevent fire accidents and ensure quick emergency response.

- 1. Ensure Chimneys and Bukharis are cleaned and maintained before use because accumulated soot and ash can ignite fires.
- 2. Avoid drying clothes directly over bukharis or heating appliances. 3. Avoid storage of dry grass, rejection wood etc. in residential houses. Store this combustible material in isolated places away
- 4. Check LPG hose pipes and regulators for cracks or leaks regularly. 5. Do not store spare LPG cylinders indoors.

14. Use certified and ISI-marked electrical equipment only.

- 6. Never leave cooking unattended. Properly Switch the LPG Stove knob and Cylinder Regulator after completing the cooking.
- 7. Keep kitchen exhaust ventilated even in cold weather to avoid gas accumulation. 8. Avoid using coal-based kangris or bukharis in poorly ventilated rooms to prevent Carbon Monoxide buildup.
- 9. Avoid overloading of electric sockets used for heating rods, blowers or radiators. 10. Ensure that all heating gadgets are unplugged and Stoves, Bukharies, LPG Cooking Gas Stoves are switched off properly,
- before going to bed or leaving the room/ home
- 11. Use Kangris with utmost care. Keep Kangris at safe places during nights to avoid its toppling.
- 12. Ensure electrical wiring and switches are properly insulated and checked by licensed electricians before the onset of winter. 13. Unplug all electrical appliances when not in use, especially at night.
- 15. Markets, religious places, government offices, and schools using electric or gas heating systems must conduct a fire safety check and ensure availability of functional extinguishers.
- 16. Ensure escape routes are clear and not blocked by snow, merchandise, or furniture.
 - 17. Do not leave heating lamps or electrical devices on near parked vehicles or fuel storage areas.
 - 18. Avoid smoking or open flames in garages or near diesel/gasoline storage.
 - 19. Do not through live cigarette butts carelessly. 20. Maintain fire lines and clearance around wooden huts, dhabas, and tourist lodges.
- 21. Keep access routes for fire tenders and emergency vehicles free from snow or obstruction. 22. Remote areas should identify local volunteers for initial fire response and liaison with nearest Fire & Emergency Station. 23. NEW DELHI, OCT 23: In a major boost to enhance the capabilities of the Indian Armed Forces, the Defence Acquisition Council, under the chairmanship of Defence Minister Rajnath Singh, approved various proposals of the Services amounting to a total of about Rs 79,000 crore, during a meeting in South Block,

In a statement issued here, the Minister of Defence while providing the breakup of the contract stated that the for the Indian Army, Acceptance of Necessity (AoN) was accorded for the procurement of Nag Missile System (Tracked) Mk-II (NAMIS), Ground Based Mobile ELINT System (GBMES) and High Mobility Vehicles (HMVs) with Material Handling Crane. The procurement of NAMIS (Tracked) will enhance the Indian Army's capability of neutralising ene-



my's combat vehicles, bunkers and other field fortifications, whereas GBMES will provide round-the-clock Electronic Intelligence of enemy emitters. The induction of HMVs will significantly improve logistic sup-

port to the forces in diverse geographical terrains.

For the Indian Navy, AoN was granted for the procurement of Landing Platform Docks (LPD), 30mm Naval Surface Gun (NSG), Advanced Light Weight Torpedoes (ALWT), Electro Optical Infra-Red Search and Track System and Smart Ammunition for 76mm Super Rapid Gun Mount. The procurement of LPDs will help the Indian Navy to undertake amphibious operations along

with Indian Army and Indian Air

The integrated sea capability provided by LPD will also help the Indian Navy to undertake peacekeeping operations, Humanitarian Assistance and Disaster Relief etc. The induction of ALWT, which is indigenously developed by Naval Science & Technological Laboratory, DRDO is capable of targeting conventional, nuclear and midget submarines. The procurement of 30mm NSG will enhance the capability of Indian Navy and Indian Coast Guard to conduct Low Intensity Maritime Operations and anti-piracy roles.

For the Indian Air Force, AoN was accorded for Collaborative Long Range Target Saturation/ Destruction System (CLRTS/DS) and other proposals. The CLRTS/ DS has the capability of autonomous take-off, landing, navigating, detecting and delivering payload in the mission area. UNI

Rajnath releases **Defence Procurement Manual 2025**

NEW DELHI, OCT 23: Defence Minister Rajnath Singh today released the Defence Procurement Manual (DPM) 2025 at a function in South Block

Effective from November 1, the new procurement manual will facilitate the revenue procurement amounting to approximately Rs one lakh crore by the three Services and other establishments under the Ministry of Defence (MoD), a Defence Ministry



Appreciating the efforts of MoD and HQ Integrated Defence Staff for the revision of the manual, Singh expressed confidence that the new manual will simplify the procedures, bring uniformity in functioning and will be helpful in providing goods and services required by the Armed Forces for operational preparedness. It will also provide more opportunities to MSMEs and start-ups in the field of defence manufacturing and technology duly ensuring fairness, transparency and accountability

Financial Advisor (Defence Services) Mayank Sharma gave a brief overview of DPM 2025 and highlighted the way the manual has been prepared in close consultation with the services and other stakeholders.

Some key provisions have been altered to expedite decision making and promote ease of doing business. Liquidated damages (LD) which is levied on delayed delivery of stores and services, has been relaxed and maximum LD to the extent of 10 percent will be levied only in cases of inordinate delay.

In addition, there are provisions for assured order ranging upto five years and beyond for the items developed by the public or private players under indigenisation. As per the revised provisions, Limited Tender enquiry can be resorted to for value upto Rs 50 lakh and beyond that in exceptional cases.

In this revised manual, condition to obtain 'No Objection Certificate' from erstwhile Ordnance Factory Board before going for procurement from other sources, has been dispensed with.

All Request For Proposals (RFPs), to be issued after November 01, 2025, will be governed by the provisions of DPM 2025.

Legendary space scientist Eknath Vasant Chitnis passes away at 100

NEW DELHI, OCT 23: Renowned Indian space scientist Eknath Vasant Chitnis passed away peacefully at his home in Pune yesterday due to a heart attack. He was 100 years old.

A towering figure in India's space saga, Chitnis was instrumental in laying the foundations of the Indian National Committee for Space Research (INCOSPAR), which later blossomed into the Indian Space Research Organisation (ISRO).

Congress leader Jairam Ramesh paid tribute on X, calling Chitnis "one of the icons of our space odyssey." Ramesh fondly recalled the historic meeting on February 10, 1962, when Chitnis accompanied Vikram Sarabhai to meet then-Prime Minister Jawaharlal Nehru at the Physical Research Laboratory in Ahmedabad, a moment that shaped India's space ambi-

Chitnis's legacy is rich and multifaceted. He played a key role in selecting Thumba, Kerala, as the launch site for India's first rocket, a decision that was pivotal in kick-starting the nation's space journey. As Director of ISRO's Space Applications Centre (SAC) in Ahmedabad from 1981 to 1985, he advanced critical projects in remote sensing, satellite communication, and the landmark INSAT programme.

Among his notable feats was spearheading the Satellite Instructional Television Experiment (SITE), an innovative project that utilised satellite technology to deliver educational programming to rural India. SITE illustrated how space technology could break barriers, enhance education, and improve healthcare access for the underserved.

Beyond his scientific achievements, Chitnis was a mentor par excellence. He notably nurtured the early career of APJ Abdul Kalam, who went on to become India's beloved President and a global icon

of scientific excellence. Chitnis is survived by his son, Chetan Chitnis, a distinguished molecular biologist and Padma Shri awardee, along with his daughter-in-law and granddaughters. His passing signals the close of a remarkable chapter in India's space exploration history, but his vision and inspiration will continue to guide future generations.

As India mourns this pioneer, his contributions remain etched in the stars that once guided his dreams and those of an entire nation. UNI

SLC postpones 2025 edition of LPL

COLOMBO: The 2025 edition of the Lanka Premier League (LPL) will not take place this year as was originally planned, SLC has announced. In a press release, SLC said that the decision was taken "after careful consideration of the broader requirement of preparing well in advance" for next year's T20 World Cup, which will be co-hosted by India and Sri Lanka. The 2025 LPL was originally slated to be held



between November 27 and December 23 across three venues - Colombo, Kandy and Dambulla. SLC, however, has now decided to move the tournament to another window, in order to allow "full focus on ensuring comprehensive venue readiness ahead of the World Cup." As per ICC guidelines, all venues for the upcoming 20-team World Cup are meant to be in perfect condition to meet the demands of hosting a major international tournament. Accordingly, SLC said they needed the time to upgrade and enhance the infrastructure in and around the grounds.

The R Premadasa International Stadium in Colombo, which is one of three venues in Sri Lanka, had temporarily paused its renovation work to host 11 matches in the ongoing Women's World Cup. SLC confirmed that the ground will resume development work immediately upon the completion of its scheduled games. The last two seasons of the LPL took place during July and August, however this year, with the 2026 T20 World Cup set to begin in February, SLC had initially felt the later window better suited their needs. ESPNcricinfo had also learnt that talks are underway to incorporate a sixth team into the LPL. The first five editions saw five teams representing Colombo, Galle, Kandy, Dambulla and Jaffna compete. Earlier this year, Jaffna Kings - formerly the longest-standing franchise, having joined in the tournament's second edition - and Colombo Strikers were terminated by SLC for "failure to uphold contractual obligations." As a result, the LPL currently has no franchise owners with a history stretching back beyond 2024.

Ngarava and Curran lead Zimbabwe to first home Test win in 12 years

Ngarava's maiden Test five-wicket haul handed the hosts their first innings win since 2001

HARARE: It took Zimbabwe less than three hours on the third day to claim their first home Test win since 2013, their first innings win since 2001 and their biggest Test win. Richard Ngarava was the star, where in overcast conditions he took his first fivewicket haul in Tests. His movement through the air and off the pitch never looked exaggerated, but it was relentless enough to break the game open and leave Zimbabwe with a win by an innings and 73 runs against a listless Afghanistan batting unit.

The day began with Zimbabwe's Test squad lining up for a group photo, a clear suggestion they were keen to finish the contest on Wednesday itself. And they started with a surprise by giving the ball to Tanaka Chivanga ahead of Blessing Muzarabani.

It turned out to be a good decision as Chivanga's third over of the morning saw Rahmanullah Gurbaz flicking one down the leg side, and Tafadzwa Tsiga, alert behind the stumps, did the rest. Three overs later, Ngarava

produced almost the same dismissal when Ibrahim Zadran, who had reached 42 with measured strokes, flicked another ball going down leg, and Tsiga took his second of the morning.

 $Hash matullah\,Shahidi\,lasted$ briefly. A full delivery from Ngarava drew a hard-handed push that went to Craig Ervine at slip. Bahir Shah and Afsar Zazai then gave the innings some momentum. Bahir found six boundaries but his counter-attack ended after Muzarabani cramped him with a short ball. The fend popped up and Ben Curran swooped in from short leg. Zazai followed soon after, easing a half-hearted drive to backward point to end the morning session

at 127 for 6. The sun broke through after lunch but offered little relief to Afghanistan. Chivanga thought he had Ismat Alam caught, only for a front-foot no-ball to intervene. Ngarava corrected it soon after with a length ball outside off that induced a cut from Alam. Tsiga flung himself to his right and pulled off a one-handed catch that drew gasps even from the slips. Two overs later Sharafud-



din Ashraf edged to second slip,

giving Ngarava his fifth. Muzarabani, quiet through much of the innings, finished it off with precision. First he flattened Khalil Gurbaz's leg stump, then beat Ziaur Rahman with a yorker that split middle stump. Those wickets gave him six for the match and ended a game Zimbabwe had controlled from

the second hour of the first day. Ngarava's five, Chivanga's pace, and Muzarabani's closing spell combined for a win that was both rare and easily earned. Curran's day-two performance of 121, which earned him a Player-of-the-Match award, and Sikandar Raza's 65 were the other highlights of their comfortable win.

After the game, Zimbabwe captain Ervine said a win in their final Test match of the year was satisfying. "I'm ecstatic. A lot of credit to the boys for fighting and winning to end a tough year of Test cricket," Ervine said. "The way we started, in the first hour of day one wasn't good, but the way the boys pulled things back was excellent. Then with the bat, Curran's innings - full of composure and discipline - was outstanding.

"The wicket offered something throughout, so the boys did well to put on some good partnerships. The boys have learnt with the Test cricket they've played in the last six-seven months to find their game. Brad [Evans] with the fivefor in the first innings and Richie [Ngarava] stepped up in the second innings. TK [Chivanga] was superb and Bless [Muzarabani] was unlucky not to take a few more wickets."

Shahidi, the Afghanistan captain, rued the batting collapse on the first day when Afghanistan slid from 77 for 1 to 127 all out.

"They played really good cricket, it was supporting the fast bowlers," Shahidi said. "Ball was seaming around but overall, we didn't play good cricket. We started the Test well with 80 for 1 [77 for 1] in the first innings, but that collapse let us down. I feel the lack of our Test-playing experience cost us since we kept losing back-to-back wickets. In Test cricket, winning the first day is very important."

The two teams now meet for the three-match T20I series starting October 29.

La Liga cancel plan to hold Villarreal vs Barcelona match in Miami

BARCELONA: La Liga's plan to hold a Barcelona match in Miami in December has been called off because of "uncertainty" about the game within Spain, the Spanish top flight said in a statement Tuesday. Champions Barca were set to face Villarreal in the United States on December 20, which would have been the first European league fixture to be played abroad.

La Liga said their promoter for the match decided to cancel the organisation of the event because of "uncertainty generated in Spain in recent weeks". The Spanish top flight said they "deeply regret that the project, which represented a historic and unparalleled opportunity to take Spanish football to the international stage,

cannot go ahead". Tickets for the game at the Hard



Rock Stadium were due to become available on Tuesday, but organisers said the presale was "delayed" before the plan was scrapped. The match will now be held at Villarreal's Estadio de la Ceramica home as normal.

"Barcelona respects and accepts the decision to cancel the match against

Villarreal in Miami... just as we respected and accepted the decision to play when it was made at the time," said Barcain a statement. The Catalangiants said they regret "the lost opportunity to expand the image of the competition in a strategic market with growth potential" and that US-based fans "will be deprived of witnessing" the game in the flesh. La Liga published its statement during Villarreal's 2-0 Champions League defeat by Manchester City.

"It seems to me an absolute lack of respect to put out a statement at halftime of a game about something that was planned but will not happen," said Villarreal coach Marcelino Garcia Toral.
