SRINAGAR, OCT 30: "Massacre in Pahalgam was not just another act of terror, it was an assault on the soul of India. Twenty-six innocent tourists, whose only fault was to admire the beauty of Kashmir, were executed in cold blood after being asked their religion. Such barbarity once again laid bare Pakistan's deep complicity in sponsoring terrorism across the border" Defence Minister Rajnath Singh send a stern message to the neighbouring country from a rally in Bihar's Darbhanga.

The National Investigation Agency (NIA), which is probing the case, is expected to file its chargesheet within days.

Two More Govt Employees Sacked for Terror Links Under Article 311

SRINAGAR, OCT 30: In a decisive action reaffirming the Union Territory Administration's Zero-Tolerance Policy Against Terrorism, Lieutenant Governor Manoj Sinha has ordered the dismissal of two government employees from service under Article 311 of the Constitution for their alleged involvement in terror-related activities.

The terminated officials include Ghulam Hussain, a teacher in the Education Department, who has been accused of acting as an Over Ground Worker (OGW) for the Lashkar-e-Taiba (LeT) outfit. Authorities allege that Hussain maintained close links with terrorists, facilitated their recruitment, and aided in funding activities in Reasi district.

The second employee, Majid Igbal Dar, also a teacher and former Lab Assistant, has been accused of involvement in narco-terrorism, radicalisation Turn on Page 2

HANDWARA, OCT 30: Chief Minister Omar Abdullah on Thursday reaffirmed that his government and the National Conference (NC) are fully committed to fulfilling every promise made to the

people of Jammu and Kashmir before seeking their mandate again. Addressing a large public gathering in Handwara, Abdullah said the NC would stand by each commitment it made before the last elections and would return to the people only after ensuring tangible results on the ground. "The promises we made to you before the elections will

all be fulfilled. Only after honouring those commitments will we come before you again to seek your trust," Abdullah declared amid applause. "Our aim is not to make empty assurances but to deliver measurable change that strengthens people's faith in governance."

The Chief Minister said the NC's priorities remain centred on ensuring fair representation, improving livelihoods, and expanding employment opportunities. "All these are achievable only when there is true representation. We have worked hard to ensure that Jammu and Kashmir's voice is heard again in Delhi,"

as Special Public Prosecutor for conducting trial and other matters related to NIA Case No. RC-02/2025/ NIA/JMU, on behalf of the NIA, before the NIA Special Court, Jammu, and the High Court of Jammu & Kashmir and Ladakh, for a period of three years from the date of publication of this notification or till the completion of the trial, whichever is earlier."

The development comes just as the 45-day extension granted to the NIA by a Jammu court on September 18 to complete its investigation is about to expire this week. 'We have sent three great candidates to Delhi whose voices will echo where ours had gone unheard since 2022," he said.

Abdullah accused the previous Members of Parliament of failing to represent their constituencies effectively. "We sent big names earlier, but they got affected by Delhi's pollution and their voices never reached the people," he remarked, drawing laughter from the audience. "This time, we are confident that our representatives will raise issues with courage

and consistency.' The Chief Minister emphasised that Jammu and Kashmir requires strong representation in national institutions to safeguard its interests. "Someone must be there to remind the Centre of its commitments and the constitutional guarantees that were made to our people," he said.

Referring to the resolution passed by the Jammu and Kashmir Legislative Assembly last November, Abdullah said it had reflected the collective will of the people. "That resolution, demanding the restoration of constitutional rights, was not a party decision but a people's demand," he asserted. "It reaffirmed our unity and our determination to regain our right-

ful place in the democratic framework. Promising District Status to Handwara Omar Abdullah said north Kashmir, particularly Handwara, has long suffered from inadequate representation in both the Assembly and Parliament.

"After 2014, Handwara's voice did not reach either ne Assembly or Parliament," he said. "Even today, the MP from Baramulla attends sessions only with the court's permission and remains disconnected from his people.'

He promised that Handwara would be granted district status once Jammu and Kashmir regains its full administrative powers. "You don't have to ask for it; it will be given. Handwara deserves that recognition, and I assure you it will happen," he said, earning loud applause from the gathering.
The Chief Minister also welcomed former People's

Conference (PC) leader Ashiq Neelum into the National Conference, describing him as "an influential political figure whose joining will strengthen the

NC and bring renewed energy to north Kashmir."

"His experience and influence will help the party grow and serve the people better," Abdullah

Omar also Called for Court-Led Process in Employee Terminations Responding to reporters' questions, Omar Abdullah said the termination of government employees accused of anti-national activities should follow due legal process.

"Thave always maintained that dismissals should be carried out through the court," he said. "Everyone deserves the opportunity to defend themselves. The current practice of ending services merely on suspicion is neither fair nor sustainable.

He said many employees terminated under suspicion were later reinstated after judicial review, which clearly demonstrated the flaws in the administrative process. "It would be better to allow the courts to identify the real culprits rather than penal-

ising the innocent," he added.
CM Denied Model Code Violation Charge. Asked about allegations from the Leader of Opposition that he had violated the Model Code of Conduct (MCC), Abdullah dismissed the claim as baseless. "I have not violated any code of conduct. These accusations are politically motivated and reflect desperation, not facts," he said.

The Chief Minister reiterated that his government's focus remains on delivery, not distraction. "Our opponents try to provoke and divert attention, but we are focused on our promises and the people's trust." he said.

As the gathering concluded, Abdullah reminded

upporters that governance is a "sacred trust between he people and those they elect." "We in the National Conference understand that trust must be earned not demanded. Before we seek your votes again, we will ensure every promise is fulfilled," he said to a standing ovation.

However, the BJP members did not relent and continued with their demand.

"Don't you want the Question Hour," the Speaker asked, and said, "I promise I will find some wav." Rather said the adjournment motion has been disallowed as Rule 58 (12) puts a bar on admitting an

adjournment motion on a subject which has already

been disallowed in the session.

Responding to that, BJP MLA from Jasrota, Rajiv Jasrotia, said, "You (Speaker) had promised to allow the resolution. But, you did not keep it." The Speaker responded by saying the resolution did not come

up due to the paucity of time.
"You could have extended time yesterday," Jasrotia said. "You should have raised this yesterday," the

Speaker shot back. Amid the din, Leader of Opposition (LoP) Sunil Sharma said the August rainfall affected most areas

of J&K, and the people of the Union territory have expectations with this House that the MLAs will

raise their issues. "We respected the House rules ... And followed your promises. Resolutions were managed yesterday in such a way that this important resolution did not even come up. The government seems disinterested in this important issue," Sharma said, adding that the flood-affected victims have been disrespected.

The LoP said there should have been a discussion on the issue on the very first day of the assembly session, and accused the government of running

away from a discussion.
"What does the government want to hide? A scam in PWD has been unearthed in media today. Why is the government running away? They want to hide corruption," Sharma added.

Sharma's comments led to protests by the treasurv benches. With both the treasury and the opposition members on their feet, there was uproar in the House.

Ruling National Conference (NC) MLA from Gurez, Nazir Ahmad Khan Gurezi, said the BJP members 'are enacting a drama" and "wasting the time of the

As the accusation and counter-accusation flew, deputy chief minister Surinder Choudhary, while pointing towards the BIPMLAs, said, "Chor machaye shor" (thieves were making noise).
Another NC MLA, Salman Sagar, asked the BJP to give an account for the ten years from 2014 to 2024

— when the BJP was in power with the PDP till 2018, and then J-K was under the Centre's rule. As the ruckus continued, BJP MLA from Kishtwar,

Shagun Parihar, tried to enter the well of the House, but was stopped by female watch and ward staff. Two BJP MLAs, RS Pathania and Surinder Kumar,

were marshalled out after jumping into the well. As the Ouestion Hour continued amid the noisy scenes, the BJP MLAs remained standing till its culmination.

As soon as the Question Hour concluded, the BJP MLAs staged a walkout from the House.

This was the first walkout by the MLAs in the autumn session.

The BJP MLAs shouted slogans against the government, sought an apology from CM Abdullah for "unfulfilled promises", and also demanded his resignation (Agantica) ignation. (Agencies)

Today I am allowing members to raise certain important issues beyond the Zero Hour. It is a onetime exception and will not form a precedent for future proceedings," Speaker said while allowing MLAs to speak on public issues, including the plight of flood victims of September 2025.

Emphasising upon the members to make judicious use of the limited time available, Speaker said that matters can be raised in the House in a constructive and respectful manner.

Earlier, Speaker had rejected an adjournment motion moved in by MLA Pawan Kumar Gupta for a discussion on the situation in the aftermath of the recent floods in Jammu and Kashmir. Citing procedural rules, Speaker said the House rules (Rule 58) do not permit an adjournment motion to be taken up after it has already been rejected once in the session.

However, he said that the entire House shares the plight of flood victims of September 2025, adding that their grievances and rehabilitation issues have to be taken up in the House and addressed with equal priority.

Later, initiating the debate, Pawan Kumar Gupta highlighted the severe damage caused by recent floods in the Jammu division, including his own constituency. He pointed out that the floods have extensively damaged houses, schools and other public infrastructure. Gupta emphasized that the relief efforts so far have been both inadequate and delayed, leaving affected people in continued hard-

Gupta said that affected people expect their representatives to raise their concerns in the Assembly, urging that there should be a broader discussion on the issue to ensure proper rehabilitation and ssistance to the victims.

MLA Tral, Rafiq Ahmad Naik while speaking on the issue urged upon the government for permanent restoration of damaged infrastructure in his constituency. He also raised upgradation of school infrastructure and other issues.

MLA Kathua, Rajeev Jasrotia participating in the discussion on flood relief measures said that government should frame a comprehensive plan for providing compensation to the affected population. He urged the government to take concrete steps for permanent restoration of defunct services in his

nstituency. MLA Beerwah, Dr Shafi Ahmad Wani said that the Omar Abdullah government is committed to fulfil promises made with the people. He said that a proper disaster management plan will be devised to minimise the losses suffered in the event of natural calamities, ensuring better preparedness and

timely response. MLA Rajouri, Iftikhar Ahmed raised the issue of shifting of District Hospital Rajouri, filling of vacancies and promotions in Baba Ghulam Shah Badshah University, besides issue of Katra Ropeway project.

Under the upcoming PMAY-G 2.0 phase, it was added that 5,02,101 household surveys have been conducted to identify new beneficiaries. Additionally, the Ministry of Rural Development, Government of India, has approved 5,061 houses under a special project for families affected by natural calamities. Registration for this special project is scheduled

to conclude by October 31, 2025. The Chief Secretary commended the department's significant progress in rural sanitation under Swachh Bharat Mission-Gramin, noting that the Union Territory is on track to achieve

100% ODF+ Model status across all villages. DG, Rural Sanitation, Anoo Malhotra, apprised that out of 6,216 villages, 6,115 have already been declared as ODF+ Model – achieving 98.38% saturation. The remaining 69 villages are expected to attain ODF+ Model status by mid-November 2025.

Webinar on Traditional Earthquake - Resistant **Buildings Held**

SRINAGAR, OCT 30: The National Institute of Disaster Management (NIDM), in collaboration with the Indian Buildings Congress (J&K Chapter), organized a nationallevel webinar on "Earthquake-Safe Construction Practices with Focus on Traditional Taq System."

In his inaugural address, Dr. Amir Ali Khan, Head of the Resilient Infrastructure Division, NIDM, emphasized the significance of traditional and indigenous construction techniques in enhancing regional disaster resilience. He noted that such systems are also widely practiced in other earthquake-prone regions, including Himachal Pradesh and the North East.

Er. Aamir Ali, Chairman, Indian Buildings Congress (J&K Chapter), highlighted the historical evolution and

durability of timber-laced masonry (Taq) structures, which have withstood several major earthquakes over the centuries. He stressed the importance of integrating traditional construction wisdom with modern engineering practices to promote safer and more sustainable buildings.



Dr. Hakim Sameer Hamdani, Design Director, INTACH Kashmir, delivered a detailed technical presentation on the Taq system, explaining how it uses brick, clay mortar, timber, and stone in a composite design. The embedded timber lacing, he said, ties the walls together, providing ductility and enabling the structure to flex and absorb seismic shocks.

The webinar drew participation from over 100 academicians, engineers, architects, students, and members of the Indian Buildings Congress from across the country. The session was moderated by Azra Mahwash, Consultant, NIDM, and co-moderated by Prateek Roshan, Consultant,

SRINAGAR, OCTOBER 30: Ensuring strong cognizance of the Hygiene and Sanitary violations by the Retail Meat Shops, the Food Safety Wing (FSW) of the Drugs and Food Control Organization (D&FCO), J&K has taken strict action against 05 fresh meat sellers who were found keeping carcasses of meat hanging outside

the shops at Hazooribagh and Nowgam by issuance of prohibition orders by Designated Officer in District Srinagar.

These Butchers were found repetitive offenders violating the FSS Rules and Regulations, despite being given warnings and sufficient time period in previous inspection drives. Under these orders, the sale and slaughtering activities within their shops have been pro-

hibited until further notice.

Meanwhile, the Commissioner, Food & Drugs Administration, Smita Sethi, chaired a meeting with the Kashmir Butchers Association, led by its President, Khazir Mohammad Regoo, along with other office bearers.


Mega Fruit Mandi on 300 Kanals being established in Kulgam: **Agriculture Minister**

The Minister said this while replying to a question raised by Legislator, Abdul Majid Bhat Larmi regarding compensation for crop losses to farmers in Legislative Assembly today.

He said that the department has already established $two \, Fruit \, and \, Vegetable \, Markets \, in \, the \, district \, An antnag, \,$ at Batengo and at Jablipora, which are functional and adequately cater to the marketing needs of the growers and traders of the entire district. He also added that in Kulgam district one mandi namely Apni Mandi has been established at Nunmai, which is at developmental stage.



The Minister further informed that damages to Horticulture crops in J&K has been assessed over an area of 531.06 ha, however, as per SDRF/NDRF norms compensation is admissible only for crop losses exceeding 33% which accounts for an area of 431.091 ha.

He also added that in South Kashmir districts of Anantnag, Kulgam and Pulwama, a total compensation Rs 4.088 lakh has been paid.

The Minister further informed the house that there is one C.A. Storage Unit with capacity of 5000 MT in Anant-

He said that CA stores are established by private entrepreneurs and Government provides subsidy for the same. He added that the assistance is open to any entrepreneur who is willing to apply as per the norms and

The Minister also informed that most CA stores are located in the Industrial Growth Centre at Lassipora, Pulwama, and the Industrial Estate at Aglar, Shopian, while as efforts are underway with the Industries and Commerce Department to establish sector-specific industrial estates for horticulture and post-harvest management in other

BUDGAM, OCTOBER 30: The District Legal Services Authority (DLSA), Budgam, organized an Awareness Programme on Alternative Dispute Resolution (ADR), Rights of Senior Citizens, and the Ill Effects of Child Marriage and Child Labour in collaboration with Government Higher Secondary School, Gogjipathri Nilnag, Chadoora.

The programme was conducted under the directions of Member Secretary, J&K Legal Services Authority, Shazia Tabassum,, under the supervision of Chairman, District Legal Services Authority, Budgam, O.P. Bhagat, and the active guidance of Secretary, DLSA Budgam, Nusrat Ali Hakak. Secretary, DLSA Budgam, was the Chief Guest on

the occasion. In her address, she deliberated upon the key themes of the programme and highlighted that the Alternative Dispute Resolution (ADR) mechanism primarily aims to provide a swift, cost-effective, and non-adversarial method for resolving disputes through mutual consent, cooperation, and understanding between parties. She emphasized that ADR helps reduce the burden on the judiciary while ensuring fair, accessible, and efficient delivery of justice.

Speaking about the Rights of Senior Citizens, she underlined the importance of protecting and promoting their welfare, dignity, and security in old age by shielding them from neglect, abuse, and exploitation. She emphasized that these rights aim to enhance the physical,

emotional, and social well-being of senior citizens, preserve their independence, and encourage their active participation in community life, enabling them to live with respect, comfort, and self-worth. She encouraged participants to adopt and promote ADR mechanisms as effective tools for dispute resolution.

The District Legal Services Authority, Budgam, deputed Chief Legal Aid Defence Counsel, Deputy Legal Aid Defence Counsel and Assistant Legal Aid Defence Counsel as resource persons for the programme. They delivered insightful presentations on various legal schemes and sensitized participants about their objectives and implementation.

In his address, Chief Legal Aid Defence Counsel, elaborated on the concept of mediation, describing it as a voluntary, confidential, and cooperative process of dispute resolution. He explained that mediation involves a neutral third party, known as the mediator, who assists disputing parties in reaching a mutually acceptable settlement. Unlike a judge or arbitrator, the mediator does not impose a decision but facilitates communication, promotes understanding, and guides parties toward an amicable resolution. He emphasized that the primary objective of mediation is to ensure a fair, speedy, and cost-effective resolution of disputes while preserving relationships, maintaining confidentiality, and fostering mutual respect. He also highlighted the importance of pre-institution mediation, arbitration, and other non-litigious

methods as effective tools for promoting peaceful and efficient dispute resolution. Deputy Legal Aid Defence Counsel, Budgam, spoke on the Rights of Senior Citizens. He stressed the importance of safeguarding the dignity, welfare, and legal rights of elderly persons, highlighting the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007. He explained that this law ensures social and economic security for senior citizens by placing a statutory duty on children and legal heirs to provide maintenance and by facilitating the establishment of old-age homes and welfare measures. He urged society to show greater compassion, respect, and care toward the elderly, recognizing them as valuable members of the community who deserve

protection and support in their later years. He emphasized that older persons should have the opportunity to realize their full potential and access the educational, cultural, spiritual, and recreational resources of society. He underscored that senior citizens deserve to live in dignity and security, free from exploitation and any form of abuse.

He further referred to recent Supreme Court judgments affirming that tribunals established under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 possess the authority to order the eviction of children or relatives who neglect their senior citizen parents. The Court has also ruled that such tribunals can revoke property transfers, including gift deeds, if the recipient fails to fulfill their duty of care. These rulings, he noted, reaffirm that laws concerning the welfare of senior citizens must be interpreted liberally to uphold their right to dignity, care, and secure living. Assistant Legal Aid Defence Counsel, also addressed the gathering. He emphasized the ill effects of child marriage and child labour, highlighting their grave consequences and the need for strong legal safeguards to protect children. He pointed out that child marriage deprives children, especially girl of their right to education and health, leading to early motherhood, domestic violence, and emotional distress. Similarly, child labour exposes children to exploitation, physical and mental harm, and denies them the opportunity to grow, learn, and thrive in a safe environment.

Avoid unnecessary blowing of sirens on roads

Some years back the Supreme Court of India issued directions seeking minimal use of the sirens by the government vehicles running on the roads across the country. The apex court had in fact made clear that sirens can be used by the ambulances while ferrying patients from one place to hospital or from one hospital to another hospital. It was observed that the unnecessary blowing of sirens impedes the movement of ambulances.

The apex court also observed that sirens can be used in some other situations but the condition for the same is that the situation should be of a dire nature or emergency. The directions might have been used in the different parts of the country but as far as the Kashmir valley is concerned there are very few takers. Every now and then there is blowing of sirens by official vehicles on the roads and as a result of the same the purpose of blowing sirens is not met.

In such a situation the blowing of a siren by an ambulance gets neglected by the motorists and the drivers pay no consideration. This often results in delay of arrival of a patient to a hospital and there are occasions when the same turns out to be fatal. Most of the drivers driving the official vehicles are not aware about the directions of the apex court or they violate the norms according to their own wish. These people need to be made aware about the importance of the blowing of a siren.

The official as well as other motorists should be counselled for minimizing the usage of sirens and it should be made clear to them that any violation in this regard would attract severe punishment. It is imperative to impose a penalty or take punitive action against the drivers found to be breaking the rules. Since law is equal for one and all it must be ensured that nobody takes the law into his or her hands. It is also important to impart education to the legislators in this regard.


Since each and every conscious citizen wants to follow the rules and regulations it should be kept in mind that the traffic rules and regulations are followed in letter and spirit. The motorists as a whole, especially those driving the official vehicles should give way to the ambulances so that there is no delay in the arrival of patients to the different hospitals.



Book Review: Bhalessa Cultural Heritage and History by Sadaket Ali Malik



In our era, in the neglected creases of the Himalayas, amidst whispering jungles and concealed ridges of Jammu and Kashmir, another such voice has been heard. Sadaket Ali Malik, a boy of the land from the distant hills of Doda, has written not only a book but a cultural declaration. His book Bhalessa Cultural Heritage and History, brought out in 2021 by HSRA Publications (ISBN: 9789390415809), is a candle of remembrance and reclamation. There have been very few occasions throughout the ages when the written word has moved beyond the role of recalling events and actually turned into a sacred vessel of remembrance, revolution, and continuity of culture. Such literature has not only reflected the past; it has shaped the collective psyche of civilizations. While Abul Fazl compiled the Ain-i-Akbari, he was not merely collating facts on the Mughal Empire. He created a vibrant edifice of rule and culture, demonstrating the intellectual strength of his era. When Al-Beruni traveled along the Indian subcontinent, his book Kitab fi Tahqiq ma l'il-Hind came to be a lasting record of cultural dialogue, presenting an unprecedented window into Indian philosophy and science with modesty and accuracy. And when Kalhana wrote Rajatarangini, he added to historical recounting poetry, spiritual depth, and human feeling, weaving a tapestry of Kashmiri past that lives through centuries. They were not professional chroniclers but visionaries by vocation. Their writings were acts of obligation issuing from the conviction that civilizations are lost not by conquest but by forgetting.

In our era, in the neglected creases of the Himalayas, amidst whispering jungles and concealed ridges of Jammu and Kashmir, another such voice has been heard. Sadaket Ali Malik, a boy of the land from the distant hills of Doda, has written not only a book but a cultural declaration. His book Bhalessa Cultural Heritage and History, brought out in 2021 by HSRA Publications (ISBN: 9789390415809), is a candle of remembrance and reclamation. In 164 pages, he has done what decades of neglect by the state and absence from academia could not. He has imparted identity, clarity, and dignity to Bhalessa. The book does not aim at fame through polemic. It does not scream. It breathes with sagacity, recalls with fidelity, and summons attention with the soothing authority of truth.

Bhalessa is not merely a place within the Doda district of Jammu and Kashmir. It is a cultural landscape made invisible in official discourses, overlooked by schoolbooks, and ignored by developmental imaginations. But in its silence there is a civilization. This land finds voice through the words of Sadaket. Not as relic or museum artifact, but as living, throbbing, changing part of India's soul. Malik is no detached observer. He is Bhalessa's witness, its chronicler, its champion. He brings not just scholarship but belonging. As a writer, teacher, social reformer, activist, he has the experience to combine narrative with the passion of justice and the elegance of perception.

The early chapters of the book describe Bhalessa's geography, but this is not dry reportage. Each riverbed, hill, forest, and valley is given the status of a character in a sacred narrative. One does not learn about Bhalessa. One starts sensing it. Its tough landscape, previously considered peripheral, is presented as being at the heart of the resilience and rhythm of its people. Nature in Malik's prose is alive. Not landscape, but

What ensues is a smooth and well-thought-out voyage through layers of time, society, and spirituality. The book moves with grace from historical roots to modern-day socio-political issues. It ventures into administrative frameworks, communal dynamics, and the evolving nature of education. It ventures into the forgotten and existing cultural heritage of the people – their music, language, customs, and conflicts. Malik does not simply chronicle. He crafts an experience. Every chapter succeeds the previous one with the narrative structure of a symphony where data intersects devotion and facts are contained in feeling.

Central to this work is Malik's respect for the intellects and souls that were born in Bhalessa. The book is a literary shrine to the intellectuals, teachers, and religious leaders who defined the identity of the land in spite of its marginalization. From Prof Umar Din to Ghulam Rasool Azad, from Munshi Muhammad Anwar to Ghulam Nabi Azad, Malik brings to life their memories. Most touching is his obituary to Alhaj Ghulam Qadir Gani Puri (RA), that towering figure of spirituality whose life of learning and serving others becomes, in Malik's words, a lighthouse in the fog of forgetfulness. The tone is earthy. Never holier-than-thou, always genuine.

Two chapters give a glimpse of Malik's vision more than any other. The ones on tourism and education. Here, he dreams not with naivety but with rational reasoning. He asks the country to look at what has been overlooked for so long. The untouched beauty of Bhalessa's peaks, meadows, and streams, which if nurtured, could improve its economy as well as selfesteem. But tourism in this context is not suggested as exploitation but invitation. A means of entering into conversation with an unrecollected beauty. Education, however, is presented not merely as upliftment but as defiance. In an area ravaged by state indifference, Malik demonstrates how schools have become bastions of hope and teachers — foot soldiers of dignity. His account in these pages is both a critique and a blueprint.

Malik's methodology of digital preservation is an indicator of his deep consciousness of the shifting tides of memory. By creating a Wikipedia page and a separate website for Bhalessa, he has provided assurance that the legacy of his native land will not get lost in the ocean of unrecorded history. In this, he follows the line of thinkers who knew that in the 21st century, to be searchable is to be noticed and to be archived is to be remembered. His effort is momentous. The first such digital move by a native scholar for the region. It opens a new chapter in local historiography.

The book's organization is natural but controlled. It has the rhythm of a mountain stream. Flowing, consistent, life-giving, but never stagnant. The style is neither abstruse nor naive. It spans the ordinary reader and the intellectual. Its strength is in clarity, not abstractions. The vocabulary is refined, the tone sympathetic, the message clear.

What remains longest in the reader's mind, however, is the emotional undertone. Under each statistic, each footnote, each respectful profile is a grief. The sorrow of exclusion. But Malik never lets pain turn into resentment. He converts tears into determination and invisibility into vision. His affection for Bhalessa is not wistful. It is imperative. He knows that history, when forgotten, does not lie dormant - it perishes. And thus he writes not to conserve the past but to challenge the future.

By Malik's hand, Bhalessa ceases to be a distant place and becomes an incandescent presence in the great tapestry of India. Its character is not merely defined by ritual but by the gentleness of its people, the interfaith tolerance that characterizes its roads, and the dignity with which its citizens live, labor, and aspire. Malik demonstrates that cultural pride, when based on respect and memory, is the corrective for marginalization.

This book is a necessity. It is in the hands of every historian student, every policymaker with a belief in inclusive politics, every teacher with a belief in silent revolutions, and every reader who has a belief that no corner of the world, however small, lacks greatness. It is not a regional book. It is a national imperative. It cries out not in loudness but in reason, telling us to remember, to rethink, and to rebuild.

Bhalessa Cultural Heritage and History is not a book. It is a radiant gift. It is the spark of an extinguished lamp relit by the hands of one who did not forget. Sadaket Ali Malik has given the region of Bhalessa not only a voice but a visionary. He has shown the world that one pen, inspired by duty and love, can stir the world awake. For this gift, he is not just worthy of recognition. He is worthy of reverence. Along with Al-Beruni, Abul Fazl, and Kalhana, his position is among those who remembered so that we would

Jayanta Mahapatra Gave Indian English Poetry A Global Height

He wrote in Odiyan but he even when he wrote in English Odisha is pervasively in his imagination. Odisha for him is India and the picture that he portrayed of Odisha is in reality the picture of India itself. What is more interesting that he commands more respect overseas than at home. This poet is Jayanta Mahapatra who elevated Odiyan Poetic literature nay Indian English poetry to a global height. Seven out of his 25 collection of poems were published abroad. His work appears in prestigious international $anthologies \, including \, The \, Vintage \, Book$ of Contemporary World Poetry (Random House, New York, 1996) and The Poetry Anthology 1912-2002 (Ivan R.Dee, Chicago, 2002). He focused in his poetry the regional perspective of Orissa though that symbolised India as a whole and he lifted it to a global height.. In Door of Paper: Essays: Memoirs, he wrote about his work, his thoughts on poetry, the creative process, social issues like hunger and poverty, and natural disasters like the cyclone in Orissa where he lives. His book of poetry, The Lie of Dawns: Poetry 1974-2008, gives us a picture of bleakness and barrenness. I recall what he told me in Pondicherry explaining the reasons why his Chandrabhaga stopped as a literary periodical for want of money.In the land of Kalidas and Tagore all other magazines -graphic or fashion or movie magazine get huge funding not the literary ones. His fame as a original thinker spread among the admirers of h his poetry. The anthologies that he published were all replete with these characters .They include 'Close the Sky','Ten By Ten', A Rain of Rites, Relationship, Life $Signs\,, AWhiteness\, of\, Bone, and\, Shadow$ Space. Besides being a poet, he was also a regular translator and rendered into English Odiyan writing of the poets like Gangadhar Meher, Sahi Routray, and Jnanpith awardee Sitakanta Mahapatra .Besides Chandrabhaga, he edited Kavya Bharati, and worked for the poetry section of the Telegraph. Even after being the recipient of the Sahitya Akademi Award and Padma Shri Award, and finally the SAARC Literary Award, he was not at all serious about awards. He rejected the Padma Shri Award in protest of increasing intolerance in the country. It was a bold step for a poet. He focused in his poetry the regional perspective of Odisha though it always symbolised India as a whole and he lifted it to a global height.

I had an opportunity to meet Jayanta Mahapatra in Pondicherry University Hall where he launched my poetry book Oleander Blooms I still recall the day when Jayanta Mahapatra who in a long interview told me that, he had been a chronic patient of asthma and recurrent migraines. Moreover, after the passing of his wife, he was internally shaken and weakened. However, he never lost his zest for life.. At 95 he suddenly left us leaving behind him a treasure house of poetic gems . I feel the deepest grief but still feel; proud that I met one of the bravest poets who was also widely known as one of the Trio who laid foundation of Indian English poetry the other two being A.K Ramanujan and R Parthasarthi. I like Mahapatra's poems as they demonstrate remarkable concern for both structure and linguistic versatility in both Orivan and English, yet this legendary poet of Indian English literature was all through an Odiyan poet..

Being a boy from the village and especially a backward Orissa village, he knew the rural poverty and hunger He did not think that the situation in the village had really changed .Poverty compels the parents to sell daughters and even today the tradition continues. In his autobiography his narrative reflects his anger. Mahapatra's poetry is remarkable for depth of feelings and true poetic imagination which embraces a wide variety of such themes. His poetry evokes intense emotional benefits out of things around him. His poetic imagination transforms the events into verse. Patna University was one of the best universities of India in his eyes. He was studying in that university.He was living in a small mess, small verandah, and small rented building. They were about ten students and were rented small rooms from a professor of the engineering college, Prof Ojha. The building in which they were staying was near to the Mahendru Ghat and law college. In 1949-50 he completed his Masters in Physics and in between he had to leave Patna because of the riots. A young aspiring man from Tinkonia Bageecha, Cuttack of Orissa who loves his mother tongue wrote what he felt from his own heart and from his own inside. This is later his advice also to the budding poet. In an interview with me he once told that this speaking from inside helps any writer. At first he was writing stories in the beginning, but these stories were not published, they were all rejected. What Thomas Hardy did with his Wessex novel in British literature, Jayanta Mahapatra did almost something like that transformation of the regional into the global with his poetry in India . Poems of Jayanta Mahapatra – the doyen of Indian English Poetry demonstrate remarkable concern for both structure and linguistic versatility in both Odiyan and English, yet he was all through an Odiyan poet...

The sense of failure and suffering is very much needed for being a writer. If



one has enough money to eat or a good house and a car, no one will be eager to write. `If you have no problems, why willyou write? "Jayanta Mahapatra asked me at the first meeting. Unless we have reasons to think we cannot write, ideas will not come to our mind. For ideas we need the poetry because in poetic language images supplement our ideas. He was eager to use new ideas which never come to literature before. Mahapatra's poetry is remarkable for depth of feelings and true poetic imagination which embraces a wide variety of such themes. His poetry evokes intense emotional benefits out of things around him. His poetic imagination transforms the events into verse. Being a contemporary of Ramanujan , Nissim Ezekiel and Parthasarathy, he stressed on the morality and the inner workings of the human mind when he was depicting love, sex and marriage in his poetry. M.K Naik correctly observes "Mahapatra's poery is redolent of the Odishan (Orissan) scene and the Jagnnath temple at Puri figures $quite\,often\,in\,it." Jayanta\,Mahapatra\,uses$ symbols rooted in his native state of Odisha to explore themes of tradition, spirituality, and the universal human condition. His symbols often juxtapose the region's ancient glory with the contemporary plight of its people, creating a microcosm for a larger Indian-and human-experience. The holy city of Puri is a prominent setting in Mahapatra's work, particularly in his famous poem "Dawn at Puri". Similarly in the poem Taste for Tomorrow he depicts a scene at Puri with crows making a noise. It has a very wide street with its lepers and religious people thronging at the door of the temple. Puri figures prominently in various poems of Mahapatra. The temples of Puri and Konark also have an impressive room in his poems. Cuttack

, Bhuvaneshwar and Puri form the background of his several poems. He once voiced this dilemma: "I am in love with English, And then my schooling was in English and I learnt my languae from British English Masters- mainly from English novels; so blame H.Rider Haggard and Edgar Rice Burroughs and Ballantyne from whom I caught the first delight of words gravid with meaning. Further I feel I can express myself better in English than in Oriya. And I have done a lot of translations in verse from Oriya." In some other poems such as The Orissa Poems, Orissa Landscapes and Evening in Orissa Village Mahaputra deals with Odishan landscape, its culture and the ancient history of Odisha. These poems have powerful Odishan idioms and usages and Mahapata's treatment of the landscape imagery makes the readers feel that they are transported to that region of the country. The poem 'Evening Landscape by the River ' gives a graphic description of a gloomy scene where the poet visualizes his own death. This self assimilation is really wonderful in his poetry. His psychological and philosophical themes are found in poems like The Exile, The Abandoned British Cemetery at Balasore, Total Solar Eclipse The Logic and Grass. In the Total Solar Eclipse he offers a critique of the superstitious approach of the Brahmin priest regard $ing \, the \, Eclipse. \, The \, realistic \, effect \, in \, The \,$ Moon Moments is clear in the feeling of the social concern "These women talking outside have clouds passing across their eyes. "The poet says, "How can I stop the life I lead within myself-/ They startled, pleading questions in my hands lying in my lap while the gods go by ,triumphant" The Exile is again a philosophical poem known for its realistic elements" It is an exile / Between good and evil/Where I need the sting of death"

. The poet can depict the silence of the cemetery in the poem and he can himself say,What appears to disturb me is the triumph of silence in the mind. "Jayanta Mahapatra's poem "Ash" uses the physical remnants of his deceased father's cremation as a metaphor for mortality, memory, and the transient nature of life. The poem reflects on loss and the inevitability of death, contrasting these with the fleeting beauty of nature and the hopeful, yet uncertain, search for continuity. The speaker finds solace in the cycles of nature, while simultaneously acknowledging a sense of melancholic finality. "Jayanta Mahapatra is a modern poet known for post colonial themes, his focus on Indian social issues, and a unique discursive style. His masterful use of imagery to create a vivid, postcolonial Indian landscape from the experience of the post-colonial era, addressing themes of identity, culture, and social issues with a voice shows the distinct colonial influences. The poet is known for tackling difficult subjects such as poverty, violence, religious bigotry, and the exploitation of women and children with a sense of sympathy and urge. But each time his poetry is strongly rooted in the local context of Odisha, using its culture, landscape, and life as a central subject for his verse. Thus Jayanta Mahpatra stands out clearly as an observer of the reality around him. He wasless interested in building a perfect millennium, rather he ws interested in ensuring the contnued existence of man. His characters are from the lower hierarchy of the society.- cobbler, starving street kids, slum residents, prostitutes, and a hurting woman. In Pondicherry when I talked to him personally he asked me why I write in English and not in mother tongue. This shows how like Tagore he preferred to write in his mother tongue .Many still surmise, that he studied :Physics and yet became the legendary figure in laying the foundation of Indian English Literature with R Parthsarathy and A.K.Ramanujan . More surprising thing is that he hardly mentioned the name of the English Poets- British or American literature like Shakespeare or Whitman, Eliot or Yeats . The simple logic he used to give that he did not study English literature. Here the question of inspiration is important For Jayanta Mahapatra the main source of inspiration comes from the people of his state, nay the country. The socio-political injustice that he witnessed all around him led him to write and that one may call poetry or literature. Even if you don't want to agree , you may not. But that was his inspiration for writing.

The predominance of one language is not required to maintain Indianity, but coexistence and respect for all Indian languages.

Encouragement of multilingualism: Effectively implementing policies such as the tri-lingual formula in education, which promotes mother tongue/regional language, Hindi (in non-Hindi states), and English can be a balanced approach.

Cultural preservation: It is the preservation of linguistic and cultural diversity that $strengthens, not weakens \, In dians. \, The \, true$ identity of India lies in its multiplicity, where each language and culture contributes to the national consciousness. In today's age, when English has grown in influence and the use of regional languages is declining in urban life, the question arises whether Indians should be combined with language.

Does the English-speaking Indian get away from his India? Maybe not. Indianity lies not only in language but also in thought, behaviour and values - respect for others, acceptance of diversity, and the spirit of Vasudev Kuttakum.

Yet, language is the basis of our identity. When we don't respect our mother tongue, our cultural roots begin to weaken. Language is not just a medium of communication, but an emotional and cultural heritage. Thinking and creating in the mother tongue deeply connects a person to his environment.

So "Language vs Indians" is not a conflict, but a coexistence relationship. Every Indian language has its share of Indianship. Indians are not tempted by a single language, but in the beatings of every one.

In the end, true Indians are those who respect every language, and understand that India's real power lies in its linguistic diversity--the very diversity which does not divide us but unites us.

Tobacco on the rise in Jammu & Kashmir: A growing public health challenge

Tobacco use has quietly become one of the most serious public health challenges facing Jammu and Kashmir. Despite awareness campaigns, government regulations, and warnings printed on every packet, tobacco consumption continues to rise across the region. From bustling city streets to quiet villages, smoking and other forms of tobacco use have become deeply embedded in daily life — cutting across class, gender, and age.

Recent national health surveys place Jammu and Kashmir among the states and union territories with the highest rates of tobacco consumption in India. The latest data from the Global Adult Tobacco Survey (GATS-2) and the National Family Health Survey (NFHS-5) show that 23.7 percent of adults in the region use some form of tobacco. Of these, 20.8 percent are active smokers, while 4.3 percent consume smokeless forms such as gutkha or snuff. These figures point to a worrying trend that shows little sign of slowing down.

The gender gap in tobacco use is substantial but telling. Nearly 35 percent of men in Jammu and Kashmir are smokers, compared with just 5 percent of women. While female smoking remains relatively uncommon, changing lifestyles and urban influences could shift this pattern in the future.

Equally striking are the district-level disparities. In some areas, tobacco use has reached alarming levels. Kupwara, at more than 56 percent, tops the list, followed by Shopian (52 percent), Bandipora (49 percent), and Anantnag (48 percent). In contrast, Jammu district reports significantly lower rates, suggesting that while intensity varies, tobacco use has spread across nearly every corner of the Union Territory.

Perhaps the most disturbing aspect of this crisis is the growing prevalence of smoking among adolescents and young adults. A recent survey conducted in Srinagar revealed that nearly one in four school-going students - about 23 percent - are active smokers. The findings expose how early experimentation with tobacco often evolves into addiction, locking young people into a habit that may last a lifetime.

Despite the ban under the Cigarettes and Other Tobacco Products Act (COTPA), students continue to report easy access to cigarettes and other tobacco products, often sold by local vendors near schools. The sale of single cigarettes allows minors to purchase discreetly, while the increasing popularity of hookah



lounges - offering flavored tobacco marketed as a social pastime – has normalized smoking among the

The long-term implications are profound. Early exposure to tobacco drastically increases the likelihood of chronic addiction and related health problems. In a region already burdened by unemployment and psychosocial stress, tobacco often becomes a coping mechanism — an illusion of relief that leads to greater physical and mental harm.

Tobacco's deep cultural roots in Kashmir further complicate the problem. For generations, the hookah has been a familiar presence in rural households, symbolizing hospitality and communal bonding. While modern cigarettes have replaced traditional hookahs, the underlying acceptance of smoking has endured. This social tolerance makes it difficult to stigmatize tobacco use or enforce restrictions, especially within close-knit communities where smoking is seen as a

The health consequences are devastating. Tobacco is a leading cause of preventable deaths and a major contributor to cancers, heart disease, and respiratory illnesses. Hospitals across Jammu and Kashmir are witnessing a steady increase in cases linked to tobacco use, particularly among middle-aged men. The economic cost is equally staggering. It is estimated that residents spend hundreds of crores of rupees each year on tobacco products – a sum that does not include the medical bills, lost income, and long-term care that

Although officials claim a slight decline in tobacco consumption — around two to three percent over recent years — the reality is far more complex. While urban centers show some improvement due to enforcement and awareness, rural and semi-urban areas remain deeply affected. Moreover, a drop among older smokers is often offset by rising use among younger people, threatening to undo any progress

The government has launched several initiatives under the National Tobacco Control Programme (NTCP). Cessation centers have been established, awareness campaigns intensified, and fines introduced for smoking in public places. Educational institutions regularly host anti-tobacco events, and advertisements warn about the health risks. Yet, enforcement remains inconsistent. Smoking in public spaces is still widespread, and sales near schools continue largely

One major obstacle is easy availability. Cigarettes and bidis can be found in almost every neighborhood shop, often sold without regard for age or distance from schools. Their affordability also keeps demand high, particularly among lower-income groups. Many users underestimate the dangers of "occasional smok-

ing," while cultural acceptance discourages people from quitting.

The problem extends beyond smokers themselves. Second hand smoke exposes countless non-smokers including children and women – to harmful toxins at home and in public. Surveys indicate that more than half of adolescents in Jammu and Kashmir are exposed to secondhand smoke in public places, increasing their vulnerability to respiratory diseases and heart condi-

Addressing this growing crisis requires sustained, multi-dimensional action. Stricter enforcement of existing laws must become a priority. Public smoking should be penalized more consistently, and sales of tobacco near educational institutions must be completely banned. Increasing taxes on tobacco products can make them less affordable, especially for young consumers.

Equally vital are education and awareness efforts that go beyond slogans. Schools, colleges, and community organizations must play a central role in teaching young people about the dangers of tobacco. Campaigns should highlight not only health risks but also the social and economic costs of addiction.

There is also an urgent need for accessible cessation support. Many smokers express a willingness to quit but lack guidance or counselling. Expanding cessation centers, integrating tobacco control into primary healthcare, and using digital tools for follow-up support can greatly improve outcomes. Community and religious leaders, too, can help by promoting a culture that discourages smoking and emphasizes self-discipline and health.

Accurate data and regular monitoring are essential for informed policymaking. Without updated statistics and local-level studies, interventions risk being sporadic and ineffective. Coordination between govern $ment\,departments, educational\,institutions, and\,health$ professionals can ensure that tobacco control efforts remain focused and evidence-based.

Tobacco addiction is not merely a personal habit; it is a social and economic epidemic. The rising rates of tobacco use in Jammu and Kashmir threaten to undermine years of progress in public health and place an enormous strain on the region's healthcare infrastructure. Every cigarette smoked and every hookah lit carries a cost — one paid not only in money, but in years of life and the health of future generations.

The fight against to bacco will not be won overnight, but it can be won through persistent effort and collective resolve. Jammu and Kashmir stands at a critical crossroads: either allow this silent epidemic to tighten its grip, or act decisively to protect the health and well-being of its people. The choice, and the responsibility, belong to all.

Violation of Earth Lifting Terms in Baramulla: **Vehicles Seized**

BARAMULLA, OCT 30: Serious violations have been detected in the earth lifting operations from Baramulla's "Singapore" area to Hadipora, where several truckloads of extracted material were allegedly diverted and dumped at unauthorized sites.

As per official sources, permission had been granted for lifting 708 metric tonnes of earth material strictly for a specific purpose and destination. However, instead of following the approved route, multiple dumpers were seen unloading the material near the Baramulla railway station, in clear violation of the permit conditions.

Sources said that although the permission was issued under a particular name for transportation to a designated site, some individuals allegedly sold the extracted material to local buyers, converting the permitted activity into unauthorized commer-

Confirming the violations, District Mineral Officer (DMO) Baramulla, Zulfikar Mohammad Shafi, said the department had seized one vehicle involved in the illegal operation. "We have seized the vehicle for violating the terms. Anyone found misusing permission or transporting material without autho-

rization will face strict action," the DMO said. "Those who adhere to the rules and have valid permits may continue their work as per norms," he

Authorities have initiated a probe to identify others involved in the misuse of permits, warning that stern action will be taken against violators.

Government finalises framework for transfer of **M2M SIM ownership**

NEW DELHI, OCT 30: The Department of Telecommunications (DoT) today issued an office memorandum notifying the framework for transfer of M2M SIM ownership from one M2M Service Provider (M2M SP)/Licensee to another M2M Service Provider (M2M SP)/Licensee, an official

Basically, this framework establishes a formal procedure for M2M SIM ownership transfer to ensure a smooth and compliant transition without service discontinuity. This is applicable to all M2M SIM Service Providers (M2MSPs)/Licens-

Currently, there's no provision for a change in the name of M2M SIMs under the prevailing guidelines, so M2M services for the affected end consumers may get disrupted whenever there is a situation that necessitates a change of M2MSP.

An 'M2M (Machine-to-Machine) SIM Card' refers to a specialized SIM for devices to communicate with each other automatically over cellular networks without human intervention.

The streamlined process introduced by government for M2M SIM Ownership transfer has key steps including: (i) Transfer request to be raised by M2M $Service\,User/Third\,Party\,(ii)\,No\,Objection\,Certificate$ (NOC) by Transferor (Existing M2MSP/Licensee) (iii) Understanding by Transferee (New M2MSP/Licensee)(iv) Verification, KYC and update by Access Service

Importantly, each M2M SIM must at all times remain mapped to an M2M SP/Licensee, and there shall be no discontinuation of M2M service to the user, the statement added.

The introduction of this framework underscores DoT's sustained efforts to safeguard enduser interest while supporting the operational flexibility of service providers. This will also make India's M2M and Internet of Things (IoT) services reliable and future-ready.UNI

SEBI Puts Vedanta Group's Sterlite Electric IPO On Hold

MUMBAI, OCT 30: The Securities and Exchange Board of India (SEBI) has officially announced that it has placed Vedanta Group company Sterlite Electric's proposed initial public offering (IPO) on hold.

The company had filed its draft red herring prospectus (DRHP) with SEBI earlier in October 2025. The IPO comprises a fresh issue of up to 77.93 lakh

equity shares and an offer for sale of up to 77.96 lakh shares, aggregating to a total of 1.56 crore equity shares.

Sterlite Electric, which operates in the power transmission and distribution segment, manufactures and supplies a wide range of overhead conductors, power cables, optical ground wire, as well as provides master system integration services. It has customers in over 70 countries, including the USA, Brazil, Sweden, South Africa, Egypt, the UAE, Chile, and Peru.

The company is majorityowned by Twin Star Overseas, while Vedanta Ltd held a 1.51

per cent stake as of March 2025. The company's promoter, Anil Agarwal, who is Chairman of the Vedanta Group and Twin Star Overseas Ltd, is scheduled to participate in the Offer For Sale (OFS) along with other sharehold-

Proceeds from the proposed IPO issue are meant to be utilised for repayment or prepayment of borrowings, funding capital expenditure requirements, and general corporate purposes.

Twin Star Overseas Ltd is the promoter offloading the stake through the Offer for Sale (OFS) route. It holds 69.46 per cent of the pre-IPO equity capital in Sterlite Electric. The Mauritiusregistered firm is a subsidiary of Vedanta Resources Ltd and acts as a parent organisation for companies like Sterlite Technologies Ltd, Sterlite Electric Ltd, and Serentica Renewables India 9 Ltd.UNI

Amazon cuts 14,000 jobs

NEW YORK, OCT 30: Ecommerce major Amazon said it would cut 14,000 corporate staffers this year in a mass layoff aimed at readying the company for wide adoption of AI technology.

The company noted that it would be hiring in key areas and would prioritize those who lost their jobs for those roles. But the company also said it wasn't done with layoffs, reports CNN.

"We expect to continue hiring in key strategic areas while also finding additional places we can remove layers, increase ownership, and realize efficiency gains," said Beth Galetti, Amazon's senior vice president of people experience in a memo to employees that the company put on its public blog.

Reuters, which on Monday first reported Amazon would lay off staff, said the job cuts could ultimate-



ly reach 30,000.

Galetti said Amazon needs to operate more leanly to achieve CEO Andy Jassy's vision of operating like the world's biggest startup. Jassy wants the company to remain nimble so it can adapt and change quickly as AI upends the technology sector.

"What we need to remember is that the world is changing quickly. This generation of AI is the most transformative technology we've seen since the Internet, and it's enabling companies to innovate much faster than ever before," Galetti said. "We're convicted that we need to be organized more leanly, with fewer layers and more ownership, to move as quickly as possible for our customers and business."

Amazon has over 350,000 corporate employees, according to a 2024 survey filed to the US Equal Employment Opportunity Commission, so the cuts represent about 4 percent of the company's overall

Layoffs will begin Tuesday. Most employees will be given 90 days to look for new roles internally, while people that can't get new jobs at Amazon will be given severance pay and additional benefits.UNI

India's GDP growth this fiscal at 6.5pc, with risks tilted to downside: Crisil

NEW DELHI, OCT 30: India's gross domestic product (GDP) growth this fiscal is projected at 6.5 per cent, with risks tilted to the downside, according to a CRI-SIL report, released today. This is mainly driven by strong domestic consumption, a good monsoon, tax relief, and anticipated interest rate cuts.

Pointing towards the downside, CRISIL noted that exports to the United States (US) shrank by 11.9 pc year-on-year in September as higher tariffs kicked in. The rating agency also showed some optimism if a trade deal with the US were concluded soon.

Also, the rating agency attributed the subdued growth in primary goods, which led to the steady industrial growth as measured by the Index of Industrial Production (IIP) at 4pc year-on-year in September from 4.1pc in August.



The Credit Rating Information Services of India Limited (CRISIL) said, "The September quarter, however, saw a strong 4.1 per cent growth compared with 2 per cent in the June quarter, which is driven by the infrastructure and construction goods (11.5pc vs 6pc),

consumer durables (7pc vs 2.7pc) and primary goods (2pc vs 1.4pc) segments."

CRISIL sees an interplay of downside and upside risks of growth. The downside risks stem from an uncertain global environment, and upside risks from the improvement in domestic demand conditions post the Goods and Services Tax (GST) ratio-

De Kock Rediscovers

Purpose After Break Now a senior voice in a new dressing room, de Kock comes into the Proteas set-up with fresh perspectives

ST LUCIA: Quinton de Kock had to walk away from his childhood dream of becoming an international cricketer to realise he hadn't quite fulfilled as much of it as he wanted. And he did it quietly.

After South Africa lost last year's T20 World Cup final in heart-wrenching fashion by seven runs to India, de Kock, in his words, "disappeared".

He hadn't retired from T20Is, hadn't said any goodbyes, and simply wasn't named in any of South Africa's squads. Rob Walter, now the former white-ball coach, spent press conference after press conference saying he hadn't spoken to de Kock and had no idea of his future plans until, eventually we stopped

Everyone - with good reason - assumed, $de\,Kock\,was\,done.\,He\,popped\,up\,in\,T20\,leagues$ as one spring came and went, but by the time another arrived, de Kock had spent enough time in the cold.

"I missed the camaraderie and the whole thing of representing the Proteas," de Kock said in his first media interaction post-comeback. "I'd played so much for the Proteas over the years that I kind of forgot about that feeling, as a kid that's grown up to be a Proteas

"After having a bit of a break from the team, that childhood dream came back."

Many players say this kind of thing when they walk away: the achievements will blur into the background and it's the friendships they'll miss. Some keep them going at league level, and de Kock has, but not many return to make new connections. De Kock has decided that's what he wants.

"What I've really enjoyed is all the new faces," he said. "There's only a handful of the guys who are still here from when I left. Now I'm playing with a whole bunch of youngsters, new guys, new coaching staff, so it's quite refreshing. I'm making some new friends now and there's a new style within the team."

Those words may sound strange to those, like many of us, for whom de Kock is still the uber-talented 20-year-old who burst into South Africa's squad in late 2012. But 13 years have passed, de Kock is 32 and is South Africa's 10th most-capped international across all formats. Not much has changed about his public persona - he still "just doesn't watch cricket," - and didn't say much about the women's team making their first ODI World Cup final, but he's no newbie. He is a senior and he intends to behave like one.

"Apart from trying to win games, I'm going to try to help youngsters grow in their careers. Obviously, I play a lot more international cricket than a couple of the guys on the team, so I'm just here to help them out where I can," he said. "When I started, one of the big guys that I stuck close to, and is now one of my very good friends is Dale Steyn.

"He taught me a couple of lessons along the way that really helped my career. A couple of the youngsters have been asking me questions and how to improve their game, so I'm happy to be here and help where I can, kind of like what Dale did for me. If I make an impact in their careers, it will be great. It's very different, me coming back as one of the older guys. I've always been used to being one of the young guys in the team. So it's a bit of

Equally, it will take some getting used to that de Kock, a former captain, is not guaranteed a place on reputation alone and he knows it. "I don't think the door is completely open for me," he said. "I still need to come here and

After only two matches, the comeback's sample size is small but de Kock hasn't had it all his way. He was out for 1 against Namibia earlier this month and made a good-looking 23 off 13 balls against Pakistan in the first T20I. Both times, he sliced the ball to fielders, which may indicate a little patience is required. De Kock's time away, mostly spent as father to a young daughter, is likely to have taught him some. With the calendar head, he has more than enough matches to show it.

South Africa play two more T20Is against Pakistan followed by three ODIs. Then, after two Tests in India (which won't feature de Kock), they will play three ODIs and five T20Is in India in preparation for next year's T20 World Cup. If de Kock is included in the India series, it would be a strong sign that he is being considered for the World Cup, but he isn't thinking that way yet.


