

## **Operation Sindoor Proved India Can Act** Firmly Against Terror': President Murmu

Success of mission hailed as defining moment in nation's counter-terror strategy at Chanakya Defence Dialogue-2025

SRINAGAR NOV 27: President Droupadi Murmu on Thursday declared that Operation Sindoor had demonstrated India's ability to respond to terrorism with decisive force and moral clarity, asserting that the world now recognizes the country's strengthened counter-terror capabilities. She was speaking at the inaugural session of the third edition of the Indian Army's 'Chanakya Defence Dialogue-2025' in the national capital.

Calling the operation a "defining moment" for India's deterrence strategy, the President said it showcased not only military preparedness but also the nation's commitment to act responsibly while ensuring peace. "The success of Operation Sindoor represented a defining moment in India's counter-terror and deterrence strategy. It demonstrated the nation's military strength as well as its moral



clarity in acting firmly yet responsibly to maintain peace," she said.

President Murmu praised the armed forces for their professionalism across conventional warfare, counter-insurgency operations, and humanitarian missions, noting that they have consistently shown remarkable adaptability and resolve. She

also highlighted the Army's contributions to national development, from improving border infrastructure and connectivity to supporting tourism and education in remote regions.

Pointing to the rapid evolution of global security dynamics—driven by technological advancements, shifting alliances, and emerging domains such as cyber and space the President said India's strategic conduct remains rooted in its civilisational ethos of Vasudhaiva Kutumbakam. This approach, she stressed, balances strategic autonomy with global responsibility.

Murmu lauded the Army's sweeping reforms under its 'Decade of Transformation' initiative, aimed at modernising structures and capabilities to remain ties to remain corts, she said, efence self-reliess.

### Valley-Wide Raids Target Jel-Linked **Network as Police Intensify Crackdown**

SRINAGAR, NOV 27: Jammu & Kashmir Police on Thursday launched a large-scale crackdown across the Valley, conducting coordinated searches at dozens of residential, commercial and institutional premises allegedly linked with the banned Jamaat-e-Islami (JeI). Officials said the operation was part of an intensified effort to curb radicalisation and

prevent attempts to revive the proscribed organisation's network.

In Srinagar, police teams searched the residences and business establishments of several individuals believed to have associations with Jel. These included locations linked to Umar Sultan Guru of Chanpora; Mohd Abdullah Wani of Budgam, currently living at Baghat; Gh. Mohd Bhat of Bemina; Haji Mohammad Ramzan

IAMMU, NOV 27: In a major crackdown on recruitment malpractice, the Jammu and Kashmir Government has blacklisted LMES IT LLP and its principal stakeholder, Maharaj Krishan Wali, debarring them from all future recruitment-related tenders in the Union

Territory. The action follows extensive inquiries that exposed irregularities in the controversial 2020 Fire & Emergency Services recruitment process.

The probe began with a committee set up on December 12, 2022, to examine allegations in the selection of Firemen and Firemen Drivers. After the committee submitted its report on

February 10, 2024, the matter was escalated—on approval of the competent authority to the Anti-Corruption Bureau (ACB) for a detailed investiga-

**NEW DELHI, NOV 27:** Union Minister of State (Independent Charge) for Science & Technology and Minister of State for Earth Sciences, Dr Jitendra Singh, on Thursday chaired a high-level review meeting at the India Meteorological Department (IMD) to assess the progress of procurement and installation works under the ambitious 'Mission Mausam'.

## Kashmir parts record coldest Nov temp since 2007; mercury falls

SRINAGAR, NOV 27: Kashmir witnessed a severe drop in night temperatures on Thursday, with Srinagar, Qazigund and Kupwara registering their coldest November minimum temperatures in more than a decade, signalling an early peak of winter conditions in the Val-

Meteorological data shared with the news agency—Kashmir News Observer (KNO) by weath-

er expert Faizan Arif shows that several stations recorded their lowest November night temperatures since 2007 and 2009, accompanied by widespread sub-zero readings across the

According to the figures, Srinagar recorded a minimum temperature of -4.4°C, marking its coldest November night since 2007, when -4.8°C was recorded on November 28. The lowest ever November minimum in Srinagar remains -7.8°C, regis-

tered on November 29, 1934. Qazigund also recorded its

coldest November temperature since 2007, touching -4.0°C. The town last saw a similar minimum of -5.5°C on November 28,2007. Its lowest-ever November reading stands at -8.2°C, recorded on November 24, 1962.

Kupwara dipped to -4.4°C, the lowest November minimum in the district since 2009, when -4.6°C was recorded on November 19. The all-time lowest Turn on Page 2

continuous and evolving process that cannot be achieved in a short span of time.

He maintained that establishing a strong foundational ecosystem would provide the necessary momentum and allow gradual expansion and strengthening of skilling initiatives in future.

He emphasized the urgent need for a welldefined and targeted action plan to skill lakhs of individuals in the 18–39 age group, enabling them to enhance their employability and secure sustainable livelihoods.

Drawing parallels with sectors such as medicine and engineering, he highlighted how the creation of dedicated regulatory frameworks like NMC and AICTE, along with premier institutions such as AIIMS, IITs and NITs, led to the systematic development of trained manpower and attracted private sector participation.

The Chief Secretary called for emulating a similar model in the skill development sector, stressing its alignment with the National Education Policy (NEP) 2020. He underlined the necessity of defining clear roles for schools, colleges, universities, institutions of excellence like IITs, IIMs, AIIMS, and technical institutions such as ITIs and Polytechnics.

He further stressed that the success of this model should be measured through tangible outcomes, with strong linkage to employment whether through self-employment or private sector placements.

Participants from academic institutions and stakeholder departments shared valuable insights and assured their full cooperation by contributing resources, expertise and manpower to ensure the effective implementation and success of the proposed action plan in accordance with its core objectives.

Secretary, Skill Development Department, Kumar Rajeev Ranjan, elaborated on the roadmap, stating that the proposed framework envisions skilling as a lifelong process beginning right from school education. He outlined a structured approach whereby students from Classes 6th to 9th would be imparted foundational vocational skills, followed by elective courses in Artificial Intelligence and Entrepreneurship from Classes 9th to 12th. This initiative aims to equip every learner with essential competencies required to thrive in the rapidly evolving global econ-

He further explained that at the collegiate level, a 'Career Launchpad' model would be introduced, offering minor skilling courses in digital and technology skills, business, finance, entrepreneurship, green energy, creative and design fields, complemented by soft skills, workplace readiness and structured placement support.

Director, Skill Development, Shahzad Alam, informed that technical institutions would be transformed into industry-ready skilling hubs in collaboration with MSMEs. This would involve curriculum revision, capacity building of trainers and infrastructure upgradation, with Polytechnics being strengthened and eventually developed into a dedicated Skill University for J&K.

The meeting also highlighted the importance of integrating short-term skilling programmes, mid-career upgradation courses and competitive examination packages to institutionalize lifelong learning as a social and economic norm. This would encourage individuals to continuously invest in enhancing their professional competencies throughout their careers.

Among the key ecosystem enablers dis-

cussed were effective placement coordination mechanisms, skill financing solutions, introduction of 'Skill Passports' reflecting individual skill scores, and establishment of a comprehensive institutional framework for continuous monitoring and evaluation of skilling initiatives across J&K.

The Chief Secretary underscored the  $critical\,importance\,of\,continuous\,monitoring$ and stringent enforcement of the legal framework to protect public health. He stressed that food safety is a non-negotiable aspect of public welfare, as food is consumed daily and has a direct and lasting impact on the health of citizens.

He called for a robust, technology-driven and proactive enforcement mechanism to eliminate adulteration and ensure compliance with prescribed quality standards.

The meeting assessed the department's overall activities carried out under the mandates of the Food Safety and Standards Act (FSSA), highlighting significant progress in surveillance, inspections and legal action against violators.

Commissioner, Food & Drug Administra-In November 2022, Skyroot launched its tion, SmethaSethi informed the meeting that the department has substantially intensified its surveillance operations. Against an annual target of 7,080 samples, the department has already lifted 10,620 surveillance samples, achieving over 150% of the target, reflecting a strong commitment toward consumer safety.

In terms of enforcement, Food Safety Officers conducted 1,423 Risk-Based Inspections and 13,944 Routine Inspections across the Union Territory. To ensure infrastructure and hygiene compliance, 943 Improvement Notices were issued to Food Business Operators (FBOs) under Section 32 of the FSS Act, surpassing the target of 625 notices.

The Chief Secretary was apprised that strict legal action is being taken against violators. Under the civil adjudication process (Section 30), a total of 718 prosecutions have been launched, of which 671 cases have already been decided, resulting in penalties amounting to Rs 84.33 lakhs. Additionally, 21 criminal cases pertaining to unsafe food have been filed, with convictions secured in 10 cases involving fines and imprisonment.

The meeting also reviewed the outcomes of special enforcement drives conducted during November. A dedicated drive on Ghee led to the seizure of 80.78 kg of stock. Of the 41 samples tested, 12 failed to meet quality tandards. Consequently, Prohibition Orders have been issued against the manufacturers of the failed products and the information has been shared with FSSAI and concerned States including Uttar Pradesh, Haryana and Gujarat for action at the source.

Similarly, a drive on Poly Pack Milk saw 95 samples tested, out of which only 2 failed, indicating high compliance levels. Meanwhile, 32 samples of Packaged Drinking Water were

collected and their test reports are awaited. The meeting further reviewed the department's roadmap for strengthening the food safety ecosystem in the UT. Key strategic decisions included upgrading laboratory infrastructure to enhance testing capabilities. The FSSAI-NABL integrated assessment for the State Food Testing Laboratory (SFTL), Jammu is scheduled within one month, while the upgradation of laboratories in Jammu and Srinagar for advanced antibiotic and microbiological testing is targeted for com-

pletion within three months. Regarding expansion of infrastructure, proposals have been submitted for establishing two additional state-of-the-art food testing laboratories and procuring 10 more 'Food Safety on Wheels' mobile vans to enhance outreach and surveillance in remote and rural areas.

To enhance consumer awareness and promote responsible food practices, the department will roll out "Eat Right Initiatives" and structured training programmes for street food vendors across all districts within the next quarter.

The Chief Secretary directed the concerned officers to maintain strict vigil on the market, especially with regard to high-risk commodities, and expedite rationalisation and strengthening of enforcement staff to bridge manpower gaps. He emphasized that sustained vigilance, strong enforcement and public participation are essential to ensuring a safe and healthy food ecosystem in Jammu and Kashmir.

It guides how the whole-of-nation ecosystem must deliberate, coordinate and act through the 'Amrit Kal' towards a Viksit Bharat," he said.

He said the theme of Chanakya Defence Dialogue 2025 is "Reform to Transform: Sashakt and Aur Surakshit Bharat".

Gen Dwivedi recalled the 'Decade of Transformation' vision earlier announced by the Army for the period 2023-2032, and outlined a three-phase plan to make it a future-ready force.

The phase one, 'hop', set the agenda for the journey of the force by 2032.

Phase two, for 2037 vision, is a five-year consolidated period, drawing on the gains from phase one, and phase three, 'jump', with a 2047 vision, to graduate to the next level of "integrated future-ready force design", Gen Dwivedi said.

This trajectory has been further strengthened by Defence Minister Rajnath Singh earlier designating 2025 as the 'Year of Reforms' and it proved its merit in Operation Sindoor, where years of reforms and readiness, translated into "decisive outcomes".

"So, as we carry this sovereign strategic success forward for future operations, and the larger aspirations of a Sashakt, Surakhshit and Viksit Bharat, the real question before us is what must propel our next leap," the Army Chief said.

He outlined a set of springboards that will drive the years of transformation ahead.

The second one is accelerated innovation, he said, adding, "we must now move on from experimentation to enterprise-scale impact at a much faster pace in AI, cyber, quantum, autonomous systems, space and advanced materials.'

receiving retirement benefits through banks or treasuries must submit their Life Certificate every November to ensure uninterrupted pension disbursement.

A special campaign launched jointly by the Finance Department and J&K Bank this year facilitated easier submission of Digital Life Certificates. Officials said that out of nearly 2.5 lakh pensioners in J&K, around 1.80 lakh have already complied.

However, close to 70,000 pensioners have yet to complete the process, making them vulnerable to stoppage of pension payments beginning November 2025 if they fail to meet the requirement.

To avoid inconvenience, the department has granted a final extension up to December 15, 2025, stressing that no additional relaxation will be granted. Pensioners have been advised to submit their certificates-preferably through digital mode—at their respective

banks or treasuries before the deadline. A circular issued by the Director General, Accounts and Treasuries on November 26, 2025, cautions that pension disbursement will be withheld from December 2025

onwards for those who do not comply. Authorities have appealed to all pending pensioners to complete the process immediately to ensure continuity of their monthly pension.

Lone of Soura associated with the Ramzana Memorial Educational Institute; Shahid Zahgeer of Buchpora connected with Ramzana Memorial School; Mohd Ramzan Naik alias Faheem of Lalbazar; Bashir Ahmad Lone of Harwan; Peer Giyas-ud-Din of Nowgam linked to the Falah Research Ramzan Centre; and Manzoor Ahmad of Nowgam Chowk. Searches were also carried out at institutions reported to be aligned with JeI ideology, including Jamiat-ul-Banaat at Kashmir University, Rahat Manzil (JK Yateem Khana) in Chattabal, Chinar Publication Trust at Maisuma and Al-Kousar Book Shop in Maisuma.

Police said all searches were conducted in accordance with legal procedures and in the presence of independent witnesses. Incriminating documents and electronic devices seized from multiple sites have been taken into custody for detailed examination.

Similar operations were conducted in other districts. In Awantipora, police searched several houses belonging to individuals identified as Jel members, recovering digital material and questioning multiple persons who were later bound down under preventive laws. In Handwara, a raid at Jamia Islamia Institute in Waripora led to the seizure of electronic devices now being analysed for suspected links with Jel. Anantnag police teams searched multiple premises associated with JeI-linked individuals as part of efforts to disrupt suspected support mechanisms. In Budgam, raids in Chadoora, Soibugh and Beerwah resulted in the recovery of documents and electronic gadgets. Kulgam police also seized gadgets, literature and documents during coordinated searches across the district.

In Pulwama, early-morning searches were carried out in the presence of an Executive Magistrate, though no incriminating material was found. Shopian witnessed wide-ranging raids targeting persons with past or present affiliations to JeI, with police recovering electronic gadgets and documents which have been sent for forensic and technical analysis.

Officials said the Valley-wide exercise forms part of sustained preventive action aimed at countering any revival of the banned outfit and checking radicalisation. Further investigations are underway, and legal action will follow based on the findings. Authorities urged the public to cooperate with law enforcement agencies and report activities that could threaten public order. KNO

Investigators found that LMES was ineligible on multiple fronts under the mandatory conditions laid out in the e-NIT. Despite quoting 179 per candidate and standing as the L-2 bidder, the firm was awarded the contract, while the L-1 bidder, M/s UMC Technology Pvt. Ltd., which quoted a significantly lower rate of 107.50, was neither called for negotiations nor formally accepted or rejected.

The ACB further noted that LMES lacked mandatory experience in conducting recruitment for at least two State or UT police forces or central paramilitary organisations. Financial scrutiny revealed additional gaps: the company, incorporated only in November 2017, failed to provide three years of its own balance sheets and IT returns, instead submitting documents belonging to another entity, M/s Energy & Software Pvt. Ltd.

The inquiry also pointed to a conflict of interest. Wali, holding 99% shareholding in LMES, had previously served as a resource person for M/s Timing Technologies Pvt. Ltd. (TTPL), whose recruitment process for the Fire & Emergency Services Department in 2018 was scrapped with explicit instructions to replace the agency. Despite this, LMES owned by the same individual was awarded the fresh contract, a move the ACB said gave him "undue leverage" supported by departmental officials.

Based on these findings, the Home Department recommended blacklisting under Rule 151 of the General Financial

Rules (GFR) 2017, supported by communications dated June 27 and September 16, 2025. After reviewing all reports, the competent authority approved the decision.

The government has now formally barred LMES IT LLP, with offices in Jammu and Gurgaon, along with Maharaj Krishan Wali, from participating in any recruitment-related tenders across Jammu and Kashmir.



## TN: From Sangam To Silicon – 1

## Unraveling a civilisation: Past, present, prospects



HEADLINES

I have always thought and wrote of my home state, Tamilnadu as a forbidden land: Forbidden to the India that is Bharath beyond the Vindhyas, the allusion being to the infamous North-South divide. This is said in every context, from geography to geology, religion and race, culture and history, ethnicity and language, from kingdoms of yore to the politics of the present, over millennia to every millisecond that ceaselessly passes under the relentless march of time. Indeed, Tamilnadu, ancient

and immediate, defies easy explanations. The virtual Tropic of Cancer is often considered as a simple straight line bisecting the nation and separating the peninsular South from North; but there are more visible markers than a mere imaginary latitude. Reliefs like the Deccan plateau consisting of many mountain ranges and the Narmada and Godavari rivers flowing through the middle of India into seas East and West act as natural boundaries.

These demarcating physical features also have a matching rift in the psyche of the South, especially in Tamilnadu, our prime focus. The barrier was mirrored in the mind too, a carry-over from pre-history to the present with the South and North perennially set in diametrically different and diffident paths and polemics. There were of course common grounds, in terms of overlapping territory as also

exchanges and consequent influences in the realms of culture and religion between the two regions. Separate in some and seamless in some.

A cursory dip into history would be of relevance here while a deeper dive can be taken later. The largest and the most powerful empire of India, Mauryas of 4th century BCE, that ruled the entire North and much beyond, could not make any inroads in the south, particularly Tamilnadu. Repeated attempts by Bindusara and Ashoka were repulsed by the ever-warring triumvirate of Cholas, Pandyas and Cheras who however united to fight off the invaders many times. These failed incursions remain a blot on Maurya empire's otherwise relentless run. Ditto with other major dynasties like Guptas.

The non-Tamil presence happened after two thousand years - of the Vijayanagar empire, Marathas who were not exactly North and a few others at different times, all from the South. The Islamic invaders came often, saw much, plundered a lot and left with the loot. This was followed by the imperial Europeans. But India's North was never in the reckoning as a political project. Tamil Nadu remained exempt from that

But the same cannot be said of religion and culture. Jainism, Buddhism and Vedic Hinduism riding on Sanskrit achieved what emperors could not. Monks of the former two and the priestly classes of the latter inundated this land and blended into the daily lives of the people here, but the primordial Tamil held its fort, accepting and assimilating into its welcoming fold all the 'alien' offerings. But this was not always a melting pot of milk and honey. With Buddhism and Jainism going out of circulation in the first millennium CE, Sanathana and Sanskrit remained to hover over and haunt the land well into modern times.

The North-South divide, though having many manifestations from time immemorial, is still only a euphemism for a deeper debate: The Aryan-Dravidian conflict. Aryan is synonymous with Brahminism and Sanskrit. Dravidian, it follows, is about anti-Brahminism and Tamil. These simplistic definitions come embedded with many contradictions. For one, Aryan and Dravidian are not watertight compartments, given archaeological, anthropological and evolutionary realities. This deliberate distortion driven by the British imperial zeal to divide and rule India was dutifully adopted by politicians in this part of the country who nurtured a similar divisive agenda.

On balance, it must be said that a theory that lacked scientific sanction however secured legitimacy from the skewed social and educational set up that obtained here: The disdain for Brahminism and Sanskrit carried the day because not just the proponents, but the people at large too found some basis for it. And to the State's credit, it must be acknowledged that even at the height of the anti-Brahmin movement in early and mid-20th century, barring some petty, puerile displays, I am unable to recall any major acts of violence against this numerically miniscule and physically weak minority. Even Periyar's frequent calls to annihilate Brahmins remained on paper, like many of his other exhortations. Again, TN of today is one of the last bastions of religious harmony and peace, thanks to a tradition of inclusive hospitality. This is in sharp contrast to the polarisation witnessed in the North.

To quote, or rather, misquote, a bard, 'consistency is the virtue of fools'; what is implied is that opinions should be altered or updated in tune with fresh information or findings. In that vein, here too, many a discourse have changed course in the last

century itself, to suit prevailing exigencies and situations, compulsions of realpolitik and whims of various leaders. Dravidanadu is now just Tamilnadu. Hindi has replaced Sanskrit as the new ratha of the Aryan invaders. Distant Delhi is the most preferred destination for power, profit and pelf. Indeed, many ideals have been shredded, new ideas have been added and most ideologies traded.

But one tendency remains threaded: the Tamilnadu cauldron is always simmering with some discontent. Why is this State always in a, well, state of disconnect with the rest of the country? Is there any justification in the Dravidian leaders' constant claim that TN is more sinned against than sinning? Is the State's isolation self-inflicted or imposed? Is the local outfits' inbuilt impulse cause for the alienation or is it because of the Northern netas deliberate negligence? Will TN always tread a lonely trail, or will it at all get into lockstep with the rest of India? With all national parties abdicating from and abandoning it, is TN perennially stuck with the Kazhagams, old and new? Will a BJP, riding piggy-back on pliable proxies, throw pebbles into the pristine communal waters here and fish for trouble?

And there are these visible conundrums: A pious people voting for atheists; a reasonably well-educated populace following film stars to doom; a welfare state selling liquor; among the top in growth indices, yet a debt ridden exchequer and an almost bankrupt treasury; land with a great past staring at a grim future; abolitionists of castes names obsessed with caste identities; The list is long and is lingering in the minds of observers, within and without.

There are also a host of current issues: Relevance of social justice and sundry Dravidian jargon, Demography and Delimitation, Autonomy and Federalism, Climate and Civic problems, Economic Ambitions

and Technology, Transitions and Tensions etc all with a particular peculiarity here.

One starting point is to accept the fact that TN is indeed unique in many aspects, as a continuous civilisation and a distinct geo-political entity of the present. This part of the country did not exactly sign up for the kind of Constitution that came into force ... by force, many here stil aver. Even when secession was given a burial two decades later, the leaders and their cadre believed that they were doing a favour to the Union, a warranted compromise in lieu of guaranteed concessions. This streak has not disappeared but remains dormant and can be invoked and ignited any time: A tinder box accompanied by lighted matchsticks galore.

In the coming weeks I intend to embark on a verbal journey across time and themes, covering politics and personalities, parties and policies, pan-Indian issues that resonate here and local ones that have national relevance. I will delve into whatever is in my  $comfortzone \, and \, shelve \, what \, is \, not. \, Instead \,$ of a linear narrative, I will criss-cross and cut across topics, move back and forth at will; and why not, this being 'Tippler Nadu'.

The point and purpose of these articles are to primarily present Tamilnadu's point of view, for better understanding of all, mainly the clueless and clouded northern mind, and many others to whom it remains opaque. As also to proclaim the glories, articulate the grievances and think aloud about the goings on in this secluded State. The motive is not to belittle the problems elsewhere which anyway get adequate bandwidth but to widen the arch light on the narrow stretches here.

Welcome to my forbidden land and read on as it unfolds.

## Where Road Dust Settles: India's Challenge in Cleaning Its Air



#### Why Road Dust Matters for Air Quality

Road dust is not a minor pollutant—it is one of the largest contributors to particulate matter in many Indian cities. Studies, including those from IIT Kanpur, show that in Delhi it is a leading source of PM10 and PM2.5 pollution.

Road dust originates from multiple sources: construction material, degrading road surfaces, soil on unpaved shoulders, and the wear and tear of vehicle tires. Even more importantly, dust that settles on the road is not static. When vehicles pass—especially on damaged or poorly maintained roads—this dust gets lifted back into the air, repeatedly contributing to particulate pollution.

#### Where Road Dust Physically Settles Understanding where dust settles helps in identifying how it keeps re-entering the atmosphere.

a) On Road Surfaces and Shoulders

Unpaved Shoulders: Many Indian roads have paved main sections but unpaved edges that collect significant soil and silt.

Damaged Roads: Cracks and potholes trap loose particles, increasing dust accumulation.

Construction Activity: Materials such as gravel and soil from construction sites often spill onto adjacent roads, increasing the dust load.

#### b) In the Air (Ambient Environment)

Frequent Resuspension: Traffic activity constantly pushes settled dust into the air.

Local Urban Dust: In cities like Delhi, much of the dust is "in situ"—originating from within the city rather than being blown in from deserts.

Deposition: Dust settles on buildings, plants, and pavements but is quickly kicked up again, creating a cycle of lifting and re-settling.

#### **Health and Environmental Impacts**

Road dust contributes significantly to PM10 and PM2.5 levels, which penetrate deep into the lungs and worsen asthma, bronchitis, and other respiratory conditions. It also reduces visibility and disrupts urban microclimates by trapping heat.

India's Efforts to Reduce Road Dust

India has initiated several approaches to control road dust, though challenges remain.



#### Mechanical Sweeping and Water Sprinkling

Cities are increasingly adopting mechanical or electric sweepers. Water sprinklers and misting systems are used to suppress dust-Mumbai's civic body, for example, deploys misting vehicles to settle dust on

#### Paving and Better Road Design

Paving unpaved shoulders and repairing damaged roads reduce resuspension.

In the Delhi-NCR region, agencies such as CAQM,

CSIR-CRRI, and SPA are jointly redesigning roads with

#### improved surfacing and greenery. **Greening and Vegetation Barriers**

Trees, grass strips, and green walls along roads act as natural dust filters and significantly reduce dust

#### **Regulating Construction Activity**

Authorities mandate dust suppressants at construction sites and require wheel-washing systems so vehicles do not carry soil onto roads.

#### **Institutional Mechanisms**

The CAQM-CRRI-SPA partnership includes a Project Monitoring Cell to track dust-control implementation. Under the National Clean Air Programme (NCAP), cities are required to adopt systematic dust-management practices.

## Here's how dementia patients can live a better life

PHILADELPHIA: Patients with lung cancer have high levels of cytoskeleton-associated protein 4 (CKAP4) in their blood compared to healthy individuals, suggests a recent research. In the study, investigators found that CKAP4 levels are already elevated in the blood of patients with stage I disease, making it a potential noninvasive diagnostic marker that could change current practices in the diagnosis and treatment of some types of lung cancer, including non-small-cell lung cancer and squamous cell carcinoma, and improve patient outcomes.

Lung cancer is associated with a poor prognosis because most of the times it is diagnosed at an advanced

"The identification of patients at an early stage of cancer when it can be treated surgically is extremely important to improve prognosis. We need better biomarkers for early diagnosis," explained Yuichi Sato, a professor. Current biomarkers for lung cancer include carcinoma embryonic antigen (CEA), sialyl Lewis X antigen (SLX), squamous cell carcinoma (SCC) antigen, and cytokeratin fragment (CYFRA) 21-1, but these are not sensitive enough to detect tumors early, according to another professor Ryo Nagashio.

"The results of our study provide evidence that the CKAP4 protein may be a novel early sero-diagnostic marker for lung cancer," Nagashio said.

Researchers performed reverse-phase protein array analysis using a monoclonal antibody designated as KU-Lu-1 antibody on the blood of 271 lung cancer patients and 100 healthy individuals.

London [U.K.], May 09 (ANI): Good relationships, social engagement, better everyday functioning, good physical and mental health, and high-quality care have been identified as some crucial factors linked to better quality of life for people with dementia, according to a study.

'While many investigations focus on prevention and better treatments, it's equally vital that we understand how we can optimise quality of life for the 50 million people worldwide who have dementia," said professor Linda Clare.

## EAT **TOMATOES** TO FIGHT LIVER CANCER, INFLAMMATION

Higher consumption of tomatoes could be associated with a decreased risk of liver cancer caused by high-fat diets, a study has found.

The study, conducted on mice, showed that tomatoes are rich in lycopene – a strong antioxidant, anti-inflammatory and antiphenolic compounds and dietary fibres.

In addition, feeding mice tomato powder increased the richness and diversity of beneficial micro biota and prevented the over-growth of some bacteria related to inflammation, said the study, published in the journal Cancer Prevention Research.



cancer agent — which helps in effectively reducing fatty liver disease, inflammation and liver cancer development.

"Consuming whole foods like tomatoes and processed tomatoes from sauces, tomato paste, canned whole tomato products, ketchup and juice, provides the best source of lycopene," said Xiang-Dong Wang, Professor at Tufts University in the US.

Interestingly, we observed that tomato powder is more effective than the same dose of purified lycopene supplementation to prevent liver cancer development, said Wang.

This could be due to the potential beneficial effects of other nutrients in a whole tomato, such as vitamin E, vitamin C, folate, minerals,

For the study, infant mice were infected with a liver carcinogen and then fed an unhealthy high-fat diet similar to a Western diet, with or without tomato powder containing lycopene.

Other foods including guava, watermelon, grapefruit, papaya, and sweet red pepper also contain lycopene, but in much lower concentrations compared to tomatoes.

Eating tomatoes and tomato products such as tomato sauce rich in lycopene is also associated with a lower risk of cardiovascular disease, osteoporosis, diabetes, and certain cancers, including prostate, lung, breast and colon cancer, the study showed.

## Smoking raises lifetime risk of irregular heart rate

Smoking and alcohol consumption increase lifetime risk of a rapid and irregular heart rate, called atrial fibrillation, which can lead to a stroke, dementia, heart failure and other complications, a new study says. The results, published in the journal The BMJ, showed that that among individuals aged 55 years or older, the overall lifetime risk of atrial fibrillation (AF) was 37 per cent and was influenced by the burden of lifestyle risk factors such smoking and drinking alcohol. 'We examined the lifetime risk of atrial fibrillation, which measures the cumulative risk of developing a disease

life," said study co-author Ludovic Trinquart, Assistant Professor at Boston University School of Public Health in Massachusetts, US.

"It is essential to look at lifetime risks in addition to short-term risks, because it may enable early identification of individuals at higher long-term risk and facilitate lifestyle change counseling,

Trinquart said. In the study involving more than 5,000 participants, the researchers identified smoking, alcohol consumption, body mass index, blood pressure, diabetes, and history of myocardial infarction or heart failure as risk factors.

"Studying atrial fibrillation is important because it is emerging as a global epidemic; it also imposes considerable socioeconomic burden. Atrial fibrillation hospitalisations follow an exponential increase and have surpassed heart failure admissions," Trinquart said.

The programme, organised under the supervision of Prof. Dr. Iffat Hassan, Principal and Dean, GMC Srinagar, featured a series of academic and awareness oriented activities aimed at promoting responsible

Prof. Dr. Iffat Hassan appreciated the Microbiology department for its initiative and stressed the need for strong antimicrobial policies in hospitals. She called for routine antibiogram updates, strict monitoring of prescription patterns, and the establishment of structured stewardship teams in every clinical unit, urging students to integrate laboratory data into clinical decisions and reduce unnecessary antibiotic

Head of the Department, Prof. Dr. Asifa Nazir, highlighted the urgent need for correct antimicrobial use, accurate diagnostics, strict infection control, and rational prescribing. She emphasized responsible laboratory practices, regular surveillance of resistance patterns, and urged students to understand MIC values, follow hospital guidelines, and identify high risk organisms early.

The week included sessions on antimicrobial stewardship, infection prevention tools, rapid diagnostics, emerging resistance trends, and quality

Students participated in poster presentations, a quiz competition for UG and MD students, and case based discussions on multidrug resistant pathogens,  $antibiogram \, interpretation, and \, point \, of \, care \, diagnostic$ tools.

## DC Reasi reviews performance of **Revenue Department**

The DC took a detailed assessment of key areas including land acquisition cases, digitization of Jamabandies, georeferencing of cadastral maps, and revenue court cases. ADC Rakesh Kumar, ACR Nitin Verma, SDMs, all Tehsildars and other officers were present in the meeting.

Reviewing the ongoing digitization of Jamabandies, the DC assessed the Tehsil-wise progress of Geo-referencing of Cadastral Maps. She directed the concerned officers to expedite the remaining work and ensure early completion. She emphasized that timely digitization would enhance transparency, improve land record accessibility and provide significant benefits to the public. The Deputy Commissioner also reviewed the progress of eviction of encroachments from State land. She instructed revenue officers to intensify anti-encroachment drives, submit updated reports and take strict action as per norms to safeguard government land. Additionally, the DC reviewed the status of pending Revenue Court cases, stressing the need for their timely disposal. She urged officers to prioritize old cases, adhere to prescribed timelines, and ensure regular hearings for quick resolution. She also reviewed Tehsil-wise progress under the SVAMITVA Scheme, emphasizing the importance of completing property card preparation and verification at the earliest to extend scheme's benefits. The DC further  $reviewed\,the\,progress\,of\,land\,acquisition\,cases\,and\,directed$ officials to expedite processing, remove bottlenecks and ensure timely release of funds. She also reviewed the status of complaints received on the SATARK NAGRIK Portal and JK SAMADHAN, underscoring the need for prompt, transparent and time-bound disposal to strengthen citizen-centric governance. ### DC Kishtwar reviews drug control measures at District-Level NCORD Meet

**KISHTWAR, NOVEMBER 27:** District-Level Narco

Coordination Centre (NCORD) meeting was today convened under the chairmanship of the Deputy Commissioner Pankaj Kumar Sharma to review the ongoing measures to combat drug abuse, strengthen the de-addiction framework, and the progress of the Information, Education & Communication (IEC) campaign under the Nasha Mukt Bharat Abhivan.

District Social Welfare Officer Tariq Parvez Qazi apprised the meeting about the Action Taken Report on the decisions of the previous meeting.

The Deputy Commissioner conducted a comprehensive review of the prevailing drug abuse scenario in the district and sought detailed inputs regarding vulnerable areas, affected age groups and identified hotspots.

He also assessed the preventive and enforcement actions being taken by the stakeholder departments.

Emphasizing the crucial role of community participation, the DC called for active involvement of all stakeholders in the IEC Campaign 2.0. He stressed on wider outreach and effective public awareness on drug abuse prevention by proactively utilizing the services of the resource persons nominated by the line departments. The Heads



of Departments were asked to ensure proactive role of nominated resource persons. "Non-compliance or absenteeism will be viewed seriously" the DC cautioned.

Expressing dissatisfaction over the progress reported by the Excise and Taxation Department, the DC directed the department to station enforcement team at Paddar to curb the sale of illicit liquor.

He also directed all Sub-Registrars to share lists of properties

belonging to persons involved in NDPS cases to initiate attachment proceedings.

The NRLM authorities were directed to furnish block-wise list  $of Self Help \, Groups (SHGs) \, for \, their \,$ capacity building . The DC also ordered declaration of the educational institutions as tobaccofree zones, strictly in accordance with the prescribed SOPs and testing protocols.

Further, the DC directed for random testing of drivers by the Motor Vehicles Department (MVD) and joint initiation of wall paintings by the Municipal Council, Kishtwar, and the Excise and Taxation Department to spread awareness on drug abuse. He further directed to display toll-free helpline numbers

at prominent locations.

Stress was laid on intensifying awareness drives by organizing sensitization camps and Nukkad Nataks across all 13 wards of the Municipal Council with active involvement of youth, parents and civil society members.

The Chair took serious note of the absence of the Drug Inspector and issued a strict warning to ensure his presence in all future meetings.

## India's dharma-rooted democracy offers a beacon of hope in turbulent times

NEW DELHI, 23 NOV: India needs to send a message of oneness, democracy, and inclusiveness to the world – the idea of Vasudhaiva Kutumbakam – especially in today's turbulent times.

Seshadri Chari, a well known RSS ideologue and foreign policy analyst, addressed a gathering at Delhi's India International Centre said Indian democracy serves as a beacon of hope in an unstable neighbourhood.

He was delivering the III Memorial Lecture on the birth anniversary of GVG Krishnamurthy, former Election Commissioner of

Chari recalled the ideals taught by luminaries such as GVG Krishnamurthy, Murli Manohar Joshi, and others.

India, he said, has never faced a conflict between nationalism and internationalism because its civilisational thinking did not rest on geographical or political boundaries.

"We had no boundaries," he said. "Democracy has no boundaries, with our roots emanating from

In today's increasingly intolerant world, he felt compelled to clarify that dharma refers to "a set of laws," not religion.

Acknowledging that India is surrounded by countries, including Pakistan, Bangladesh, Sri Lanka and Nepal, that are grappling with conflict, he linked the region's tensions to a drift away from dharma.

He noted that, unlike many neighbouring countries governed



by the Western concept of theocracy, rule in the name of God or religion, India "never had a religion." A state, he argued, cannot and should not have one.

"We had what we call darshan, shastra – ideas, philosophies, and non-conflicting traditions," he said. "No two philosophers ever agreed on the same thing. That is why we have Dwaita, Advaita, and Vishishta Advaita."

Chari added that Indians even revered Charvaka, who held a worldview directly opposing the Vedas, as a great thinker. "Discuss, debate, and arrive at a conclusion,"

"Your point may not be right; my point may not be wrong, or it could be the other way around. But the willingness to come together and talk is the essence of democracy. Vade vade jayate tattva bodha — through debate, truth emerges. Keep discussing. Keep debating."

Calling this tradition of discussion and debate the very essence of democracy for Indians, he said this mindset has been ingrained in people for ages and represents the highest form of secularism.

"For us, the king or ruler is not a representative of God. He is not meant to implement God's orders. No. Even the gods are not above the rashtra. Gods are not above democracy in this concept."

"This," Chari said, "is the origin of our democratic ethos, and the reason it survives today." Anyone who believes India's democratic

institutions are strong should look to history, he argued. "You will see that whenever someone has stepped outside the bounds of dharma, which is unchangeable, conflict has followed."

Circling back to the roots of Indian democracy, he noted that when people speak of democratic strength, they often say, "We have a Constitution that protects our democracy."

However, he argued, "the Constitution alone does not protect democracy." He quoted B.R. Ambedkar's address to the Constituent Assembly: "It is not the Constitution which is going to save democracy. It is the people who have to put that Constitution into practice."

Expanding on Ambedkar's

is effective only as long as the people responsible for upholding it are themselves responsible. "If the people are bad, however good the Constitution may be, democracy will not survive. If the people are good, however bad the Constitution may be, democracy will survive."

Democracy's survival, he said, rests on society, on each individual. He argued that India's long tradition of democratic and inclusive thinking has endured largely because of the ethos of the Hindu society, which he described as inherently secular and inclusive.

According to Chari, neither the king nor the state holds society together. "The king does not control the state or the people.

The king does not make the law. The king does not keep society united or protect it. Governments don't protect society. Law-enforcing agencies, the police, the courts, don't protect society."

"It is the people who protect one another," he said. "And not on the basis of politics, fear of punishment, or law and justice, but on the basis of dharma."

Citing the Sanskrit saying na r j na r jasi na da cha gh tan -dharma eiva sarv rak antisma parasparam ("Not the king, not the state, not punishment, it is dharma through which people protect one another"), he stressed that the duty of every individual is to safeguard dharma. "Dharmo rak atirak ita ,ifyouprotect dharma, dharma will protect you," he concluded. UNI

### 'Long peace is declining': COAS flags global turmoil, calls for rapid military reform

NEW DELHI, NOV 27: Chief of Army Staff General Upendra Dwivedi on Wednesday called for an accelerated transformation of the Indian Army to meet the challenges of an increasingly volatile global security environment.

Speaking at the opening day of the Chanakya Defence Dialogue (CDD) 2025, General Dwivedi said the world is transitioning through a turbulent phase where major powers are "continuously jostling and

"The world has moved from the Cold War's bipolarity,



through a brief unipolar moment, into an uncertain and fractured order," he said. "With over 50 ongoing conflicts, to say we live in turbulent times may actually be an understatement."

As global geopolitics shifts toward deterrence, national security and warfighting preparedness, he said that India must confront a fundamental question: How should the Indian military transform to remain decisive and ready?

The Army Chief detailed a long-term transformation blueprint designed to build an integrated and technologically advanced force.

He identified four key "springboards" that will propel the Indian Army's next phase of transformation including Deepening Self-Reliance, Accelerated Innovation, Adaptation and Ecosystem Reform, and Military-Civil Fusion.

Highlighting the need for "deep cross-domain synergy," he said warfighting capability development must be a multi-agency and multimodal effort.

"The military is shedding inhibitions, opening ranges, funding start-ups and joining national technology missions," he said.

 $He\,stressed\,that\,academia, industry\,and\,the\,military$ must collaborate to build long-term global partnerships. Based on the theme "Reform to Transform: Sashakt,

Surakshit aur Viksit Bharat," the CDD is being organised by the Indian Army, in collaboration with the Centre for Land Warfare Studies (CLAWS).

Speaking about the conclave, the COAS said that CDD's first edition was instituted in 2023 by his predecessor General Manoj Pandey after he declared the year of transformation for the Indian Army.

"It underscored that genuine transformation cannot be driven in isolation as it demands great understanding and cooperation with all stakeholders across the technology spectrum. Since then, this forum has grown in scale, depth and influence drawing some of the finest strategic minds from India and abroad," he added.UNI

#### **Wealthy Indian states lag in** digital adoption

NEW DELHI, NOV 27: India's wealthiest regions are adopting digital payments at significantly lower rates than poorer states, according to new research which also highlights a sharp age and gender divide in the country's muchcelebrated fintech revolution.

The study, published in the Journal of Emerging Market Finance by economists Nilanjan Banik and Pranjal Chandrakar, finds that older Indians and women are markedly less likely to use digital payments, even after accounting for access to bank accounts, smartphones, and internet

Meanwhile, prosperous states such as Delhi, Gujarat, Karnataka, and Chandigarh show unexpectedly weak uptake compared with states like Telangana and Tamil Nadu. Drawing on a nationally representative survey of more than 40,000 households across 23 states, the researchers present one of the most granular analyses to date of who uses digital payments in India—and who does not. Their findings challenge the narrative of uniform digital adoption in a country that now handles nearly half of the world's real-time payment transactions through UPI. Despite this global leadership, the study notes that only 18 percent of respondents in the sample actually use digital payments. Age emerges as a decisive factor. Banik and Chandrakar find that the probability of using digital payments peaks among younger adults and declines sharply thereafter, with older individuals significantly less willing-or ableto shift away from cash. The gender divide is equally striking: women are seven percent less likely than men to use digital payments, a gap that persists across income groups and regions. The authors attribute this to lower digital and financial literacy among women, as well as entrenched social norms that limit women's control over household finances. Perhaps the most counterintuitive finding is the relatively low adoption in India's economically advanced states. After controlling for education, income and infrastructure, the study shows that richer regions are less likely to embrace digital payments.

The research argues that the dominance of high-value transactions in these economies, often exceeding UPI's daily transaction limit, pushes users back towards cash. They also point to the incentive to avoid tax scrutiny: digital payments leave a trail, and merchants and professionals in wealthier states may prefer the opacity of cash.UNI

#### ED arrests WinZO games directors, Rs 505 cr seized amid money-laundering probe

#### **NEW DELHI (NOVEMBER 27**

The Enforcement Directorate (ED) on Wednesday night arrested Soumya Singh Rathore and Pawan Nanda, directors of WinZO Games Private Ltd, and produced them before the residence of a Bengaluru judge. The court has remanded both the directors to ED custody and ordered that the accused be produced again on Thursday at 11:30 AM for a hearing on the arguments regarding the remand application filed by the agency. TThe arrests follow a series of recent searches conducted by

The ED's Bengaluru zonal team carried out raids at four locations

in Delhi and Gurugram between November 18 and 22, 2025, in connection with a moneylaundering case linked to the WinZO Games app. The action was conducted under the Prevention of Money Laundering Act (PMLA), 2002. During the investigation, the ED froze suspected proceeds of crime amounting to approximately Rs 505 crore, held in bank accounts, bonds, fixed deposits, and mutual funds linked to WinZO Games

The investigation began after multiple FIRs alleged serious offences by WinZO and others, including cheating, blocking user accounts, creating fake identities, misusing PAN cards, and Several complainants reported



tampering with KYC records.

that their KYC details were misused to conduct transactions in their names, resulting in significant financial loss.

The probe revealed that WinZO was operating its real money games (RMGs) in countries like Brazil, the USA, and Germany using its app from within India. It also emerged that despite a ban on RMGs by the central government from August 22, 2025, the company did not return approximately 43 crore to its users, and this money remained with the company.

A major revelation from the ED"s investigation was that WinZO forced its users to play against software and algorithms instead of real players, while customers were told they were playing against real people. The company had blocked many users from withdrawing money from their wallets, causing them losses. The company made illegal profits from the money deposited and lost by customers.

Furthermore, the ED''s investigation revealed that WinZO was running its global operations from India and had sent large amounts to the USA and Singapore in the name of overseas investment. Nearly 489.90 crore (55 million USD) was parked in the account of a shell company named WinZO US Inc. in the USA, while all operations of that company were being conducted from India.UNI

## Congress calls for Judicial review of Supreme Court's Aravalli definition

**NEW DELHI, NOV 27**: Senior Congress leader Jairam Ramesh on Thursday issued an urgent warning, calling for an immediate review of a Supreme Courtaccepted definition for the Aravalli Hills. He cautioned that the new criterion could strip legal protection from approximately 90 percent of the vital hill range, opening vast tracts to unregulated mining and construction.

The controversy centers on

a definition recommended by union Ministry of

Environment, Forests and Climate Change (MoEFCC) and formally adopted by the Supreme Court in a November 20 judgment. This new uniform definition classifies "Aravalli Hills" only as landforms in designated districts with an elevation of at least 100 meters above their local relief.

Ramesh, in a post on X, the Ministry recommended the "100-metreabove-local-relief" definition

"ostensibly to restrict mining," but argued that the threshold would effectively exclude most of the Aravalli Hills from being legally classified as such.

Experts and environmental bodies have also voiced grave concerns over the court's acceptance of this high-altitude cutoff. The Forest Survey of India had previously warned that the 100-meter limit would protect only a few "guard posts" while surrendering the "fences below."

The Aravalli range extends

from Delhi through Haryana and Rajasthan to Gujarat. Its lower hills are considered crucial for curbing desertification and airquality deterioration in the

National Capital Region (NCR). Ramesh wrote that the revised definition "will have very grave environmental and public-health consequences," calling the court's

acceptance of the criteria "bizarre" and a case of "the road to hell paved with good intentions." Environment Secretary Tanmay Kumar defended the government's stance, stating that the Supreme Court had "commended the work of the committee" and "appreciated its recommendations aimed at preventing illegal mining and permitting only sustainable mining in the Aravalli Hills and Ranges." Despite the acceptance of the definition, the Supreme Court's order temporarily halted the grant of fresh mining leases until the Indian Council of Forestry Research and Education (ICFRE) prepares a comprehensive Management Plan for Sustainable Mining (MPSM) for the entire Aravalli stretch. The Congress party has now formally requested a judicial review of the definition, urging the apex court to reconsider the criteria before the MPSM is finalized. The matter remains pending before the Supreme Court.UNI

### **Bavuma's SA left** 'no stone unturned' to conquer India after 25 long years

GUWAHATI: At the start of 2025, South Africa coach Shukri Conrad encouraged his team to "just dream a bit" because "some of the best things happen in dreams" and they ran with it. They had already qualified for the World Test Championship final and dreamt of winning it. But even after that, even in their wildest dreams, they didn't go as far as thinking they would sweep a series in India, nevermind subject them to their worst home defeat. That was something they only believed when it became reality.

"Coming here, I would never have thought 2-0 would be the result of the series," Temba Bavuma, South Africa's still-undefeated captain, said at the post-match press conference. "What makes it sweeter is the fact that we've been on the other side of the result, so we know how dark it can be. It's an incredible achievement for the group of players. Again, we've gone on to paint ourselves in history and we are creating some memorable

The last time South Africa won a Test series in



India was a quarter of a century ago, when Bavuma was a boy and two of his squad - both of whom made series-swaying contributions - Marco Jansen and Tristan Stubbs were not even born. To say that South Africa went into the India series with players who had mostly bad baggage or others who carried none at all is accurate.

Those things combined to deepen their resolve to give as good an account of themselves as they could, especially as mace holders with a reputation to upkeep. Under Conrad, and with their firstchoice side available, South Africa have not lost a series (their only defeat was to New Zealand in 2024 with an understrength squad) and Bavuma holds the record for the most Test wins as captain before a loss (ten before Guwahati, 11 in 12 Tests after). Against an Indian side in transition, South Africa fancied their chances but they didn't fancy them this much. "I would have never confidently thought we'd walk away with a 2-0 series win and maybe that apprehension would have forced us to bring a higher level of intensity in our play," Bavuma said. "But also in our preparation, we made sure that no stone went unturned."

Apart from a helpful FTP, which saw South Africa tour Pakistan the month before heading to India, they also sent an A team, which Bauvma was part of, as an advance party for this series. That team played two four-day matches, albeit on benign surfaces in Bengaluru but against some of the Indian first-choice attack. The spoils were shared 1-1 and included South Africa A successfully chasing 417 in the second match, a sign that anything is possible. Bavuma scored 59 runs in the chase, which he described as the start of his uplevelling to meet the squad's standards.

"The boys were in Pakistan and they got a proper taste and sense of what's to come in subcontinental conditions, so the guys came in ready," Bavuma said. "For me, it was a case of getting up to speed with the guys having been out with injury. But coming back into the team, I felt as if the guys were at a higher level and the onus was more on me to up my game."

Bavuma missed both South Africa's previous Test tours to the subcontinent through injury. He had an elbow injury last year when they beat Bangladesh 2-0 and a calf niggle sustained in a white-ball series in England kept him out of the Pakistan Tests. Despite those absences, there has never been any doubt that it is his South African team, with Conrad calling him both their best batter and their leader. And it's clear that he is received that way. Bavuma received a standing ovation at Eden Gardens and was well celebrated in Guwahati and appears to have taken ownership of the job fully. He called his ascendency "a process of discovery" that has come from being "a lot more assured of myself as a person and as a captain and of what I'm trying to do out there".

Two and a half years into the job of Test captain, and with the experience of the white-ball leadership under his belt, Bavuma's biggest lesson is the ability to delegate so that he does not carry all the responsibility on his own. "We have a lot of leaders within the team and it's understanding where certain guys provide value and allowing them to flourish within that space," he said. "I've got your Keshav [Maharaj], I've got Aiden [Markram], I've got your KG [Rabada] even though he wasn't there this time. From a tactical point of view, those are the guys, I can always bounce ideas around. I set that vision clear, but there's other guys who help me make sure that we're all on the same page."

## **Food charities benefit from Perth Test catering surplus**

PERTH: Australia's two-day victory in the first Ashes Test at Perth has led to a record donation of surplus catering supplies to Western Australia's leading food rescue service. More than 51,000 spectators had attended the opening day of the series, and according to The Guardian, 20 pallets of fruit and vegetables, four pallets of sandwiches and salads, two pallets of bread and four pallets of milk and dairy, totalling hundreds of kilos, were donated to OZHarvest after the match, making it the single biggest single donation ever received in Western Australia.

"Every effort has been made to maximise food recovery," Mike McKenna, Optus Stadium's chief executive, said. "Our chefs are busy turning about 450kg of sliced tomatoes into passata, some of the excess milk will become white sauce and lemon wedges preserved for future use. Being able to support those in need is really a silver lining for the stadium team."

WA's deputy premier, Rita Saffioti, said the move was "community spirit at its best", adding that the redistribution of the supplies would aid charities, schools, women's refuges and individuals in need across Perth.

England's capitulation on the

second day, following a tenwicket haul for Mitchell Starc and a stunning 69-ball hundred from Travis Head, left Cricket Australia with a \$4 million shortfall for the Test, even allowing for the cost savings in not having to open the stadium for the final three days.

The England squad left Perth on Wednesday. The majority of the squad is heading direct to Brisbane - the venue for the day-night second Test on December 4 - while three players, Josh Tongue, Jacob Bethell and Matthew Potts, have been drafted into the Lions' daynight fixture against Australia A in Canberra, starting on Friday.

## SSC ground in Sri Lanka to get floodlights for men's **T20 World Cup**

**COLOMBO:** The Sinhalese Sports Club (SSC) ground in Colombo will get floodlights and other upgrades in preparation for the Men's T20 World Cup, which Sri Lanka co-hosts with India in February and March next year. Although the SSC has occasionally hosted daytime limitedovers internationals - especially women's games - Colombo's day-night games have all been played at Khettarama (R Premadasa Stadium), which in any case is the highest-capacity stadium in

SSC's first match that will require lights will be the T20 World Cup Group B game between Oman and Zimbabwe, scheduled to start at 3pm local time on February 9. It is one of five matches the SSC is due to host at this World Cup. The first of those - between Netherlands and Pakistan on February 7 - will begin at 11am local time whereas the third fixture - between Pakistan and USA on February 10 - is the only match there to start at 7pm local time. Khettarama is set to host at least eight matches, and possibly the first semifinal and the final if Pakistan make it that far. Pallekele, the only Sri Lanka World Cup venue not in Colombo, will host seven games.

Building floodlights at the SSC will open up fresh possibilities for Sri Lankan cricket with daynight Tests becoming more viable in the country. Although Khettarama is the preferred limited-overs venue in Colombo, the SSC and the P Sara Oval are still preferred for Tests, owing partly to their reputation for being boutique Test venues.

Sri Lanka has never hosted a day-night Test, but Sri Lanka's Test captains have also asked their board to arrange such a fixture, over the

The ICC announced the schedule for the T20 World Cup on Tuesday, with the tournament set to run from February 7 to March 8 across five venues in India and three in Sri Lanka.

## You can't take cricket for granted, we need to get better: Pant

Pant said India will have to learn from the series and get better in future. "We need to take the learning and stick as a team. We needed to be clear with our mindset. In the future, we need to learn from it and get better."

The wicketkeeper-batter admitted that South Africa played better cricket throughout the

"They played better cricket; cricket demands that you need to capitalise as a team. And we did not do that and that cost us the whole series. The positive will be focussing on our own plan and that's what we will take from this series," he added.

South Africa captain Temba Bavuma was delighted to sweep the series. "It's massive. For me personally, I've been out of the game for a couple of months with an injury. Not every day you can come to India and walk away with a 2-0 series win. What's special is that we had dark days as a group and it's a credit to them. There's a big shift in our mindsets in terms of what we want to do. I think our preparation is something -- guys go out there looking to contribute,"

Bavuma lauded spinners Si-

mon Harmer and Keshav Maharaj for their consistency in the Simon has the experience of


playing here in India in 2015; he complements Keshav quite well. Bit more guile with the ball, it's a struggle to take the ball out of their hands. Simon was the man for us in this series, he said.

Off-spinner Harmer was adjudged the player of the series, and he said he will leave these shores with fond memories.

"Like I said in the last Test, it's been a long road. 10 years later, a completely different feeling. Will leave with a lot more fond memories from then. To beat a very good Indian team is a hell of an

effort. I was just watching our second innings, after 40 overs, the ball got softer and it became easier. But there was the odd-ball, the ball that Rishabh got. Nice to contribute, nice to get wickets and nice to get a fifer in India," said Harmer.
