

After Decades of Neglect, Justice Finally Being **Delivered to The Victims: LG Manoj Sinha**

Handed Over Appointment Letters to 39 Next of Kin (NoKs) of Terror Victims

SRINAGAR, DEC 13: Lieutenant Governor Shri Manoj Sinha on Saturday handed over appointment letters to 39 Next of Kin (NoKs) of terror victims from the Kashmir Division at Lok Bhavan, Srinagar, marking a significant step towards justice, rehabilitation and dignity for families devastated by terrorism.

Addressing the gathering, the Lieutenant Governor said the administration is committed to correcting historical wrongs suf-

fered by terror victim families. "For these families, the long wait for justice has ended. With concrete steps for rehabilitation, we have restored their dignity and renewed their faith in the system," he said.

The Lieutenant Governor observed that terrorism not only claimed innocent lives but destroyed entire households, forcing families into years of silence, stigma and economic hardship. "Behind every brutal terror killing is a home that never recovered, children who grew up without parents, and families left to struggle alone," he added.

Several families, whose pleas had remained unheard for decades, finally received government jobs. Among them were Pakeeza Riyaz of Anantnag, whose father Riyaz Ahmed Mir was killed in 1999, and Shaista of Hyderpora, Srinagar, whose father Abdul Rashid Ganai was murdered in 2000. Ishtiyaq Ahmad, son of BSF braveheart Altaf Hussain who was martyred

NEW DELHI, DEC 13: The nation on Saturday paid homage to the brave personnel who laid down their lives while thwarting the terrorist attack on Parliament on December 13, 2001, as the 24th anniversary of the assault was observed with solemn dignity at Samvidhan Sadan.

Vice President CP Radhakrishnan, also the Chairman of the Rajya Sabha, led parliamentarians in offering floral tributes to the martyrs. Prime Minister Narendra Modi was among the first to pay his respects at the commemorative ceremony held outside the old Parliament building.

CISF personnel presented a ceremonial "samman guard," followed by a moment of silence in memory of those who made the supreme sacrifice. Until 2023, the CRPF had traditionally rendered the 'salami shastra' during the annual observance.

Senior Congress leaders Sonia Gandhi, Leader of the Opposition in the Lok Sabha Rahul Gandhi, and Priyanka Gandhi Vadra were present at the ceremony, reflecting a collective remembrance that transcended party lines. Union ministers Kiren Rijiju, Jitendra Singh and Arjun Ram Meghwal also offered floral tributes.

Lok Sabha Speaker Om Birla did not attend the event as he was in Latur to participate in the funeral of former Lok Sabha Speaker and ex-Union minister Shivraj Patil.

Naxalism benefits nobody, only peace can pave way for development: Amit Shah

RAIPUR, DEC 13: Union Home Minister Amit Shah on Saturday said Naxalism does not benefit anyone – neither those who take up arms nor the security personnel, and asserted that only peace can pave the way for development.

Reiterating the Narendra Modigovernment's resolve to end Naxalism by March 31, 2026, he said the Centre has decided to transform Chhattisgarh's Bastar division, comprising seven districts, the most developed tribal region in the country in the next five years.

Addressing the closing ceremony of Bastar Olympic 2025 sport event at Indira Priyadarshi-

ni Stadium in Jagdalpur, the headquarter of state's Bastar district, Shah said Naxalism was like a "poisonous snake" that stalled the development in the region, and a "new chapter of development" will begin once the menace ends.

He appealed to those who are still associated with outlawed CPI (Maoists) to lay down arms and join the mainstream of society.

The government has decided to end "red terror" across the country before March 31, 2026, and the goal is now within reach, the Union minister said.

"I came here to participate in Bastar Olympic 2024, again in 2025, and I promise I will come Turn on Page 2

Justice was also delivered to the family of Dilawar Ganie and his son Fayaz Ganie of Qazigund, brutally killed in 2000, leaving behind a traumatised family that has lived in fear and grief for 25 years. The family of Abdul Aziz Dar of Srinagar, killed by terrorists three decades ago, also saw closure after years of struggle.

The Lieutenant Governor said that for a long time, real victims of terrorism were ignored, while elements linked to the terror ecosystem benefited from the system. "On one hand, OGWs were given government jobs, while NoKs of terror victims were left to fend for themselves. This injustice will not be allowed to continue," he

Highlighting a change after the abrogation of Article 370, LG Sinha said terror victim families are now speaking up without fear. "For generations, the system failed them. Today, we are empowering victims' voices and ensuring they receive the rights and dignity they deserve. We are also committed to swift and fair justice against perpetrators," he said.

Calling for collective resolve, the Lieutenant Governor said the fight against terrorism is a shared responsibility. "We must confront this menace with determination and patience and foil the designs of our adversaries," he said.

Reiterating the government's firm stance, LG Sinha said, "Our policy on terrorism is unequivocal—zero tolerance in all its forms. Every resource will be used to make Jammu and Kashmir terrorfree. Those providing shelter or support to terrorists will pay a heavy price.'

On the occasion, appointment letters were also handed over to beneficiaries under Compassionate Appointment Rules SRO-43 and the Rehabilitation Assistance Scheme (RAS). The administration has provided self-employment opportunities to 156 family members of terror victims under schemes including Mission Yuva, HADP and PMEGP. Additionally, encroachments have been removed from properties belonging to 17 victim families, while 36 families have been identified for house reconstruction, with more to be included.

Senior officials, representatives of social organisations and family members of terror victims were present at the event.

Presentation Programme (PGRP-2025) and felicitation of PGRP awardees, doctors, nursing staff and employees of SKIMS.

"Accessible and affordable quality healthcare has turned into a reality under the leadership of Hon'ble Prime Minister Shri Narendra Modi Ji," LGSinha said, adding that transformative changes have reshaped I&K's medical education and public health landscape since 2019.

Highlighting major achievements, the Lieutenant Governor noted that it took nearly seven decades to create 500 MBBS seats in the region, whereas 800 additional MBBS seats were created within just four years. "Issues such as lack of government medical colleges and unaffordable Through bold and systemic reforms between 2020 and 2024, quality medical education has become more accessible," he said.

Reiterating his commitment to equitable healthcare, LG Sinha stressed that special focus is being laid on underprivileged sections and residents of far-flung areas. Guided by the vision of 'Health for All', he called upon the healthcare fraternity to work towards an inclusive, resilient and people-centric healthcare system.

"We must enrich healthcare through knowledge, innovation and research. A multidisciplinary approach that addresses physical, mental and social well-being, beyond just treating illness, is the need of the hour," he said.

The Lieutenant Governor also lauded the significant transformation of SKIMS over the last four to five years, citing execution of over 1,100 long-pending promotions, clearance of more than 1,800 DPC cases, revival and referral of around 1,300 paramedical and ministerial posts, including 120 faculty positions, and referral of additional gazetted and non-gazetted posts to recruiting agencies. He said SKIMS is planning to establish future Centres of Excellence in transplant services, emergency and trauma care, neurosciences, cardiac sciences, renal medicine, pulmonary diseases, and endocrine and metabolic disorders.

On the occasion, LG Sinha inaugurated several key projects at SKIMS, including an Emergency S.M.A.R.T. Lab, ICU-VII, a heavy-duty lift and a new firefighting system. He also laid foundation stones for major upcoming facilities such as a Centre for One Health, a 3 MLD sewage treatment plant, multi-level car parking, Attendant Inn Phase-II and a shopping complex for hostels. New digital initiatives were also launched.

Emphasising technology-driven reforms, the Lieutenant Governor outlined five goals for healthcare transformation: data-driven care for personalized treatment, robust auditing of patient outcomes, 100 per cent digital health records, decentralized healthcare enabling timely treatment in remote areas, and collaborative efforts to promote preventive health and wellness.

The valedictory ceremony was attended by Prof. Mohd Ashraf Ganie, Director SKIMS; Prof. Vivek Lal, Director PGIMER Chandigarh; Prof. A. Drawing attention to the visible effects of climate change, the Chief Minister expressed concern over declining snowfall in recent years. He said that while Gulmarg earlier witnessed heavy snowfall by mid-December, recent winters have seen minimal snow, posing a serious challenge to winter tourism. Warning against inaction, he remarked that without timely adaptation, skiing in Gulmarg could turn into a thing of the

Pitching a technology-driven revival, he advocated the introduction of artificial snowmaking systems, as used in several European ski destinations. He suggested storing rainwater and deploying snow machines during sub-zero temperatures, particularly on slopes equipped with newly installed drag lifts. He also proposed installing floodlights on select slopes, on the model of Japan, to extend skiing into evening hours and make better use of short winter days.

These measures, he said, would enhance visitor experience while providing sustained $livelihoods \, to \, skiguides, instructors, equipment$ rental operators and others dependent on winter tourism. He stressed that infrastructure investments alone would not deliver results unless backed by assured snow cover and longer operational hours.

The Chief Minister also suggested exploring the feasibility of summer skiing on higher-altitude slopes where snow persists, urging the Tourism Department to optimise existing infrastructure with minimal modifications.

Highlighting the significance of the ATOAI convention, Omar Abdullah said it offers a valuable opportunity to exchange best practices from across the country while showcasing Jammu and Kashmir's vast but under-utilised adventure tourism potential. With the right mix of local expertise and national collaboration, he expressed confidence that Jammu and Kashmir could emerge as India's leading adventure tourism hub.

He reiterated that the true success of tourism lies not just in attracting visitors, but in ensuring they return with positive and lasting experiences. Reaffirming the government's commitment, the Chief Minister said infrastructure development and tourism promotion would continue without interruption, assuring stakeholders of full support.

He concluded by expressing hope that the pcoming ATOAI Annual Convention would be successful and mutually beneficial, further strengthening Jammu and Kashmir's standing on the national and global adventure tourism

Six Delhi Police personnel, two members of the Parliament Security Service, a gardener and a television cameraman were killed in the line of duty. All five terrorists were neutralised in the forecourt of the Parliament, cementing the day as a powerful reminder of sacrifice, vigilance and the nation's unwavering resolve.

Cold Wave.....

has issued an advisory urging people to take precautions against extreme cold, especially luring late night and early morning hours.

Power demand has surged as temperatures dipped, with increased use of heating devices and traditional warming methods such as kangris. However, locals in several areas complained of unscheduled power interruptions during night hours, adding to discomfort during the cold spell.

Markets witnessed thin footfall during morning and late evening hours, reflecting the impact of harsh weather on routine economic activity.

Doctors have advised people to avoid prolonged exposure to cold, wear layered clothing, and ensure adequate indoor heating. Health officials said respiratory infections and coldrelated complaints typically rise during such weather conditions.

The Meteorological Department has forecast the continuation of cold and dry weather over the coming days, with the possibility of further drops in minimum temperatures. [KNT]

Cold, Cloudy.....

of snowfall has been recorded over Zojila, Drass, Sankoo Zanskar, Shinkula, Khardongla and other higher altitude areas. The prevailing weather conditions are expected to persist today, with cold and cloudy skies dominating most parts of Ladakh.

The forecast indicates that similar weather conditions are likely to continue during December 14 and 15, with snowfall expected over peaks and high-altitude passes. From December 16 to 19, the weather is expected to remain partly cloudy, offering a brief window of relatively stable conditions

However, between December 20 and 22, there is a possibility of light to moderate snowfall at several places along the Zojila Kargil Zanskar axis and over higher reaches of the Leh Changthang area. Weather officials said no major snowfall is forecast in the western Himalayan region, including Ladakh, at least until December 20.

Authorities have clarified that there is no weather warning in place at present. However, an advisory has been issued urging travellers to exercise extreme caution while moving over mountain passes, as low temperatures combined with snowfall can make roads slippery and risky.

People have also been advised to switch off Kongdoori, completed at a cost of ₹0.90 crore. bukharis and other heating devices before going to bed, as improper use can lead to asphyxiation and pose serious life-threatening risks.

Meanwhile, officials said road conditions and weather updates will continue to be closely monitored, especially along vital passes that connect Ladakh with Kashmir and other regions.

fraud involving ?53 lakh, officials said.

The chargesheet, as per statement issued to KNS, has been filed in FIR No. 23/2025 against Tariq Ahmad Hajam, Ghulam Hassan Mir, Mohammad Sultan Mir alias Sulla and Abdul Razaq Mir, all residents of Barthana Qamarwari area of Srinagar, under Sections 420 and 120-B of the Ranbir Penal Code.

According to officials, the case was registered on a complaint alleging that the accused had fraudulently obtained ?53 lakh from the complainant and his father on the pretext of selling a piece of land.

However, after receiving the money, the accused allegedly sold the same land to other parties and transferred portions of it to their family members.

Investigations revealed that the accused, acting in connivance with each other, entered into a criminal conspiracy to cheat the complainantinadealinvolving 2.09 kanals of land at Estate Barthana in Srinagar, officials said, adding that both oral and documentary evidence collected during the probe supported the allegations.

With the filing of the chargesheet, the case is now ready for judicial proceedings, officials said.(KNS).

and later set ablaze to erase evidence, triggering outrage among locals and environmental concerns.

Local sources told the news agency Kashmir News Trust that the incident occurred in the Boti Nar Gundkamal Gundchubutra area of Mawer Forest Range-1 under Langate Forest Division. Smugglers reportedly targeted mature deodar trees under the cover of darkness, felling them quietly before attempting to destroy proof of the crime by setting the remaining stumps

Locals said that the freshly cut deodar stumps with burn marks and smoke indicate a deliberate attempt to conceal illegal activity. Forest dwellers and villagers who noticed the damage expressed shock over the brazenness of timber smugglers and alleged lax enforcement in sensitive forest

Locals said the repeated incidents of forest plunder are threatening the ecological balance of the area and demanded immediate action against those involved. They also called for fixing responsibility within the Forest Department, alleging that such large-scale felling cannot take place without lapses in monitoring.

When contacted for comment, the Divisional Forest Officer, Langate, confirmed the incident, saying a team has been deployed to ascertain the facts.

Locals have appealed to the Forest Department and district administration to conduct a thorough investigation, strengthen night patrolling, and ensure strict action against smugglers and any officials found negligent, to prevent further damage to the region's forest wealth. [KNT

The BJP governments at the Centre and in the state are committed to ensuring housing, electricity, toilets, tap water, LPG connections, five kg of free foodgrains and free medical treatment up to Rs 5 lakh for every household in these districts, he said.

The Bastar division will be the most developed tribal region in the country, Shah said, adding that every village will be connected by roads, have electricity, banking facilities within a five-km radius and a strong network of primary and community health centres.

"Naxalism acted like a poisonous snake blocking development in this region. With its end, a new chapter of development will begin," he said.

"Naxalim will be eliminated by March 31, 2026, but I want to appeal to those still associated with it to lay down arms and ioin the mainstream for the welfare of their family and society.

"Naxalism benefits no one – not those who take up weapons, not tribals and not security personnel. Only peace can pave the way for development," he said, calling on misguided youth to take advantage of the rehabilitation policy and lead a dignified

Highlighting the changing face of Bastar, Shah said fear has been replaced by hope, schools bell now ring where gunfire once echoed, and roads, railways and highways are being built where development was once a distant dream.

Slogans of "Bharat Mata Ki Jai" have replaced slogans of 'Lal Salaam', marking a

major transformation, he added. "We are all committed to a developed Bastar. In this campaign that has been launched, the Chhattisgarh government and the Centre did not set the goal of merely engaging in encounters with armed cadres and killing them. More than 2,000 Naxalites have surrendered (in the last two

years)," he said. "I want to tell you today that the leaders of tribal communities have made a huge contribution (in the surrender). Their guidance has given courage and strength to the Naxalite youth to lay down weapons, and the state government has also stepped forward. Today, I appeal to all the leaders of the community to work towards bringing those who are still carrying weapons back into the mainstream by explaining

things to them," he said. Referring to the Bastar Olympic, Shah said more than 700 surrendered Naxal youths participated in the sports event as a powerful symbol of choosing unity over division and development over destruction.

He added that officials from the Sports Authority of India are present in the event to identify talent and nurture players from Bastar for future national and international events, including the Commonwealth Games and the 2036 Olympics.

"Bastar is changing, and when the Olympics are held again in 2026, they will be organised in a terror-free Bastar," Shah

SIR strengthens democracy, protects constitutional values: Sat Sharma

JAMMU, DEC 13: The Bharatiya Janata Party (BJP) on Saturday held a comprehensive meeting on Electoral Reforms and the Special Intensive Revision (SIR) at the party headquarters, Trikuta Nagar, Jammu.

The meeting was chaired by J&K BJP President and Rajya Sabha MP Sat Sharma, along with General Secretary (Organization) Ashok Koul, BJP National Spokesperson Pradeep Bhandari joined the deliberations virtually as a key resource person. The meeting was attended by BJP state officebearers, party spokespersons, and other senior leaders.

During the session, participants collectively watched the address of Union Home Minister Amit Shah on electoral reforms and SIR and raised queries to gain deeper clarity on the issue.

Addressing the gathering, Sat Sharma reaffirmed that the BJP has always stood for free, fair, and transparent elections, which form the foundation of India's democratic system. He said that Parlia-

ment remains the highest forum for debate and discussion, and the BJP has never hesitated to engage on sensitive and significant issues, including electoral reforms.

Sat Sharma emphasized that SIR is a constitutional and routine exercise conducted by the Election Commission under Articles 324, 325, 326, and 327 of the Constitution, aimed at ensuring that only eligible Indian citizens are included in electoral rolls. He stated that opposition to SIR by Congress and other parties effectively amounts to questioning the Constitution framed by Dr. B.R. Ambedkar and undermining democratic institutions.

Presenting the organizational roadmap, Ashok Koul announced a structured series of programmes across districts of Iammu and Kashmir. He said awareness sessions, workshops

for party workers, press interactions, and public outreach programmes would be organized to educate citizens on the constitutional validity and necessity of SIR. He stressed that party cadres would be equipped with factual material to counter misinformation and take the message of electoral purity and national security to the grass-

In his detailed presentation,

Pradeep Bhandari highlighted what he termed as the opposition's double standards and undemocratic conduct. He pointed out that Congress introduced **Electronic Voting Machines** (EVMs) but questions their credibility only after electoral defeats, while remaining silent when it wins. He recalled that the Supreme Court has repeatedly upheld EVMs, and no opposition leader has successfully challenged them within the legally mandated 45-day period.

Bhandari further noted that SIR has been conducted multiple times since 1952, mostly under Congress governments, and was never opposed earlier. He explained that SIR aims at voterlist purification, removal of duplicate entries, deletion of names of deceased persons, inclusion of new eligible voters, and identification of illegal immigrantssteps essential to protect democracy and national security. He also criticized the opposition for walking out of debates on illegal immigration, questioning their credibility and intent.

JAMMU, DECEMBER 13: Minister for Jal Shakti, Forest, Ecology&Environment and Tribal Affairs, Javed Ahmed Rana, today chaired a meeting at the Civil Secretariat to review the status of power distribution and transmission infrastructure besides irrigation works and hydropower projects in the border districts of Poonch and Rajouri.

The meeting was attended by Managing Director JKPDCL, Rahul Yadav; Chief Engineer I& FC, Manoj Gupta; Chief Engineer Transmission JPDCL, Habib Choudhary; Chief Engineer, Distribution JPDCL, KKThappa; CE Planning and Procurement, JPDCL, Vijay Kumar Balmotra; Chief Engineer Projects, Vikas Anand and other senior officers.

The Minister emphasised the need to further strengthen the electricity infrastructure and ensure a reliable and uninterrupted power supply to the region, particularly in remote and border areas. He underlined that robust power infrastructure is essential for economic growth, public welfare and improved service delivery.

During the review, the Minister held detailed discussions on the condition and expansion of distribution lines, substations and transmission corridors. He also assessed the progress of works being executed under various Central and UT-sponsored schemes. Issues related to rightof-way, erection of electric poles and clearance delays were

The Minister was informed

that coordination between the Power Development Department (PDD) and allied departments is underway to resolve these bottlenecks. Directing the concerned officers to expedite the resolution of all pending issues, Rana stressed strict adherence to prescribed timelines. He cautioned that delays in infrastructure projects adversely impact the public service delivery, especially in sensitive and remote areas such as Mendhar. He also underscored the importance of regular



monitoring and prompt redressal of public grievances to enhance the consumer satisfaction.

The Minister specifically reviewed progress on the Siot-Rajouri Receiving Station, terming it a major power infrastructure project for Rajouri district. He noted that the project is vital for high-voltage power transmission and meeting the growing electricity demand of the region.

Reviewing the Parnai Hydropower Project, Rana reiterated the Jammu and Kashmir government's focus on hydropower development and self-sufficiency, energy particularly in Poonch district. He directed the executing agency to ensure timely completion of the project, highlighting that it would significantly enhance the energy security, promote economic growth, improve living standards and support equitable

development in the region. Managing Director, JKPDCL,

Rahul Yadav, informed the meeting that work on the project is progressing steadily and is expected to be completed by December 2027.

Taking serious notice of the prolonged delay in the Anas Irrigation Canal project, the Minister instructed the concerned departments to explore all feasible options for initiating work at the earliest. He emphasized that the project has the potential to deliver substantial and ensure sustainable water

He further directed the Irrigation & Flood Control $Department\, and\, JKPDCL\, to\, revisit$ the project parameters and work out a viable and resource-efficient solution. Once completed, the project is expected to improve the power availability, support local economic activities and enhance overall service delivery in the region.

The Minister also conducted a comprehensive review of implementation of the Revamped Distribution Sector Scheme (RDSS) in Poonch and Rajouri districts. He assessed both physical and financial progress, as well as the quality of work being executed under the scheme, describing RDSS as a critical initiative aimed at transforming the power distribution sector. He urged the officers to identify the existing challenges and adopt a proactive approach to ensure successful implementation.

It was informed during the meeting that physical progress in Rajouri and 19 percent in Poonch. The officials assured the Minister that all the pending works would be completed within the stipulated timelines.

Reviewing the progress on DAJGUA programme for rural electrification, Rana directed the local officials to accelerate project execution to bridge infrastructure gaps in tribal villages. He emphasized that priority must be accorded to unelectrified and underserved areas, with active monitoring to ensure that basic services effectively reach tribal communities.

The Minister stated that strengthening infrastructure in areas such as Mendhar is crucial for boosting economic activity, improving public welfare and ensuring overall regional development. Forest Rights Act in J&K gets a booster dose

In a significant decision the Jammu & Kashmir government led by chief minister Omar Abdullah has designated the tribal affairs department as the nodal department for the implementation of Forest Rights Act of 2006 in the union territory. Up to this moment the forest department was the nodal department for the implementation of Forest Rights Act in Jammu & Kashmir and the concerned stakeholders were not happy with the same.

Jammu & Kashmir was probably the only state or union territory in the country where the forest department was designated as the nodal department for implementation of the Forest Rights Act of 2006. The replacement of the forest department by the tribal affairs department as the nodal department would go a long way in settling the claims of tribals and others over forests. Given the fact the forest department was the nodal department it seemed that the implementation of Forest Rights Act in Jammu & Kashmir was merely on papers.

The announcement about making the tribal affairs department as the nodal department was made by chief minister Omar Abdullah on social media. Tribal Affairs Minister, Javed Ahmed Rana was the first one to welcome the decision and he hailed his own government's decision to designate the tribal affairs department as the nodal department for implementation of Forest Rights Act (FRA), 2006 across Jammu & Kashmir. Describing the move as a historic and corrective intervention, the minister emphasized that this is a landmark step, reflecting the long-standing aspirations of tribal communities.

The minister said that the step will ensure a more community-centric, accessible and responsive institutional mechanism for implementation of FRA. He highlighted that transferring the FRA responsibilities from the forest department to the tribal affairs department will usher in fair, transparent and time-bound recognition of individual and community forest rights. He assured that every necessary step will be taken to ensure the benefits of FRA reach every eligible tribal family across Jammu & Kashmir.

It would be in place to mention here that the tribals had been demanding that instead of the forest department the tribal affairs department should be made as the nodal department for implementation of Forest Rights Act in Jammu & Kashmir. Over the years the Jammu & Kashmir Forest Rights Coalition carried out a campaign in this regard and many programmes were held so as to make the people at helm aware about the need to make the tribal affairs department as the nodal department for implementation of



A brother has gone to take part in an army running test. On a dusty track, where dreams are tested with elsewhere pain, a young man runs with everything he has. This is not just an army running test for him; it is a test of his courage, patience, and the future he dreams of building. The Revival Of Domestic Hamaams In Contemporary **Kashmir... A Blessing Or A Silent Burden?**

A Deep Reflection on Heritage,

Family, and Modern Life There are moments in the story of a society when something ordinary becomes extraordinary not because it changes in shape or form but because the world around it changes so fast that the old thing suddenly feels precious again. In Kashmir the domestic hamaam that warm stone-floored room heated by firewood has always been a symbol of comfort, culture and family life. But in today's fast-moving world, where winters feel harsher and electricity feels weaker the hamaam is returning not just as a physical space to stay warm but as an emotional space many families are trying to reclaim. The revival of domestic hamaams in contemporary Kashmir looks beautiful from a distance: families gathering together elders talking softly, children playing, neighbours sharing warmth and students finding a corner to read in peace. But when we look closely, we also see a silent struggle happening inside these heated rooms a struggle between comfort and laziness, connection and isolation family bonding and digital distraction, tradition and modern habits. The same hamaam that once brought people together is today becoming a place where silence grows louder not because people are lost in thought but because everyone is lost in

There was a time not very long ago when the hamaam was meant more than heat. It meant winter stories whispered by grandparents it meant dried fruits shared among cousins, it meant lessons of life given by elders while the fire crackled gently in the corner, it meant families learning to sit together, eat together and simply exist in the same space without being pulled away by screens or notifications. Today when we step inside many homes, the hamaam is still warm, still glowing, still comforting but the people inside it are colder to each other than ever before. Families sit together physically but live in separate worlds mentally. Students who once

revised lessons here now scroll endlessly on their phones. Women who once used this space to pray or finish chores now lose hours watching videos. Men who once returned home tired now enter the hamaam and forget time, drifting into the lazy comfort of heat and endless phone-scrolling. Even children whose bodies should run and minds should grow, sit like statues, sleepy and slow, waking up late and studying less. The hamaam is still good but humans have changed. The warmth is still there but the purpose has weakened.

It Is not wrong to love the hamaam. Kashmiris have loved it for centuries. It is part of our history, our architecture our survival techniques against harsh winters and even our culture of togetherness.But problems arise when a blessing becomes an excuse. The revival of the hamaam has also revived a new lifestyle waking up late because the hamaam is too warm, skipping studies because the hamaam makes one sleepy, praying less because comfort overtakes discipline and spending more time on phones because the heat makes the mind unwilling to work or move. For students, this is becoming dangerous. Many teachers across Kashmir complain that winter months bring a sudden drop in attention, motivation, and responsibility. Students who should wake up early and revise lessons before school now wake up late because the warm hamaam delayed their sleep. Their books lie untouched, while their phones glow bright. Assignments remain incomplete, but social media is updated. Exams come closer, but seriousness melts away. The hamaam does not make the student lazy, but the comfortable environment makes it easy for the student to choose

comfort over effort. Parents also notice this change. They see their children spending hours in thehamaam and yet achieving nothing productive. They see their homes filled with warmth but lacking the warmth of conversation. They see families sitting together under the same roof but emotionally far from each other. The family gathering looks beautiful in pictures but feels empty in reality. The hamaam once allowed people to talk openly, share memories and strengthen relationships. But now when everyone sits inside, their heads bend toward their screens, their fingers move rapidly, their eyes stay fixed on digital worlds and no one even notices who entered or who left. A mother may sit next to her daughter and still not

know what she is going through. A son may sit next to his father and still feel distant. The hamaam that should heal hearts sometimes becomes the room where silence grows heavy.

Women face a different kind of challenge. Winter in Kashmir is already a demanding season cooking on time, keeping the house warm, filling water buckets, managing kitchen work and taking care of children is not easy. The hamaam was always a place where women could sit for a few minutes, rest their backs and warm their cold hands and feet. But now, hours are lost scrolling through reels, laughing at videos, or chatting endlessly. Prayers get delayed. Chores pile up. Work becomes slow. A simple five-minute break becomes a two-hour distraction by the end of the day, exhaustion doubles, guilt grows and important tasks remain unfinished. The warm room becomes the place where

time slips away unnoticed. The criticism here is not against the hamaam. Kashmir needs it. It is a blessing in harsh winters. The criticism is about human habits, human choices and human weaknesses. We have allowed comfort to win over discipline. We have allowed screens to win over relationships. We have allowed laziness to win over productivity. The hamaam is only a room what happens inside it depends on the people. If people enter with purpose, they came out better. If they enter with phones, they came out empty.

There is also a psychological angle to this problem. Human beings naturally choose warmth and relaxation during winter. The body becomes slower, the mind becomes softer and motivation decreases. But what makes the situation worse today is the over touch of smartphones. When a person sits in a warm room with nothing to do, the phone becomes the easiest escape. once the phone enters the hamaam, the hamaam becomes a trap. The heat relaxes the body, the phone captures the mind and both together create a dangerous mix of comfort and addiction. Hours pass without movement. Minds become dull. Creativity dies. Conversations disappear and families lose a chance to connect

Students especially are suffering the most from this lifestyle. Winter should be a time of focus, reflection, revision and improvement. It is a season when the outside world slows down giving enough opportunity to study, read books, work on skills and plan the future. But

many students use winter as an excuse to escape from hard work. Instead of using the hamaam as a quiet study corner, they use it as a digital playground. Instead of using the warmth to comfort their minds for learning, they use it to sleep for long hours. Instead of waking up early, they stay in bed until late morning because the cold outside scares them. when the results come they blame win-

ter for their failure, not their habits. If this continues the revival of hamaams will bring warmth to our homes but coldness to our progress. We will raise a generation that knows how to stay comfortable but does not know how to struggle how to read, how to think deeply, or how to build discipline. Laziness is not created by stone floors or warm fires rather it is created by the mind that chose ease over responsibility again and again.

To save the beauty of the hamaam and the strength of our society we need to change how we use this space. Let the hamaam remain a place for bonding not addiction. Families should set simple rules at least one hour every day in the hamaam without phones, where everyone talks, shares, laughs, or simply sits together in peace. Students should bring their books instead of their phones. Women should use it for rest but not let it consume their entire day. Men should use it to relax but not to disconnect from family responsibilities. Everyone should remember that warmth is only useful when it gives energy not when it steals time for. The true revival of the hamaam will not come from firewood and stone alone but from the choices we make inside it choices that decide whether this ancient room becomes a sanctuary of discipline or a shelter for distraction a space that strengthens families or silences them, a place where children learn resilience or lose it and ultimately a reminder that the future of Kashmir will never be shaped by the heat under our feet but by the strength of our minds the sincerity of our habits and the courage of our families to reclaim connection, conversation, purpose and responsibility before comfort quietly replaces everything that once made us strong, because as Kashmiris often say, the walls may hold the heat, but only intention can hold a life together, and only discipline can hold a nation upright.

International Mountain Day and Ecological Consciousness in Mountain Writing



Jahangir's famous declaration—"If there is heaven on earth, it is here"—owes much to the enthralling mountain backdrop that cradles Kashmir like a natural amphitheatre. Ancient scriptures referred to the Himalayas as Devabhumi-the land of gods-and their peaks as the abodes of Shiva, Parvati, and other deities. The Mahabharata narrates journeys through icy passes and forests, while Kalidasa's Kumarasambhavam vividly paints Himalayan flora, fauna, and divine presences. These early texts treat mountains as spiritual stages where human emotion and cosmic play intersect. In modern Indian literature, mountains appear in varied forms. The works of Rabindranath Tagore, Saratchandra Chattopadhyay, and Mahasweta Devi include Himalayan landscapes as metaphors of purity and inner awakening. Writers like Manjushree Thapa, Ruskin Bond, Anita Desai, Kiran Desai, and Temsula Ao portray mountains with ecological sensitivity, highlighting both their beauty and fragility. Bond's Mussoorie, for instance, captures the innocence of Himalayan life, while Kiran Desai's The Inheritance of Loss explores the tensions of postcolonial mountain societies. Kashmir occupies a special place in mountain literature due to its $geographical\,setting\,and\,its\,centuries-old$ literary heritage.

The valley, encircled by the Himalayas, Pir Panjal, Karakoram, and Zabarwan ranges, has inspired poets, mystics, historians, and travelers. Classical Sanskrit poets described Kashmir as the "abode of spring" and the "emerald set in the Himalayas." Kalhana's Rajatarangini documents the region with a keen sense of landscape. Persian and Mughal chronicles—from Abul Fazl to Jahangir—overflow with admiration, recording how the mountains create the valley's climate, charm, and agricultural abundance.Kashmir's mountains are central to its spiritual literature. The songs of Lal Ded and Sheikh Noor-ud-din (Nund Rishi) often carry images of mountain meadows, icy rivers, forests, and mist. Their mystical verses use the mountain as a metaphor for inner ascent, discipline, and renunciation. Rishi literature portrays hermitages, caves, and high-altitude retreats as places of meditation and selfdiscovery. In Indian thought, mountains are not mere physical formations; they are sacred symbols. With climate change altering Himalayan landscapes, Indian mountain literature has become increasingly ecological. Writers express concern over melting glaciers, loss of biodiversity, landslides, and over-tourism. Kashmir's literature reflects similar anxieties: disap-

pearing snowlines, shrinking lakes, deforested slopes, and erratic weather. For Kashmiri Pandit writing-such as the works of Nilkanth, Hari Krishna Kaul, and contemporary diaspora poets—the mountains often appear as symbols of longing, home, and exile. The snow peaks stand as witnesses to cultural displacement.

Similarly, Muslim writers from the valley portray mountains as sites of resilience and continuity. Across Indian literature, mountains often embody memoryancestral heritage, forgotten histories, and timeless wisdom. Kashmir's mountain narratives combine all these layers. Travel writing on Kashmir—from British colonial accounts to contemporary journalism often romanticizes mountain landscapes. From Walter Lawrence's The Valley of Kashmir to modern travel memoirs, writers describe the dazzling whiteness of Harmukh, the slopes of Gulmarg, the meadows of Sonamarg, and the alpine lakes like Gangbal and Tarsar. These writings contributed to the global imagination of Kashmir as a paradise encircled by divine moun-

In Kashmiri literature, snow is not just meteorological; it is emotional and philosophical. Snow signifies purification, silence, erasure, and sometimes mourning. Writers use snow to mirror personal states-love, separation, nostalgia, or despair. In Agha Shahid Ali's poetry, snow becomes a metaphor for memory frozen in time, as well as for the silence of suffering. Since the late twentieth century, mountain literature in Kashmir has also absorbed themes of conflict. Mountains appear as both shelters and witnesses, as hiding places and barriers. Fiction and memoirs describing the conflict often include descriptions of mountain passes, remote valleys, and snowy borders. Here, the mountain becomes both a topographical and political character. In many works, the calm snow-covered peaks stand in stark contrast to human turmoil below-creating a powerful literary tension between eternal nature and temporary violence. Mountain literature in India is not a single genre but a vast, evolving tradition. It blends mythology, travelogue, nature writing, poetry, ecological consciousness, and cultural memory. Within this tradition, Kashmir holds a luminous position. In modern poetry and fiction, Kashmiri writers evoke mountains to capture beauty, longing, memory, and conflict. The works of Agha Shahid Ali transform mountain landscapes into powerful symbols of identity and loss. His metaphors of snow, peaks, and winter reflect both ecological and emotional coldness. Poet Dina Nath Nadim and Rehman Rahi use mountain imagery to depict $cultural\,continuity\,and\,political\,turbulence.$ Kashmir's mountains also feature in travel literature. Writers like V. S. Naipaul, Rahul Sankrityayan, and contemporary essayists have chronicled the valley's fragile ecology. Many describe how seasonal changes spring bloom, summer clarity, autumn chinar glow, and winter snow-are choreographed by the surrounding peaks.

Kashmiri literature transforms mountains into symbols of beauty, spiritual ascent, ecological fragility, cultural identity, and emotional depth. The Himalayas around Kashmir are not simply scenerythey are participants in the narrative, shaping the valley's literary voice. On International Mountain Day, therefore, Kashmir becomes a crucial point of reflection as to how we sustain such landscapes while respecting the needs of its people. Sustainable mountain development in Kashmir must combine traditional knowledge with modern ecological understanding. The valley has always been home to communities—Gujjars, Bakarwals, shepherds, farmers-whose lifestyles evolved in harmony with mountain rhythms. For centuries, their grazing cycles, water usage patterns, and agricultural practices worked in tandem with nature's limits. This indigenous wisdom, if revived and integrated into contemporary policy, could guide present conservation efforts.

International Mountain Day emphasizes responsible tourism. In Kashmir, this translates into developing eco-friendly infrastructure, promoting waste-management systems, encouraging off-season tourism to reduce peak pressure, and educating tourists about the fragility of mountain ecosystems. Small steps—from banning plastic in certain zones to promoting trekking routes that follow low-impact guidelines—could significantly alleviate stress on the environment. Moreover, engaging local communities as custodians of eco-tourism initiatives ensures that the benefits remain within the region while fostering a sense of collective responsibility. Today, as climate change and modern pressures threaten these fragile environments, mountain literature becomes more crucial than ever. It preserves memory, inspires stewardship, and reminds us that mountains-silent, majestic, and eternalare central to India's ecological and cul-

tural imagination. In celebrating International Mountain Day, one must inevitably hear Kashmir's call—a voice woven of snow, stone, forest, river, and human longing. Kashmir's mountains are more than scenery; they are identity, memory, and livelihood. The Pir Panjal, the Zabarwan, the Karakoram—all form an unbroken ring of presence around the valley, shaping its climate, culture, and collective consciousness. The mountains determine everything: the crispness of winter, the softness of spring, the fertility of soils, the abundance of orchards, and the quiet retreat of glaciers that once defined the seasonal rhythm of life. For centuries, poets, mystics, travelers, and soldiers have looked upon these mountains and felt humbled. The valley itself evolved around the moods of mountains-from the myths of Satisar to the geopolitics of modern borders. But to appreciate Kashmir on International Mountain Day, one must look beyond postcard aesthetics.

One must understand the valley as a living mountain ecosystem facing unprecedented stress. Across the Himalayas, climate change has accelerated warming at twice the global average. Glaciers retreat faster here than in many other parts of the world, rivers swell unexpectedly or shrink

unpredictably, rainfall patterns destabilize, and extreme weather events become frighteningly common. Kashmir, with its unique mountain ecology, finds itself on the front line of this planetary upheaval. The mountains, once symbols of permanence, now seem delicate and vulnerable. The forests of the Himalayas are among the richest repositories of biodiversity, and Kashmir's slopes nurture countless plant species, medicinal herbs, and animal life. The musk deer, the Hangul, the brown bear, and the snow leopard inhabit these upper zones-creatures whose survival depends on the integrity of the region's forests and alpine meadows. International Mountain Day is not only a call to protect landscapes but also the lives that flourish within them, including species whose existence is now a silent plea for conserva-

The theme of International Mountains Day varies each year, but the underlying philosophy remains: mountains matterand their protection is an essential component of global environmental health. In Kashmir, this philosophy acquires sharper contours. The valley's economy-built upon tourism, horticulture, pastoralism, and handicrafts—relies heavily on the stability of mountain ecosystems. The mountains of Kashmir have always supported a delicate balance of ecological relationships. Yet challenges are immense. Deforestation, though reduced in recent years, remains a historical wound. Overgrazing in sensitive meadows, unregulated construction in fragile zones, pollution from expanding towns and tourism hubs, and climate-induced degradation collectively strain the resilience of mountain ecosystems. In many parts of Kashmir, the once-clear streams now bear sediment load from erosion, while wetlands—the natural sponges of mountain hydrologyshrink under pressure from encroachments. Dal Lake, for example, symbolizes both the breathtaking beauty of the valley and the consequences of ecological neglect. Any disruption in snowfall patterns affects water availability; any retreat of glaciers alters river flow; any degradation of forests destabilizes slopes and increases vulnerability to lands lides. Thus, the health of Kashmir'smountains is inseparable from the social and economic well-being of its people.

Tourism is another dimension of Kashmir's mountain narrative. The valley has long been celebrated as "Paradise on Earth," attracting travelers drawn to its serene lakes, snow-laden slopes, and lush meadows. Habba Khatoon's hill, the Shankaracharya peak, the Harmukh revered in lore, the passes once used by caravans—all stand as cultural monuments shaped by both nature and human story. On International Mountain Day, celebrating Kashmir means honoring this cultural heritage alongside ecological preservation. Mountain cultures often embody principles of coexistence, balance, and humility—values the modern world desperately needs. Another critical issue is the necessity for peace and stability. Mountains in the Himalayan region, including Kashmir, are often entangled in geopolitical complexities. But mountains thrive on harmony-between people and land, between communities, and across borders. Environmental cooperation can become a powerful avenue toward soft diplomacy. Shared glaciers, rivers, and biodiversity corridors demand collaborative management. International Mountain Day is a reminder that mountain conservation can transcend political divisions and encourage shared ecological

The future of Kashmir depends on thoughtful environmental governance. Policies must integrate climate adaptation, biodiversity protection, sustainable tourism, forest preservation, and disaster risk reduction. Investment in scientific research, particularly in glaciology and hydrology, will be crucial. Strengthening community participation ensures that solutions are grounded in local realities. On International Mountain Day, as the world celebrates these towering sentinels of Earth, Kashmir offers itself as a luminous reminder that mountain conservation is not merely an environmental necessity—it's a cultural, emotional, and existential imperative. The mountains call, and we must answer. Mountain literature in India represents a unique confluence of geography, culture, imagination, and spiritual quest. From the towering Himalayas to the verdant ranges of the Western Ghats, Indian writers have long viewed mountains as living presences-timeless, wise, and deeply symbolic. Dry air can also induce respiratory tract irritation and make it easy for the virus to enter the body and create havoc on the overall well-being of the child. Moreover, the child's immunity can take a hit during winter. Shorter daylight hours reduce exposure to sunlight and lead to low vitamin D levels. The child should maintain optimal vitamin D levels to boost immunity and bone health. A majority of children also stay indoors when the weather outside is cold, and this can further increase the infections when they are in enclosed spaces. Hence, take charge of the child's health,"," she adds and shares important tips to take care of children's health.

The child should be given a well-balanced diet: Parents need to include seasonal vegetables such as spinach, carrots, peas, beetroot, whole grains, and soups. The child needs to avoid junk, oily, canned, and processed foods. Vitamin C-rich foods such as oranges, guava, amla, and strawberries help boost immunity and should be added to the diet without fail. The child should drink enough water, opt for warm milk to strengthen the immune system.

Sleep well: A good night's sleep improves immunity and aids the growth of the child.

Vitamin D exposure: The child should be exposed to the sun for at least 20 minutes in the morning to be able to maintain appropriate vitamin D levels.

ASEAN- India tourism exchange kicks off in Guwahati, puts NE at heart of regional travel plans

NEW DELHI, DEC 13: Guwahati hosted the opening of the ASEAN-India Tourism Professionals Exchange Programme 2025, bringing together tourism professionals from India and ten ASEAN member countries for a weeklong engagement aimed at strengthening regional travel linkages and positioning the North East as a key connector in ASEAN travel circuits.

The programme, organised by the Assam Tourism Development Corporation Ltd under the aegis of the Ministry of External Affairs, is being held from December 12-17 across Guwahati, Kaziranga and New Delhi. It focuses on building practical partnerships through business meetings, trade interactions and on-ground exposure to tourism products, with an emphasis on communityled and sustainable models.

The exchange follows India's participation at the MATTA Fair 2025 in Kuala Lumpur, where Assam and the North East were showcased as emerging destinations during the ASEAN-

India Year of Tourism. The current initiative seeks to convert that interest into tangible outcomes by giving ASEAN stakeholders a first-hand experience of the region's tourism infrastructure, heritage and natural assets.

They are joined by representatives from Indian tourism industry bodies and regional organisations. The opening days in Guwahati featured formal sessions, B2B meetings and experiential activities designed to encourage collaboration between tour operators and policymakers.

The programme began with the arrival of delegates in Guwahati on December 12, followed by a sunset cruise on the Brahmaputra that highlighted Assam's river tourism and community-based experiences. On December 13, the exchange was formally inaugurated at Hotel Mayfair, Guwahati, with structured business meetings



between tour operators from the North East, other parts of India and ASEAN countries. The day concluded with a cultural evening showcasing Assamese music, dance and cuisine.

Discussions during the opening phase also focused on improving regional connectivity, including new air routes, upgraded highways and the upcoming terminal at Guwahati International Airport, which is expected to ease access for international visitors. Participants explored multi-destination itineraries linking Assam with other North Eastern states and ASEAN destinations, supported by coordinated marketing and digital outreach.

Air quality in the national Capital slipped into the 'severe' category, with Delhi recording an AQI of 431. Other NCR cities also figured among the most polluted in the country: Greater Noida at 442, Ghaziabad at 430, and Panipat at 426, according to the 4 pm national bulletin released by the Central Pollution Control

Board (CPCB) on Saturday. The deterioration has been swift. On Friday, Noida AQI stood at 386 in the "very poor" category, but surged dramatically over the last 24 hours due to calm winds and nipping cold that prevented the dispersal of pollutants.

Experts warned that the situation could worsen in the coming days. Dense fog is likely to prevail over Delhi during the morning hours on Monday and Tuesday, officials from the India Meteorological Department (IMD) said, further hampering air quality.

Forecasts indicate that pollution levels are likely to remain in the "severe" category over the weekend, with the likelihood of improvement from Monday onwards slipping back to the "very poor" category. The Air Quality Early Warning System for Delhi (EWS) has projected severe conditions for Saturday and Sunday, with AQI expected to stay above 450.

As per the CPCB classification, air quality readings between 300-400 fall under the 'very poor' category, which causes respiratory illness on prolonged exposure, while AQI levels above 400, in the 'severe' category, affect healthy people and seriously impact those with existing diseases.UNI

GRAP-3 kicks in; non-Delhi vehicles barred from Delhi-NCR

NEW DELHI, 13 DEC: As Delhi's air quality slipped to the severe category, Graded Response Action Plan 3 (GRAP 3) measures were rolled out across the national capital and neighbouring cities by the Commission for Air Quality Management (CAQM) on

Low wind speeds over the past three days have sharply worsened Delhi's air quality, with the Air Quality Index (AQI) rising from 259 ('Poor') on December 10 to 307 ('Very Poor') on December 11, and further to 349 ('Very Poor') on December 12. The deteriorating conditions pushed air quality into the 'severe' category during the early hours of Saturday.

Noting the sharp increasing trend of pollutants with the persistence of unfavourable weather conditions, in the coming days, the pollution watchdog announced GRAP3 measures for Delhi-NCR.

CAQM noted that PM2.5 is the primary pollutant trapped near the surface, with almost all air quality monitoring stations in Delhi reporting PM2.5 as the predominant pollutant. The city's AQI stood at 387 at 6 am, worsened to 393 by 8 am, and touched 401 at 10 am on Saturday, breaching the 'severe' category. The emergency measures were invoked to prevent further deterioration of air quality in the region, which had declined drastically in the last few days.

"Keeping in view the prevailing trend of air quality and in an effort to prevent further deterioration of air quality in the region, the CAQM GRAP Sub-Committee today has taken the call to invoke all actions as envisaged under Stage-III of extant GRAP - 'Severe' Air Quality (DELHI AQI ranging between 401-450), with immediate effect, in the entire NCR," CAQM said.

Stage 3 restrictions include a ban on non-essential construction, the closure of stone crushers and brick kilns, and restrictions on the use of diesel generators, among other emergency steps aimed at preventing further deterioration. Entry of diesel and petrol vehicles of different, below BS-IV norms in Delhi and the neighbouring NCR region, including Gurugram, Faridabad, Ghaziabad, Gautam Budh Nagar, is not permitted under

To prevent the entry and movement of banned vehicles in Delhi and the NCR, the monitoring agency ordered intensified surveillance using Automatic Number Plate Recognition (ANPR) cameras at fuel stations.



Warner: Head at No. 5 'a worse result' for England

BRISBANE: David Warner has backed his former opening partner Usman Khawaja to return to the top of the order for the third Ashes Test in Adelaide, believing that having Travis Head at No. 5 is the option that can give England the most problems.

If Khawaja is passed fit following his back spasms, Australia's selectors face a huge call ahead of the match where the home side could secure the Ashes. Since Khawaja was unable to open in Perth, Head and Jake Weatherald, the latter in his first Test series, have produced two impactful partnerships. Opinions are divided over the

best way for Australia to go, and coach Andrew McDonald suggested that using Khawaja in the middle order could be an option. But Warner is of the view they should revert to their original

"I think Uzzy comes back in, slides to the top, and Trav goes down," Warner told reporters ahead of captaining Sydney Thunder in the BBL "That's probably a worse result for England, Travis Head going back down the order."

Head averages 41.46 at No. 5, where he has made eight of

his ten Test centuries including three on his home ground at Adelaide Oval. Warner added that Head opening could remain an option when Khawaja retires, although he said there was no guarantee it would work in the

"At the end of the day, Travis not work and Travis will have to put his hand up to bat in the situation he was in," Warner said. "He came out and batted in the way Travis Head does. You see plenty of interviews from Trav saying that is Uzzy's spot, and if when the time comes they ask him to go up the order, he wouldn't

mind to do that. "We didn't have that aggres-

sor down in the middle order [in previous years]. Australia has that now as well, and moving forward with whatever Uzzy decides to do, if he hangs them up, they can look that way. "But then it's on all of us to

understand that potentially might

go back down the order. And then they are going to have to look for another replacement. The selectors have a headache." Warner endorsed Queensland's Matt Renshaw as

the long-term option to open when Khawaja steps away.


'We've got a lot of young [opening] talent there at the mo-

ment that's coming through," he said. "But what I will say to George Bailey and the selectors is to show faith in their 31-yearold, Jake Weatherald. I think experience is key as well.

"So credit to them if they've picked him. But moving forward, Renshaw could be one. I think he'll slide straight back in there. He's had a taste of Test cricket."

Australia have not had a settled opening combination since Warner retired in early 2024. Prior to Khawaja's injury, he had gone in with five different opening partners across 15
