


Defend Post-2019 Security Gains, Neutralise Every Terrorist & Enabler : LG Manoj Sinha

Chairs UT-level Security Conference in Jammu; calls for coordinated, AI-driven offensive against terror ecosystem

JAMMU, DEC 18: Lieutenant Governor of Jammu & Kashmir, Shri Manoj Sinha, on Wednesday chaired a UTlevel Security Conference in Jammu and issued a strong call to defend the security gains achieved since 2019 by decisively neutralising every terrorist, overground worker (OGW), supporter and ideologue operating across the Valley, forests, hills and villages.

Addressing senior officers from the J&K Police, Army, Intelligence agencies,



Civil Administration and Central Armed Police Forces (CAPFs), the Lieutenant Governor said the conference, held under the guidance of Hon'ble Prime Minister Shri Narendra Modi and Hon'ble Union Home Minister Shri Amit Shah, aims to strengthen a "whole-of-government" approach to counter terrorism in all its

Referring to the recent DGPs/IGPs Conference, the Lieutenant Governor noted that extensive deliberations were held on the theme "Viksit Bharat: Security Dimensions," reflecting the Government of India's commitment to modernising policing and security institutionsto meet emerging challenges.

V.K. Paul, Member, NITI Aayog, in the presence of Chief Secretary, Atal Dulloo.


The high-level interaction focused on strategic interventions, technological integration, academic collaboration, and capacity augmentation aimed at ensuring equitable, accessible, and quality healthcare services across all districts of the UT.

The meeting was attended by the Secretary, Health & Medical Education Department; Managing Director, National Health Mission; Director, SKIMS; Principals of Government Medical Colleges; Executive Director, SMVDIME; Director Health Services, Jammu/ Kashmir; CEO, State Health Agen-

cy, besides other senior officers. Addressing the meeting, Dr. V.K. Paul assured the UT of NITI Aayog's full support in strengthening institutional capacities and developing human resources. He advised the Department to imple-

Highlighting achievements over the past six years, Shri Sinha said the strengthened security grid and close coordination among the J&K Police, Army, Intelligence agencies and CAPFs have resulted in a significant decline in terrorist violence, the number of active terrorists and

He further stressed that armed terrorists, their supporters, OGWs and elements intimidating common citizens must be dealt with

"They must be made to pay a very heavy price for their actions," the Lieutenant Governor

Addressing evolving security challenges, Shri Sinha said the threat landscape has undergone profound changes, necessitating a shift from reactive to proactive strategies. He called for the adoption of advanced technologies, including Artificial Intelligence, to counter terrorism, terror financing, radicalisation and narco-terrorism.

The day-long UT-level Security Conference focused on strengthening intelligence capabilities, enhancing inter-agency coordination and building a next-generation security grid to tackle new-age threats effectively.

environment, the Defence Minister said public confidence in India's defence preparedness was clearly visible during attempts to target Indian installations, as citizens remained calm and reassured of the country's air defence

Singh stressed the importance of continuously assessing an adversary's offensive and defensive strengths to maintain a decisive operational edge, urging commanders to stay vigilant against emerging and unconventional

Referring to recent global and regional conflicts—including the Russia-Ukraine war, the Israel-Hamas conflict, the Balakot air strikes and Operation Sindoor—he said air power has become a defining element of modern warfare. Air power, he noted, now serves not only tactical objectives but also strategic messaging through speed, reach and precision.

The Defence Minister observed that 21stcentury warfare is increasingly driven by technology and adaptability, with cyber operations, artificial intelligence, unmanned platforms, satellite-based surveillance and space capabilities playing an expanding role. Precisionguided weapons, real-time intelligence and data-centric decision-making, he added, are now integral to military planning.

Reiterating the government's commitment to strengthening national security, Singh said the proposed Sudarshan Chakra air defence initiative, announced earlier by Prime Minister Narendra Modi, would significantly enhance protection of critical national assets. He also described the development of indigenous jet engines as a national mission.

Singh said the government is actively partnering with private industry, start-ups and MSMEs to modernise the Armed Forces through initiatives such as iDEX and ADITI. As of November 2025, he noted, 672 winners had emerged from 565 challenges under iDEX, including 96 aligned with Indian Air Force requirements.

Describing Operation Sindoor as a model of tri-services coordination, the Defence Minister emphasised the need for greater jointness to enhance operational effectiveness. He also lauded the IAF's contributions to humanitarian assistance and disaster relief missions, both within the country and overseas.

The conclave was attended by Chief of Defence Staff General Anil Chauhan and senior IAF commanders. Air Chief Marshal A P Singh briefed the Defence Minister on the force's current operational preparedness.

taken into custody from New Delhi under relevant provisions of the Unlawful Activities (Prevention) Act, 1967 and the Bharatiya Nyaya Sanhita (BNS), 2023 in case RC-21/2025/NIA/ DLI, sources told Kashmir News Observer (KNO).

According to the NIA, investigations have revealed Yasir's active involvement in the conspiracy that led to the high-intensity explosion on November 10. The agency said he had sworn allegiance and taken an oath to carry out "selfsacrificial" operations, indicating deep ideological and operational commitment to the

plot. Probe findings further suggest that Yasir was in constant contact with other accused, including Mufti Irfan and Dr Umar Un Nabi, the suicide bomber who detonated the explosives while driving the vehicle near the historic Red Fort area.

The anti-terror agency said it is working in close coordination with central and state agencies to unravel the entire terror network, its logistics, and support systems. As part of the ongoing investigation, the NIA recently carried out extensive searches across Jammu and Kashmir and Uttar Pradesh, seizing digital devices and other incriminating materials.

Earlier, similar searches were conducted at the premises of the prime accused, Dr Muzammil Shakeel Ganie and Dr Shaheen Saeed, at the Al Falah University complex and other locations in Faridabad, Haryana.

So far, nine accused have been arrested, including several medical professionals, pointing to what investigators have described as a "white-collar terror module." Following the

arrest of co-conspirators Dr Adeel and Dr Muzammil, Jammu and Kashmir Police recovered over 2,900 kilograms of explosives from Faridabad, marking a major breakthrough in

The blast investigation was transferred to the NIA by the Ministry of Home Affairs soon after the attack. The agency said it is tracing every link, associate, and angle connected to the incident to expose the full scope of the conspiracy behind one of the deadliest attacks in the national capital in recent times.

power supply, unlike several other renewable sources that are intermittent in nature. He noted that India is increasingly positioning itself as a global leader rather than a follower in areas such as clean energy, climate action and ener-

"In the last 10–11 years, India has assumed global role for itself. We are no longer following others; we are offering cues for others to follow," Singh told the House.

He said that since 2014, the government has rioritised global concerns including clean and sustainable energy, with a clear push towards reducing dependence on fossil fuels and petroleum resources. Nuclear energy, he added, is a critical component of this transition.

Singh informed the House that significant steps have been taken to strengthen the nuclear sector. The budget of the Department of Atomic Energy has increased from ₹13,879 crore before 2014 to ₹37,483 crore in the current financial year. He also recalled that in 2015, the government allowed joint ventures in the nuclear sector, though initially limited to public sector undertakings.

Further expansion followed in 2017 with Cabinet approval for setting up 10 nuclear reactors. In September 2025, the Prime Minister laid the foundation stone for four nuclear reac-

The minister said India's nuclear power capacity has nearly doubled from 4.7 GW in 2014 to 8.9 GW at present. However, nuclear energy currently accounts for only about 3 per cent of the country's total power generation. To raise this share to at least 10 per cent by 2047, the government has launched a dedicated nuclear energy mission in the current budget.

A key element of the mission, Singh said, is the entry of private players into the nuclear sector, supported by robust safeguards and monitoring systems. The Bill also provides statutory status to the nuclear regulatory board to strengthen oversight.

"Let me assure the House that no compromise will be made on the safeguard mechanism," the minister said, reiterating the government's commitment to safety and regulation as India expands its nuclear energy footprint.

aimed at attracting both domestic and international tourists and increasing overall footfall.

The minister said the Union government is also extending financial and technical support for strengthening tourism infrastructure in the Union Territory through central sector schemes such as Swadesh Darshan, the Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD), and Assistance to Central Agencies for Tourism Infrastructure Development (ACATID).

Under the Swadesh Darshan scheme, several projects were sanctioned in Jammu and Kashmir under the Himalayan Circuit during 2016–17. These include development of the Jammu-Srinagar-Pahalgam-Bhagwati Nagar-Anantnag-Salamabad Uri-Kargil-Leh circuit at a sanctioned cost of ₹77.33 crore, with ₹67.37 crore released, and development of tourist facilities along the Jammu-Rajouri-Shopian-Pulwama circuit for ₹81.60 crore, of which ₹67.35 crore has been released.

Shekhawat said other projects under the scheme include reconstruction of tourism assets damaged in the 2014 floods under the Prime Minister's Development Package, sanctioned at ₹90.43 crore with ₹74.70 crore released, and development works at Mantalai and Sudhmahadev at a cost of ₹91.99 crore, nearly fully released.

Tourism infrastructure has also been developed along the Anantnag-Pulwama-Kishtwar-Pahalgam-Zanskar-Padum-Daksum-RanjitSagar Dam circuit at a cost of ₹86.39 crore, with ₹69.95 crore released, and the Gulmarg-Baramulla-Kupwara-Kargil-Leh circuit at a cost of ₹91.84 crore, with ₹85.80 crore released,

the minister said. Under the PRASHAD scheme, ₹40.46 crore was sanctioned for development works at the Hazratbal Shrine in Srinagar, against which ₹34.30 crore has been released. In addition, a sound-and-light show at Nigeen Lake was approved under ACATID at a cost of ₹5 crore. with ₹3.08 crore released, he added.

year of simple imprisonment and ordering substantial monetary compensation to the complainant.

The judgment was pronounced on December 17 by the Court of the Chief Judicial Magistrate, Shopian, in the case Shahnawaz Ahmed Bhat vs Bashir Ahmed Bhat. The court found the accused, Bashir Ahmed Bhat of Bongam, Shopian, guilty under Section 138 of the Negotiable Instruments Act.

According to the court record, the complainant Shahnawaz Ahmed Bhat stated that the accused had issued a cheque of ₹5 lakh in September 2018 towards a financial liability arising from joint work undertaken by both parties. When the cheque was presented at the J&K Bank, HR Shopian branch, it was returned unpaid with the endorsement "Exceeds Arrangement."

The complainant subsequently issued a statutory demand notice, which the court held was duly served on the accused. During the trial, multiple witnesses were examined, and the court observed that the accused failed to rebut the mandatory legal presumption of liability. The defence plea that the cheque had been lost or misused was also rejected.

Holding that the cheque was issued in discharge of a legally enforceable debt, the court sentenced the accused to one year of simple imprisonment and imposed a fine of ₹10,000. In addition, the court directed him to pay the cheque amount of ₹5 lakh along with six percent interest from the date of issuance, besides ₹50.000 as compensation to the complainant.

The court also cancelled the bail bonds of the convicted person and ordered his immediate custody, directing that he be lodged in District Jail, Pulwama.

defined hub-and-spoke model, with institutions frozen for specific roles and responsibilities. Emphasizing structured execution, he called for clearly detailing institutional activities to ensure time-bound progress toward predefined goals.

Dr. Paul also stressed the need for a flexible and collaborative framework, enabling institutions to seek support from one another and adopt best practices nationally. He urged the Department to go beyond the Terms of Reference of the high-level committee constituted by the UT and explore the establishment of advanced facilities such as Eye Banks, strengthening Forensic Medicine, and upgrading Emergency and Trauma Care services across health-

Calling for a pragmatic yet ambitious approach, Dr. Paul assured that NITI Aayog would facilitate linkages with premier national institutions and provide expert guidance to help J&K achieve its healthcare objectives.

On the occasion, Chief Secretary Atal Dulloo sought NITI Aayog's guidance on strategies to retain senior faculty in medical colleges, attract talent from outside the UT, and extend specialized healthcare services to far-flung, mountainous, and border areas.

He also acknowledged NITI Aayog's crucial role in guiding the UT's health sector reforms, particularly over the past few months, which resulted in the addition of dozens of postgraduate seats and hundreds of MBBS seats across medical colleges in J&K.

The Secretary, Health & Medical Education Department, Dr Syed Abid Rashid Shah presented a comprehensive overview of the initiatives undertaken following sustained consultations with Dr. Paul over the past several months.

He outlined progress in expanding tertiary healthcare services to district hospitals, augmentation of UG, PG, and DNB seats, and development of a robust governance framework. He also detailed the proposed roles, responsibilities, accountability mechanisms, monitoring and evaluation systems, and implementation time-

The Executive Director, SMVDIME, Dr. Yashpal Sharma, made a detailed presentation on the proposed healthcare interventions envisaged with active support from NITI Aayog.

Key interventions deliberated during the meeting included the strengthening of critical care services through Tele-ICU rollout in government hospitals under a hub-and-spoke model. It was revealed during this meeting that the Tele-ICU tender, vetted by Team NITI Aayog, has already been floated. To address diagnostic gaps, particularly in peripheral and underserved areas, the UT also plans to implement Tele-Radiology services, for which the tender is in the final stages.

The Health Department is also exploring the establishment of a Dentistry Department, while the creation of Oral & Maxillofacial Surgery and Pedodontics departments in newly established GMCs is under active consideration, the meeting was informed.

Dr. Paul was further apprised about the constitution of a high-level committee tasked with devising collaborative models among AIIMS Jammu, SKIMS Soura, GMC Jammu, GMC Srinagar, and the newly established GMCs. The committee was tasked to focus on cardiology, cancer care, mental health, telemedicine, tele-

radiology, and academic integration, including enhancement of UG, PG, and DNB training capacities.

The Department also sought NITI Aayog's assistance in taking up the matter with the National Medical Commission (NMC) for designating District Hospitals as Associated Hospitals of Government Medical Colleges, a move aimed at improving clinical exposure and decentralizing healthcare delivery.

Detailed deliberations were also held on strengthening Drug De-addiction, Mental Health, and Social Health priorities, with a draft action plan titled "Circle of Care", prepared by Dr. Arshad Hussain, Professor of Psychiatry, GMC Srinagar, submitted to NITI Aayog for its consideration.

In another major development, facili-

tated by NITI Aayog, it was learnt that the Institute of Liver and Biliary Sciences (ILBS) has agreed to provide training to transplant teams along with continued technical support and mentoring. In this regard, a formal request has been submitted by the Health & Medical Education Department seeking support for establishing Liver Transplant facilities in the UT.

The meeting concluded with a reaffirmation of NITI Aayog's continued guidance and support in transforming Jammu & Kashmir's healthcare landscape through technology-driven solutions, academic collaboration, and systemic capacity building, ensuring accessible, affordable, and quality healthcare for its citizens across the length and breadth

KUPWARA, DEC 18: In continuation with the government's public outreach programme, Minister for FCS&CA, Transport, Youth Services and Sports, IT, Science and Technology, Satish Sharma, along with Advisor to the Chief Minister, Nasir Aslam Wani today reviewed the progress and performance of several departments during a meeting held at Kupwara.

The meeting was attended by MLA Kupwara Mir Mohammad Fayaz, MLA Karnah Javid Ahmad Mirchal, MLA Langate Khurshid Ahmad Sheikh, Deputy Commissioner Kupwara Shrikant Suse, ADC Handwara, RTO Kashmir, Joint Director FCS&CA and Joint Director Youth Services & Sports, Chief Planning Officer and other concerned district officers.

While reviewing the Food, Civil Supplies & Consumer Affairs Department, the Minis-

ter was informed that a total of 6,67,755 beneficiaries have been registered under NFSA and non-NFSA categories in the district. It was further informed that 267.81 metric tonnes of rice have currently been stocked at the main FCS&CA depot at Bumhama. Adequate stock of rice, atta and sugar have already been pre-positioned in border and snow-bound areas, including Karnah, Machil, Keran, Budnamal, Jumgund and Kumkadi, which are being serviced through 170 centres.

The Minister emphasized the need to ensure an uninterrupted supply of essential commodities, particularly in snowbound and hard-to-reach areas, so that the residents do not face any inconvenience during harsh weather conditions.

Reviewing the Transport Department, the ARTO Kupwara apprised the Minister of the number of passenger buses, trucks and cabs operating in the district. It was informed that ₹15.91 crore have been realized

Allegations of Illegal Soil Extraction from Saffron Land Rock Konibal Pampore; DC **Assures Action**

PAMPORE, DEC 18: Serious allegations of largescale illegal extraction of soil from saffron-bearing land at Konibal, Pampore, have triggered concern among locals and agricultural stakeholders, as the activity is believed to pose a serious threat to the region's centuries-old saffron cultivation.

According to residents of the area, heavy quantities of soil are being unlawfully excavated from saffron fields and smuggled towards Ramban and Jammu, where it is allegedly sold at a rate of nearly ₹20,000 per dumper. Locals claim that the illegal activity has been going on for some time and is being carried out brazenly during night hours. Three individuals, whose identities have been withheld. are alleged to be directly involved in the operation. Residents allege that these persons frequently spend several nights every week at Konibal and carry out the extraction of soil from saffron land without any

The alleged extraction is a clear violation of the standing orders issued by the Hon'ble Deputy Commissioner, Pulwama, Dr. Basharat Qayoom, who has categorically prohibited the removal of soil from saffron land in Pampore in order to safeguard the fragile ecosystem and protect the unique crop for



which the area is internationally renowned.

Taking cognizance of the complaint, the Deputy Commissioner Pulwama has assured that the matter will be looked into. Responding to the allegations, the DC stated, "Yes, I will look into it and review the Action Taken Report (ATR)." In official administrative terminology, an Action Taken Report (ATR) refers to a formal account of the steps initiated by the concerned authorities after verification of the complaint.

The assurance from the district administration has brought some relief to the locals. However, residents have stressed that mere assurances are not enough and have urged the authorities to take swift and stringent action against those involved. They warned that continued illegal extraction could cause irreversible damage to Pampore's saffron fields, threatening both livelihoods and the cultural heritage associated with the prized crop.

Locals have appealed to the administration to conduct ground verification, deploy enforcement teams, and ensure strict implementation of existing orders to preserve the iconic saffron landscape of Pampore.

Comprehensive Assessment Ordered to Ensure Rational Stamp Duty Implementation from January 1, 2026

BUDGAM , DECEMBER 18: A review meeting regarding the revision of stamp rates for the year 2026 was chaired by the Deputy Commissioner (DC) Budgam, Dr. Bilal Mohi-ud-Din Bhat, at the District Headquarters.

The meeting was attended by the ADC Budgam Mehraj-uddin Shah ,General Manager, District Industries Centre Budgam Zahid Ahmad; Assistant Commissioner Revenue, Budgam; Assistant Commissioner Panchayat, Budgam; Divisional Forest Officer, PP Forest Division Budgam; Sub Registrar, Budgam;

Development Department, Sub-Divisional Budgam; Magistrate Beerwah/Chadoora/ Khansahib; and Executive Officers of Municipal Councils/Committees of Budgam, Beerwah, Chadoora, Charar-i-Sharief, Khansahib and Magam.

During the meeting, a detailed review of the existing stamp rates was undertaken in light of the proposed revisions for 2026.

The DC emphasized that the revision process must be carried out in a scientific, data-driven and objective manner, taking into account prevailing market trends, recent developmental activities,



and variations in land use patterns across urban, semi-urban and rural areas of the district.

He directed that a comparative analysis of current stamp rates and proposed revised rates be conducted with due consideration commercial viability, residential expansion and overall economic activity in different localities. The DC highlighted about importance of ensuring uniformity, transparency and rationality in the revised rates so as to prevent both undervaluation and undue financial burden on the public.

The DC further stressed the need for close inter-departmental coordination, directing all concerned departments to furnish relevant inputs and factual data within the prescribed timeframe.

He underlined that the revised stamp duties must be well-

and aligned with existing legal provisions and government policies.

The DC also emphasised timely finalization of the exercise so that the revised stamp duties are notified and implemented uniformly with effect from 1st January, 2026, ensuring smooth administration and enhanced revenue realization for the district.

He directed all concerned officers to submit their detailed reports and recommendations promptly for further examination and necessary action at the District

Air Quality in Focus: J&K's Window of Opportunity Amid a **National Challenge**

As air quality makes headlines across India, with the National Capital continuing to report the highest pollution levels today, the broader national picture presents a mix of concern and cautious optimism. In several regions, a marginal easing of Air Quality Index (AQI) levels has been observed, largely due to changing weather conditions and ongoing mitigation efforts. For Jammu & Kashmir—particularly the Kashmir Valley and its summer capital Srinagar this moment offers an important opportunity to consolidate relative gains and plan wisely for the future.

Although J&K Better Than Many, But Not Immune Compared to the severely polluted urban centres of the northern plains, air quality across Jammu & Kashmir has generally remained in the moderate category in recent days. Srinagar's AQI, while fluctuating, has not approached the alarming levels seen in Delhi and parts of the NCR. This relative advantage stems from a combination of factors: lower industrial density, greater forest cover, and periodic ventilation from western disturbances.

However, geography is a double-edged sword. The Valley's bowl-like topography, coupled with winter temperature inversions, can trap pollutants close to the ground. Localised sources—such as domestic heating with firewood and coal, open waste burning, brick kilns, and vehicular emissions—become more prominent during colder months. As winter deepens, even moderate pollution can have pronounced health impacts, particularly on children, the elderly, and those with respiratory ailments.

We need to Learn from the National Experience. Delhi's continued position as the most polluted city today serves less as a point of comparison and more as a cautionary tale. It demonstrates how quickly air quality can deteriorate when emissions meet unfavourable weather conditions. For J&K, this underscores the value of early, preventive action rather than reactive crisis management.

Authorities in the Union Territory have already taken steps to strengthen monitoring and regulate major pollution sources. These efforts deserve recognition, especially in a region with unique climatic and logistical challenges. Continued focus on cleaner household heating options, phased reduction of high-emission fuels, and strict checks on construction dust and waste burning can help prevent sharp winter spikes.

A Balanced, Forward-Looking Approach is the need of the hour. Improving air quality is not about assigning blame; it is about shared responsibility and steady progress. In J&K, the emphasis should be on preserving existing environmental advantages while addressing emerging risks.

Cleaner heating solutions for urban and semi-urban households to reduce winter smoke.

Enhanced public awareness so citizens understand how everyday practices affect local air.

Urban planning and green cover protection, especially in Srinagar, to maintain natural sinks for pollutants. Reliable, transparent AQI reporting, enabling schools, hospitals, and workplaces to take timely precautions.

Weather may offer temporary relief, but durable improvement comes from consistent policy, community cooperation, and long-term planning. Jammu & Kashmir still has the chance to chart a different path from the heavily polluted metros—one that balances development with environmental stewardship.

As the country watches AQI trends closely, J&K's relative stability should not breed complacency. Instead, it should encourage timely action so that clean mountain air remains a defining feature of the region, not a seasonal memory.



To conclude, the youth should realize the purpose of their lives & should read the Quran & understand its teachings so that they can live a successful life in this world & the life hereafter.



For many, the Army isn't just a job; it's a lifestyle where cantonments become homes, bugle calls mark mornings, and fellow soldiers become family, fostering a profound sense of belonging and pride in serving India.

The Honour of the Tricolour

The monsoon rain had softened the earth around the flagpole, but it did little to dampen the spirits of the small band of soldiers. It was a time of immense turmoil; the air crackled with the fervent energy of a nation demanding its independence.

Among them was Corporal Ayyappan, a man whose quiet resolve belied his youth. A few years prior, he had left college to join the Quit India Movement, driven by Mahatma Gandhi's call for autonomy. The alpha paused, confused, then slowly led his pack away, not defeated, but understood, teaching the village that courage wasn't just fighting, but finding a path through fear, even for a wolf.


Maulana Iftikhar Hussain Ansari (RA): A Legacy of Faith, Leadership and Public Service

A FATTY LIVER CAN BE DANGEROUS TO YOUR HEART

'Fatty Liver' commonly finds mention in an ultrasound examination report and is often passed off as an incidental finding, it may not be innocuous after all, suggest recent studies in reputed medical journals.

Japanese and European scientists were the first to report a strange four-fold increase in heart disease in these patients compared to those of the same age and sex who had normal livers. And their observations are proving true across the world.

Using sophisticated techniques, doctors have found the wall of arteries to be thicker and the lumen narrower, causing reduced flow of blood to their heart muscles and brains, in these patients. Their findings support the clinical observation that those with excess fat in their livers are more vulnerable and die earlier from heart problems.

The appearance of a 'bright' and swollen liver suggesting excess fat deposition is a common finding on ultrasound examination. While it is commonly seen in drinkers, it is often seen in tee-totallers too, and is referred to as nonalcoholic fatty liver disease or NAFLD in them. Although the risk of liver damage due to this fat is modest and occurs in only 20 per cent when present for over 20 years, proneness to heart attacks grossly increases.

If a fatty liver is detected or suspected, a reliable simple way to find out "how much fat" and "how bad the liver's condition is" can be answered by a test called Liver Fibroscan (with CAP), a simple, painless, non-invasive test that takes only 10 minutes and gives you the important answer.

NAFLD is usually associated with obesity, diabetes, hypertension or high amounts of circulating fats in the blood, and is often called a "Lifestyle Disorder". Lack of adequate exercise and consumption of excess calories have been shown to lead to obesity and excess fat deposits in the liver. The mechanism underlying this disorder called Insulin Resistance, is like that which occurs in diabetics of the Type 2 variety or the common adult type, in which patients have high circulating levels of Insulin that prove ineffective in driving sugar into cells. Insulin Resistance also causes excess accumulation of fat in liver cells, as well as thickening of arteries that cause heart or brain disease.

Regular exercise and reduction of weight form the fulcrum of treatment for this disorder. Apart from helping reduce weight, aerobic excercise up-regulates a protein (glut-4) that restores the sensitivity of cells to circulating insulin. Hence insulin and sugar levels both come down, fat gets mobilised from the liver, buttocks and abdomen, and the increased risk of heart disease is restored to normal levels.

India is in the eye of an emerging global epidemic of diabetes and heart disease. While our genes may be partly accountable for our misfortune, the greater share of blame lies in our reluctance to exercise regularly. While vagaries of weather and unsafe roads may come as handy excuses, we Indians, more than any other race, need to shake off our laziness and indulge ourselves in far more and regular exercise than what we are doing at present. And we need to start quite urgently if we need to live longer and healthier lives.

Effective medications are now available to help you shed fat from your liver. But much depends on your motivation and will power to adhere to a "diet-and fitness" regime to get your liver and heart into good shape.

Natural Vs Refined Sugar: **Nutritionist Decodes The Difference**

Simply put, sugar is a form of simple carbohydrate that the body converts into glucose and uses for energy. But the effect on the body and overall health depends on the type of sugar one is eating, either natural or refined. Natural sugars are found in fruit as fructose and as lactose in dairy products, such as milk and cheese. They contain essential nutrients that keep the body healthy and help prevent disease. The natural sources of sugar are digested slower and help you feel full for longer. It also helps

keep your metabolism stable. Natural vs refined sugar

Refined sugar such as: white sugar, brown sugar, cane sugar, coconut sugar, palm sugar, highfructose corn syrup, etc. All these sugars mainly come from plants but have been processed in some way to a simple, sweet form, thus they are processed or refined. Due to which an increase in the consumption of refined sugar has led to the rise in obesity rates, which is associated with higher risks of cancer.

Fibre is a huge key. When sugar from fruit is taken



up, the fiber that comes with it slows down the absorption rate of sugar. This is so, because natural sugars found in whole foods don't increase blood sugar levels as fast as refined sugar. Adding up, to help slow down the absorption of the fruit even more is to pair your fruit with a meal, including a protein.

Berries such as strawberries, raspberries and blackberries are lowest in natural sugar, while the highest are dried fruits, bananas, and mangoes. Fruit juices are also high in sugar, so opt for whole fruit instead. Even though if one consumes the same number of calories from whole fruit and juice, the metabolic effects are very different. Thus, metabolically speaking, juice is more or less similar to soda than it is to whole

Metabolism Matters

The way body metabolizes the sugar in fruit and milk differs from how it metabolizes the refined sugar added to processed foods. The body breaks down refined sugar rapidly, causing insulin and blood sugar levels to skyrocket. Because refined sugar is digested quickly, one doesn't feel full after you're done eating, no matter how many calories you consumed. Hence, the fiber present in fruit brings down metabolism, as fruit in the digestive tract expands to make you feel full.

To understand better about added and natural sugar, the best piece of advice we have now is to simply eat less sugar, with the whole fruit as a notable exception to this rule. Ideally, our diets should be low in sugar and high in fibre, consisting primarily of fruits, vegetables and whole grains.

Thus, there is not much difference between sugar that is present in food naturally and the one that is added. Yet, how it's presented to the body, what comes with it, and the quantity is masks much, much difference.

This human molecule is helping Covid virus escape antibodies

A natural molecule called biliverdin present in human body is helping SARS-CoV-2, the virus that causes Covid-19, escape antibodies - a discovery that can help explain why some Covid patients become severely ill despite having high levels of antibodies against the virus, report researchers.

When SARS-CoV-2 infects a patient's lungs, it damages blood vessels and causes a rise in the number of immune cells.

'Both of these effects may contribute to increasing the levels of biliverdin and bilirubin in the surrounding tissues. And with more of these molecules available, the virus has more opportunity to hide from certain antibodies," said Annachiara Rosa, first study author

at the Francis Crick Institute in the UK. "This is a really striking process, as the virus may be benefiting from a side-effect of the damage it has already caused," Rosa said in the paper published in the journal Science Advances.

In their research, teams from the Francis Crick Institute, in collaboration with researchers at Imperial College London, Kings College London and UCL (University College London), found that biliverdin and bilirubin, natural molecules present in the body, can suppress the binding of antibodies to the coronavirus spike. As vaccines are rolled out globally, understanding immunity to SARS-CoV-2 and also how the virus evades antibodies is critically important.

The ability of the immune system to control the infection and the quality of the antibody response are highly variable, and not well correlated, between individuals. The scientists discovered that the SARS-CoV-2 spike protein strongly binds to biliverdin, a molecule which was giving these proteins an unusual **Courtesy Healthline** green colouration.

J&K to crack down on bird hazards near airports

2 committees formed to curb birdattracting activities near aerodromes

SRINAGAR, DEC 18: In a move to safeguard air travel, the Jammu & Kashmir government has constituted two committees to monitor and regulate activities prohibited under Rule 91 of the Indian Aircraft

The government has constituted two committees, one each for Kashmir and Jammu, for strict implementation of the Rule 91, which prohibits activities near airports which attract birds, as these can cause dangerous bird strikes to aircraft.

According to an order issued by General Administration Department, a copy of which is in possession of news agency—Kashmir News Observer (KNO), the committee for Jammu is headed by the Divisional Commissioner, Jammu, and comprises Administrative Secretary, Civil Aviation Department; Deputy Commissioner, Jammu; Commissioner, Jammu Municipal Corporation; Senior Superintendent of Police, Jammu ;Director, Urban Local Bodies, Jammu (Member); Member Secretary, J&K Pollution Control Board (Member); and Director, Airport Jammu

The committee for Kashmir is headed by Divisional Commissioner, Kashmir and comprises Administrative Secretary, Civil Aviation Department; Deputy Commissioner, Srinagar; Deputy Commissioner, Budgam; Deputy Commissioner, Pulwama; Commissioner, Srinagar Municipal Corporation; Senior Superintendents of Police, Srinagar/Budgam/Pulwama; Director, Urban Local Bodies, Srinagar; Member Secretary, J&K Pollution Control Board and Director, Airport Srinagar (Secretary)

 $As \, per \, its \, term \, of \, references, the \, committee \, would \,$ immediately identify and map all unauthorized slaughterhouses, meat shops, dairies, piggeries, garbage dumps and other prohibited facilities within 10 km range of International Airport, Srinagar.

The committees have also been mandated to ensure strict enforcement measures including closure or relocation of non-compliant units, in coordination with Urban Local Bodies, Municipal Corporations, Pollution Control Board and law enforcement authorities. The committees would institutionalise the compliance monitoring mechanism with quarterly reports to be submitted to the Director General of Civil Aviation, Government of India—(KNO)

The event will also serve as an effective platform to propagate key government social initiatives, particularly the "Nasha Mukt Abhiyan" and the ongoing war against drugs. By actively engaging youth in sports and physical fitness, the championship seeks to promote a healthy, disciplined and drug-free lifestyle,

The championship, being underlining the role of sports as a powerful tool for positive social change. The Government of Jammu & Kashmir, through the Department of Youth Services and Sports alongside J&K Sports Council, continues to play a sports encouraging traditional and

proactive role in strengthening infrastructure. modern sports alike, and creating opportunities for athletes at all levels. KVB-GRAM GBill, 2025 passed amid strong Opposition protests in Lok Sabha

NEW DELHI, DEC 18: The Lok Sabha on Thursday passed the Viksit Bharat – Guarantee for Rozgar and Ajeevika Mission (Gramin) Bill, 2025, abbreviated as VB-G RAM G, despite strong and vociferous protests from opposition parties.

The bill aims to overhaul India's rural employment framework by providing a statutory guarantee of 125 days of wage employment to rural households, aligning with the national vision of Viksit Bharat

Under MGNREGA, the central government provides the entire cost of wages for unskilled manual work, up to three-fourths of the material cost, and a share of administrative costs.

State governments provide one-fourth of the material cost, administrative costs, unemployment allowance, and compensation in case of delay in wage payments.

The Bill amends this to provide that the scheme will be implemented as a centrally sponsored scheme. State governments will notify a scheme consistent with the Bill, within months from its commencement. The fundsharing pattern between the

central government and state governments will be 60:40 for all states other than the Northeastern and the Himalayan states (90:10). A state and the central government will share the cost of wages, material costs, and administrative costs in the above ratios. The state government will continue to pay unemployment allowance and compensation.

Under the new laws, State governments to bear expenditure in excess of normative allocation: The Bill provides that the central government will determine statewise normative allocation for each financial year. The parameters for these allocations will be prescribed by the central government under Rules. The state government will bear any expenditure incurred in excess of this allocation.

Union Minister of Rural

Development Shivraj Singh Chauhan moved the bill for passage, describing it as a transformative step to strengthen and expand the existing Mahatma Gandhi National Rural **Employment Guarantee Act** (MGNREGA). "The main aim of the Bill is to align the rural development framework with the national vision of Viksit Bharat at 2047 by providing a strengthened statutory wageemployment guarantee of 125



days per financial year to rural households whose adult members volunteer for unskilled manual work, thus enabling their greater participation in the expanded livelihood security system," he

The legislation focuses on empowerment, growth, convergence, and saturation of multiple government schemes through initiatives such as the 'Viksit Gram Panchayat Plans' coordinated via the PM Gati Shakti programme. It also envisions an integrated 'Viksit Bharat National Rural Infrastructure Stack' to manage rural public works effectively, emphasizing water security, core rural infrastructure, livelihood generation, and climate resilience. Addressing concerns about agricultural labor availability, Minister Chauhan noted, "Given the enhanced wage-employment guarantee for the rural workforce, ensuring the availability of farm labor during peak agricultural seasons is essential. Accordingly, the Bill empowers States to notify in advance specific periods covering peak sowing and harvesting seasons during which work under this Bill will not be carried out."

He further explained the funding structure: "Each State Government must prepare a scheme to implement the guarantee under this Bill within six months of the Act's commencement; this will be executed as a Centrally Sponsored Scheme.The Central Government will allocate normative funding

 $to\,each\,State\,based\,on\,objective$ criteria set out in the rules. Any expenditure beyond the approved allocation will be the responsibility of the State Governments.'

On wage provisions, the Minister assured, "The Central Government will notify wage rates for unskilled manual labor under this legislation. Until new rates are set, those under the Mahatma Gandhi NREGA will apply." He added, "If an eligible applicant is not provided work within the prescribed timeframe as per this Bill, the State Government must pay unemployment allowance at the prescribed rate."

For oversight, Chauhan announced the formation of Central and State Gramin Rozgar Guarantee Councils to monitor implementation and advise on key matters. "Transparency and accountability will be ensured through biometric authentication, spatial technology-based planning, mobile and dashboard monitoring, and weekly public disclosures. The social audit mechanism will be strengthened,"

However, the bill met with intense opposition criticism. Congress leaders demanded referral of the bill to a Parliamentary Standing Committee for detailed scrutiny. Senior Congress leader Priyanka Gandhi condemned the bill. stating, "No law should be passed based on someone's whim, ambition and prejudice." Congress members protested in the Parliament premises, holding photographs of Mahatma Gandhi, in whose name the existing MGNREGA was established.

Congress President and Leader of the Opposition in Rajya Sabha, Mallikarjun Kharge, called the renaming of MGNREGA to VB-G RAM G "not just a name change but a planned assassination of the world's largest employment scheme." He accused the government of insulting Mahatma Gandhi and undermining the Right to Work that has transformed rural India. "Against the oppression of this authoritarian ruling government, we will fight from Parliament to the streets," Kharge declared amid protests.

The Bill's passage marks a significant moment in India's rural development policy, reflecting evolving aspirations and a push for integrated, technology-driven governance. Yet, its future implementation faces scrutiny and debate given its profound impact on millions of rural livelihoods. UNI

Delhi govt to install water sprinklers on all flyovers to tackle pollution

NEW DELHI, DEC. 18: Amid mounting concerns over air pollution in the national capital, Public Works Department Minister Parvesh Verma on Wednesday announced a series of infrastructure and enforcement measures aimed at controlling dust and particulate pollution across Delhi.

Under the plan, water sprinklers will be installed on top of all flyovers in the city, supported by dedicated RO plants beneath each flyover.

Sprinklers will be installed on both sides of the flyovers to help suppress dust and reduce pollution levels, the minister said.

Verma said that around 200 anti-smog guns are currently operational across Delhi and are being monitored through GPS. In addition, 270 PWD maintenance vans have been deployed on roads, while 250 mist poles have been installed at key locations. He said the number of mist poles would be increased further, especially at identified pollution hotspots on PWD roads, to strengthen pollution control efforts.

Acknowledging the scale of the challenge, the minister said Delhi's pollution problem could not be resolved in four or six months and would require sustained efforts over several years.

"Pollution will be reduced gradually, year after year. No harsh rules will be imposed on the public," he said, adding that citizens should follow government advisories and adopt lane discipline to ease traffic congestion.

He said the Delhi government is planning for the next 40 to 50 years and urged people to have patience. "You have given us a five-year mandate, not a one-year mandate. Problems cannot be solved overnight, but they will be addressed step by step," Verma said.

The minister also spoke in support of the "One Nation, One Election" concept, saying frequent elections disrupt governance. Citing recent municipal by-elections, he said that ministers, legislators and chief ministers often remain occupied with polls.

"If elections are held once every five years, governments will get adequate time to work effectively," he said.

Launching a sharp attack on the Aam Aadmi Party (AAP), Verma alleged that key works required to tackle pollution such as removal of garbage mountains, footpath repairs, e-waste management, Yamuna cleaning, repair of roads and parks, water treatment plants, drain construction and cleaning, plastic waste management and electric $vehicle\,policy\,implementation\,should\,have\,been\,completed$ during AAP's 11-year rule. "None of these were done. Today, we have to do all this work," he claimed.

He said pollution in Delhi was not a one year old problem but had worsened over many years due to inaction. "Had Arvind Kejriwal done even a little work, we would only have had to complete the remaining

tasks. Instead, the problems have piled up," Verma said. Referring to protests by AAP leaders, Verma alleged that no green waste plant was set up under the previous government, while the present government had initiated work on six green waste plants soon after assuming

office. Describing pollution as a serious issue, Verma said the current leadership was committed to addressing it on the ground. "Unlike the previous government, we are not running away from responsibility. The Chief Minister, ministers and officials are on the streets, working in mission mode to resolve every problem," he

Implementation alone will decide success of labour codes: Justice Manmohan

NEW DELHI, DEC 18: The success of India's landmark labour reforms will ultimately depend on how effectively the four labour codes are implemented on the ground rather than on legislative intentalone, Justice Manmohan of Supreme Court said on Thursday.

lustice Manmohan was delivering the keynote address at 'Decod $ing the Codes-Conference \, on \, Four \,$ Labour Codes', a one-day national conference jointly organised by the Society of Indian Law Firms (SILF) and the Confederation of Indian Industry (CII) here.

The conference brought together members of the judiciary, senior government officials, legal experts and industry leaders to deliberate on the transition to India's new labour law regime. Stressing the importance of clarity, consistency and institutional preparedness across States, Justice Manmohan said many of India's labour statutes, including laws dating back to 1926 and 1936, had become outdated

 $Dr Kumar emphasised \, that \, the$ shift from multiplicity to harmonisation was aimed at ensuring that economic growth and worker protection are not seen as competing "By moving from multiplicity

to harmonisation, the Codes seek to ensure that economic flexibility and worker protection are complementary objectives." he said. Noting that labour is a concur-

rent subject, he added that the success of the reforms would depend heavily on cooperation between the Centre and States.

"Their success will depend on harmonised rule-making by States, capacity-building across stakeholders, and the use of technology to enable transparent, inclusive and simplified compliance," Dr Kumar said, adding that if implemented with care and consensus, the Codes could support India's journey towards Viksit Bharat 2047.

Offering a contrasting view, Senior Advocate Colin Gonsalves raised concerns over the impact of the reforms on workers' rights.

"At a time when India's GDP is growing at nearly 7 per cent, this growth is being built on an army ofinsecureworkers," he said, warn $ing \, that \, the \, increasing \, reliance \, on \,$ arbitration, mediation and conciliation could weaken independent judicial protection for labour.

Inhis inaugural address, Dr Lalit Bhasin, President of SILF and Chairman of the CII National Committee on Legal Services, said the conference was aimed at unpacking the practical implications of the new framework.

"The Codes represent new wines in old bottles," he said, explaining that while they retain the essential ingredients of earlier laws, they introduce new features in line with contemporary industrial relations. "There may be issues in implementing these laws but these would be ironed out in due course," he added.

The conference featured detailed panel discussions on all four Labour Codes — the Code on Wages, Industrial Relations Code, Code on Social Security. UNI

Vajpayee stood for 'politics of conviction, not convenience': Nitin Gadkari

NEW DELHI, DEC 18: Releasing a political memoir on former Prime Minister Atal Bihari Vajpayee in Delhi on Wednesday, Minister Nitin Gadkari $recalled Vajpayee \, as \, a \, strong \, practitioner \,$ of "politics of conviction over politics of convenience". The memoir 'Atal Sansmaran' is penned by Ashok Tandon, who served as media relations incharge in the PMO under Vajpayee.

The release of the book coincides with the 100th birth anniversary month of former prime minister.

Gadkari underlined the relevance of the book in today's political scenario and recalled his personal interactions with the former Prime Minister. He said that a very few leaders matched Vajpayee's intellectual depth or his engagement with literature, art, and culture in the political history of independent India.

Gadkari noted that Vajpayee viewed development as more than physical infrastructure, insisting that it must also encompass human development, patience, and social sensitivity.

Recounting his years of working with Vajpayee, he said the former Prime Minister spoke sparingly but acted decisively. "He believed that if someone came to meet you, you must never



refuse them time," Gadkari said, describing this as a life lesson he learnt as a young party worker and continues to follow as a cabinet minister.

The Minister added that Vajpayee rejected power-centric politics, advocating instead a politics rooted in ideology, conviction and social responsibility. While Vajpayee was not scared of disputes, Gadkari said that he believed it should not be at the cost of ideals.

Vajpayee, he said, believed governance was about institutions and ideas rather than individuals. "Who occupies the Prime Minister's chair matters less than the inheritance of ideas," he said, recalling Vajpayee's

Gadkari also highlighted Vajpayee's ability to disagree without bitterness and his insistence on dignity in public life, even amid sharp political differences. "He believed protest was important, but discussion was indispensable," he said, adding that differences are natural in a democracy, but hatred, personal animosity, should

Present at the release, India TV Editor-in-Chief Rajat Sharma said that one of the most enduring qualities of Vajpayee was he knew when to remain silent. Drawing from poetry and personal exchanges, he described Vajpayee as a leader for whom disagreement never translated into bitterness and for whom dialogue always took precedence over confrontation.

Sharma also reflected on Vajpayee's moral authority and the enduring relevance of his politics. Invoking idioms closely associated with Vajpayee, he said the former Prime Minister often questioned whether power made leaders better human beings.

"Atal ji reminded us that politics must refine people, not corrode them," Sharma said, likening power to a 'kajal ki kothari', a place where stains can appear without warning.

Emphasising the importance of preserving political memory, Sharma said such recollections were vital to guide future generations and ensure that history is not forgotten.UNI

Security heightened in Delhi's **Tihar jail after gangster Anmol Bishnoi's transfer**

NEW DELHI, DEC 18: Security has been significantly strengthened at Delhi's Tihar Jail following the arrival of gangster Anmol Bishnoi, who was recently extradited from the United States. Jail authorities are on high alert, monitoring all movements closely. Anmol Bishnoi is the younger brother of incarcerated gangster Lawrence Bishnoi. His presence in Tihar has raised concerns of a potential gang war, as rival gangsters are already housed in the same facility. Key rival gangsters include Rohit Godara, the Goldy Brar gang, and others linked to the Neeraj Bawana, Bambiha, Himanshu Bhau, Kaushal Chaudhary, and Jaggu Bhagwanpuria networks. In a previous court hearing, Anmol Bishnoi had claimed his life was under threat from Pakistan-based gangster Shahzad Bhatti. The threat landscape is complex, involving former allies turned foes. Lawrence Bishnoi and Goldy Brar, once close associates, are now engaged in a feud, with $threats\,regularly\,exchanged\,on\,social\,media.\,Lawrence$ Bishnoi is currently held in Sabarmati Jail. Tihar Jail has a history of gang violence. In 2023, inmates Prince Tewatia and Tillu Tajpuria were killed in separate incidents inside the prison, raising serious questions about security. CCTV footage of Tajpuria's murder had circulated widely. The central question now is whether Anmol Bishnoi's incarceration will lead to renewed gang conflict within the prison walls or if the administration will be able to maintain control. The situation remains under close watch.UNI







Smith Out With Vertigo; Khawaja Recalled

OVAL: Steven Smith has been ruled out of the third Ashes Test on the morning of the match in extraordinary circumstances with Usman Khawaja earning a recall just a day after it seemed unlikely that he would play another Test for Australia.

Cricket Australia (CA) confirmed just before the start of play that Smith was suffering vertigo type symptoms, something he has battled with in the past. He left the ground during the warm-up after he had batted in the nets and had a conversation with coach and selector Andrew McDon-

Smith missed training on Monday due to illness but had trained on Sunday at Adelaide and then played golf with his team-mates at Kooyonga on Sunday afternoon.

He returned to training on Tuesday and was first in the nets. But he did not look in full health during the net session and was also hit in the groin at one point which felled him and caused him to take a lengthy

"Over the past few days he has been feeling unwell, with symptoms including nausea and dizziness," a CA spokesperson said.

"He was assessed and monitored closely and was close to being available to play. However, given the persistence of symptoms, a decision was made not to proceed.

"He is being treated for a potential vestibular issue. This is something Steve has experienced intermittently in the past and is being managed accordingly. He is expected to be available for the Boxing Day test in Melbourne."

Pat Cummins, who returned as captain after Smith had led the first two Tests, confirmed after winning the toss that Khawaja would replace

"Steve's been feeling a bit unwell the last couple of days," Cummins said. "He came and gave it a crack this morning but didn't think he was going to get up for this one. So he's headed off home. But pretty lucky we've got someone like Usman who can step right in. Usman will bat No. 4"

Khawaja has been recalled after Australia had elected to leave him out despite returning to full fitness from a back injury, with the success of the Travis Head-Jake Weatherald opening partnership in the first two Tests forcing the selectors' hand. Even

with Khawaja's last-minute return, the selectors have decided to keep Head and Weatherald at the top. Khawaja will slot in at No. 4 with the rest of the order remaining the same.

Khawaja has only twice batted at No. 4 in Test cricket, including in the first innings of the first Test in Perth when he was unable to open due to back spasms. It has been his preferred spot to bat in first-class cricket, averaging 53.15 with 10 centuries. He batted at No .4 in Sheffield Shield cricket for Queensland for several years while he was Australia's Test

Khawaja will turn 39 on Thursday, and become the first 39-year-old to play for Australia in 40 years.

Smith has missed two of Australia's last six Tests through injury or illness. He missed Australia's first Test of the West Indies tour in June due to a finger injury he suffered in the WTC final. Josh Inglis batted at No. 4 on that occasion.

Prior to that he had not missed a Test since the third Test of the 2019 Ashes series when he was ruled out with concussion. He has suffered several bouts of vertigo in the intervening years but none that have kept him out of a Test match.


