
Mother Tongue Sustains Culture and Identity: Amit Shah

Urges Families to Speak Local Languages at Home, Calls for Swadeshi Push to Achieve Atmanirbhar Bharat by 2047

JODHPUR, JAN 10: Union Home Minister Amit Shah on Saturday said that language is the foundation of society, culture and religion, asserting that the use of mother tongues within families is essential to keep India's civilisational roots alive.

Addressing the Maheshwari Global Convention in Jodhpur, Shah said people are free to learn and use any language for education or professional growth, but communication with children at home should be in Hindi or regional languages. He said this practice helps children remain emo-



tionally and culturally connected to their history and native place.

"Language alone keeps society and culture alive," the Home Minister said, adding that speaking in one's mother tongue at home naturally instils values, traditions and a sense of belonging in the younger generation.

Stressing the importance of economic self-reliance, Shah said the vision of making India a developed nation by 2047 can be realised only through Atmanirbhar Bharat, with Swadeshi as its guiding principle. He urged business communities

He was speaking during an informal New Year luncheon hosted for journalists and media persons at his residence here, continuing a decade-long tradition of periodic interactions aimed at fostering open dialogue and constructive feedback.

reforms and national development. Journalists from print and electronic media shared their perspectives on policy implementation and emerging areas of public interest.

J&K GEARS UP FOR CENSUS 2027

CS-led committee to decide on 30-day window for houselisting operations

SRINAGAR, JAN 10: Jammu & Kashmir has geared up for Census 2027, with the Union Territory-level Census Coordination Committee expected to soon decide on a 30-day window for houselisting operations (HLO) between April 1, 2026, and September 30, 2026.

Talking to news agency—Kashmir News Observer (KNO), Amit Sharma, Director of Census Operations and

Director of Citizen Registration for the Union Territories of Jammu & Kashmir and Ladakh, said that Jammu & Kashmir is expected to decide shortly on the timeline for conducting houselisting operations.

"The census coordination committee will decide on a 30-day window between April 1 and September 30, 2026," he said, adding that houselisting operations constitute Phase 1 of the census exercise.

He further said that Phase 2—the population enumeration exercise will be undertaken in September 2026 in snow-bound areas of

the UT level coordination committee for census is headed by Chief Secretary Atal Dulloo. It is expected to decide on a 30-day window for HLO in its next meeting.

Sharma explained that houselisting operations constitute Phase 1 of the census exercise.

Anaemia Shadows Childhood in J&K : Over 72% Under-Five Affected

Doctors Link Alarming Prevalence to Poor Nutrition, Iron Deficiency and Inadequate Feeding After Six Months

SRINAGAR, JAN 10: More than 72 per cent of children below the age of five in Jammu and Kashmir are anaemic, placing the Union Territory among the worst-affected regions in the country and raising serious concerns about child health and development.

According to the Children in India 2025 report released by the

Ministry of Statistics and Programme Implementation, 72.7 per cent of under-five children in J&K suffer from anaemia. The prevalence is higher among boys (73.9 per cent) than girls (71.4 per cent), with rural areas reporting 73.5 per cent and urban areas 70.1 per cent.

Medical experts have described the figures as a major public health challenge, warning that anaemia in early childhood can impair

physical growth, weaken immunity, delay brain development and reduce learning ability, besides increasing vulnerability to infections.

Child health specialists say nutritional deficiency particularly iron deficiency is the primary cause. Young children require high levels of iron for rapid growth, but many diets fail to provide adequate

Security Tightened as Tourists Surge in Snowy Bhaderwah

BHADERWAH/JAMMU, JAN 10: Security arrangements have been strengthened across snow-bound tourist destinations in Jammu and Kashmir's Doda following a surge of tourists over the past fortnight, officials said on Saturday.

The visible deployment of security personnel at popular high-altitude meadows, including Chattargalla (11,000 ft), Pan Nallah (10,200 ft) and Guldanda (9,555 ft) along the Bhaderwah-Patankot highway, is aimed at boosting visitors' confidence and maintaining strict vigilance to ensure their safety, the officials said.

Despite harsh weather conditions, the strong presence of Jammu and Kashmir Police's Special Operations

CS Pushes Expansion of AYUSH Services Across J&K

JAMMU, JAN 10: Chief Secretary, Atal Dulloo, today chaired a review meeting to take stock of the progress achieved under the National Ayush Mission (NAM), with emphasis on service delivery, infrastructure creation and outreach initiatives aimed at strengthening Ayush-based healthcare across the districts of J&K.

Those who attended include Secretary, H&ME; Principal, GMC Srinagar; Commissioner, FDA; Director, Health Kashmir/Jammu; Director, Ayush and other concerned officers.

During the meeting, the Chief Secretary was informed that all 523 Ayushman Arogya Mandirs (Ayush) across the UT have been fully operationalized since 31st March 2025. These centres are providing a wide range of Ayush wellness interventions and patient care services based on Ayush principles and practices.

Reviewing the status of infrastructure development, it was apprised that the 50-bedded Integrated Ayush Hospital at Chawgam, Kargil, has been completed and made fully operational. The hospital recorded an OPD footfall of 12,852 patients during 2024-25



and 5,546 patients during 2025-26 up to December 2025. An amount of Rs 105 lakh has been approved under SAAP 2025-26 for completion of allied works, including landscaping, herbal garden development and other facilities, besides manpower support.

The meeting was further informed that the 50-bedded Integrated Ayush Hospital at Billawar, Kathua, has achieved around 80 percent physical progress, with finishing works such as tiling and aluminum works underway. An allocation of Rs 70 lakh has been approved for construction of

to focus on indigenous manufacturing and take up production of at least one item that is not currently made in the country.

The Home Minister lauded the Maheshwari community for its contribution to the freedom movement and its continued role in India's development after Independence. He said such community conventions strengthen national unity and do not divide society.

"If every community supports its weaker sections and becomes self-reliant, the nation as a whole will move forward," Shah said.

On the occasion, Shah also released a commemorative stamp recognising the contribution of the Maheshwari community to the country's social and economic development.

Media Is Key.....

During the interaction, Dr. Jitendra Singh spoke about key legislative and policy developments, including provisions of the SHANTI Act, the significance of Small Modular Reactors in India's clean energy transition, and the progress of nuclear power projects across different parts of the country. He emphasized that nuclear energy will remain central to India's long-term energy security while supporting climate goals.

Highlighting governance reforms, the Minister said technology-driven initiatives are enhancing transparency and accountability, citing platforms such as CPCRAMS as examples of citizen-centric digital governance. He also pointed to growing international interest in India's administrative and digital governance models.

Referring to citizen-focused initiatives, Dr. Singh highlighted the Digital Life Certificate campaign and other digital reforms that have simplified procedures for pensioners and improved ease of living and ease of working.

On the research and innovation front, the Minister described the ₹1 lakh crore Research, Development and Innovation funding initiative as a transformative step to strengthen India's innovation ecosystem, boost private sector participation and accelerate the journey from research to real-world impact.

He also shared updates on developments in the space sector, including upcoming lunar missions such as Chandrayaan-4 and Chandrayaan-5, and underlined the expanding role of space applications in areas like communication, weather forecasting, disaster management, agriculture and navigation.

Touching upon science-led socio-economic initiatives, Dr. Jitendra Singh referred to programmes such as the Lavender Revolution, noting their contribution to livelihood generation in rural and hilly regions through the integration of science, technology and local entrepreneurship.

The interaction concluded in an atmosphere of mutual appreciation, reaffirming the shared commitment of the government and the media to informed discourse, transparency and collaborative nation-building.

Jammu & Kashmir and in February 2027 in the plains of the Union Territory.

"The population enumeration exercise will be undertaken in September 2026 across Ladakh, keeping in view its classification as a snow-bound region," he added.

The census holds significance for Jammu & Kashmir for two reasons: it will reveal the exact population of reserved categories, and it will serve as the basis for the next delimitation of Assembly and Lok Sabha segments.

For the first time, the Papadis, Paddaris, Gadda Brahman, and Koli tribes added to the Scheduled Tribe list of Jammu & Kashmir in 2024 will be enumerated as separate tribes.

The census will also provide data on Other Backward Classes (OBCs) in J&K for the first time.

According to details available with KNO, 20 castes/communities are included in the Central list of OBCs for J&K, while 41 are listed in the State (UT) list. In J&K, OBCs are entitled to 8 percent reservation in government jobs.

More importantly, the census will form the basis of the next delimitation of electoral constituencies in the Union Territory, as laid down in the Jammu & Kashmir Reorganisation Act, 2019.

The law stipulates that there cannot be any readjustment of Assembly and Lok Sabha seats in the UT until the figures of the first census conducted after 2026 are released.

The last delimitation exercise in Jammu & Kashmir was completed on May 5, 2022 (KNO).

coldest in the city so far this season, they said. The minimum temperature in the city was 3.8 degrees below the seasonal average.

The bone-chilling cold conditions led to the freezing of the parts of several water bodies, including the interiors of the Dal Lake here.

In south Kashmir, Shopian town was the coldest across the valley, as the mercury settled at minus 8.2 degrees Celsius. Pahalgam tourist resort, which also serves as one of the base camps for the annual Amarnath yatra, registered a low of minus 7.8 degrees Celsius.

The night temperature in the popular ski resort of Gulmarg in north Kashmir's Baramulla district settled at a low of minus 6.8 degrees Celsius, up from the previous night's minus 7.2 degrees Celsius, they said.

The tourist resort of Sonamarg in central

Kashmir's Ganderbal district recorded a minimum temperature of 6.3 degrees Celsius.

Qazigund, the gateway town of the valley, registered a low of minus 6.3 degrees Celsius, the season's coldest, officials said. Kokernag recorded a low of minus 4.0 degrees Celsius, and Kupwara minus 6.1 degrees Celsius, they added.

Kashmir is currently in the midst of 'Chilla-i-Kalan,' 40 days of extreme cold, during which night temperatures often drop several degrees below the freezing point, and the chances of snowfall are the highest.

'Chilla-i-Kalan,' which began on December 21 last year, ends on January 30.

The plains of the valley have not received any snowfall so far this season.

The India Meteorological Department has said the weather is likely to remain dry but cloudy till January 21. (Agencies)

ABC Residency, Gani, and Aksa, and homestays Al Habib, Golden Moon, and Divine Holiday, it reads.

Fines were imposed on the violators for operating without mandatory registration. Additionally, preventive action under Sections 126/170 of the Bharatiya Nagarik Suraksha Sanhita (BNSS) shall be initiated against the owners of all such unregistered establishments, it reads.

Srinagar Police have advised all owners and operators of homestays, hotels, and guest houses to strictly comply with the prescribed legal requirements and ensure timely registration with the concerned authorities to avoid legal action, it reads.

Such verification and enforcement drives will continue in the future to ensure adherence to regulations and to promote safe, lawful, and responsible tourism in the district. (KNC)

iron, folate and vitamin B12. Diets heavily dependent on staple grains and lacking iron-rich foods such as green leafy vegetables, lentils, eggs, meat and fortified cereals further aggravate the problem.

Doctors also point to maternal health as a key factor, noting that children born to anaemic mothers are at a higher risk due to low iron stores transferred during pregnancy and early infancy.

Another major concern highlighted by physicians is improper feeding practices after six months of age. While exclusive breastfeeding for the first six months provides optimal nutrition and easily absorbed iron, breast milk alone cannot meet a child's iron requirements beyond this period. Failure to introduce iron-rich complementary foods, or reliance on watery cereals and low-nutrient diets, significantly increases the risk of anaemia.

Parasitic infections such as hookworm and other gastrointestinal illnesses were also cited as contributors, as they can cause blood loss and hinder nutrient absorption. Doctors added that excessive consumption of fried and packaged foods, though not a direct cause, displaces nutritious foods and leads to "empty calorie" diets deficient in essential micronutrients.

Health experts have urged parents and caregivers to introduce iron-rich complementary foods after six months, combine them with vitamin C-rich items to enhance iron absorption, and avoid overdependence on junk food. They also stressed the importance of government initiatives such as Anaemia Mukt Bharat and Mission Poshan 2.0, which provide iron and folic acid supplementation, fortified foods, routine deworming and immunisation to combat anaemia among children and mothers. Security Tightened.....

Group (SOG) and paramilitary forces, coupled with local hospitality, has helped allay initial apprehensions, enabling tourists to enjoy the natural scenery and activities such as playing with snow.

Bhaderwah is one of the most beautiful destinations and attracts a large number of tourists, but heavy snowfall in the high-altitude mountains surrounding the valley poses significant security challenges, as visitors tend to venture into snow-covered meadows and passes, particularly along the Bhaderwah-Pathankot Highway and the Bhaderwah-Chamba inter-state road," Superintendent of Police Vinod Sharma told PTI.

Despite recent snowfall and very harsh weather conditions with night temperatures dropping to several degrees below the freezing point, the forces are providing security cover in high-altitude tourist destinations for the tourists so that they can feel completely secure.

Visitors are also appreciating the round-the-clock security arrangements and hospitality extended by local vendors.

"We were initially a bit skeptical about safety before coming here, but after reaching Guldanda and visiting Chattergalla Pass, all our fears fizzled out. The police presence along these snow-covered passes is excellent, allowing us to enjoy ourselves to the hilt. The warm hospitality of the locals has made our visit truly memorable, and we would surely love to visit Bhaderwah again," Vishal Sharma, a tourist from Maharashtra, said.

Another tourist, Satish Singh Jhadav from Gujarat, said they received full support from the policemen, noting that adequate check posts

were in place and that the friendly attitude of the local made the trip more enjoyable.

Local stakeholders and tourism strategists have attributed the recent boom in the industry to timely snowfall, coupled with the robust security grid provided by the police and other security forces.

"Earlier, we used to see only the Army deployed at high altitudes during this time of the year when snowfall occurs and temperatures drop well below zero. However, this time, despite limited resources, Jammu and Kashmir Police is doing a commendable job by providing round-the-clock security," Rashid Choudhary, a local, said.

According to president of the vendors association Guldanda, Yasir Wani, more than 19000 tourists have visited the destination in the last 15 days after the first snowfall.

Meanwhile, the residents of Bhaderwah in general and tourism stakeholders in particular have welcomed the Centre's decision to construct a multi-crore cable car project from the Mathola village to 12,500-foot-high Seoj Dhar in the foothills of mighty Kailash Kund glacier.

Seoj Dhar is one of the largest and most beautiful meadows, spread over 30 km, which starts from Bhaderwah in the Doda district to Basantgarh area of the Udhampur district. The meadow remains covered with snow for seven months from November to May, making it the ideal destination for adventure and winter sports.

"...Update on cable car (Gandola) from Mathola to Seoj Dhar. After a day to day follow up with the concerned authorities, the National Highways Logistics Management Limited (NHLML) has invited bids for DPR, which is likely to be awarded by the end of January, so that the study gets completed in next 4 months, and thereafter the execution of work may be undertaken," Union Minister Jitendra Singh said in a recent post on X.

Bhaderwah is also gearing up for a two-day winter festival to be held on January 17 and 19 at Guldanda and New Bus Stand Bhaderwah.

Doda Deputy Commissioner Harvinder Singh said the district administration has made the best possible arrangements for the success of the festival aimed at promoting winter tourism and boosting local economic activities. He said that comprehensive security arrangements would be put in place at all tourist destinations and religious sites to ensure the safety of tourists and residents. (Agencies)

"Revenge is not a good word, but it can be a huge force. We have to avenge our history and take this country to the point where it is great again not just in terms of border security, but economy, social development, every aspect," he said.

Calling those present at the event leaders of the future, Doval stressed the need for strong leadership, which he said has been demonstrated by Prime Minister Narendra Modi.

"Napoleon once said, 'I am not afraid of 1,000 lions led by a sheep, but I am afraid of 1,000 sheep led by a lion.' That is how important leadership is," the NSA said.

"We were a progressive society. We did not attack other civilisations or their temples, but since we were not self-aware when it came to security, history taught us a lesson. Did we learn that lesson?" he asked.

"It is important that we remember that lesson because if the youth forget it, then it would be tragic for the country," he said.

Doval said every conflict in the world is born out of security concerns.

"Why do conflicts happen? It is not that people are psychopaths and enjoy seeing dead bodies. It is because you want to subjugate the enemy nation to protect yourself and make it agree to your terms. You see any conflict in the world right now, it is about imposing one's terms on the other country for security," he said.

"So, we also have to protect ourselves. It is a powerful sentiment; we should be inspired by it," he added.

Doval began his speech by saying that he was taken aback by the invitation from Youth Affairs and Sports Minister Mansukh Mandaviya to address a gathering of youngsters.

"Most of you are at least 60 years younger than me... and I was wondering what could I possibly discuss with you. My youth is long over, I do not even know what your youth is all about," he quipped.

But he did have some advice for the youngsters based on "lived experiences" — be decisive and have the conviction to stick to those decisions.

"And please remember, dreams do not make a life, they merely give direction to it and also, they are not fulfilled in a day," he said.

"For dreams to become real, you have to prove your decisions to be correct. Also, motivation is temporary, but discipline is enduring. So, do not quit, tenacity is very important. Do not lose faith in yourself," he added.

The NSA said the youth should focus on innovation in technology and science.

"No message is more powerful than performance. Innovate and achieve silently. Propaganda cannot deliver the message, only what you do gets it across. Remember that all courageous people are patient, all cowards are impatient and noisy," Doval said. (PTI)

Troops intensify.....

sectors, as well as critical areas in the Jammu region, are under intensified monitoring.

Along the IB, BSF personnel are carrying out continuous patrolling, digital surveillance, and other precautionary measures.

Officials told the news agency—Kashmir News Observer (KNO) that troops are maintaining strict dominance over sensitive sectors and are ready to respond promptly to any security threats.

They said the Border Security Force (BSF) recovered an arms and ammunition consignment dropped by a Pakistani drone near the IB in Samba district.

The packet discovered in the Regal forward area during routine surveillance contained two pistols, three magazines, 16 rounds of ammunition, and a grenade, they said.

"The consignment was likely intended to fuel disruptive activities in the border region. The timely recovery prevented a potential security threat," a BSF spokesperson said in a statement, adding that security measures have been strengthened and additional surveillance has been deployed.

Meanwhile, a suspicious pigeon was caught in the forward village of Kharah in the Akhnoor sector near the LoC.

The pale grey bird, marked with red and yellow rings on its legs, inscribed with "Rehmat Sarkar" and "Rizwan 2025," was found by a 13-year-old local boy.

Officials said the pigeon's wings were also stamped, and the bird has been handed over to Pallanwala police for further investigation.

In a separate development, Jammu Police continued their crackdown against narco-terror networks under Operation Sanjeevani.

Rohit Kumar alias Makhan, a key accused, was arrested on January 3, leading to the seizure of a pistol, magazine, and live rounds from his residence in R.S. Pura.

Officials said investigations are ongoing to trace cross-border and inter-state linkages of arms and narcotics supply—(KNO)

the boundary wall, and the project is scheduled for completion by March 2026.

Similarly, the 10-bedded Integrated Ayush Hospital at Gadhia Garh, Jammu, has been made operational in the building of Sub-Centre Lower Gadhia Garh. OPD services at the facility have catered to 7,609 patients during 2024-25 and 4,713 patients during 2025-26 up to December 2025. An amount of Rs 122.50 lakh has been approved for construction of an additional block and engagement of manpower.

The Chief Secretary reviewed the implementation of Ayush Public Health Programmes, and it was reported that targets have been exceeded in several areas. Under the National Programme for Prevention and Management of Osteoarthritis and other Musculoskeletal Disorders, 62 units have been operationalized, with 59,628 people screened and 48,576 patients provided Ayush treatment.

Highlighting the performance the Director, Ayush, Dr Suresh Sharma apprised the meeting that under SUPRAJA, focusing on maternal and neonatal health, 33 units have been made functional, while 40 units

each have been operationalized under AYURVIDYA for school health and KARUNYA for palliative care.

He further divulged that the VAYO MITRA programme for geriatric healthcare is being implemented through 22 units, benefiting thousands of senior citizens. He added that the Mobile Medical Units and NPCDCS components are also expanding Ayush outreach to remote and under-served areas.

The meeting also reviewed the outcomes of Ayush wellness interventions delivered through Ayushman Arogya Mandirs. It was given out that during 2024-25 and 2025-26, lakhs of beneficiaries were reached through yoga sessions, OPD consultations, distribution of medicines, non-communicable disease screening, Prakriti Parikshan, and community awareness initiatives, reflecting the growing acceptance of Ayush services among the public.

On financial progress, it was informed that during 2024-25, an expenditure of over 71 percent was achieved under NAM. For 2025-26, funds amounting to Rs 37.31 Cr have been on-boarded through SNA-SPARSH, with significant releases already made to implementing agencies. Overall expenditure of over 80 percent is expected to be achieved by the end of March 2026.

The Chief Secretary also reviewed progress in Ayush educational institutions, including Government Ayurvedic, Unani and Homeopathic Medical Colleges. Academic activities, infrastructure strengthening, creation of teaching and non-teaching posts and approvals for new courses were discussed as part of the efforts to strengthen human resource capacity in Ayush systems.

Measures undertaken to enhance the visibility of Ayush in the UT were also highlighted. Large-scale IEC and BCC campaigns have been conducted across the districts of the UT, covering lakhs of beneficiaries through themes such as Har Ghar Ayush, Yoga and Meditation, Nasha Mukt Abhiyan, Anemia M

J&K indivisible, division talk mere propaganda: Ansari

SRINAGAR, JAN 10: Peoples Conference General Secretary Molvi Imran Reza Ansari has strongly affirmed that Jammu & Kashmir remains an indivisible entity, bound together by a shared history, deep economic interdependence, cultural links and a common future. He stated that attempts to portray it otherwise ignore both historical reality and ground sentiment.

Acknowledging regional disparities, Ansari noted that for decades, Kashmir has borne the brunt of conflict, instability and economic stagnation, while Jammu has witnessed greater progress in infrastructure, connectivity and access to opportunities. "This imbalance is real but exploiting it to argue for division is neither honest nor constructive," he asserted.



The General Secretary dismissed what he termed the "selective development" narrative, calling it a carefully crafted piece of political propaganda repeatedly pushed to justify fragmentation. He criticized a handful of individuals with clear malafide intent who are projecting themselves as spokespersons for entire J&K.

"They do not represent Jammu and Kashmiris are not even part of these conversations. No individual or pressure group has the moral or democratic authority to speak on behalf of millions or to toy with the future of an entire region. These are not jokes or social media debates, they are serious matters with long-term consequences," Ansari emphasized.

Pointing to Ladakh's experience as a stark warning, he stated that fragmentation did not deliver the promised empowerment or stability; instead, it deepened alienation, uncertainty and administrative disconnect. Ansari concluded that the way forward is not through division, but through unity, through the restoration of full statehood to the entire Jammu & Kashmir, equitable and region-balanced development, respect for democratic voices and a sustained commitment to peace and political empowerment for all its people.



During the meeting, the Deputy Commissioner took a comprehensive review of key health indicators with respect to progress of the enrolment of Ayushman Bharat Health Account (ABHA) IDs, the status of enrolment of eligible beneficiaries under the Ayushman Vay Vandhana Card and the implementation of Tuberculosis



(TB) control and surveillance measures in the district.

While reviewing the medical zone-wise progress in the generation of Ayushman Bharat Health Account (ABHA) IDs, the DC stressed the need for accelerating

enrolment to ensure seamless digital health records and improved access to healthcare services. He directed the concerned officers to intensify awareness campaigns and ensure maximum coverage, particularly among vulnerable

sections of the population.

The DC also reviewed the status of enrolment of eligible senior citizens under the Ayushman Vay Vandhana Yojana and emphasised swift enrolment to enable senior citizens to avail the benefits of

free and cashless healthcare services. He directed Zonal Medical Officers and other concerned officials to coordinate closely with field staff to ensure that no eligible beneficiary is left out.

DC Kupwara reviews implementation of NRLM in district

The Deputy Commissioner conducted a thorough block-wise evaluation of bank linkage advancement, credit disbursal to SHGs, physical accomplishments, identification of prospective Lakhpati Didis, development of Agri-Nutri Gardens, and constitution of Producer Groups. He directed concerned officers to rectify deficiencies in capitalization and guarantee prompt credit provision to all qualifying SHGs.

Achievements under Lakhpati Didi initiative were also discussed. He also directed optimal utilisation of Community



Mobilization and Training Centres (CMTCs).

Pending matters at banks were scrutinized, with directives to financial institutions to resolve them on utmost priority. NRLM officials were instructed to enhance collaboration with banking entities for seamless credit facilitation.

Convergence with line departments including Agriculture, Animal Husbandry, and Horticulture as well as with Mission Yuva was reviewed, advocating intensified integration.

He also directed special focus in vibrant villages. Coverage under different social security schemes and mobilisation of SHG members in Nasha Mukta Bharat Abhiyan was also discussed during the meeting.

DC Ramban reviews JKRLM, sets targets for social security coverage

It was further informed that SHG savings have reached 648.39 lakh, while 2,292 SHGs have received 343.80 lakh as Revolving Fund and 1,400 SHGs have been provided 910 lakh under Community Investment Fund (CIF).

The Deputy Commissioner directed officials to ensure 100 percent achievement in bank linkages, SHG formation, household coverage, Lakhpati Didi initiatives, women farmers' training in agro-ecological practices, Integrated Farming cluster, agri-nutri gardens, producer groups and establishment of custom hiring centres and other related initiatives.

The Deputy Commissioner also directed to ensure that all SHG members in the district are covered under key insurance schemes, especially the Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and Pradhan Mantri Suraksha Bima Yojana (PMSBY), within the

stipulated timeframe.

He also directed field functionaries to intensify awareness about the Atal Pension Yojana (APY) and encourage SHG members to enroll for long-term social security benefits.

Time to regulate consultation fee for doctors carrying out private practice

Thousands of doctors are carrying out private practice at the different clinics in the union territory of Jammu & Kashmir, but it is quite surprising that there is no fixed consultation fee for the same. The doctors charge according to their own wish and they are least bothered about the affordability of a particular patient. At times the patients could be seen pleading with the owner of the clinic over this issue, but at the end of the day they fail to convince the other side.

Some years back the health & medical education department had fixed consultation fees for the different levels of medicos carrying out practice at the private clinics. However, it has been observed that the consultation fee charged by a doctor is according to the wish of that particular doctor. At times the consultation fee of a particular medico is decided by the owner of the clinic and the people are more than willing to pay for the consultation fee fixed by the clinic owner.

It seems that the health & medical education department has limited its mandate in this regard to the mere issuance of the order since no follow-up action was taken. No raid was carried out on any clinic and this inaction from the people at helm emboldened the doctors and the clinic owners to fix consultation fees of their own. At the end of the day, it is the common man who suffers and there are very few people who are concerned about the same.

It is very important that the consultation fee of a particular doctor is fixed according to his or her experience in that particular field of medicine. At the same time, it is important that strict vigil is carried out on the doctors working in the government sector. Many of such doctors usually leave the hospitals earlier and can be seen rushing towards their clinics in order to earn quick bucks. This is a serious matter and needs immediate action from the concerned authorities.

In places other than Jammu & Kashmir a medico has to choose between a government job and a private one. The union territory of Jammu & Kashmir has its own set of rules in each and every sphere of life and medicine is no exception. There is no harm in earning more but the doctors should remember that medicine is a noble profession and people consider a doctor no less than a God.



Amin Bhat's most acclaimed plays termed as plays of Identity by Indian

Express, have been staged during the past decade when a bold initiative was taken by Bhat and some of his theatre colleagues to re-start theatre activities in Kashmir. The plays like Naad, awarded as the best play by Academy and Doordarshan; Tchal (The Trap); White Paper, Shinakti Card, acknowledged as a classic in Kashmiri literature and filmed by Doordarshan; White Paper and April Fool, are some of the highly acclaimed stages plays written and directed by Bhat. Our ears and eyes have grown so accustomed to mortality from disease and disaster, that increased life expectancy, courtesy cutting edge medical technologies and their implications, seldom catch attention. The foremost impact is an ageing world population, likely to overtake the child population. This change will be more pronounced in middle to lower-income countries. Before we traverse the distance any further, it is important to understand what are the issues which elderly people face universally. Top of the charts is deteriorating health which can be age-related or due to a specific disease. Ailing with ageing infests inability thus affecting the quality of life. The life cycle characterized by total dependence to reduced dependency and independence completes the circle to culminate again on partial or total dependence. It starts from physical incapacitation, leading to economic insecurity. People who have been pillars of strength for their families, start feeling unwanted and redundant. Mental depression sets in, and with it comes

isolation from rest of the society. This isolation can be manifested in different ways. It can lead to neglect, neglect of oneself or neglect by those who are around them. Unfortunately, physical and mental abuse can be triggered by none other who otherwise are considered part of social support networks like children, siblings and even caregivers. A sense of fear can creep in. Fear of looming death or the unknown, fear of moving around, fear of all round dependency and the ultimate fear of being useless and being redundant. Boredom is yet another fallout of neglect which further impairs the social behavior of ageing people. The overall outcome can be low self-esteem and loss of control of one's life.

From the caregivers' perspective, irrespective of, providing kin-care or paid care to the elderly people, it imposes few challenges. It is a common observation that elderly people are demanding individuals who put on extra expectancy load on caregivers. Owing to the effects cited above, they tend to be reclusive and less sharing, more rigid and stubborn in their attitudes and opinions. The sheer notion of life experience makes them authoritarian who are more nagging and ruthless critics. Therefore, taking care of elderly requires calm, composure, training and above average interpersonal communication skills. The aforesaid issues call for ease of access to healthcare and economic security for the ageing people, discussion on dynamics of which is not aimed here, however focus

shall remain on social aspect and fallouts of the same. Western societies, providing for growth opportunities for everyone, are more liberal in formulation of basic unit of society i.e. home and family. Family ties have different meanings and cultural connotations of social support. Children attaining adulthood make their way out of parental controls. They start a life of their own only communicating with or attending to their parents as and when hectic schedules allow them to do so. In many cases communication completely breaks down. Siblings normally show up for family reunions only.

Broken families or passing away of life partners also beacons a lonely old age, in those societies.

In eastern societies like ours, the basic social unit; family, is still rigidly intact. With religion as the driving force in lives, such like caregiving remains more of an obligation than a favor. Off springs tend to be cognizant of the sacrifices the parents made in rearing and providing for them. This obligation is also fulfilled by grandchildren, siblings, nephews and nieces, where required. Kin-care to be precise. But times are changing, with five percent of Pakistan's population over sixty-five years and unabated rural to urban migration for better livelihoods, demography is being altered, resulting in parents being left behind, warranting dependent care for elderly.

What to do? We got three choices at hand keeping in view our social setup. One, we keep mum, as we are now and keep contesting the idea of elderly care away from families. Two, we follow the west and leave the elderly in old homes and secludes. Three, we develop a hybrid of the first two options. Instead of inflicting the psycho-social trauma of isolation, neglect and abuse to the elderly at home, afford them an opportunity to be socially active, wanted, and feel good, through a combination of family and peer support. Places, need to be developed where elders can be brought in from nearby places or dropped in by the families to share their thoughts and activities. Group discussions can be arranged, experience of

healthy and active peers can be put to use. Yoga sessions under the supervision of trainers can be planned. Lectures on health issues of the elderly and its management, can be delivered. Elderly can be grouped as per their interests and pertinent activities can be generated. At the end of the day these elderly people can go back to their families, giving a rundown of the day. Imagine the positive effects of it on their mental and physical health and of course, family ties.

All this will need direct and indirect patronage by the government. Requisite infrastructure (can be make shift initially) for these recreational homes housing, kitchens, clinics, gymnasiums, lounges, prayer places, libraries and gardens can be developed. Qualified human resource like health-care workers, nutritionists, fitness trainers, and hobby specialists shall be required to run such places. Transportation facility, to and from such like recreational homes can be charged. Separate spaces can be allocated for elderly men and women keeping in view our cultural and religious confines. A pilot project to this effect can be launched at the selected district headquarters and basing on the response and efficacy these facilities can be extended nationwide. Later, private sector can be incentivized to develop such facilities. For sure, society has got a responsibility towards its senior citizens, they may be old but, are gold.

Best Foods to Help You Live a Longer, Healthier Life, According to Research

Looking to boost longevity in 2026? A Mediterranean diet may be the best place to start. Numerous studies indicate the Mediterranean diet affords many health benefits Trusted Source, including promoting longevity.

"This diet is anti-inflammatory, it's cardio-protective [and] protects our heart and other organs," said Dana Hunnes, PhD, a senior clinical dietitian at UCLA Health.

"It is full of unprocessed, whole foods," Hunnes said of the Mediterranean diet.

"It is high in fiber, which helps keep us regular and can help decrease inflammation. It has heart-healthy fats, primarily monounsaturated fats and some polyunsaturated omegas from plant sources. It's full of water from the high amount of plant-based foods, and it's a lifestyle, so the calorie intake is within reason to keep us maintaining our weight properly," she noted.

■ Mediterranean diet linked to lower mortality rates

The Mediterranean diet consists of fruits, vegetables, legumes, tree nuts, and whole grains. It emphasizes minimally processed, plant-based foods, along with lean meats or fish, and olive oil.

Of all diets, the Mediterranean diet is one of the most extensively studied, and the science supports it as a good choice for health promotion.

Research indicates that following a Mediterranean eating pattern is associated with a 25% reduction in overall mortality rates as well as significant reductions in rates of cardiovascular disease.

The foods eaten in a Mediterranean diet pattern have omega-3 fatty acids, monounsaturated fats, and polyphenols, which all provide antioxidant and anti-inflammatory benefits.

"Reducing oxidation, inflammation, and maintaining a healthy gut microbiome promotes health and longevity," Mir Ali, MD, board certified general surgeon, bariatric surgeon, and medical director of MemorialCare Surgical Weight Loss Center at Orange Coast Medical Center in Fountain Valley, CA, told Healthline.

"Foods that promote life expectancy include proteins,

non-starchy vegetables, some fruits like berries, whole grains, nuts, legumes, and seeds. These types of foods promote cardiovascular health, reduce insulin resistance, decrease inflammation, and help to maintain a healthy weight."

Dietary patterns, such as the Mediterranean diet, are popular in countries like Greece, southern Italy, and Spain, as well as in some "Blue Zones," which have high concentrations of centenarians or people living to 100 and beyond.

■ How nutrition impacts the life span

It is believed that diet can play a significant role in longevity. "Food in general has a huge impact on health and longevity;

eating foods that can promote adverse health effects like diabetes, hypertension, and obesity will decrease a person's lifespan; whereas, foods that help someone avoid adverse health conditions, and maintain a healthy weight and lifestyle will increase lifespan," Ali said.

Research suggests that nutrition plays a crucial role in mitigating the effects of aging mechanisms on the body and enhancing longevity.

Diet can influence the level of oxidative stress in the body, age-related damage, inflammation, and cellular function.

"There are foods [and] diet patterns that keep us healthier, decrease inflammation in the body, and may decrease the rate at which our DNA [telomeres] shortens or gets damaged," Hunnes said.

■ Coffee may play a role in longevity

Along with the foods that form part of the Mediterranean diet, coffee may also be beneficial for improving longevity.

Around 60% of Americans drink coffee every day, and research suggests that may be a good thing.

Moderate coffee intake (about three to five cups of coffee per day) is associated with reduced overall mortality. It may also reduce the risk of major diseases like diabetes, stroke, cardiovascular disease, respiratory conditions, cognitive decline, and some types of



cancers like uterine and liver cancer.

"Coffee is rich in antioxidants and does have a positive metabolic effect as well. It also may improve glucose control and slow DNA breakdown (which can lead to early cell death)," Ali said.

Coffee can also improve lung function and increase fat oxidation. However, Hunnes warns that adding too many ingredients to a cup of coffee could reverse some of its benefits.

"It has many antioxidants in it and phytonutrients (nutrients derived from plants) that may reduce inflammation and therefore morbidity (illness), chronic disease, and mortality. Reducing inflammation in the body is associated with longevity, so, the more we can do to reduce inflammation, the better. Coffee benefits aside, what you put into your coffee is also important. Heavy cream or excess sugar could negate some of the health benefits, Hunnes said.

Whilst coffee and the Mediterranean diet are believed to boost longevity, red meat is believed to do the opposite.

Research suggests that red meat can accelerate aging and is associated with a variety of adverse health outcomes. "Red meats are higher in saturated fats and nitrates, which has been shown to have a negative effect on cardiovascular health as well as cancer, which will decrease life expectancy," Ali said.

However, research on saturated fats has been inconclusive so far. Research also shows that nitrates may only be problematic when they are additives, not when they are from natural sources.

Along with red meat, sugary beverages are also believed to have a negative impact on aging.

Recent research Trusted Source suggests an inverse association between sugary beverages and healthy aging.

"Drinks high in sugar lead to weight gain, diabetes, and cardiovascular disease, all of which contribute to decreasing life expectancy," Ali said.

In the standard Western diet, sugary drinks are a leading cause of added sugars.

Data Trusted Source from the Centers for Disease Control and Prevention (CDC) suggests that roughly half of adults consume a sugar-sweetened beverage every day, while more than 60% of kids do the same.

"(Sugary beverages) replace healthier foods/beverages in the diet that don't add calories (and nothing else healthy) to the diet. They increase insulin need, inflammation, increase the risk for fatty liver, diabetes, heart disease, metabolic syndrome, and do not provide vitamins or minerals (naturally occurring). We don't need empty calories in our diets," Hunnes said.

■ Ultra-processed foods may raise death risk

Sugary drinks are just one of many ultra-processed foods that can have a negative impact on overall health and longevity.

health issues.

"Ultra-processed foods are high in preservatives and unhealthy chemical additives to promote shelf life and increase taste. They are also high in sugar, low in fiber, and low in critical nutrients. All of this promotes cardiovascular disease, diabetes, and cancer, thus leading to a decreased life expectancy," Ali said.

Making dietary swaps from ultra-processed foods to whole foods is a good starting point toward improved longevity, but experts acknowledge that, at an individual level, this is a process that takes time. "The biggest health concern in the U.S. and most westernized countries is obesity, and implementing healthy foods, as discussed, can reduce obesity, and thereby increase longevity," Ali said.

"This has been known for some time; however, implementing significant dietary changes and educating many people remains a challenge."

Vaccination and screening target cervical cancer

Doctors are urging people to be screened and vaccinated in a bid to eliminate cervical cancer by 2040.

NHS England South West said there were more people in the region proportionally who have been diagnosed with cervical cancer than in the rest of England.

Public health consultant Dr Matthew Dominey, the screening and immunisation lead, said the 2040 goal was achievable and encouraged people to have cervical screening and be vaccinated for human papilloma virus (HPV).

He said cervical cancer "absolutely can be eradicated" and evidence from the HPV vaccination programme started in Scotland in 2008 showed no-one fully vaccinated had developed cervical cancer.

Dominey said cervical cancer leads to about 685 deaths in England each year and more than 99% of cases were caused by HPV.



He said the higher average of cases in the region was partly because there was a "really good screening program in South West that is really good at picking up cancer at an early stage".

The other reason was the region being rural, so there were issues around accessing hospital appointments and challenges

of public transport that could delay treatments.

Dominey said: "The most important thing is, if you are a woman aged between 25 and 64, attend for your cervical screening appointment.

"For younger people, boys and girls get a vaccination in school."

He said women could check with their GP surgery if they were due for a cervical screening test.

"If you're overdue, they'll be able to book you for appointments, so it's absolutely never too late to go and get screened."

The consultant encouraged anyone who was worried about the cervical cancer screen test to take a friend or family member with them and advised women they could request a female doctor or nurse carry out the test.


Some women may benefit from a familiarisation visit beforehand to see how the test would happen and surgeries would organise that, he added.

Dominey concluded: "There is treatment and we know that this is a disease that, if we get younger people vaccinated, we can prevent and we can eliminate in its entirety if we get people vaccinated." (BBC)

ACB traps, arrests Patwari in Budgam for demanding bribe

SRINAGAR JAN 10: Acting on a complaint, the Anti-Corruption Bureau (ACB) Jammu and Kashmir on Saturday said it has arrested a Patwari from Budgam for allegedly demanding and accepting a bribe of rupees 10,000 / 30,000 for issuance of a revenue extract and bank lien certificate.

According to a statement issued to the news agency—Kashmir News Observer (KNO), the Jammu and Kashmir Anti-Corruption Bureau received a written complaint wherein the complainant has alleged that he had applied before the concerned Revenue authorities for issuance of Revenue extract and bank lien certificate for the said property situated at Rakh Soothu BK Pora for Bank Guarantee. For getting these documents he approached the concerned patwari of Halqa Rakh Soothu, namely Riyaz Ahmad Khan, but instead of processing the case in due manner, the concerned patwari demanded bribe of rupees 10,000 / 30,000 before he would prepare and provide the required documents.

The statement reads, the complainant, stating that he is against corruption, has approached ACB



Srinagar seeking legal action against the accused official. On receipt of the complaint, discreet verification was conducted, which confirmed the demand of bribe by the accused public servant.

"Accordingly, Case FIR No. 02/2026 U/S 7 PC Act 1988 was registered at Police Station ACB Srinagar and investigation was taken up. During the course of investigation, a trap team was constituted which laid a successful trap and caught the accused Riyaz Ahmad Khan, Patwari Halqa Rakh Soothu, Budgam red-handed while demanding and accepting the bribe amount of ₹10,000 from the complainant."

Each month pairs imagery of Kashmiri shawls and craft traditions with selected couplets attributed to Sheikh-ul-Alam (RA), presenting poetry as a living cultural presence rather than a historical reference.

The calendar's design draws on traditional motifs such as paisleys, chinar leaves, almond blossoms, and the tree of life, commonly found in Kashmiri textile and decorative arts.

Recurring focus throughout the calendar is the shawl as a cultural object—from raw Pashmina fibre to intricate weaving techniques—positioned alongside Sheikh-ul-Alam's verses that speak of simplicity, ethics, labour, and harmony with nature.

Satish Sharma seeks major sports infrastructure push for J&K

Submits comprehensive memorandum to Union Sports Minister

NEW DELHI, JANUARY 10: Minister for Food, Civil Supplies & Consumer Affairs (FCS&CA), Information Technology, Youth Services and Sports and Transport, Satish Sharma, today met with Union Minister for Youth Affairs and Sports, Dr. Mansukh Mandaviya and projected several issues and initiatives related to sports upgradation aiming transformation of Jammu and Kashmir into a national hub of sports excellence.

The Minister submitted a comprehensive Memorandum outlining an ambitious, multi-sectoral roadmap to upgrade sports infrastructure, promote youth engagement, generate employment and position Jammu and Kashmir as a premier destination for sports tourism and high-performance training.

Highlighting cricket as a passion for the people of Jammu and Kashmir, Satish Sharma sought sanction of international-standard cricket stadiums at Srinagar and Jammu. He stated that the absence of such facilities has long restricted the region from hosting national and international fixtures. He emphasized that these stadiums would not only revive top level cricket in the UT but also boost tourism and inspire a new generation of athletes.

The Minister also proposed creation of a Border Sports Development Circuit spanning Kathua-Samba, Akhnoor-Chhamb, Poonch-Nowshehra-Rajouri, Uri-Baramulla-Kupwara and Karna-



Gurez, aimed at harnessing the sporting talent of youth living in border and far-flung areas. He sought special grants for development of Dangal Akharas, cycling tracks, hockey and football fields besides provision of sports equipment in all border panchayats to strengthen grassroots sports and youth engagement.

To promote employment through sports, Satish Sharma requested for a financial support of 600 crore over five years for establishing 10 Border Sports & Employment Hubs (BS-EH), five each in Jammu and Kashmir, equipped with multi-sport facilities,

skill training classrooms and residential infrastructure. He also proposed a Border Youth Sports Apprenticeship Programme with an outlay of 300 crore, a Coaches & Trainers Wage Support Scheme of 150 crore and a High-Altitude & Winter Sports Livelihood Programme of 120 crore for areas like Gurez, Tangdhar and Teetwal.

The Minister laid special emphasis on water and winter sports, seeking establishment of a National Water Sports Centre of Excellence at Basohli (Kathua) by upgrading the world-class facility at Ranjit Sagar Dam. He also proposed declaring Jammu &

Kashmir as India's National Hub for Paddle and Water Sports, leveraging its unparalleled natural water resources.

Satish Sharma further sought revival of the Arun Jaitley International Cricket Stadium Project at Hiranagar, whose upgradation had been sanctioned earlier but stalled due to external impediments. He requested the Union Ministry's intervention to remove obstacles and ensure completion of the project, calling it a landmark for the Jammu region.

To optimally utilise the growing sports infrastructure in J&K, the Minister proposed a Special Coaches

Engagement Scheme for hiring qualified national and international-level coaches on contract basis, especially in priority disciplines like gymnastics, water sports, winter sports and cricket. He also called for regularisation and utilisation of registered NYCs as a skilled human resource base in sports.

Recognising the need for quality accommodation to host national and international sporting events, Satish Sharma sought development of modern Youth Hostels at Jammu and Srinagar under the Khelo India framework to boost sports tourism and training capacity.

Satish Sharma also called for expediting the long-pending National Winter Sports Centre of Excellence at Gulmarg, seeking direct facilitation for engagement of international consultants and release of funds to the J&K Sports Council to kick-start this landmark project.

Speaking on the occasion, Satish Sharma said that Jammu and Kashmir has immense untapped sporting potential and world-class natural advantages. "With focused national support, our youth can become champions on the global stage while sports can become a powerful engine of employment, tourism and regional development," he said. The Minister expressed confidence that the proposals, aligned with the Khelo India vision and National Sports Development Agenda, would help establish Jammu and Kashmir as a leading sporting destination and talent hub of India.

DSU organises one day training cum review meeting under IHIP-IDSP

JAMMU, JANUARY 10: A Divisional-Level One-Day Training cum Review Meeting under the Integrated Health Information Platform (IHIP)-Integrated Disease Surveillance Programme (IDSP) for District Surveillance Units (DSUs) was organised by the State Surveillance Unit (SSU), IDSP, Jammu Division, under the guidance and supervision of Mr. Basser-ul-Haq Chaudhary, Mission Director, National Health Mission (NHM), Jammu & Kashmir and supervised by Dr. Abdul Hamid Zargar, Director Health Services Jammu.

The meeting was organized with the objective of reviewing district-wise implementation of IHIP-IDSP, strengthening disease surveillance systems, improving timeliness and quality of reporting and enhancing preparedness and response to public health emergencies across the Jammu Division.

Dr. Harjeet Rai, Epidemiologist & State Surveillance Officer (SSO), IDSP, Jammu Division, briefed the participants about the purpose and agenda of the training cum review meeting. Dr. Abdul Hamid Zargar, Director Health Services, Jammu, underscored the importance of IHIP as a robust digital platform for real-time disease surveillance, data-driven decision-making and strengthening public health response mechanisms.

Dr. Harbakh Singh, Chief Medical Officer, Jammu, emphasized the critical role of District Surveillance Units in early detection, reporting and containment of outbreaks. The Technical Sessions focused on district-wise review and thematic discussions of all the districts of Jammu division. Key thematic sessions included Community Reporting under IDSP by Dr. Prem Lata, Medical Officer (Epidemiology); Outbreak Investigation and New Initiatives under IHIP-IDSP by Dr. Simran Nag, State Epidemiologist, IDSP; DPHL Assessment by Ajay, State Microbiologist, IDSP and Community Assessment for Public Health Emergencies by Umar Anayat, District Epidemiologist, IDSP, Doda. The sessions emphasized strengthening laboratory support, community-based surveillance, outbreak investigation protocols and recent initiatives under IHIP. The meeting was attended by Chief Medical Officer, District Surveillance Officers, Epidemiologists, Microbiologists, Data Managers and Data Entry Operators who also presented their performance, challenges and best practices related to IHIP-IDSP implementation.

NEW DELHI, JAN 10 : Captain Brijesh Thapa, Lance Naik Stanzin Targias, Rifleman Mohit Rathour, and Rifleman Hilal Ahmad Bhat were posthumously awarded the Sena Medal (Gallantry) during the Western Command Investiture Ceremony organised on Saturday at the Manekshaw Centre in New Delhi.

The ceremony also saw the conferment of other prestigious honors, including Yudh Seva Medals (6), Sena Medal (Gallantry, 30), Bar to Sena Medal (Distinguished, 1), Sena Medal (Distinguished, 19), and Vishish Seva Medal (44).

Hailing from the Army Air Defence and serving with the 10 Rashtriya Rifles, Captain (Late) Brijesh Thapa displayed extraordinary courage on 14 July 2024, leading a search operation based on specific input regarding the presence of terrorists in the forested area of Kishtwar district.

The next day, drawing upon his extensive knowledge of the terrain gained through exhaustive reconnaissance and patrolling, he correctly assessed the likely escape routes of the terrorists and initiated a thorough search of the Gwaries of Gujars in the higher reaches.

During the operation, the search party came under intense and indiscriminate fire from terrorists, resulting in his scouts being hit and falling to the ground.

The officer dashed forward under heavy fire and pulled his injured scouts to safety while during at the terrorist. Owing to limited cover in the open meadows, the officer was hit by terrorist fire and later succumbed to gunshot wounds.

Rifleman Hilal Ahmad Bhat of 19 Rashtriya Rifles demonstrated exemplary courage during a joint operation in Sheikhpura Forest on 8 October 2024.

While tactically closing in on suspicious movement along with his buddy, the duo was suddenly confronted at close range by terrorists lying in ambush.

Realising the imminent threat, Rifleman Bhat fearlessly counter-challenged the terrorists in a close-quarter engagement, deliberately drawing enemy fire upon himself to allow his buddy to disengage, move to safety and alert other surveillance teams.

Despite being repeatedly fired upon, he continued to engage the terrorists until his comrade was

clear of danger. In the course of this gallant action, Rifleman Hilal Ahmad Bhat sustained multiple gunshot wounds and later succumbed to his injuries.

Rifleman Mohit Rathour of 57 Rashtriya Rifles Battalion, serving with the Battalion Ghatak Team, was engaged in an enemy attack in the Gulab Sub Sector on July 27, 2024.

At around 0340 hours, Border Action Team terrorists positioned near the perimeter fence of a post launched a coordinated assault by lobbing grenades and opening

intense small arms fire on the troops.

Responding instantly, Rifleman Rathour moved out from the living bunker and took up a position to engage the terrorists. He crawled forward under heavy fire and engaged the enemy, successfully injuring a terrorist.

During the fierce exchange, he sustained multiple gunshot wounds, yet despite severe injuries and profuse blood loss, he continued advancing towards the enemy. He was struck again by enemy fire and subsequently collapsed and succumbed to his injuries.

Lance Naik Targias of 5 LADAKH SCOUTS was a key member of the Faculty Development Programme for the ascent of Mount Kun (7077 m).

On 08 October 2023, during a route-opening mission on Mount Kun, he voluntarily took the initiative to open the route from Camp-I to Camp-II, to be established at an altitude of 20,250 feet, in extremely steep, treacherous terrain and harsh climatic conditions.

He led the effort to open the route to ensure the smooth conduct of the expedition. During the course of the hazardous mission, a lethal avalanche struck, burying Lance Naik Stanzin Targias, following which he lost his life. UNI

Delhi assembly seeks explanation from Punjab police within 48 hours over FIR linked to Atishi video

NEW DELHI, JAN 10 : Delhi Legislative Assembly Secretariat has issued notices to senior Punjab Police officials over the registration of an FIR in Jalandhar related to an alleged doctored video clip of Delhi Assembly proceedings involving Leader of Opposition Atishi.

According to the notices dated January 10, the FIR was registered by the Jalandhar Police Commissionerate on the basis of a press release claiming that a video clip from the Delhi Assembly proceedings of January 6, 2026, was forensically examined and found to be deliberately doctored.

The matter was brought to the notice of the Speaker during the House sitting on January 9.

Secretariat stated that the Delhi Assembly is already seized of the issue concerning remarks allegedly made by Atishi on the floor of the House.

The matter has been referred to the Committee of Privileges of the Delhi Assembly. It was also noted that the video clip had already been sent for forensic examination on the request of opposition members.

Speaker has expressed grave concern over the action taken by the Punjab Police, stating that the issue falls exclusively within the domain of the privileged House. The proceedings of the Assembly are privileged and are the property of the House, the notice said.

Speaker has directed that an explanation be sought on how the Punjab Police interfered in a matter that was under the consideration of the Delhi Assembly. The notices ask the concerned officials to submit a written explanation along with relevant documents, including copies of the complaint, FIR and forensic report, within 48 hours.

Separate notices have been issued to the Police Commissioner Jalandhar, the Special DGP Cyber Cell Punjab, and the Director General of Police Punjab. Delhi assembly also mentioned that the notices have been issued with the approval of the Speaker.

On Friday, the Jalandhar Police Commissionerate said an FIR has been registered on the complaint of Iqbal Singh regarding the uploading and circulation of an edited and doctored video of Atishi, MLA and Leader of Opposition in the Delhi Vidhan Sabha.

According to the police, several social media posts circulated a short video clip allegedly showing Atishi making derogatory and blasphemous remarks against Gurus, along with inflammatory captions.

A police spokesperson said the investigation was conducted in a scientific manner. The video clip containing Atishi's audio was downloaded from a social media post shared from the X account of Kapil Mishra and was sent to the Director, Forensic Science Laboratory, Punjab, SAS Nagar, for examination.

Jalandhar police statement claimed "as per the forensic report dated January 9, 2026, the word Guru was not uttered by Atishi in the audio contained in the video clip circulated on social media. The report said the video was deliberately doctored and words were falsely attributed through captions that were never spoken by her."

After the FIR was registered by the Punjab Police, Kapil Mishra reacted on social media platform X, saying that FIRs and police pressure cannot scare him.

He claimed that the video is part of the Delhi Assembly records and has been heard by everyone. He alleged that Atishi has not attended the Assembly since that day despite being called several times by the Speaker.

Mishra also accused the Punjab Police of ignoring crimes in Punjab and instead filed an FIR to shield the Leader of Opposition. UNI

What sports needs is a TV push

NEW DELHI, JAN 10 : Olympic sports like athletics, swimming, gymnastics, or, for that matter, the Paralympic Games must have quality telecasts as a first step to nurture and produce champions.

Anyone who has followed Indian sports would know that there is only one sport that dominates the Indian sporting arena, and that too by miles, and that's cricket. While we flounder in our progress in Olympic sports, cricket does teach us a very important lesson or two. The first real step forward in cricket was achieved by the administrative duo of Jagmohan Dalmia and Inderjit Singh Bindra, who realised that quality telecasts of the sport were vital for its popularity and progress.

They fought a battle in the Supreme Court to allow the uplinking of signals, which would allow private TV sports channels to telecast the sport in India and worldwide. Once that victory was achieved, the private sports channels started to bring the sport alive by their quality production and paying of TV rights to the cricket board.

The next step up came with the introduction of the IPL in 2008, following the 2007 World Cup T20 victory for India. The IPL has now been hosted continuously for 18 years and the progress of the sport is there for everyone to see. Stories of Yashasvi Jaiswal, Mohammed Siraj, and, more recently, Vaibhav Suryavanshi abound, while Rishabh Pant's contract of Rs 27 crores has become every sportsperson's and indeed every parent's ambition.

We coach many talented 14-year-olds in athletics who may be technically at a higher level than Vaibhav Suryavanshi, but can we support them even with basic financial assistance to continue playing? Coming from economically challenged backgrounds, they can hardly afford the basic nutrition or protein necessary to pursue their sport. If India is serious about progressing in Olympic sports, and it has shown interest in bidding for the 2036 Olympics, quality telecasts of core Olympic sports like athletics, swimming, and Paralympics must be the first step taken by the government. Many more steps to incentivise sporting activities could follow. Right now, our sports channels have 85 per cent cricket being shown, and thus 85 per cent of the sponsorship and advertising from corporate India also goes to cricket and cricketers. So, the Indian population at large does not know that Sachin Yadav and Sarvesh Kushare are the only two finalists from the current World Championships and may bring glory at the next Asian or Commonwealth Games, and perhaps even the next Olympics too. They struggle to be seen on TV and consequently have very little or no chance to be aided in their endeavours through sponsorship. It is time to immediately get the federation, government, and the corporate world to work on this first step towards making India an Olympic powerhouse. UNI

14 killed, 50 injured as bus plunges into 500-foot gorge; PM announces ex-gratia

NEW DELHI, JAN 10 : Fourteen people, including eight women, were killed and 50 others injured after a private bus traveling from Shimla to Kupvi plunged into a 500-foot-deep gorge in the Haryana region on Friday.

Preliminary investigations indicate that the accident occurred in Himachal Pradesh's Sirmour district. The bus, which has a seating capacity of 39, was reportedly carrying more passengers than its capacity when it lost control and fell into the gorge.

Prime Minister Narendra Modi announced on X, that an ex-gratia of Rs 2 lakh from the PMNRF would be provided to the next of kin of each deceased, while the injured would receive Rs 50,000.

Expressing grief, President Droupadi Murmu wrote on X, "I express my deepest condolences to the bereaved families who have lost their loved ones in this accident. I pray for the swift recovery of the injured individuals."

Himachal Pradesh Chief Minister Sukhdev Singh Sukhdev conveyed his deepest condolences and directed district authorities to provide all possible assistance and ensure the best medical care for the injured.

India presses EU on climate rules as FTA talks near crucial juncture amid US threats

NEW DELHI, JAN 10 : In the midst of US tariff threats to India and an imbroglio over American demands that Greenland be handed over, New Delhi and Brussels are racing to bridge gaps on carbon pricing, steel access and market openings, with a new urgency to clinch a long-delayed free trade pact. India's commerce minister

Piyush Goel had remained locked in marathon trade talks on Friday with his European Union counterpart Maros Sefcovic to try and come to a consensus on contentious issues including Europe's controversial carbon tax and India's red lines on farm subsidies.

Top commerce ministry officials told UNI, "We need the deal, they need it too as both want stable markets, which are shielded from tariff threats

and we both want to decouple from China-led supply chains."

India and EU both want to clinch the deal ahead of the Republic Day visit by European Commission President Ursula Von Der Leyen and European Council President Antonio Costa.

"We are near... very near as far as

I know. Compromises are being found

over EU's carbon border adjustment

mechanism tax and India's labour

movement demands," said Prof Biswajit Dhar, former Head of the Centre for WTO Studies at Indian Institute of Foreign Trade (IIFT). "By the time European Union leaders arrive in New Delhi for the Republic Day celebrations later this month, trade negotiators on both sides hope to have something concrete to show," Dhar said. Other than the threat from US tariffs and policy decisions, other strategic

considerations are also reshaping the talks. Under its Critical Raw Materials Act, the European Union has identified India as a key potential partner for diversifying supplies of rare earths and other strategic minerals in an effort to reduce dependence on China.

India's state-run miner, Indian Rare

Earths, produces between 1,300 and

1,500 tons of neodymium oxide annually, a material vital for electric

vehicles, wind turbines and advanced electronics. "Friend-shoring" such supply chains, European officials argue, could cushion the bloc against future disruptions. The talks which had dragged on for more than a decade, have more or less settled other contentious points and India can hope for tariff concessions on a host of goods ranging from textiles, gems and jewellery to electronics and steel. Shreyas Iyer Cleared To Join India Squad For NZ ODIs

JAIPUR: Shreyas Iyer has been cleared to join India's squad for the upcoming three-match One Day International series against New Zealand, bringing welcome news for the team management ahead of the crucial assignment. The middle-order batter, who was named in India's 15-member squad earlier this month subject to fitness clearance, has successfully proven his readiness through competitive match action and is now set to return to international cricket. Shreyas will link up with the Indian squad on Friday, just two days before the opening ODI against New Zealand, scheduled to be played in Vadodara. His clearance follows a solid outing in the ongoing Vijay Hazare Trophy, where he featured for Mumbai and demonstrated both physical fitness and batting form. The selectors and team management had been closely monitoring his progress, and his performances in the domestic 50-over tournament played a key role in confirming his availability.

India's ODI vice-captain has been out of action since October after suffering a serious spleen injury during the Sydney ODI against Australia on October 25. The injury occurred while he was attempting a catch, and he was subsequently admitted to hospital due to internal bleeding caused by a spleen laceration. As a result, Shreyas was ruled out of India's home series against South Africa, raising concerns about the timeline of his recovery. However, after months of rehabilitation and medical supervision, he has made a full recovery and is now ready to resume duties at the international level.

Shreyas used the Vijay Hazare Trophy as a platform to regain match sharpness and confidence. He scored an impressive 82 and a steady 45 in his two appearances for Mumbai, showing composure and fluency at the crease. In the absence of the injured Shardul Thakur, Shreyas also took on additional responsibility by leading Mumbai as captain in those matches, further underlining his leadership credentials and fitness. Meanwhile, most members of India's ODI squad arrived in Vadodara on January 7 to begin preparations for the series. The opening match holds special significance as the city will host its first men's international fixture in more than 15 years. The newly constructed Kotambi Stadium, which has already staged Women's Premier League matches and women's ODIs, will make its men's international debut on Sunday.



It was meant to be: Young India spinner Vaishnavi on cricket career

Long before Vaishnavi Sharma picked up a cricket ball, she says her future as a sportsperson was known to her astrologer father, Narendra Sharma. "When I was four years old, my journey in sports began. As you all know, my father is an astrologer. He looked at my horoscope and said that I should either go into sports or into the medical field," Vaishnavi told PTI Videos.

"I can't sit idle at home. Even if I'm doing my favourite things, when I have that love for cricket, I don't think about anything else," she added.

Kristian Clarke

After being around New Zealand's squads across formats during the home summer, seam-bowling allrounder Kristian Clarke is in line for a potential international debut, away from home. A tall bowler who can hit the deck and also give it a whack with the bat lower down the order, Clarke is regarded as an allrounder with a high ceiling in New Zealand cricket. In the first chunk of the one-day Ford Trophy, Clarke clattered his maiden List A century against a Central Districts attack, which included Lennox and Ajaz Patel, and followed it with a three-wicket haul. His family - his parents and his partner - have planned to travel to India for

Clarke's potential debut and watch him go up against Virat Kohli and Rohit Sharma.

Adithya Ashok

A legspinner with a sharp googly in his repertoire, Adithya Ashok has been earmarked as Ish Sodhi's successor. Adithya, 23, has already played three white-ball internationals, the last of which came in December 2023. He won his maiden New Zealand contract just before Gary Stead exited as coach, but Walter, the new coach, has preferred the experience of Sodhi. Can Adithya move up the hierarchy in the New Year?

Michael Rae

What's common between All Blacks coach Scott Robertson and Black Caps fast bowler Mi-

chael Rae? Well, both share the same nickname: 'Razor'.

A tall fast bowler, who can move the new ball and bang the older one into the pitch, Rae also rocks the headband like Chris Martin did back in the day. When he felt that his time at the top level had passed, Rae was called into the New Zealand Test squad after a litany of injuries. The 30-year-old played two pre-Christmas Tests and drew messages from a number of people, including someone who sold him a Kiwi saver scheme at his parents' house when he was in his teens. Rae's inbox might be flooded with more such messages if he takes out the likes of Kohli and Rohit in India.
